## Jury Gives Robert Miller Two Life Sentences

A 31-year-old man accused of a \$26,000 burglary in O'Donnell March 13, 1998 was assessed two life terms after a jury in 106th District Court here found him guilty of that charge and another charge of possession of a firearm by a felon.

Robert Miller of O'Donnell received the two concurrent life terms

A 31-year-old man accused of a after the jury also ruled he should be sentenced under the habitual criminal statute because of two or more prior felony convictions.

Dist. Atty. Ricky Smith, lead prosecutor in the case, explained that neither the charges of burglary nor possession of a firearm would have mandated a life term, but because of Miller and another O'Donnell man, who was sentenced after pleading guilty before Dist. Judge George Hansard Tuesday, burglarized the home of attorney John Saleh in O'Donnell on March 13, 1998, and later in Lubbock Miller sold a handgun stolen in the burglary.

The Boy Scouts always have taught high standards in morals and citizenship and in hands-on activities.

When I was in high school, I stayed in Scouting for several years, although I never could quite measure up to some of their standards of achievement. I stayed a tenderfoot all those years because I never could cook a potato fit to eat. I tried several times to complete this part of the second-class scouting requirements, but the scoutmaster just couldn't choke a few bites down. I did win a knot-tying contest once, and I can still tie something called a sheepshank.

I don't mean to slight the Girl Scouts or Cubs here, because they do some great things for youngsters, too. It's just that I never was a Girl Scout myself, except maybe for keeping a sharp lookout a few years in college.

An assistant coach at West Texas A&M University in Canyon was hired as head girls basketball coach for Tahoka Independent School District, and a former teacher here was named Assistant Elementary Principal at the Tahoka I.S.D. Board of Trustees meeting Monday night.

Scott Lucas will begin his coaching duties here at the beginning of the 1999-2000 school year, coming to Tahoka from Canyon, where he is currently assistant women's basketball coach at West Texas A&M University. Trustees unanimously approved a one-year teacher/coach probationary contract with a coaching bonus

Prior to his current position at Canyon, Lucas spent three years as junior varsity and assistant varsity girls basketball coach at Brownfield High School, and he was also an assistant coach for one year at Roosevelt High School.

He earned his Bachelor of Science from Wayland Baptist University in 1994, majoring in history/physical education. While at Wayland, he was a student assistant in the basketball program.

Lisa Ruiz Ramirez was named Tahoka Elementary Assistant Principal in a unanimous decision by trustees, with an administrative contract at a salary of \$33,000. Her term will begin July 1.

meeting, Superintendent David Hutton informed trustees of two teacher resignations effective at the end of the school year. Elementary teacher Misty Guess and high school history teacher Lupe Bernal both have submitted resignations.

Two students transfers were approved, and policy updates adopted as presented. Monthly bills were approved as presented, and Business Manager Ken Eudy reported the 1998 tax collection totaled \$1,005,133 which is 93.37 percent complete.

# County Landfill Hours To Change

The county landfill will be open on Tuesdays, Thursdays and Saturdays, beginning May 1, Lynn County Commissioners decided during their regular meeting Monday morning. The landfill is currently open Mondays, Wednesdays and Saturdays. Commissioners said the change would facilitate better usage, since the site is emptied on Mondays. Hours for the landfill will be 9 a.m. until 6 p.m. on Tuesdays and Thursdays, and 8 a.m. until 5 p.m. Saturdays

In other business, commissioners heard a presentation from Tommy Gonzalez, Managing Director of Civic Services of the City of Lubbock, regarding a feasibility study for the Ports-to-Plains agricultural corridor. Gonzalez explained the routes from Canada to Mexico, and told the court that the City of Lubbock is forming a coalition of members for an interlocal cooperative agreement with cities and counties along the route. Members who join the coalition pay dues based on population.

The City of Tahoka voted just recently to join the coalition, as the route includes Highway 87 through Tahoka and may enable federal grant

funding for road maintenance in the future. Commissioners asked Gonzalez to bring more information regarding the amount of dues for Lynn County.

A new backup generator is needed for the county jail, Sheriff Jake Diggs told commissioners Monday. The generator currently being used needs to be replaced, he said. Commissioners directed Diggs to bring cost proposals for a new generator at a future meeting.

A new sound system will be installed in the district courtroom, at a cost of \$1,046.50. Commissioners voted unanimously to accept a proposal from The Music Box in Lamesa for the sound system.

Also approved by the court was a motion to establish fire guards near a residence in Precinct 3 as well as a home in Precinct 4, for safety measures prior to controlled burns in those areas.

No decisions were made regarding insurance for the county. Monthly bills were approved as presented.

All four commissioners and Judge J.F. Brandon were present for the meeting.






#### **Little League Opens Play Next Week**





#### NOTICE OF WATER QUALITY APPLICATION PERMIT NO. 10632-001

APPLICATION. City of New Home, P.O. Box 274, New Home, Texas 79383, has applied to the Texas Natural Resource Conservation Commission (TNRCC) for a major amendment to Permit No. 10632-001, to increase the acreage irrigated from 6 acres to 35 acres of non-public access agricultural land. The proposed amendment also requests to reduce the disposal of the treated domestic wastewater from a daily average flow not to exceed 50,000 gallons per day to a daily average flow not to exceed 30,000 gallons per day and to change the treatment method from imhoff tank to a facultative lagoon system. This permit will not authorize a discharge of pollutants into waters in the State.

The wastewater treatment facilities and disposal area are located approximately 0.25 mile northwest of the intersection of Farm-to-Market Road 1730 and State Highway 211 in Lynn County, Texas. The plant site and disposal area are located in the drainage basin of Double Mountain Fork Brazos River in Segment No. 1241 of the Brazos River Basin.

The Executive Director of the TNRCC has prepared a draft permit which, if approved, will

#### **Rylander Delivers** Sales Tax Rebates

Texas Comptroller Carole Keeton Rylander last week delivered a total of \$170.7 million in monthly sales tax payments to 1,094 Texas cities and 118 counties, a 7.5 percent increase over the \$158.7 million allocated to cities and counties in April

Year-to-date rebates to cities and counties are up 7.4 percent over the first four months of 1998.

This month's sales tax rebates include local sales taxes collected in February and reported by businesses filing monthly tax returns in March.

"April sales tax rebates reflect that the Texas economy continues to expand, but at a more moderate pace than we saw a year ago," Rylander

Wilson showed a whopping 229.97 percent increase over last year's rebate, receiving \$357.26 this year versus \$108.27 for the same period last year. O'Donnell showed a 36.89 percent loss however, receiving \$1,137.48 last year and only \$717.85 this year; while Tahoka showed a loss of 5.09 percent, receiving \$4,787.86 this year as opposed to \$5,044.64 last year.

The Comptroller's next sales tax allocation is scheduled for Friday, May 14.


