#### Mother Nature Wins: **Stormy Skies Force Sail Planes** To Land At Tahoka Airport

Two sail planes were forced to land at the Tahoka T-Bar Airport last Wednesday afternoon due to surrounding thunderstorms south of town. Tim Feager of St. Louis, MO, and David Martin of Willis, TX, were competing in the 15 Meter National Sail Plane Championship competition being held in Hobbs, NM.

"Our mission today was supposed to be to fly from Hobbs to Brownfield to Big Spring and back to Hobbs," stated Martin. "Obviously, it helps if we can end up back where we started out," he added. The two aviators landed at T-Bar Airport without any problems and then had to call their respective crew members to come bring their trailers to load the planes and take them on to Hobbs.

The 10-day competition in Hobbs includes approximately 45 sail planes in the 15-meter division. The sail planes have no motor or engine and are taken up by another plane and then released in order to begin their flight.


"We started out at 2,000 feet to-

day ... our rate-of-sink is less than 120 feet per hour. We were in the air approximately 3 hours and 45 minutes today before having to land here due to the thunderheads between here and Hobbs," Martin said.

The planes are equipped with a small battery to operate their flight instruments, a parachute, a small bottle of oxygen (for altitudes above 10,000 feet), a radio, and a parachute. Both men also carry cell phones and water bottles.

"My sail plane weighs approximately 1,100 lbs. when I'm inside, along with some water ballast weight. David's plane weighs approximately 1,000 lbs. when flying," stated

After landing, the two men contacted Sam Pridmore of Tahoka and he and his wife, Betsy, offered dinner and dessert while they waited for crew members to show up with trailers to return the planes to Hobbs. The wings of the sail planes detach in order to be loaded alongside the fuselage of the planes in the trailers.

#### Comptroller Announces Oct. 2 **Unclaimed Property Auction**

Close to 90,000 items from abandoned safe deposit boxes will be sold to the highest bidder on Saturday, Oct. 2, at the state's next unclaimed property auction, Texas comptroller Carole Keeton Ryland announced.

Jewelry, coins and currency, stamps, historical documents and a wide variety of other collectibles and curiosities will go on the auction block.

The next unclaimed property auction was not expected until the summer of 2000, but the Comptroller's unclaimed property vault has filled so rapidly that an earlier sale is needed.

"The state is receiving more and more unclaimed property - not only abandoned items from safe deposit boxes, but also forgotten money, such as bank accounts, utility deposits, paychecks, and investment dividends," Comptroller Rylander said.

"There are two key reasons for the increase in unclaimed property. First, we live in a very mobile society. People move frequently and it is easy to leave money behind. Also, banks and businesses that are holding unclaimed money and other valuables are becoming more aware that the law requires them to turn those assets over to the state if the owners

cannot be located," Comptroller. Rylander said.

The Comptroller's office tries to: locate owners of unclaimed property by placing their names in an annual: newspaper insert and on the Comptroller's Window on the State Government internet site at. <www.window.state.tx.us>. There is no time limit for owners to claim their property; however, in the case of safe deposit box contents, the items are auctioned after about one year. If the owners turn up, they may claim the proceeds from the sale of their prop-





#### Rambo Attends Conference On Brain Development Research

Recent insights into brain development research has profound implications for more than neuroscientists - indeed, it affects parents, childcare workers, educators, policy makers, and more. Patti Rambo, Home Economics teacher at Tahoka High School, attended an in-service program last month to learn about the new research and its practical implications for the family and consumer sciences profession. Mrs. Rambo was the only Texas educator trained at the conference among the 40 participants present. The "Early Childhood Initiative Train the Trainers" program was a pre-conference to the American Association of Family and Consumer Sciences (AAFCS) 90th Annual Meeting and Exposition in Seattle, Washington.

Since 1997, the AAFCS Early Childhood Initiative (ECI) has been involved with an unprecedented public awareness and engagement campaign to focus on the importance of the first three years of life, and on what families and communities can do to promote young children's healthy development and school readiness.

The purpose of the "Train the

Trainers" program was to develop and empower an ongoing cadre of trainers versed in brain development research. The session, led by Marilyn Swertz and sponsored by the ECI Task Force, translated technical neuroscience findings on early brain development and its implications into language that is useful to family and consumer sciences professions. Participants gained a basic understanding of how the brain develops, became familiar with recent research findings, and discussed implications for home economics policy and program directions.

"The conference was one of the best I've ever attended, and it was an honor to be selected to represent Texas home economics teachers," states Mrs. Rambo. "It will now be my task to transfer the knowledge to Tahoka High School students so they may become better parents of healthy children and to other educators so that they may use the knowledge in their classrooms. It is very exciting information. This information will be presented to Preparation for Parenting classes, Child Development classes, and to community groups as the need arises."



#### **TEXAS Grant Program** Offering Financial Help For College

High school graduates of the class of 1999 enrolling at The University of Texas of the Permian Basin in Odessa this fall could find their education practically paid thanks to a new grant program through the State of Texas. The TEXAS Grant Program, which stands for Toward Excellence, Access and Success, rewards graduates of Texas high schools who completed the recommended or advanced high school curriculum and who demonstrate financial need.

"There is no reason, with all of the money available, that a student in this day and age can not afford to attend college, particularly if the student can demonstrate a financial need," said Pat Jaramillo, UTPB Vice President of Student Services.

The total financial aid award at UTPB will include the TEXAS Grant as well as other funding sources and could cover all tuition and fees for qualified students. To be considered for financial aid at UTPB, students must first submit an application for federal financial aid.

In an effort to help students who have already applied for financial aid or admissions at UTPB take full advantage of the TEXAS Grant, Financial Aid Director Bob Vasquez is notifying students by mail of the opportunity to apply for the grant.

"It's important to us at UTPB to go the extra mile in helping our students capitalize on this opportunity," said Vasquez.

The amount an individual receives through the TEXAS Grant, according to information from the Texas Higher Education Coordinating Board, will depend on the number of hours taken by the college student and the type of institution which the student attends



#### Schools considering options to downsize

COLLEGE STATION - Dividing heavily populated high schools into smaller units to help students feel more a part of the school community is a concept being given increasing consideration - and even more so in the wake of recent school events.

Arnold Oates, a Texas A&M University education professor who specializes in school facilities standards, says educators are concerned that students may become alienated in "mega" high schools, schools with 500 or more students per campus.

"The concern is the disenfranchised students," says Oates, who assists school districts with campus design. "In a school with 500 or more students, some kids tend to lose their identities because there are so many students on one campus. Educators want kids in an environment where they have identities."

The options schools are considering for creating smaller units involve the ninth grade, since it is usually the most populated of all the high school grades. Oates notes that some schools have created ninth grade centers, a campus fully devoted to the one grade; however, a few schools have returned to the traditional junior high school with seventh, eighth and ninth grades on one campus.



#### Athletic Physical **Exams Scheduled**

Athletic physicals will be offered for Tahoka Independent School District student athletes Friday, July 23 in the office of Dr. Griffith Thomas at the Lynn County Hospital Clinic. According to Athletic Director Troy Hinds, physical examinations are required by UIL rules for all athletes entering seventh and ninth grades (or any student who has not participated in athletics before).

Cost for the exams will be \$5 per athlete. Athletes must come by the high school office anytime before July 23 and pick up a physical exam form to be filled out and signed by the doctor upon completion of the exam. Athletes are asked to hold the completed form until their first practice where forms will be collected by

Exams for female athletes will be from 9 a.m to noon on July 23. Male athletes may take their physicals from 1:30 to 5:00 p.m. July 23.

Students who cannot get a physical on that day may have a physical with the doctor of their choice (at that doctor's regular office visit price), as long as the required physical exam form is completed.

"UIL rules require all students participating in athletics who are entering seventh and ninth grades, or who have never been in athletics before, to have a physical exam," said Hinds. "We cannot issue athletic equipment without physicals and the proper forms completed," he added.

Some student athletes may have taken their physicals during the spring, and if so, are not required to have another exam.

#### Sales Tax Holiday Coming Aug. 6-8

Summer is in full swing, but Texas families might want to start thinking about their back-to-school shopping. Why? Thanks to Senate Bill 441, which the Legislature passed and Governor Bush signed earlier this year, Texas families will enjoy 72 hours of tax-free shopping in early August.

Aug. 6-8, Texans will enjoy the first-ever Texas sales tax "holiday". Items of children's and adult clothing, and non-athletic shoes, costing less than \$100 will be completely exempt from sate and local sales taxes. Texas leaders estimate this sales tax holiday will save Lone Star State consumers \$69.2 million.

The sales tax holiday means that consumers will save up to 8.25% on many of their purchases.

Athletic shoes and clothing commonly used as everyday wear, such as football jerseys, baseball caps, or running shoes costing less than \$100, will be exempt. But items used exclusively for athletic purposes, such as golf shoes or football pants, are not eligible for the sales tax break. In addition, jewelry, handbags, wallets, and formal wear are not exempt.

Texas' Aug. 6-8 sales tax holiday is part of a package of pro-consumer tax relief measures aimed at putting money back into the pockets of Texas

The Legislature also eliminated sales taxes on over-the-counter medications and up to \$25 per month in internet access charges. Altogether, state leaders cut consumers, sales, business and property taxes by nearly \$2 billion the year allowing citizens to keep more of their hard-earned

#### **USDA To Lower Cotton Insurance Rates** In Some States; To Analyze Texas Rates

Glickman announced last week that cotton insurance rates for many farmers in Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, Missouri, North Carolina, South Carolina, and Tennessee will be reduced for the 2000 crop year.

"Cotton farmers in the Southeast have long believed that the rates charged for their crop insurance were excessive," said Glickman. "So we looked at the problem and found several areas where these concerns were justified. We intend to lower rates indicated by this review and conduct a similar analysis of rates in Texas, Oklahoma, New Mexico, Arizona, and California."

Premium rates for crop insurance are established using traditional insurance industry techniques. RMA uses the pure premium (loss cost) methodology because it is the most appropriate. Crop insurance rates are based in large measure on at least 20

Agriculture Secretary Dan years of insurance experience in counties within a state where the program is offered. If the insurance experience for a particular crop is significantly different from the overall production history in the county, rates, could be skewed. The review compared crop insurance loss data with other reliable data like National Agricultural Statistics Service production statistics and participation data to identify irregularities and make adiustments.

RMA is already implementing the results of this study, including calculation of cotton rates in the affected states. Additional details will be available later this summer. While important, rates are just one factor. determining the overall value of any insurance product to the producer. Commodity prices, policy provisions, program oversight, and a hostof other factors contribute to the overall value and acceptance of the prod

COLLEGE STATION - Workers: who meet via computer technology. are more democratic and compromising in their decisions than; those who meet face-to-face, says: a Texas A&M University business professor who specializes in the impact of information technology on group interaction.

Maha El-Shinnawy, who teaches management information systems in the Lowry Mays College & Graduate School of Business, has found that workers making decisions face-to-face tend to be more swayed by the opinions of the group leader. But among workers that meet using computers, each member's comments have a better

chance of being recognized.






