# **AD Troy Hinds To Leave In May;** Supt. Parker Gets Renewal, Pay Hike

Tahoka High School Athletic Director Troy Hinds is resigning his position at the end of May, ending a six-year career here, of which the last four were served as head football coach and athletic director for the district. Hinds' resignation was officially accepted at the Tahoka Independent School District Board of Trustees meeting last Thursday.

"This community has been so good to me and the kids have been the best I have ever coached in my life – the kids here are great," Hinds told *The News* this week, adding that he felt it was time for him to try to finish his education in the administrative area and then make a decision as to whether to continue working in the coaching area or to move into the administrative field. He says he is not sure what his future plans are.

"Mr. Parker is good for this school, and has been very supportive, and I want to express my appreciation to him as well as to the school board. This has been the best six years of my life," Hinds added.

In addition to Hinds' resignation, the board was informed of the resignation of Reggie Moore, who left the district in December for another employment opportunity. Moore served as a district-wide aide.

In other business, trustees met in closed session for an annual job performance evaluation of Superintendent Parker, who is completing his first year as superintendent here. Upon returning to open session, trustees unanimously approved a oneyear extension on Parker's three-year administrative contract and a \$2,500 salary increase. The increase gives the superintendent an annual salary

Trustees unanimously approved a budget amendment of \$25,000 to purchase new band uniforms for the school. The current uniforms are ten years old, and trustees approved 80 new uniforms at a cost of \$305 each, at a total of \$24,400. Band students were being measured this week for the new uniforms, which are expected to arrive in time for the next school year. Band Director Carroll Rhodes showed a sample of the new uniforms to trustees at the board meeting, and expressed the band's appreciation for the purchase.

In other action, trustees gave Supt.

Parker the authority to fill the position of Tahoka I.S.D. Police Officer, which became vacant when Tahoka City Police Officer Lucinda Mann resigned her position at the city/ school. The position, which in the past has been a joint position between the city and school, and of which both entities contributed a salary, will no longer be a joint venture, school officials said. The school district, with the approval of the board, will hire a Texas Certified Peace Officer to be paid entirely from Tahoka I.S.D. funds, who will serve the district as both a peace officer and attendance

Superintendent Jimmy Parker said County Appraisal District was approved as presented. Monthly bills were approved as presented, and business manager Ken Eudy reported tax collections as of Dec. 31, 1999 of \$767,988.08, which is 68.83 percent complete.

Board President Greg Henley gave the audience an opportunity to question or make comments to the board concerning the 1998-99 TEA District AEIS Report, but no comments were given.

In administrative reports, principals noted attendance rates and enrollment figures, with a total of 760 students enrolled in the district. Athletic Director Hinds reported all varsity athletes passed all classes for the third six weeks in a row, and that random drug tests were administered to extra-curricular students at high school on Wednesday, Jan. 12.

Supt. Parker said that certificates for Tahoka's perfect attendance at the annual school board convention held in October would be presented at the South Plains School Board Association meeting in Lubbock Feb. 24. He reported that he is still checking on options for the football field lighting project, and also checking on options to move employee health insurance from a March 1 anniversary date to

All seven trustees were present for the meeting, including Greg Henley. Carmen Chapa, Joe Calvillo, Brad Hammonds, Leighton Knox Jr., Ty Askew and Math Bartley, as well as district personnel, TISD attorney Cal Huffaker, and several visitors. The board met in closed session for approximately 2-1/2 hours for personissues (including the superintendent's evaluation), and the meeting adjourned at 10:30 p.m.

His five children — sons, Chester and Robert, and daughters Ollie Brown, Henrietta Burleson, and Perlie Payton all live in Tahoka. He has 23 grandchildren, 47 great-grandchildren, and 22 great-greatgrandchildren. One of his five siblings, a sister, is still living. His

wife, Mary, died in 1986. Hood has been a resident of the Tahoka Care Center since 1994.

# **Hospital Approved Again As Basic Trauma Facility**

Lynn County Hospital has been redesignated as a "Basic Trauma Facility in Trauma Service Area B," which means the hospital is fully approved by the State Dept. of Health for caring for Level 4 trauma patients for the next three years.

A letter from Dr. William Archer III. Commissioner of Health, to hospital Administrator Louise Landers said "Your hospital is to be commended for your ongoing commitment to quality care for the trauma patients in your area...congratulations on this impressive accomplishment."

Mrs. Landers said this week that this means the hospital, originally approved to serve Level 4 patients three years ago, has met all the stringent requirements of the Texas Health Dept. regarding emergency room care, doctors, nurses and other personnel and equipment needs to continue caring for persons suffering trauma at the designated level for whatever reason.

# Rylander Delivers Sales Tax Rebates

Texas Comptroller Carole Keeton Rylander has delivered \$197.2 million in monthly sales tax payments to 1,105 Texas cities and 119 counties, a 20.3 percent increase compared to the \$163.8 million paid

January's sales tax rebates include local sales taxes collected by monthly tax filers in November, and reported to the Comptroller in De-

"This month's sales tax rebates are a good start to what could be another good year for the Texas economy," Comptroller Rylander

Lynn County received \$6,332.26 this year as opposed to \$5,991.12 last year for an increase of 5.69 percent. Wilson showed the largest gain (138.1%), receiving \$672.77 this year versus \$282.66 for the same time last year. O'Donnell also showed a gain over last year, receiving \$935,12 this year and \$802.82 last year. Tahoka received \$4,724.37 this year versus \$4,905.64 last year, for a decrease of 3.69 percent.

# Two Traffic Accidents **Investigated In County**

Two more traffic accidents on last week. A 1989 Chevrolet pickup roads in Lynn County were investigated by DPS patrolmen during the last week, with no serious injuries in

The driver was taken to Lynn County Hospital by O'Donnell EMS ambulance and treated for bruises and then released. Two other passengers were not in-

Another accident Tuesday on County Rd. B near FM 179 in the northwest part of the county resulted in two persons being treated at Lynn County Hospital for minor injuries prior to their release. Details were not available, but the two occupants of a pickup which overturned were from the New Home area.

Two boys, age 16 and 15, were turned over to juvenile authorities after they were questioned about two vehicles being shot with a BB gun owned by Guy Witt had a window glass broken as he was driving it on Ave. P, causing damage estimated at \$422.13. Damage to an Isuzu Rodeo owned by Charlie Engle was estimated at \$248 after it was struck in the left quarter panel as it also was being driven on Ave. P.





# **Counts Urges Students To Apply For TEXAS Grant Program**

With the beginning of the spring semester, high school seniors across Texas will begin to fill out college admission applications for the fall semester, which are due as early as February. State Representative David Counts (D-Knox City) encourages students to submit their financial aid application along with their application for admission.

By enacting House Bill 713 earlier this year, the Texas legislature opened the doors of college to more high school graduates by making \$100 million commitment to fund the "Toward Excellence, Access & Success" (TEXAS) Grant Program. TEXAS grants provide money to academically eligible students who wish to attend public and nonprofit col-

To be eligible for a TEXAS Grant, students must be Texas residents who graduated from a public or accredited private high school no earlier than the fall 1998 semester. Students must also show financial need, and have not been convicted of a felony or a crime involving a controlled substance.

In order to continue to receive grants throughout their college career, students must demonstrate satisfactory academic progress by maintaining at least a 2.5 grade point average. Grant-award students can receive awards for up to 150 semester hours or for six years, whichever occurs first.

This new program is expected to make the promise of a college degree a reality by paying tuition and fees for eligible students. These fees average \$2,400 per year at universities, \$940 at community colleges, and \$1,400 for Texas State Technical College students. By 2005, approximately 40,000 students are projected to benefit from the program. Counts points out that TEXAS Grants will help maintain a highly educated workforce in Texas, which is vital to continuing the state's economic pros-

Counts said, "It is extremely important as we head into the 21st century that our young people are given every opportunity to further their education, they are going to be the future of our workforce and this country."

To apply for a TEXAS Grant or any other financial aid, students must complete the Free Application for Federal Student Aid (FAFSA) form. Counts encourages college-bound high school students to contact their guidance counselor or their college financial aid office to obtain the

The weather during the month of December was near normal according to the National Weather Service


