IF THE following remarks sound familiar to anyone, it is because they have a better memory than I do. Most of it comes from a column published in 1993, and when I found it in my files, I didn't remember saying those things.

EVERY DAY my mailbox yields at least one envelope of junk from some insurance company, trying to get me to sign up for something I don't need, and trying to get some of those premium dollars which I spend with local agents who advertise in this newspaper.

Much of it is for "accidental death" policies, which for most folks is a waste of money. "So," said one agent, "you don't think there's a chance you will die accidentally?"

"On the contrary," I told him. "I sure don't expect to die on purpose." Of course, they don't define accidental death as any time you don't die on purpose. If they did, I'd have some of those policies.

This week one of the companies sent a brochure called "LMS", explaining that this means Life Made Simple. Under this it said "Simplified-Issue Whole Life Level Death Benefit." Simple, huh? That statement alone is pure gobbledegook to anyone except possibly insurance agents and lawyers.

I'd guess that it means you have to live your whole live before you die, and death has to come on a perfectly level or flat surface before they will pay your survivors.

I never have been especially fond of the idea of buying something which I have to die to collect. All of this reminds me of some jokes and cartoons I have seen in the past. One was the old man who told the insurance salesman, "I don't want no insurance. When I die, I want everybody to be sad!"

Then there was this cartoon of an attorney reading a will in front of a group. From the will, the attorney read, "In my lifetime, I made just over a million dollars. Being of sound mind, I spent it."

And there was this older couple sitting around one evening, and he said, "You know, Elsie, we've had a good life together for all these years." And she replied, "We sure have, all right."

"Yes," he said, "It has been really good. But I've been thinking lately that one of these days, one of us will be gone, and what will the other one do then?"

Over 1200 youth who earned top prizes in their local, regional state or national science fairs entered projects in the international fair, sponsored by Intel and administered by Science Service since its inception in 1950.

Grand Awards at the Intel ISEF are valued at close to \$1 million in cash prizes, scholarships, tuition grants and scientific field trips.

A new waterslide is one of the new features at the Tahoka City Pool, scheduled to open for the summer session on Thursday, June 1, and adding to the new look will be summer retro murals in the 60's and 70's theme, according to city officials this week.

The new waterslide is expected to be installed soon on the north edge of the pool, curving into the shallower end to allow usage by all patrons of the pool. Additionally, the 10' high diving board has been lowered for safety reasons, and is now slightly higher than the low diving board, both on the deep end of the pool.

The look of the pool is also being upgraded, with fresh paint and new murals to be depicted on the walls in a summer retro 60's and 70's look. Murals which were painted three years ago are peeling, city officials said, necessitating the new paint job.

Pool lifeguards will be Suzanne

Baker and her son Warren, with Kassidi Andrews filling in as parttime lifeguard and assisting during the opening three weeks. Meredith Pittman and Lindsay Preston will share concessions/admissions duties. Pool parties may be booked through Mrs. Baker.

The pool will be open Monday through Saturday, from 12:30-5:30 p.m., with Sunday afternoons and weekday evenings available for booking pool parties. Admission is \$2 for children up through 11 years of age, with ages 12 and older admitted for \$3. Summer pool passes may be purchased at City Hall, at a cost of \$50 for children ages birth through 11 years, \$75 for ages 12 and older, and \$100 for family passes. Gift certificates are also available in any denomination at City Hall, phone 998-4211.



Thank you Shea Pridmore for calling bingo on Saturdays for me. You are doing a great job.


We are still working on our back yard, it's beginning to look good. We are also still working on our new activity room, where the residents can do art projects and play games. We are looking forward to utilizing it.

## TISD Kindergarten, First Grade Teaching Staff To Be Reduced

After looking at continued low enrollment and subsequent declines in state funding due to lower enrollment figures, school trustees last week reluctantly directed Tahoka Independent School District Superintendent Jimmy Parker to reduce the current four Kindergarten classes and four first grade classes to only three classes in each grade next year. This year's kindergarten class enrollment was much lower than usual, with only 40+ students at the beginning of the 1999-2000 year, and the 2000-2001 pre-registration enrollment indicates continued smaller classes. In prior years, kindergarten enrollment hovered in the 50-60 numbers.

"Compared to a year ago, our ADA is down 42 students, and that is going to significantly affect our state funding," Supt. Parker explained to The News. "You can basically figure about \$5,000 per student in ADA funding, and when the district's student enrollment lowers you lose considerable funding. For whatever reason, enrollment in the past year or two is steadily declining - it's not our dropout rate, which is good, but incoming enrollment," he explained.

Supt. Parker told The News that no firm decisions have been made regarding the professional teaching staff in Kindergarten and first grade, but administrators hope to be able to reassign positions and fill expected vacancies elsewhere in the elementary campus rather than cutting staff members. However, if state funding numbers continue to look bleak, the superintendent said the district may be forced to look at cutting staff and/



#### Wanted: New Ambulance For Lynn County EMS

In an emergency, the last thing a victim or emergency personnel need to worry about is what kind of shape the ambulance itself is in - that means maintaining vehicles in good condition and, eventually, replacing older vehicles for new.

That's the case with Lynn County Emergency Medical Services (EMS), who are beginning the process of raising funds, searching for grants, and considering options available for purchasing a new ambulance. Cost estimates for such a purchase range around the \$80,000+ mark, according to Lynn County Hospital's EMS Coordinator Jeanie Stone.

Currently, Lynn County EMS uses a 1994 model for the main ambulance - and that already has 78,600 miles on it - and the old 1988 ambulance as a backup unit. The backup unit, EMS personnel say, is not as well equipped as the main unit, nor does it run very fast.

"The backup unit is not really reliable, and we have a lot of maintenance expense on it," explains Mrs. Stone. "And, we are putting lots of miles on the main ambulance. What we would like to do is purchase a new ambulance and use the current main ambulance as a backup unit," she

EMS representatives have approached hospital officials with the need for a new ambulance and have gotten approval to begin fundraising and looking at grants and other options. Additionally, EMS supporters encourage donations to the Lynn County EMS Memorial Fund, which may be made at Lynn County Hospital's business office.

During the last fiscal year, Lynn County EMS responded to 341 calls, of which 230 involved "on the scene" runs and 111 were transfers. Of those 341 calls, 160 were Tahoka calls and the remainder were made elsewhere in the county. And, according to EMS records, 192 calls required basic life support emergency treatment, while 149 required advanced life support treatment. The service averaged 30 mergency runs per month.

Lynn County EMS is staffed with 14 volunteers, including nine basic EMTs, two intermediate EMTs, and three drivers, who work round-theclock shifts to offer 24-hour-a-day volunteer service to the Lynn County area. In addition to her duties as EMS Coordinator, a paid position at Lynn call as a Basic EMT, and her husband Kent is one of the Intermediate EMTs. Dee Dee Pridmore is the other

Intermediate EMT, and other Basic EMTs include Alana Sholer, Stephen McKay, Kathy Long, Bobby Jolly Jr., Todd and Ginger Henry and Vondell Elliott. Jeremy Brandon, a Tahoka college student, offers his services as a Basic EMT during the summer months when home from college. Volunteer drivers on-call include Andrew Chapa, Janie Isbell and Daniel Garvin.

Lynn County EMS policy is to transport patients to the closest appropriate medical facility, whetherthat is Lynn County Hospital or a facility in Lubbock, according to information provided by Mrs. Stone.

"Just because a facility is the closest does not always mean it is the most appropriate," Mrs. Stone explains. "It depends on the condition of the patient at the time of our arrival. Our procedure requires us to call Lynn County Hospital and be released by Medical Control, but this is only if the patient's condition is considered stable. If a patient is critical, a different set of protocols are followed which allow us to make a decision based on patient condition, extrication time, enroute time, transport time, etc. without contacting Medical Control. A helicopter could even be called for air support if we felt it was needed," she added.

Additionally, Lynn County EMS may request advanced lifesaving support or further assistance from another service such as Lubbock or Slaton, if the situation requires such

"Requesting further assistance from other services or air support is about treating and giving the citizens of Lynn County the best pre-hospital emergency care possible," Mrs. Stone said.

To begin the fund-raising process for a new ambulance, EMS personnel will be planning several events for the coming months, and will appreciate the patronage of Lynn County citizens. The first fund-raiser will be a car wash this Saturday, beginning at 10 a.m. at the First United Methodist Church parking lot.

#### **County Ground Water Levels Decline** Slightly, Measurements Indicate

els declined an average 0.10 of a foot in 1999 in 81 privately-owned wells in the observation network maintained by the High Plains Underground Water Conservation District No. 1 in its 471,613 acre service area within the county. This represents a decrease of 8,574 acre-feet of water in storage in the Ogallala Aquifer last year in Lynn County.

Ground water levels within Lynn County declined an average 0.63 of a foot annually during the 10-year period form 1990 to 2000. An average annual decline of 0.88 of a foot was recorded during the five-year period from 1995 to 2000.

Ogallala Aquifer within the 6.8 million acre Water District service area declined an average of .68 of a foot from January 1999 to January 2000. This decline is 1.47 feet less than the 2.15 feet decline recorded for 1998.

A network of 1,214 privatelyowned observation water wells is used to determine the annual change in the quantity of water in the Ogallala Aquifer within the High Plains Water District. The depth-towater measurements are taken in info@hpwd.com>.


Lynn County ground water lev- January and February of each year to allow water levels to stabilize from pumping during the previous growing season.

> Three counties within the Water District recorded water level increases of less than one foot last year. Five counties showed average annual water level declines of more than one foot, while seven counties had average annual water level declines of less than one foot.

the following growing season. The number of weevils recovered in Lynn County in this year's survey was 40 percent lower than in 1999. The part of the county inside the active eradication zone, the Western High Plains Zone, had a 58 percent reduction while the area outside the active zone had a 30 percent reduction in the number of weevils recovered when compared to 1999. However, of the total weevils recovered in 2000, 52 percent come from within the zone and 48 percent came from outside the zone. The possible explanation for why there was not a bigger difference in the number of weevils recovered from within the active and non-active zones is that three of the sampled locations inside the activ

zone are right along the zone boundary, within two miles. These three sites represent 46 percent of the weevils recovered within the active zone. An elm leaf litter site, located on the access road at the cemetery exit on the southern edge of Tahoka, accounted for 35 percent (14 live, four dead) of the weevils recovered from within the active zone. From this same site there were 20 live and five dead weevils recovered in 1999.

In 1997 and 1998, several habitats in Lynn County were sampled to measure the overwintering boll wecvil population. The results showed that overwintering boll weevils used most any habitat to successfully overwinter especially in mild winter conditions. Starting in 1999, elm leaf litter, being the best habitat in which weevils overwinter, represented all samples.

The number of weevils recovered in this year's survey in Dawson County was the lowest ever. The number of weevils recovered in Dawson County this year was five, compared to 126 in 1999 and 433 in

This habitat survey is being conducted in 16 counties across the High Plains, extending from Dawson County in the south to Swisher County in the north. As in Dawson County, counties that are in an active eradication zone experienced a decrease in the number of boll weevils being recovered in their overwintering habitat survey, while counties that are not currently in an eradication zone experienced more boll weevils being recovered in their overwintering habitat survey.

Habitat refers to the dominant plant type in the area in which the samples were taken. Samples were one square meter in size and consisted of the ground-trash (leaves, stems, debris, etc.) along with approximately a quarter inch of loose soil. Samples were collected during late-February through early-March. Typically, three samples are taken from each location. Samples are processed through a trash separator machine which collects material the size and weight of adult weevils into a pan. Material from the pan is spread onto a heat table where it is examined visually for both live and dead adult boll weevils.


