



I'M MUCH MORE interested in healthy eating and healthy other things than I was when I was a teenager and was sure I was going to live forever.

I was reading the other day about Julia Child, who is 88 years old, author of 11 cookbooks, and is still healthy and energetic. And she says, "I don't eat between meals. . . I don't snack. . . and I like small portions. We all need to enjoy good food, but we all need not overindulge."

She offers a bunch of tips about how to cook things, such as "To peel whole garlic cloves, drop them into a pan of boiling water, for 30 seconds. The peels will come off easily." And "to prevent nuts from turning oily when you grind them in a blender

or food processor, always add at least one tablespoon of sugar." Well, if you're diabetic and do that last once every day, I promise you won't live to be 88.

Several other publications I have read say it's okay to eat red meat. But most of them say do it just once a day and eat no serving larger than four ounces. Four ounces? That's just two bites. (Unless it's chicken gizzards, which get bigger every time you chew on them).

One interesting tip from Julia, who apparently never has known the ecstasy of pigging out, is how to clean a heat-blackened pan. Fill it with water, adding two tablespoons of baking soda per quart. Simmer 10 minutes (my wife simmers longer than that when I cook something and leave the pan all grossed up on the cabinet). Remove the pan from heat and cover it up (Julia doesn't say with what), let it soak overnight. "The black residue should come off easily with a stiff brush". If that doesn't work, should we try an electric sander?

A magazine called Remedy suggests that for good health, you eat a bunch of stuff which is mostly inedible, like corn/black bean salad, turnips, and snacks of air-popped popcorn (popcorn is no good unless it contains lots of salt and a stick of butter).

County Takes Hard Hit From Energas Bill

Businesses and residents alike have been afraid to open their Energas bills in recent days due to the dramatic increases reportedly from production costs and other factors, and Lynn County Commissioners were no exception. The county's Energas bill more than doubled from last month, Lynn County Treasurer Janet Porterfield reported at Monday morning's regular meeting, costing the county a whopping \$4,169 this month compared to last month's bill of \$1,769.

The gas bill was among other monthly bills approved by commissioners, including a payment to the City of O'Donnell Fire Department for fire protection in the county. Lynn County annually approves a proportionate amount to each of the four fire departments in the county, with O'Donnell Fire Department receiving \$1,875, which was approved at Monday's meeting. Approved at last month's meeting were payments to Wilson and New Home Fire Departments in the amount of \$1,125, and \$4,500 to the Tahoka Fire Depart-

In other routine business, commissioners drew names from a jury list to serve on the Lynn County Grievance Committee, including Santos Luna, Janelle Ashcraft Neal, Oscar Garcia Jr., Roy White, Kimberly King Smith, John Quintilla, Carolyn Luker Klaus, Consuelo Villarreal and Elizabeth Bengoa-Munoz. The Grievance Committee meets only when called in special session to hear grievances from elected county offi-

Selection of a county Historical Committee was postponed until a later meeting. The lease for a building located on South 2nd and Ave. H which had been paid by the county

was discussed, with commissioners suggesting that the county split the lease cost with the probation department, but no action was taken on the lease agreement.

County Judge J.F. Brandon informed the court that he had borrowed \$15,000 from the First National Bank of Tahoka to put in escrow for the S&K building (to be remodeled into new county jail facilities) and that the funds had been turned over to the lawyers handling the agreement. Commissioner Mike Braddock noted that an escrow contract had been signed by the selling

The judge was granted permission by commissioners to look into a new phone system for the courthouse through Poka Lambro, at an estimated cost of \$10,000 which may be funded through the county's Security Fund. The system, if installed, would allow offices within the courthouse to transfer calls from one office to another. Currently, calls cannot be transferred from one office to another.

Commissioners appointed Braddock as their representative on the Wes-Tex RC&D committee.

Lynn County 4-H and FFA mem- judging at 10 a.m. The Pee Wee Barbers are making last-minute preparations for the Lynn County Stock Show which begins today (Thursday) at the county showbarn. The numbers are up slightly from last year's event, which had 372 animals, including 279 barrows.

The showbarn opened Wednesday for the weighing of steers, lambs and goats. Thursday events begin at 9 a.m. with the weighing of barrows. Steer judging begins at 5 p.m. followed by lamb judging, and concluding with goat judging.

Friday events include barrow judging at 9 a.m., with baked goods row Show will begin 30 minutes after the barrow show.

A judging contest will be conducted Saturday morning; and a barbecue lunch will be served at 11:30 a.m. The presentation of awards and the auction sale begins at 1 p.m.

Judges for the show include Steve Bradshaw in the barrow division, Dirk Aaron in the steer division, and Steve Sturtz in the lambs and goats

Lynn County Approved For Federal Funding Due To 'Disaster' Status From Winter Storms

An additional 28 Texas counties, including Lynn, have been added to the list of jurisdictions eligible for funding for debris removal and other forms of public assistance, federal and state disaster recovery officials announced this week.


Federal Coordinating Officer A. David Rodham of the Federal Emergency Management Agency (FEMA) announced the additions following a review of information regarding damages incurred by winter storms from Dec. 12, 2000 through Jan. 15, 2001. The counties are Borden. Carson, Cherokee, Cooke, Dawson, Delta, Gaines, Garza, Gray, Gregg, Grayson, Fannin, Franklin, Harrison, Hopkins, Hunt, Lamar, Lynn, Marion, Montague, Morris, Panola, Rains, Rusk, Smith, Titus, Upshur and Wood.

For debris removal associated with the severe storms, the federal government has increased its reimbursement to 90 percent of the cost through March 9, said State Coordinating Officer Richard Boltz. After that date the federal cost share will be 75 percent. Communities and some non-profit agencies in the designated 31 counties are also eligible for 75 percent federal share of the costs of emergency services and repair or replacement of public facilities such as roads, bridges, buildings and utilities. Federal funding is also available on a cost-sharing basis for measures to prevent or lessen future damage (hazard mitigation).

Lynn County officials requested disaster status following a severe ice storm which virtually paralyzed the county during the week following Christmas Day, causing physical and economic losses in the county.

In a letter to Texas Governor Rick Perry, Lynn County Judge J.F. Brandon noted that an estimated 350 homes were without power for several days, and approximately 500 oil wells were affected by the power outage. Lyntegar Electric Cooperative reportedly lost over 750 poles (250 in Lynn County) with several hundred miles of line destroyed by the storm. Repair costs due to storm damage in the county were estimated at \$1.2 million, Brandon's letter



The Leopards defeated Southland on Jan. 16, by a score of 80-51.










