

# Destroys Building

# Sought After Grant Received

A \$35,000 grant from the Meadows Foundation to Lynn County Hospital District has been received and the district will seek to buy a new ambulance at an expected cost of

Hospital Administrator Dan Powers told the hospital board at its regular monthly meeting last Wednesday that the Meadows grant matches the \$35,000 Texas Dept. of Health matching grant approved earlier. The balance of the \$80,000 comes from \$5,000 of EMS ambulance funds raised by donations and volunteer work projects, and \$5,000 from the Hospital Auxiliary, which donated the money from its recent Fun/Food

Powers, commenting on the success of the recent festival, said that "community support of this event is remarkable," and praised the Auxiliary members and other volunteers for their work.

Powers also reported that the hospital district has received \$29,666 in tobacco settlement funds for this year.





Beginning May 1, Travelers Express - the "paystation" vendor that handles in-person payments of electric bills from Southwestern Public Service Company - began to charge customers a \$1 fee for the service.

For Tahoka customers, that means when paying their SPS bills at Tahoka Family Flowers, a \$1 service fee will be assessed - and the pay station will only accept cash for payment of electric bills. Checks or money orders will no longer be accepted at paystations for payment of SPS bills, according to notices issued by Travelers Express to their paystation agents.

Gail Stark, owner of Tahoka Family Flowers and paystation agent for Tahoka SPS and Energas customers, said she has no control over the decisions made by Travelers Express. "This \$1 service fee is not my

is charging for collecting SPS payments. And the 'cash only' decision is strictly for SPS bills, not Energas bills," she explained, adding that she was unaware of the impending changes and is now in the position of explaining the new regulations and fees to customers who pay their SPS

bills at her store. According to a press release from SPS officials, Travelers Express will share the \$1 fee with the paystation agent who accepts and then remits the customer's electric bill payment to SPS. Southwestern Public Service will not receive any of the fee. Mrs. Stark says she does not know what percentage of the fee will be shared with paystation agents.

Previously, SPS has paid a vendor and its paystation agents for accepting in-person payments.

"The new system will be fairer,' said Bill Crenshaw, SPS communications consultant. "The customers who impose the cost for in-person payments will pay that cost, and only those customers who use the paystations will pay for that service."

Travelers Express, the paystation vendor, is replacing a vendor SPS had used since 1997. Travelers Express has not newly contracted with many of the paystation agents who previously have accepted SPS payments, Crenshaw said, but is signing up new agents as quickly as it can.

Mrs. Stark says many Tahoka SPS and Energas customers take advantage of the opportunity to pay their bills in person through her store, but payments may also be made by mail, bank draft, or telephone.

The "cash only" requirement is strictly for paystation agents, and does not apply to payments sent by mail.

"More than 80 percent of Southwestern's customers pay their bills by return mail or automatic bank drafts," Crenshaw said, adding, "Automatic bank drafts are especially convenient. Customers still receive statements monthly, never have to deal with sending checks or money orders, and are assured that their bills

# **Rural Organization Leader Urges Congress To Expand Tax Deduction**

A national rural organization recently made an urgent call for Congress to expand a tax deduction to make health insurance more affordable for more people.

The national board of directors of Communicating for Agriculture and the Self Employed (CA), including Patsy Sanders of O'Donnell, adopted a special resolution at its annual meeting on March 30. The resolution called on Congress and the President to immediately enact legislation enabling all individuals who pay for their own health insurance to deduct 100 percent of their premiums. Such an action would give everyone equal tax treatment, making tax savings for people who pay their own health insurance comparable to people who have employer-provided health insurance. -

"With health insurance premiums forecast to rise 15 to 20 percent per year over the next few years, insurance costs continue to climb beyond the reach of more and more working Americans," Sanders said. "With this in mind, it's imperative that the U.S. CA Tax Code stop discriminating against. ... www.selfemployedcountry.org.





#### **Cause For Brief Hunt**

Four Latin-American children caused quite a flurry of excitement Monday night when they became lost after leaving a Tahoka school bus near New Home. It was their first day in school.

The four children of a Mr. and Mrs. Perez, who live on the Dr. Skiles Thomas farm and work for R.M. Miller in the Petty community, enrolled in the Tahoka schools Monday morning. At end of the school day, they got on the wrong school bus, that of Tom Bartley, which goes north and west.

Not knowing the timid children, nor where they lived, he allowed them to get off near the end of his route in the New Home vicinity.

As dark approached and the children had not returned home, Perez went in search of his children. Bill Balch at New Home notified Tahoka school authorities the children were missing, and Principal Archie Sims and Mr. and Mrs. Pete Hegi started out to hunt them. A number of other people joined the search.

The children were found, one of them asleep, in a pasture west of the Donald Caudle place and about six miles from their home.

Since no school bus from Tahoka runs to the immediate area of their residence, Supt. Otis Spears Tuesday made arrangements with Supt. James Vaughn of New Home for them to attend school there. - Oct. 5, 1951

#### **New Window Resists Atom Bomb Effects**

Pittsburgh - The new Flexseal Bomb Glass units open automati-

cally in four triangular sections when an explosive force strikes. This release of pressure prevents the window frame from being blown in and greatly reduces the possibilities of flying fragments.

The window consists of withree layers laminated into a single unit. The outer layer is a \*\* sheet of glass, the middle layer a sheet of polyvinyl butyral plastic, and the inner layer is four triangular shaped pieces of glass. The plastic layer extends beyond the glass edges and is bolted to the window frame to serve as hinges, permitting the four segments to open like doors when the outer piece of glass is broken.

After an explosion of sufficient force to open the bomb window, the four segments may be returned to position and retained there by a bolt, as shown above, or even a wad of chewing gum. The crevices may then be closed with adhesive tape, putty, clay or whatever is handy, and the restored window again affords protection from cold, Frain, storms, etc., until such time as the glass may be replaced.



# Lynn County SWCD Receives State, **Regional Awards For Council Sponsorship**

Conservation District (SWCD) was selected as the outstanding State and **Regional Resources Conservation** and Development (RC&D) Council Sponsor of the Year. Award presentations were made at the Regional RC&D Convention on Feb. 26 in Midland and at the State RC&D Convention in Wichita Falls on April 18.

The Lynn County SWCD Board of Directors (W.R. Steen, Chairman; H.G. Franklin, Vice Chairman; Michael White, Secretary/Treasurer; Todd Lockaby, member; Glen Brewer, member and Helen Saldana, District Clerk/Technician) represent one of the 21 sponsors serving the Lynn County RC&D Council. Franklin, Saldana and USDA-NRCS Natural Resources Manager, Mario Avila attended both award ceremonies and accepted the awards on behalf of the SWCD.

Wes-Tex RC&D Coordinator, Claude Ross, nominated the Lynn County SWCD for their outstanding achievements. He said, "Their council has fulfilled many project goals through community efforts, and their success continues to grow."

The SWCD's leadership role has made a profound impact on the council's existence. Through diligent planning efforts and hard work, many. projects have become reality for the Lynn County RC&D Council. By utilizing grant funding from private foundations the Council was able to secure computers for the Lynn County Sheriff's Department and the Tahoka Volunteer Fire Department, as well as "bunker gear" for the Lynn and New Home Fire Departments. In addition, they were the first county on the Southern High Plains to install dry hydrants. These dry hydrants provide a fire protection plan for rural communities and residents. NRCS Natural Resources Manager Mario Avila was instrumental in the development of the design for dry hydrants, located on irrigation wells. The dry hydrants are a popular cost-

The Lynn County Soil and Water share program administered by the Texas Forest Service. Lynn County has now installed a total of 24 dry hydrants.

Lynn County has also benefited from the council's grant proposals and funding. The funding acquired was used to purchase Emergency Medical Service (EMS) pagers and pay for continuing education classes for volunteer Emergency Medical Technicians (EMTs). Additionally, funding was applied for and received through the council for the Tahoka EMT's to acquire a training mannequin called a "Resusci Anne." The Council also assisted the Wilson volunteer fire department to obtain air pacs for their fire fighters.

Lynn County SWCD chairman W.R. Steen said, "Our council has been well represented. We set out to make community projects happen for everyone's benefit, while continuing to improve our rural communities."

RC&D is a unique program, operated under the auspices of the USDA-NRCS, but county councils and local volunteers set the direction. The Lynn County Council was formed in 1992 and the Lynn County SWCD hosted the original Wes-Tex RC&D formation meeting. During that process, Lynn County acted as the steering county for the development of Wes-Tex RC&D. By directing the program at the local level, the council provides a focal point of local leadership bringing together private citizens, local, state and federal agencies to improve economic, social and environmental well being. Each council has a governing body consisting of representatives of all RC&D sponsors. While many locally elected officials such as mayors, judges, commissioners or soil and water conservation district directors serve on RC&D councils, many businesses are also represented on these councils.



# **Targets Area Senior Citizens**

The Better Business Bureau of the South Plains, Inc. (BBB) is issuing a caution to senior citizens regarding a company known as R&R Financials, Peace and Quiet or R&R Consultants. This company appears to be targeting senior citizens with a program in which they claim to be protecting the seniors from telemarketing and direct mail scams.

According to consumers contacting the South Plains BBB, the company asks for credit card numbers with expiration dates to take credit card information off the internet. Some consumers report the company is identifying themselves as being with a government agency.

Consumers have told the BBB that they are supposed to receive a packet explaining that their credit card information is on the internet, and the company has a way to take it all off. In realty, local residents have been charged \$289 for a book, which, although it does have useful information in it, also warns consumers to beware of companies that are doing the very thing that Pease and Quiet is doing.

They leave a phone number of 877-590-9492. If that number is called, the caller is prompted through a series of selections, but callers often report they are never able to actually talk to a live operator.

A Canadian watchdog agency,

"PhoneBusters," which is affiliated with various Canadian law enforcement agencies, has told the BBB system that the company has been the subject of multiple complaints, with many thousands of dollars in losses.

**BBB** offices across the nation have compared notes and discovered numerous addresses for the company, including some in Canada and New York. The Bureaus in those areas have requested information from the company, such as the actual type of business, how long they have been in business, the principals, etc. however the company has not responded to the requests. The Bureau in New York has received complaints against the company, but so far the company

has not responded. The BBB system warns consumers not to give any information re-

garding credit cards or bank account numbers to any company contacting them in this manner.

At this time, the BBB has no reliable information on the company to determine the real intent or what services it provides, if any.



**Wilson Volunteer Fire Department** Tip of the Week: Many people are out doing yard work and cleaning up around their places using various power tools. If these include electrical tools, there is a good chance that extension cords are involved. Before using these cords, make sure that both ends of the cords are in good repair and that the cord itself is not split or otherwise damaged. Then be careful of where the cord is in relation to the work being done, so that you do not run over the cord with your power equipment. Not only can this be a danger to the operator of the equipment, but it can also cause a fire if you are working in dry grass or brush and the cord is damaged or cut and electrical sparks start to fly.



# Following Prairie Dog Die-off

The Texas Department of Health curred in 1982. Medical personnel throughout

(TDH) has issued a number of precautions after concluding that plague was the cause of a prairie dog die-off at Lake Meredith National Recreation Area.

According to Dr. James Alexander, a zoonosis control veterinarian with TDH, evidence of the prairie dog die-off was investigated at Lake Meredith, about 30 miles north of Amarillo, on April 19, raising suspicions that plague could be responsible.


On Tuesday, preliminary test results at the U.S. Centers for Disease Control and Prevention Plague Laboratory in Fort Collins, Colorado, identified the bacteria (Yersinia pestis) responsible for plague in fleas from the Lake Meredith prairie dog town.

Plague is a bacterial disease of rodents that can be spread to humans and other animals by infected fleas. It has three forms: bubonic (infection of lymph nodes), septicemic (infection of the blood) and pneumonic plague (infection of the lungs). Pneumonic plague is the only form that can be spread from person to person.

Humans can become infected with plague by the bites of infected fleas, by direct contact with the tissues or body fluids of a plague-infected animal, by inhaling infectious airborne droplets from persons or animals with pneumonic plague or by laboratory exposure to plague bacteria.

Plague is common in animals in West Texas and New Mexico, and the disease is occasionally seen in rodent and rabbit populations in the area.

No cases of plague in humans have been reported at this time. Human plague is rare, averaging 12 cases per year in the United States. The last case of human plague in Texas was reported in 1993, and the last human plague death in Texas oc-
