# Suspects In Robbery **To Face Grand Jury**

A young couple from Lamesa by a clerk Saturday night. who are suspects in the armed robbery of Allsup's store in O'Donnell on Nov. 16 have been returned to Lynn County jail from El Paso, where they were arrested several days after the robbery. Charged with aggravated robbery were Brandon Matthew Smith, 18, and Misty Dawn Nunn, 18. Their case will be considered by a 106th District grand jury scheduled to meet Friday.

During the week, Tahoka Police arrested one man on an outstanding warrant and investigated an incident in which a Tahoka man allegedly took \$40 cash from Allsup's, but returned the money after being caught O'Donnell Police Dept.

Forty-three persons were in jail as of Wednesday, with 16 of these held for Lubbock County. Eleven persons were jailed during the last week on these charges: bond surrender/possession of cocaine, speeding, aggravated robbery, Dept. of Public Safety warrants, criminal mischief, evading arrest, driving while intoxicated, possession of marijuana, possession of controlled substances

During November, dispatchers at the sheriff's office processed 234 calls, including 81 for Tahoka Police, 111 for the county, 22 ambulance calls, four fire alarms and 16 for

### Council Has Routine Meeting

Tahoka City Council met in routine session Monday night, hearing a report from Kent Satterwhite, General Manager of the Canadian River Municipal Water Authority, about the Lake Meredith water level situation, from which Tahoka gets its water. Satterwhite told the group that there is nothing unusual in the water level dropping during certain times of the year and that it was not time to panic.

More information about Lake Meredith and the water supply will be given to The News at a later date, City Administrator Jerry Webster said. Larry Hagood, the city's representative on the Water Authority Board, also attended the meeting.

In other business, council members tabled discussion on the city's land leases near the sewer plant, currently held by Joe Calvillo and David Cook. Bids that had been received were not opened, as the issue was tabled for the next meeting, due to a question about the legal notice concerning the lease.

Monthly bills were approved as presented.

All five council members, Mayor Mike Mensch, Webster and others were present for the meeting that lasted approximately 1-1/2 hours.

The Abbotts live and work at the Baptist Mission Hospital in the Ivory Coast in West Africa. David's ministry there is manifold, as he handles the business administration and finances of the hospital and is also responsible for the maintenance of the hospital and its equipment. He also preaches the good news of Christ to patients and travels to outlying churches.

In Africa, Ann Abbott home schools their two boys, Davy, age 15, and Stephen, age 9. She also encourages other missionary moms and African mothers. Ann leads a Bible Study in a courtyard near the hospital compound, where many gather to hear her tell stories from the scrip-

In September of last year, a civil war broke out in their area. After many dramatic events, the Abbotts were evacuated by the French Foreign Legion and the U.S. Special Forces and taken to safety. They eventually returned home to Lubbock to wait out the turmoil

While in Lubbock, the Abbotts have been able to tend to Davy's need for heart surgery. Davy has Down Syndrome and was born without a pulmonary valve. Last June, doctors in Houston were able to repair Davy's





Local Number Portability, which will enable home phone numbers to be switched to cellular phones, will be implemented in Valor Telecom's West Texas service area on May 24. 2004.


Implementation will only occur next Monday, November 24, in the nation's 100-largest metropolitan statistical areas-none of which are in





### Lyntegar Co-op To **Purchase Electricity** From Golden Spread

Lyntegar Electric Cooperative, headquartered in Tahoka, is one of five electric cooperatives that have joined Amarillo-based Golden Spread Electric Cooperative, bringing member cooperatives to 16, with loads exceeding 1,000 megawatts and annual revenues exceeding \$300 million.

According to information released this week by Golden Spread, the new members will assign their existing wholesale power contracts to Golden Spread. As soon as all required contractual and regulatory approvals can be obtained, Golden Spread will become responsible for supplying electricity to these new members.

Lyntegar officials say the move will not change day-to-day operations at the local cooperative.

New members of the alliance other than Lyntegar are Coleman County Electric Co-op, headquartered in Coleman; Concho Valley Electric Co-op, headquartered in San Angelo; Southwest Texas Electric Co-op, headquartered in Eldorado; and Taylor Electric Co-op, headquartered in Merkel.

Golden Spread is a consumerowned generation and transmission cooperative organized in 1984 to profor 11 rural distribution cooperatives. The original members cooperatives are located in the Texas Panhandle, the Oklahoma Panhandle and the Texas South Plains. The new member co-ops serve counties in West Texas and the Edwards Plateau re-

Golden Spread and its 16-member system will now serve approximately 184,000 meters in 80 counties, and have a combined 68,400 miles of energized line. Golden Spread generates a portion of its members' electricity needs and purchases the balance from other wholesalers. Golden Spread also sells energy to other utilities when its power supply resources are not needed to serve member system loads

Golden Spread owns 50 percent of Mustang Station, a state-of-the-art generating facility located near Denver City. Mustang Station burns natural gas in two large turbine-generators to produce 300 megawatts of power. Exhaust heat from the gas turbines is converted to steam to power a third generator with no additional fuel cost. The combined output of Mustang Station is 480 megawatts.

Applications for emergency farm loan for losses caused by excessive rain, hail, and high winds, that occurred from June 1, 2003, through June 30, 2003, are being accepted at the Farm Service Agency (FSA) office located in Tahoka, FSA Farm Loan Manager Curtis Barlow said.

Lynn County is one of 12 counties recently named by Secretary of Agriculture Ann M. Veneman as eligible for loans to cover part of actual production losses resulting from the rain, hail and high winds.

Barlow said farmers may be eligible for loans of up to 80 percent of their actual losses or the operating loan needed to continue in business, whichever is less. For farmers unable to obtain credit from private commercial leaders, the interest is 3.75 per-

"As a general rule, a farmer must have suffered at least a 30 percent loss of production to be eligible for an FSA emergency loan," Barlow said. Farmers participating in the Federal Crop Insurance program will have to figure in proceeds from this program in determining their loss. "Applications for loans under this emergency designation will be accepted until July 6, 2004, but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possibly over into the new farming season," Barlow

### Texas Farm Bureau **Resolutions Committee** Meets In Waco

The annual session of the Texas Farm Bureau Resolutions Committee provides a unique perspective on the thinking of the farm and ranch community. The Resolutions Committee is charged with sifting through the hundreds of policy resolutions submitted by County Farm Bureaus, and prepare them for action by the voting delegates at the Texas Farm Bureau convention. The committee completed its work Wednesday at the TFB state headquarters in Waco.

Lloyd Arthur of Ralls, TFB Vice President, chaired the committee, which consisted of three farmers or ranchers from each of TFB's 13 Districts, plus the chairman of the TFB Young Farmer and Rancher Commit-

Arthur said that recent improvements in cattle and cotton prices have some segments of agriculture in an "improvement mode," but he said the industry remains vulnerable.

Among the resolutions the committee approved for consideration by convention delegates:

+ Support of a ban on packer ownership of livestock 14 days prior to

+ A proposal to establish country of origin labeling (COOL) as voluntary and not mandatory

+ Opposition of the transferring of water through rivers, lakes and streams for the purposes of water marketing

+ A recommendation to the American Farm Bureau Federation Board to study the Fair Tax consumption tax plan that has been proposed to replace federal income taxes

+ Proposal for schools to be financed by means other than property

The Texas Farm Bureau state convention will be held in Waco on December 7-8. State resolutions approved there will become policy of the Texas Farm Bureau. National resolutions that are approved at the meeting will be' forwarded to the American Farm Bureau Federation, which meets in Hawaii in January.

Notice of Drinking Water NITRATE Violation The Texas Commission on Environmental Quality (TCEQ) has notified the City of Wilson ater system that the drinking water being supplied to customers had exceeded the maximum Contaminant Level (MCL) for NITRATE. The U.S. Environmental Protection Agency (U.S. EPA) has established the MCL for NITRATE at 10 mg/L, and has determined that it is a health concern at levels above the MCL. Analysis of drinking water in your community for NITRATE indicates a level of 11.01 mg/L

Infants below the age of six months who drink water containing nitrate in excess of the MCL could become seriously ill and, if untreated, may die. Symptoms include shortness of breath and blue baby syndrome. If your child is under the age of six months, the child must be given an alternative water supply for any consumption. Boiling the affected water is not an effective

Most consumers do not need to use an alternative water supply. However, if you have health concerns, you may want to talk to your doctor to get more information about how this may affect you. At this time, the health effects to fetuses of pregnant women is unclear. If you are pregnant, you may also choose to use an alternative source of water for drinking and cooking purposes. We are working to correct the problem.
