SUMMER is definitely with us, since we already have had many days where the temperature reached 100 or more. So naturally I got to thinking about what I did in other summers in my life and, of course, I can recall more vividly things which happened 60 years ago when I was a kid than I can things which happened in the last several decades.

I grew up in Jacksboro, a couple of hundred miles east of here on U.S. 380 and summers there are hot and sultry, with blister bugs and incredible humidity and mesquite trees and rattlesnakes out in the country where we youngsters used to go hiking. Of course, when you're 12-14 years old, heat and humidity don't bother you, because that's the only climate you've ever known, and we weren't much scared of snakes and blister bugs, just wary.

We'd take our BB guns, or sometimes even a single shot .22, get our Boy Scout canteens of water and go just looking around out in the ranch country, sometimes walking several miles during the day and taking all afternoon to do it. I don't remember that we ever took any food, but we must have. I know when we ran out of water, we'd scoop some out a creek we knew about and drop in a couple of little white pills which our scoutmaster had told us would make water safe to drink.

There usually were three or four of us boys, and we found snakes, toad frogs and horned toads and varieties of bugs and birds, and once we saw a fox. Looking back, it seems we had great times, but maybe I have just forgot any bad things that

I learned to swim one summer at a place where a fairly deep creek crossed the road near town, a place we called "Water Crossing". Just off the highway the water sloped down to a depth of 10-12 feet, there were trees growing out of the water, and trees and bushes (some with poison ivy) along the banks. It was a gravel bottom and we'd just walk down into the water until it got deep enough to swim in. Only in my case, I just went out until the water was up to my chin and then turned around and tried to swim back.

Frequently we would see snakes swimming in the water. If they got up close, we'd just get out of the water and throw rocks or wait until they swam off.

If that crossing is still there and hasn't changed, there's no way anybody could entice me into that water now.

## **Cotton Crop Off To Better Start Than In Recent Years**

**Agriculture Extension Agent** The 2004 cotton crop for Lynn County is off to a much better start as compared to the last five years. Obviously, rainfall and moisture are the biggest factors to the start of this year's crop.

"We have received 13.68 inches of rain for 2004 as compared to 8.56 inches for the same time last year," said Bryan Reynolds, Lynn County Extension Agent. "Basically we have received more rain this year as compared to all of last year," stated Reynolds.

Some areas of the county received less than 10 inches of rain last year, so it doesn't take much to get off to a better start," he added.

Cooler temperatures and 2.85 inches of rain officially for June were seen by the area. Some places around O'Donnell received in excess of 6 inches of rain in June. At the same time, the area northeast-of O'Donnell probably received the roughest weather in terms of wind, sand, rain,

"They simply could not get back in the field for several days after the storms and decided to replant something other than cotton, in many cases due to the lack of growing time for replanted cotton," said the county

Certainly other areas have not received as much moisture and the cotton in those areas continues to lag behind and suffer, but overall, things are looking better than any in recent years in terms of the stage and progression of this crop

"We had cotton blooming on July 4, which is something we have not seen in a while," said Reynolds. "Producers with the early planted cotton in May took advantage of the moisture available to get the crop up and established before it dried out. said Reynolds. "These fields look good and should progress nicely as we head towards peak bloom in late July and early August," Reynolds said. "Other fields are coming along better now but are a little behind due to it being planted around June 5-10 after enough moisture was received to plant on," he explained.

Although, moisture prospects and progression of the crop are bet ter than in recent years, producers are still faced with some challenging times. One major factor is the price

"The U.S. cotton market is now being able to get other countries to utilize our commodities," said Reynolds. This makes for a more volatile situation in terms of marketing and the price received by producers. Other things such as high fuel and production costs continue to challenge our producers on a daily

"Cotton farming is not an easy living but it is a way of life and we should be proud of our Lynn County producers," said Reynolds.

## **McLelland Named Asst. Principal; Six Teachers Hired At Tahoka ISD**

Superintendent Jimmy Parker reported to trustees at their Tahoka Independent School District meeting last week that Jennifer McLelland has been named Assistant Elementary Principal, and that five teaching staff members had been hired. Trustees also approved an additional staff member during the meeting for the new three-year-old program that begins this fall.

Mrs. McLelland, a 10-year teacher at Tahoka Elementary, was reassigned by the administration as Assistant Elementary Principal, at a pay salary of \$45,000. She taught sixth grade most recently, and is filling the position vacated by Robert Webb, who was named High School Principal.

Shayla Erickson, of Tahoka, was hired as a teacher for the new threeyear-old program to be offered at Tahoka ISD this year. The program is federally funded, and will be offered to those students who meet certain qualifications, according to Head Start program guidelines.

Supt. Parker also informed trustees that five other staff members had been hired, including three coaches. Elizabeth Boyd is the new head girls softball coach, a new program being offered this year in girls athletics, and she will also coach Middle School girls basketball, and teach teacher salary schedule, at \$1000

PE/Health at high school; Katie above Step 20. The state mandates a Kraft will teach high school Biology and coach Middle School girls basketball and assist in Cross Country and Track: Jonathan Gally will teach U.S. History and be an assistant coach in football, basketball, baseball and track; Regina Oliver will teach Chemistry and Physics at high school; and Lana Bowie will be an elementary teacher, probably in fourth grade.

The superintendent told The News that this should complete the teaching staff openings, although if the district receives grant funding for a reading program there may be an additional person hired at a later date.

A \$1,000 increase was added to the salaries of the Transportation Director and Director of Maintenance, and an additional 50-cents per hour was maintenance, custodians, and grounds personnel.

Trustees also made à unanimous decision to add a Step 21 to the McLelland. Trustee Joe Calvillo was

20-step pay schedule for teachers that generally covers the first 20 years of a teacher's salary. School districts may, at their discretion, add extended pay schedules for teachers who have taught beyond 20 years. Supt. Parker said there are approximately 13 teachers at Tahoka ISD who are at Step 21 or beyond, who have not had a pay raise since 1999 when they maxed out on the state salary schedule.

In other business, the 2004-05 Student Code of Conduct was approved as presented, and trustees moved to join a purchasing coop with Lubbock ISD. A milk bid from Thriftway was approved, and Business Manager Nathan Ehlert presented the district's financial report







1 cup butter 2 cups sugar


1 tsp. Vanilla 5 cups flour



# **New Cardiac Rehab Program** Offered At Lynn Co. Hospital

Chest Pain. Heart Attack. Coronary Artery Bypass.

These are words that no one wants to hear, but if these are words that apply to you, the good news is that patients in this area won't have to add to their stress level by driving to Lubbock's busy medical centers for their cardiac rehabilitation pro-

Lynn County Hospital District announces the opening of their Cardiac Rehabilitation Program, located in the west wing of the hospital patient rooms. The new program will provide personal one-on-one attention, flexible hours, and a low-key but highly professional approach to helping patients get back their lives while coping with heart-related problems.

Richard Tamplen is Program Director of the new facility. He has a Masters Degree in Cardiac Rehabilitation, and also has years of experience in actually building treadmills and other types of cardio vascular equipment designed for cardiac rehabilitation. He says he is pleased to be at Lynn County Hospital District to offer the personal attention that the smaller cardiac rehab centers can provide. He will work closely with the patient's physician to ensure that the rehabilitation program is working for each individual patient.

"I have programs that I have developed for rehab patients, but I will also do whatever the patient's doctor has ordered to help them gain back their lives," said Tamplen. "We offer not only physical rehabilitation, but try to help people learn to deal with the stress in their lives and to feel like they do have control over their bodies," he said.

"Most people who have had heart problems are scared that they can't return to their normal lives. When a new patient comes in, we not only talk about their physical condition but also about their hobbies,

their family, their diet - I want to learn more about them personally so that we can help them with their stress levels and get back to life," Tamplen explained.

After the initial visit with patients, Tamplen will set up a rehab schedule - usually 36 sessions - and runs a stress test to determine each individual's heart patterns and stress levels. While the cardiac rehab program at Lynn County Hospital District may be housed in a small room with a select number of specialized equipment, Tamplen says he can run the exact same tests that patients would receive in larger centers but that, unlike most larger centers, he can provide one-on-one attention during the entire session.

"I'm here to monitor the entire session, talking with the patient and answering any questions he or she may have," Tamplen stressed. "Right now the smaller patient load ensures one-on-one sessions. Even when we get busier I hope to have no more than two-on-one, where I can visit with both patients while monitoring their progress," he added.

"The small towns are getting really popular for cardiac rehab programs because of the more personal attention to patients - I am looking forward to meeting the people here and working with them," said Tamplen.

Although he does not live in Lynn County, driving here from his home in Ransom Canyon, Tamplen already knows some of the hospital staff because his wife, Gina, is Physical Therapist at the hospital's Physical Therapy/Fitness Center on Lockwood. The couple has three children, ages 6, 5 and 3 years old.

He says that part of the stress of cardiac rehabilitation is that patients must travel to so many sessions to comply with the program, and that hopefully with a location in Tahoka the compliance will not be so difficult, especially for older patients

who prefer not to drive in Lubbock.

"This program is not just for people in Lynn County, but any of the further outlying areas where patients needing cardiac rehab are having to travel to Lubbock. Hey, we're not Lubbock - it's easy to get here and parking is no problem," he explained with a smile.

Stress testing is offered on Tuesdays and Thursdays at Lynn County Hospital District Cardiac Rehab center, with the regular monitored exercise sessions offered on Monday-Wednesday-Friday. Tamplen says the program is considered a Phase II program, where patients are continually monitored.

Patients may progress to Phase III at the Physical Therapy/Fitness Center on Lockwood, which offers rehabilitation programs on Monday-Wednesday-Friday afternoons. The Phase III is not continually monitored, but a close eye is kept on progress or setbacks, and any changes are reported to the patient's physician.

"All reports are sent back to the patient's cardiologist, and anytime we see something that may be unusual, we'll run a strip and send it to the cardiologist." Tamplen explained.



# **County Purchases New Maintainer**

**Lynn County Commissioners** met in regular session Monday morning, approving the purchase of a new maintainer for Precinct 4, at a trade difference of \$56,000, to be financed at First National Bank of

A new computer and software for the County Treasurer's office was also approved, allowing the treasurer to purchase the package best suited for that office.

In other business, commissioners joined other counties in Texas in supporting a resolution requesting the Texas Department of Human Services to reconsider the closing of 217 offices throughout the state.

County Judge H.G. Franklin reccived a letter from the Texas Health and Human Services Commission (HHSC) that said that as a result of HB 2292 changes are being planned that include the closing of more than 200 local offices. One of the offices under consideration for closure is the office in Tahoka that employs three full-time staff, but staff members there said they have not received any official notification that the Tahoka office would close, or the date that

such closure might occur. The letter to Judge Franklin states that changes in the process will include internet access, call centers, mail and fax options; and face-toface interviews at state field offices, which will be located so that consumer would travel no more than 5 miles for services in urban areas, 15 miles in suburban areas, and 30 miles in rural areas. Mobile offices will also help expand services in rural

"We have not yet determined which offices may be closed or where offices would be located un-

der the new model," said Albert Hawkins, Executive Commissioner, in the letter. "These changes will make the process much simpler for the more than 940 Lynn County residents who receive Medicaid, in addition to those who qualify for food stamps, TANF and other services," he added.

Another letter from the Texas State Employees Union, however, warned commissioners that the proposed changes would make access more difficult and amounts to an unfunded mandate on local governments. That letter asked county commissioners to support the resolution that Lynn County Commissioners approved.

"HHSC's letter to you fails to mention that as a result of its plan, about 4500 employees who staff local DHS offices will lose their jobs," the letter stated. "Any savings that accrue to the state will be offset by increased costs to local governments. People who need the assistance of local DHS workers to navigate the complex application process will not find the same level of help at call centers. Many will fail to complete the process ... others will be frustrated by long waits on the phone while trying to contact call centers and give up. These people will then turn to local governments for help, and local taxpayers will be forced to pick up the tab." the TSEU letter

Both city and school entities are sharing the cost of the sign, which costs approximately \$25,000.

City officials approved a request at their June council meeting by Richard Sanchez to allow a small fireworks display at the Tahoka High School homecoming pep rally and spirit fire, contingent upon Sanchez working with the Tahoka Volunteer Fire Dept. Chief for safety issues.

A request from Pegasus Communications was approved at a special session on July 1, allowing the company to lease space on the city's water tower.

Tahoka City Council members and Mayor Mike Mensch met with city officials at the regular council meeting Monday night, approving Joe F. Hays, CPA as the auditor for the city's finances for 2004. Monthly bills were also approved, and the August meeting was rescheduled for the second Monday of the month.

MEMORIAL DEDICATION CEREMONIES SLATED - Dedication ceremonies will be held at 10:30 a.m. Sunday, July 18 at the Draw-Redwine Memorial, erected at the Draw Cemetery in Lynn County in honor of war veterans who went to school at Draw or Redwine. The annual Draw-Redwine Reunion will held afterwards in Tahoka.

### **Draw-Redwine Memorial Dedication And Reunion Slated July 18th**

Lynn County residents are invited Sunday, July 18, to attend dedication ceremonies of the Draw-Redwine Memorial, followed by the annual Draw-Redwine Reunion. Dedication ceremonies will be held at 10:30 a.m. Sunday at the site of the Memorial, a 6-1/2 foot tall granite structure located at the entrance of the small cemetery in Draw.

To reach the Draw Cemetery from Tahoka, drive east on U.S. Hwy. 380 about 7 miles, and turn right at Farm Road 1054 where a sign says, "Draw." Continue south on FM 1054 about 10-1/2 miles, and

the cemetery is located on the right. just past the Draw Methodist

The Draw-Redwine Memorial, erected Oct. 15, 2003 in honor of war veterans who went to school at Draw or Redwine, lists 117 men and one woman who served their country in military service. The memorial was paid for by Draw-Redwine exes who met annually for their reunion, donating funds at each year's reunion for the memorial. Sunday's ceremonies will be followed by the annual reunion, to be held at the Tahoka Housing Authority building located

at 1400 Ave. K in Tahoka.

Draw and Redwine schools were established in Lynn County during the early years after the county's founding in 1903. Children who lived in that area went to grade school at Redwine and attended high school at Draw.

Historical accounts note that Draw School District was established May 23, 1904, with school colors of red and black and a Longhorn as the mascot. In 1936, the high school at Redwine consolidated with Draw, with high school students attending Draw and elementary students staying at Redwine School. It is not known when Redwine School was disbanded, but in the fall of 1944 the entire Draw School was bussed to Tahoka.

By 1945 or 1946, the children were back at Draw, but in 1947 a petition was approved to consolidate Draw with O'Donnell school district. Jimmie Crawford, an ex-student whonow lives in Muleshoe, said that when the Draw School closed in 1947, those who lived in the south half of the district went to O'Donnell schools and those who lived in the north half went to Tahoka schools.

Ex-students began having reunions in the 1950's, with the first events held in Lamesa and then at Tahoka and Post. Currently, the reunions are held in Tahoka on the third Sundays in July, with average attendance of 70-100 people.

"If you plan to attend the reunion, please contact Brenda Furlow at 806-428-3387, as she needs to turn in a head count to the catering service. We hope to see you at the dedication and reunion," said Jimmie Crawford, memorial chairman.
