Wrecks, Crimes **Keep Police Busy**

Vandalism, assaults, a car burglary, theft and four traffic accidents kept Tahoka Police Dept. busy during the last week. Two accidents occurred Friday and two more on Sunday, with only minor injuries reported in any of the accidents.

The two traffic accidents Friday happened within five minutes of each other, both on Lockwood St. about a block apart. At 3:40 p.m. a 1996 Pontiac Grand Am driven by Enedina Villa Arellano, 46, was in a collision with 1994 Chevrolet pickup driven by Juan Diego Perez, 17. The collision as both vehicles were traveling east on Lockwood was observed by a police officer.

About five minutes later as a 2002 Chevrolet pickup driven by Glenn Anderson 68, slowed near the scene of the first accident, it was involved in a collision with a 1995 Ford Explorer driven by Amber C. Ramirez, 27. All drivers involved in the Friday accidents listed Tahoka or rural route addresses.

Just after 1 p.m. Sunday two vehicles were involved in a collision on a parking lot at 2001 Lockwood in the city. A 1995 Chevrolet pickup driven by Armando Barrera, 38, hit a parked 2006 Chevrolet Cavalier owned by Marie Garcia of Lubbock.

At Lockwood and Ave. N 45 minutes later, a 2003 GMC Yukon driven by Kristi Dawn Lockaby, 36, was in collision with a 2003 Ford pickup driven by Omar Olveda Gonzales, 20, of Brownfield. One of the four passengers in the pickup, Clarissa Olveda, 9, was taken by private vehicle to Lynn County Hospital for treatment.

On Tuesday night near O'Donnell a wreck involving a pickup and an 18wheeler resulted in no injuries. Investigation was by a state trooper who was not available Wednesday morning.

After Lashanda Hood of Tahoka advised police last Wednesday that her

son's bicycle had been stolen from outside their apartment on N. 7th St., police located the bicycle being ridden by a 19-year-old Tahoka man. The case (See CRIME, page 5)

Early Voting Set May 1-9

Early voting begins Monday, May I for city and school elections in Lynn County. All four cities in the county will conduct elections, but only two school districts have contested races requiring elections. New Home and O'Donnell school districts have cancelled their elections, due to uncontested races, as has Lynn County Hospital District.

Early voting will be held May 1-9 for those entities having elections, and a new requirement this year is that two of those early voting days have polls open for 12-hour periods.

In Tahoka, early voting for both the city and school elections will be conducted weeksdays from 8:30 a.m. until 5 p.m. May 1-9 at the Lynn County Courthouse, County Clerk's Office, except on May 2 and May 4, when polls will be open from 7 a.m.

Wilson city and school entities have also combined early voting to be at Wilson ISD Central Office from 8-4 Monday through Friday, and from 7 a.m. until 7 p.m. on May 3 and May 4.

Early voting for the City of New Home election will be held at New Home City Hall from 8 a.m. until 11 a.m. weekdays May 1-9, and from 6 a.m. until 6 p.m. on May 2 and May 3.

And in O'Donnell, early voting for the City of O'Donnell election will be held at O'Donnell City Hall during weekday hours May 1-9, and from 7:30 a.m. until 7:30 p.m. May 4 and May 5.





LAST WEEK I wrote about milk; this week the topic is eggs. That still leaves butter for another day, although I really didn't plan to launch a threepart dairy series. I do like dairy products, for launch, or dinner. And I don't know anything about butter (but ignorance never stopped me on the milk and egg stories).

Anyway, I read a couple of stories about eggs in last Sunday's newspaper, one of which made me feel better about all the eggs I eat. The good news story was in USA Weekend, a magazine supplement, and it said that eggs are okay for your heart, and "if you've been avoiding eggs because you think they will raise your cholesterol, stop it." According to the article, the anti-egg crusade was a mistake, and just because eggs themselves are high in cholesterol doesn't mean they raise your blood cholesterol.

According to research they quoted, people who eat an egg a day are no more likely to have heart disease than those who eat eggs less than once a week. This information was eggciting.

It takes a minute or two to realize there are words inside the magazine, because the cover photo on that issue showed actress Eva Longoria in what Ann Landers used to call an atomic blouse (60 per cent fallout).

If you're still afraid to eat plain old eggs, you might want to try the special low-fat, low-cholesterol eggs produced by Eggland's Best, a company in New Jersey, which was the subject of the other story I read.

These eggs sell for as much as a dollar more per dozen than regular eggs, and last year about \$200 million worth were sold, according to the story. Compared to regular eggs, Eggland's have 25 per cent less saturated fat, 15 per cent less cholesterol and several times more vitamin E and omega-3 fatty acid, both of which are believed to reduce the risk of heart disease, and also contain lutein, which is supposed to help prevent cancer and macular degeneration.

You many not be able to buy them around here, though. If they are that good for you, maybe a trip to New Jersey once in awhile might be in order. I'll bet that since the Associated Press story came out April 9, people are scrambling to get those eggs.



When Fido and Fluffy get the ho-hums and appear bored, playing solitaire or working on a puzzle are probably not options to solve the problem.

If your pet is acting strangely, such as a dog chasing its tail excessively or your cat over grooming itself, don't rule out the possibility of obsessivecompulsive disorder (OCD), says Dr. Bonnie Beaver, a veterinarian and behavioral expert at the College of Veterinary Medicine & Biomedical Sciences at Texas A&M University.

compulsive disorders can lead to problems for your pet.

"Obsessive compulsive behaviors tend to be repetitive behaviors that are seen in inappropriate situations, often but not always to excess," says Beaver. "They are hard to diagnose because we cannot evaluate the animal's thoughts."

She says the common causes of OCD in pets are stress, anxiety

and boredom. "Animals with too much energy and those without things to occupy their minds will find ways to do something," says Beaver. "Over time, these actions become something an animal needs to perform and are then

seen as repetitive behaviors." Stress can also trigger these behavioral problems. "Changes in routine and lack of exercise are the two most common causes of stress in animals," Beaver says.

Dogs and cats with high energy are more likely to develop obsessive-compulsive disorders.

"There also seems to be a subcategory of animals that have an imbalance of chemicals in the brain, which makes them susceptible to these disorders," she adds.

"If your pet exhibits some of these behaviors, there could be serious results. The drive to perform a behavior can be so strong the animal fails to eat or sleep. In some cases, the behavior causes self-directed aggression like chewing of the tail or leg."

But how can owners tell if their pets' behaviors can lead to serious problems?

"Any time the owner has a question about his or her pet's behavior, he or she should give their veterinarian a call," says Beaver. "If it could become a serious behavior problem, the veterinarian will let the owner know an appointment is

Sometimes animals only exhibit these types of behaviors for a short period of time. Beaver advises owners to be aware of this and if the problem progresses, owners should consult their veterinarian. "Anything that lasts for more than a few days should spark a concern," she adds.

But don't start biting you nails just yet - she says there are things you can do to help your pet with this disorder.

"Sometimes the behaviors can be prevented by being sure She believes obsessive the animal gets plenty of exercise," Beaver says. "Also make sure it has a lot of enriching things for the pet to do in its home environment.

> Obsessive-compulsive disorders can be a serious problem for you and your pet. Beaver suggests owners consult their veterinarian if they notice any odd behavior.





Risky Drinking Can Increase Risk of an ER Visit

Awareness Month in April, the American College of Emergency Physicians (ACEP) and the **Emergency Nurses Association** (ENA) have launched a campaign to educate occasional drinkers about how much is too much alcohol consumption and why it may put them at a higher risk of a trip to the emergency

Research shows that habitual drinking of more than four more than two drinks per day (on average) for a man, and more than three drinks per occasion or more than one drink a day (on average) for a woman and anyone over age 65, can put you at higher risk of injury, illnesses and even a trip to the emergency department. Alcohol contributes to the deaths of about 100,000 people annually from falls, impaired driving crashes and illnesses, such as cirrhosis of the liver, according to the National Council on Alcohol and Drug Dependency. It also contributes to suicide, homicide, domestic

As part of Alcohol violence, as well as heart disease, cancer and stroke.

"There is a rising trend in alcohol-related emergency department visits, which means cancers. people are being harmed and a health care system," said Dr. Frederick Blum, president of ACEP. "You don't have to be an higher alcoholic to have an alcohol problem. With heightened alcoholic drinks per occasion or or illness, we believe more people alcohol's effects. will think twice before

consuming too much alcohol." A 2004 study published in the Archives of Internal Medicine found 8 percent of emergency department visits to be alcoholrelated, which on average represents about 7.6 million alcohol-related visits per year. Researchers said patients aged 30 to 49 had twice the rate of emergency department visits with diagnoses completely attributable to alcohol, compared with patients aged 15 through 29, or 50 and older. The visit rate for males was three times higher than for females, and the visit rate for blacks was approximately

two times higher than for whites. "Every day, emergency nurses across the country see the tragic effects that alcohol abuse has on the lives of individuals and families," said Nancy Bonalumi, RN, MS, CEN, 2006 president of the Emergency Nurses Association. "By making educated life choices when drinking, people can prevent needless health problems or injuries, including harm to innocent victims.

About three in 10 U.S. adults drink at levels that elevate their risk for physical, mental health, and social problems, according to the National Institute on Alcohol Abuse and Alcoholism, 2002 National Epidemiologic Survey on Alcohol and Related Conditions. Older adults who drink too much alcohol are at increased risk of hypertension that can result in a stroke, impaired motor skills even at low level use, injuries such as falls, sleep disorders, suicide, and

increased dementia symptoms. Of these heavy drinkers, about one in four has alcohol abuse or dependence. All heavy drinkers have a greater risk of hypertension, gastrointestinal bleeding, sleep disorders, major depression, hemorrhagic stroke, cirrhosis of the liver and several

Tahoka Housing Authority Rated Among Best in State

Organizations in small communities are often overlooked when it comes to recognition by federal officials. but the Tahoka Housing Authority has been rated one of the best housing authorities in the state of Texas - and that's compared to 286 housing authority organizations overseen by the Texas Housing and Urban Development (HUD) officials in Fort Worth.

"We are truly .onored by this designation, and feel that the federal authorities recognize that the Tahoka Housing Authority is a viable part of this community," said Bill Miller, Executive Director of the Tahoka Housing Authority. "I was told that we are one of the highest rated housing authorities in the state, earning an overall average of 96.8 (of a possible 100 points) in the rating scale. It's just almost unheard of to get anything above a 95, so we are very pleased," added Miller.

HUD bases the rating on an annual inspection of housing authorities, with four overall components considered in the rating, including Management, Financial, Resident Survey, and Physical Inspection of all property.

Tahoka Housing Authority received a perfect component score in the Management section, and dropped only one point in the Financial section, with the other few points detracted in the

Resident Survey and Physical

Inspection of all properties.

"We really received an excellent rating in the physical inspection of our properties," said Miller, adding that the Tahoka Housing Authority is committed to maintaining the condition of

all housing properties under its jurisdiction to the highest standards.

"We have a total of 74 units. after we purchased the housing on North 7th Street from the Tahoka Industrial Housing Authority (a city-operated organization that is no longer functional). We have 'since renovated all of those units, and we strive to maintain the best possible housing for our residents," Miller explained.

"We were already considered a high performer by HUD. because of our consistently high ratings these past few years (usually around 92 points), but this year's high rating by HUD is extremely rare and ve are excited about that," said Miller, noting that Tahoka Housing Authority has more housing units compared to other communities with similar populations. HUD provides federal

funding for the operation of the local facility, and a five-member board of commissioners oversees the Tahoka Housing Authority John Krey serves as chairman of the board, Cal Huffaker is vice chairman, and three other members complete the board. including Bennie Nance, Greg Henley and Doug Wood. Miller heads a staff of three that oversees the day-to-day operations.

"Our staff members, Virginia Quintero, Raymond Quintero. and Roger Locke. Jr., do a wonderful job and we credit them with helping the Tahoka Housing Authority earn this exemplary rating from HUD," said Miller


In the Championship game, Wilson defeated the top ranked Meadow Purple team by a score of 28-20. Things did not get off to a good start for Wilson as

USDA Extends Authorization To Graze CRP Acres

In continuing response to this habitat and the environmental year's widespread drought, USDA's Farm Service Agency has announced the extension of grazing of Conservation Reserve Program (CRP) acreage in Texas to July 1,

"Certain areas of Texas continue to experience severe drought conditions and a severe shortage of forage for grazing," said CED Jimmy Woodard. County Executive Director for the Name County FSA. "Pasture recovery and new grass seedlings are delayed due to a lack of moisture and cool weather. This extension of emergency grazing to July 1, 2006 in Texas will provide forage for livestock and help producers in areas most severely impacted by these drought conditions.

This includes all counties in Texas previously approved for emergency grazing eligible for the extension. Grazing of CRP acres is authorized until July 1. 2006, or until disaster conditions no longer exist, whichever comes first. CRP participants who do not own or lease livestock may rent or lease the grazing privilege to an eligible livestock producer.

This action by USDA is in response to a request received from the Texas FSA State Committee. Producers should note that an extension for emergency haying of CRP acres past the original May 1 cutoff was NOT authorized in order to protect and preserve wildlife

benefit of the permanent cover.

CRP annual rental payments will be reduced by 25 percent for the acres grazed. Other restrictions and limitations apply therefore producers must visit the local USDA Service Center to request grazing privileges and modify existing CRP conservation plans to incorporate grazing provisions prior to relocating livestock.

CRP offers annual rental payments and cost-share assistance to establish long-term, resource-conserving cover on eligible land. USDA will monitor producers to ensure the land is grazed in a manner that does not damage existing conservation

"Although many areas of the state have received the benefit of recent rains; there are areas where the precipitation was simply too. little, too late," said CED Woodard. "Extending CRP grazing privileges provides immediate, short-term relief to producers in need of forage."

USDA also offers other programs to assist drought stricken producers, including emergency farm loans, the emergency conservation program and the noninsured crop disaster assistance program. Disaster Assistance Available For Small Businesses

Small, non-farm businesses in 204 Texas Counties, including Lynn County, (plus contiguous counties in Louisiana, New Mexico and Oklahoma) may now apply for low interest disaster loans from the U.S. Small Business Administration (SBA). These disaster loans offset economic losses because of reduced revenue to farmers and ranchers caused by the severe drought conditions, above normal temperatures and wildfires, that occurred beginning April 1, announced Alfred E. Judd, Director of SBA's Disaster Field Operations Center-West.

Small businesses may qualify for Economic Injury Disaster Loans (EIDL's) of up to \$1.5 million to help meet financial obligations and operating expenses, which could have been met, had the disaster not occurred. "Eligibility for these working capital loans is based on the

By law, SBA makes EIDL's available when the U.S. Secretary of Agriculture designates an agricultural disaster. Secretary Mike Johanns declared this disaster at the request of Gov. Rick Perry Businesses primarily

engaged in farming or ranching are ineligible for SBA Disaster assistance. Agricultural enterprises should contact the Farm Services Agency (FSA) about the U.S. Department of Agriculture (USDA) assistance made available by the Secretary's declaration. However, in drought disasters nurseries are eligible for SBA disaster assistance.

State Sales Tax Collections Increase


Texas Comptroller Carole Keeton Strayhorn announced that the state-received \$1.36 billion in sales tax revenue in March, a 13.2 percent increase compared to March 2005.

Local sales tax revenues also continue to grow. Strayhorn sent \$368.2 million in April sales tax allocations to cities, counties, transit systems and special purpose taxing districts, an 18.2 percent increase compared to April 2005. So far this calendar year. sales tax allocations to local governments are up 17 percent.

Comptroller Strayhorn sent April sales tax allocations of \$249.3 million to Texas cities, up 17.8 percent compared to April 2005. Calendar year-to-date. city sales tax allocations are running 15.5 percent higher than last year. Texas counties received sales tax payments of \$22.3 million, up 19.2 percent compared to one year ago. Calendar yearto-date, county sales tax allocations are 18.1 percent higher than

Another \$10.7 million went to 108 special purpose taxing districts around the state, up 22.5 percent compared to last April. Ten local transit systems received \$85.7 million in sales tax rebates.






