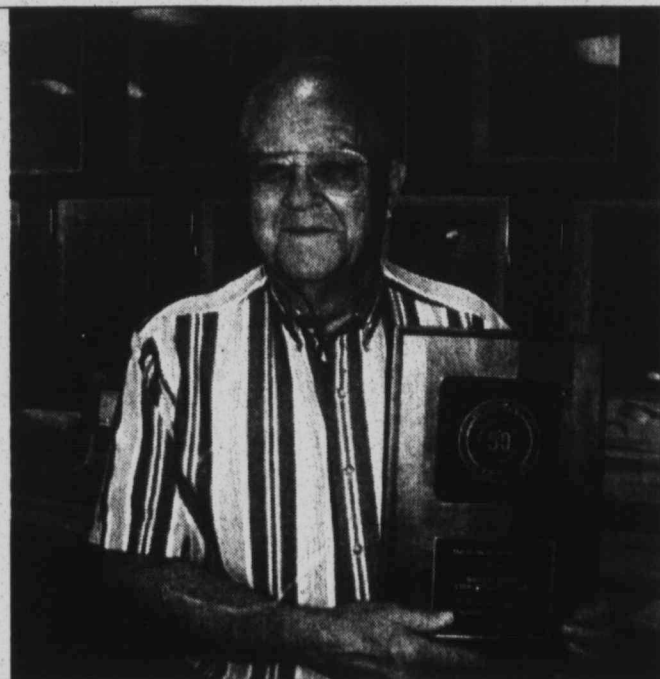

50 Years in Newspaper Industry ...

Former LCN Publisher Dalton Wood Honored With TPA 'Golden 50 Award'

Dalton Wood, former publisher of The Lynn County News who continues to write his weekly "Woodwork" column for the paper and various other articles, was awarded the Texas Press Association's "Golden 50" award recently at the TPA Summer Convention. The award honors those who have served 50 or more years in the newspaper industry.

Wood has an impressive 56 years (and still counting) in the newspaper business, and he has owned several weekly newspapers in the South Plains area, including Sudan, Amherst, Shallowater, Anton, Tahoka, and a part-interest in the Slaton newspaper. He also owned a weekly newspaper in Newburgh, Indiana for a period of time.

He began writing his weekly column, "Woodwork," in 1971 and continues today to offer his humorous point of view in his admittedly "skewed" interpretation of the world as he sees it. Weekly topics ranging from the familiar to the bizarre, and current events, or in some cases, family occurrences that some family members would just as soon he not mention, have made it into his weekly contemplations.

"Several years ago, our Mom (Lenda) was working on the roof of the Pioneer Museum here in Tahoka and the ladder she had propped up against the building blew over in the wind, leaving her stranded on top of the building. She pulled her cell phone out of her pocket to call Dad, as our office is just two blocks away, to come put the ladder back up for her, but the very first thing she said when he answered the phone was, 'You can't use this in your column and I mean it! ... but I'm stranded and need help,'" remembers their daughters with a smile. "I guess Mom learned a long time ago that if she didn't want to read about it in the paper, she had better threaten Dad with a nondisclosure clause."

"And there have been many occasions when we would wince reading his column that noted some unfortunately humorous event that befell one of us. When we were teenagers, it was an embarrassment for anybody to know we had parents, much less have one of them write about us," they added with a laugh and a nod to teen angst. Their older brother, Terry, also was unwilling teen fodder for the musings of Woodwork. "Looking back from a different perspective, now we understand why parents must find the humor in so many family situations, and it was only natural that Dad wrote about us," they admit.

Now the two twin daughters, Vondell Elliott and Juanell Jones, are co-owners of The Lynn County News, following in their father's footsteps in the newspaper industry. The twins bought the paper from their father in 1992, and he has been semi-retired for the past 14 years.

Wood began his career in the newspaper business as a reporter for the *Graham Newsfoto*, a weekly newspaper in

Graham, Texas, in September of 1950, after he earned his Bachelor of Arts degree in Journalism in 1950 at North Texas State University in Denton (later called the University of North Texas). He graduated from Jacksboro, TX High School in 1946.

From November 1950 to early 1951 he was a reporter and photographer for the *Vernon Record*. In 1951 he joined the *Lubbock Avalanche-Journal* as a reporter and photographer, later that year joining the news desk as rim man (copy editor and headline writer). The next year, in 1952, Wood worked for the *Dallas Times Herald* as copy editor and headline writer, and then in 1953 he returned to the *Lubbock A-J* as chief editorial writer, later moving to the copy desk as editor and supervising reporters. He also ran the *Throckmorton Tribune* for a short period of time.

Following a dream to own and operate a newspaper on his own, Wood moved his family to Indiana in 1955, where he purchased the weekly *Newburgh Register*, sight unseen, whose office sat on the banks of the Ohio River. He also worked part time as copy editor/headline writer/layout at the daily *Evansville Courier and Press*.

Four years later they returned to their Texas roots, and in 1959 Wood purchased the weekly newspaper at Sudan, the *Beacon-News*, and the neighboring *Amherst Press* in Amherst, seven miles away. Later he established a new weekly paper at Shallowater, the *Star*, which was published for several years, and he also owned the *Four County News* at Anton.

Eventually he sold his interest in those papers, and in 1965 he joined the staff of the *Plainview Daily Herald* as a news editor, editing and supervising copy of reporters, choosing stories from AP and UP wire services, writing headlines and laying out all the newspaper except society and sports pages. In addition to his newspaper duties, he taught night and late afternoon classes in journalism and English at Wayland Baptist College (now university), and also coached the tennis team for Wayland.

In 1971 he purchased an interest in the weekly *Slaton Slatonite*, and moved to Slaton to publish that newspaper.

Eight years later, in 1979, Wood sold his interest in the *Slatonite* and purchased the weekly *Lynn County News* at Tahoka and moved here as publisher. One of his daughters, Juanell, began working at the *Lynn County News*, in 1982, and ten years later she convinced her twin sister, Vondell, to move from Dallas to the slower pace of small-town living, and Wood sold controlling interest of *The News* to the twins, who continue to operate it today.

Wood has covered thousands of stories in his career, including natural disasters such as tornadoes, floods, and Hurricane Camille in Gulfport, Mississippi (sent to report recovery efforts by the *Plainview Daily Herald*). He has met many politicians, some now famous in-

Accidents In County Result In Two Injuries

Two persons were injured, neither seriously, in accidents which occurred south of Tahoka Monday. At 6:15 a.m. Monday a 2003 Ford Ranger pickup driven by Ramiro Resendez of Tahoka struck a deer as the vehicle was traveling south on FM 3112. Resendez was taken by Lynn County EMS ambulance to Lynn County Hospital, where he was treated and then released.

Also on Monday, Leland Rogers of Enid OK overturned his 2005 Chevrolet Impala after he dozed off, then overcorrected on U.S. 87 a mile north of O'Donnell, according to investigating state trooper Quentin Kingham. Rogers also was taken to the hospital by EMS ambulance and released after treatment.

An 18-year-old Tahoka man was treated at Lynn County Hospital and then transferred to a Lubbock hospital after he was found early Monday hang-

ing in a garage in an apparent suicide attempt. When first taken to the hospital, he reportedly was not breathing, but police said he later did start breathing on his own. No report on his condition was available Wednesday.

Town and Country convenience store officials told police Saturday that a man described as being in his 30s wearing a Hawaiian shirt obtained \$200 cash with an invalid credit card.

Police also arrested an Odessa man on a warrant for driving while license invalid and driving while intoxicated, subsequent offense and arrested a Tahoka man for public intoxication.

During the month of June, dispatchers at the Lynn County Sheriff's Dept. processed 310 calls, including 128 for the county, 129 for City of Tahoka, 25 for O'Donnell police, 23 ambulance calls and five fire alarms.

Glitch In Doctor's Schedule Puts Hospital On Standby For Day

With both of the Lynn County Hospital's regular doctors out of town while a Lubbock physician came to the hospital to cover all situations, the hospital was forced to go on a standby basis for about 12 hours last Tuesday, June 27, when the Lubbock physician unexpectedly was not available.

By law, physicians assistants may not treat patients in the emergency room or patients in the hospital unless a physician is available if needed, so the

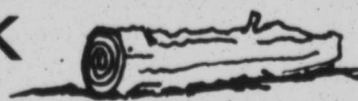
hospital had to transfer three patients to Lubbock facilities. Administrator Jimmy Morris advised the hospital board at its regular meeting last Thursday. Morris indicated that steps will be taken to assure that the situation is not repeated in the future.

Morris also told the board about plans to deal with any possible bio-terrorism events, discussed contracts for medical personnel and noted that the physical therapy department is planning a bicycle event for Tahoka.

The board voted to accept a retirement plan assessment, and also voted approval of a project to do some remodeling of an ambulance housing area to include a shower required by the bio-terrorism emergency program.

President Jerry Ford presided. Other members present were Joan Knox, Jannis Horwood, Regina Crutcher, Billy Tomlinson and Dalton Wood.

Insect Repellent Best Way To Prevent West Nile Virus

With warm weather here to stay, mosquitoes are multiplying across the state—some of them carrying the West Nile virus. But there is a simple way people can bite back: insect repellent.

"Use a good insect repellent. Use it every time you are outdoors. That's the No. 1 thing people can do to protect themselves from mosquito-borne illnesses," said Jim Schuermann with the Zoonosis Control Group at the Texas Department of State Health Services (DSHS). "It's tough to tell people to wear long sleeves and long pants in the Texas heat."

West Nile Virus can cause serious illness in humans. Mosquitoes get the virus from feeding on infected birds. West Nile virus cases usually begin in the late spring, peak in early August and continue through the fall. Last year, 128 human cases of West Nile virus were reported in Texas, including 11 deaths.

"West Nile virus is here. We know it's not going away. Now is the time people need to think about prevention," Schuermann said. "If you go outside, wear repellent."

Look for insect repellents that contain DEET, picaridin or oil of lemon eucalyptus. According to a 2005 DSHS analysis, 60 percent of the people who got the most serious form of West Nile infection never used repellent.

"Use a good repellent on bare skin and follow the directions on the label," Schuermann said. DEET is the standby—long-lasting and effective. Picaridin-based repellents are new, tend to smell better and less oily. Lemon eucalyptus-based repellents are ideal for people who are sensitive to—or just don't like using chemical repellents."

DSHS offers these recommendations:

- Store insect repellent at the front and back doors of your home

and apply when you go outside. Keep extra repellent in outdoor areas such as patios and decks.

- Mosquito proof your house. Make sure door seals are secure and window screens are intact.

- Drain standing water from around your home. Empty cans, buckets, tires, rain gutters and saucers under potted plants regularly. Change the water in pet bowls, bird baths and wading pools several times a week.

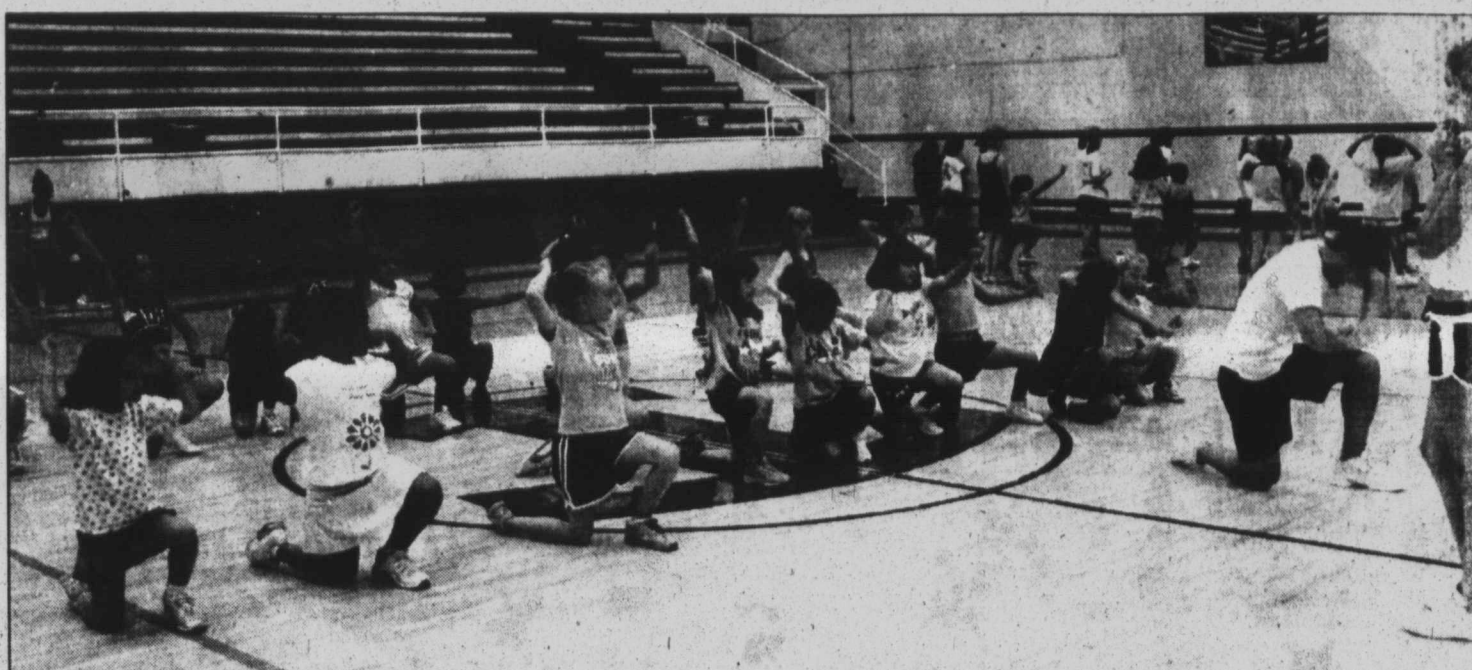
- Limit the amount of time you spend outdoors from dusk to dawn. These are the times when those mosquitoes likely carry infections are most active.

Symptoms of the milder forms of West Nile illness include fever, severe headache, muscle and bone aches, nausea and drowsiness. Symptoms of more serious forms of the West Nile include a stiff neck, visual problems, altered taste, body tremors, mental confusion, memory loss and seizures. Symptoms usually appear from three to 14 days after a person is bitten.

People most at risk of developing symptoms include those older than 50 and those with compromised immune systems. If West Nile illness is suspected, people should contact their local health care provider. A blood test can confirm West Nile infection. There is no specific treatment for West Nile infections.

West Nile virus was first identified in Texas in 2002 and has since been found throughout the state. DSHS conducts surveillance testing on mosquitoes in many areas of the state. DSHS also provides kits to local health departments, animal control facilities, veterinarians, county extension offices and other local entities for testing birds for West Nile virus.

People should not handle dead birds with their bare hands.

Instead, use a shovel, protective gloves or plastic bags. Throw birds away in an outdoor garbage can. Most bird deaths pose no threat to human health, but if West Nile virus is suspected contact your local health department.

Other mosquito-borne illnesses include St. Louis encephalitis, eastern equine encephalitis, western equine encephalitis, and dengue fever. For more information visit the DSHS web site at www.dshs.state.tx.us.

Sea Camp Offers Ocean/Marine Programs For Youth

Texas A&M University at Galveston's Sea Camp, now in its 21st year, is offering summer sessions to youngsters ages 10-18 in one of the most unusual environments anywhere—on the beach, in the ocean and never far from interesting marine life.

Since its beginning in 1986, more than 11,000 campers from all over the United States have enjoyed a wide variety of Sea Camp programs, says camp director Judy Wern.

"This is a program where the beach and the ocean are the classrooms," Wern says. "We can truly say there is no other camp like this in Texas. Sea Camp strives to teach kids about the marine and estuarine environments and how these affect the campers' own lives. It's learning through experience and is why we stress a hands-on, feet-in type of camp where the kids learn by doing."

Camps this year, running weekly through Aug. 5, will include Introduction to Marine Biology/Ecology for ages 10-12 and 13-14; Coral, Crabs and Cuttlefish for 11-12; Coastal Ecology (12-15); Fishing Camp (13-17) and Marine Mammal Explorations (15-18).

Also offered will be Coastal Camping (14-16); Ocean Careers Awareness (15-18); Coastal Photography (13-18) and

Nautical Archaeology/Oceanography (14-18).

In addition, there will be a take-off on the popular CSI (Crime Scene Investigators) called SCSi, in which campers will learn how to use the biological, chemical and physical sciences to solve crimes and mysteries much like real-life crime scene investigators do.

"Every year, our students tell us this is the most fun they've ever had while learning," adds Wern.

Sea Camp instructors include Texas A&M faculty members and graduate students from numerous departments,

including marine biology, marine sciences, zoology, wildlife and fishery sciences and others. Campers will also get the chance to meet with Sammy Ray, a member of the Texas Science Hall of Fame and one of the world's leading experts on oyster biology. Ray started Sea Camp in 1986.

Costs range from \$775 to \$850. Campers will live in residence halls on the Texas A&M at Galveston campus. A \$150 deposit is required.

In addition to Sea Camp, other summer programs include Sea Campus Kids (non-residential workshops for kids 6-

11 years old), career workshops for Talent and Gifted students 13-18 and an Intergenerational Elderhostel marine adventure program for grandparents and grandkids 6-11 years old.

SUBJECT: QUARTERLY FLUORIDE NOTIFICATION
The Texas Natural Resource Conservation Commission (TNRCC) has notified the City of Wilson water system that the drinking water being supplied to customers had exceeded the Maximum Contaminant Level (MCL) for FLUORIDE. The U.S. Environmental Protection Agency (U.S. EPA) has established the MCL for Fluoride at 4mg/L, and has determined that it is a health concern at levels above the MCL. Analysis of drinking water in your community for FLUORIDE indicates a level of 3.8 MG/L.

This is not an emergency. However, some people who drink water containing FLUORIDE in excess of the MCL over many years could get bone disease, including pain and tenderness of the bones. Fluoride in drinking water at half the MCL or more may cause mottling of children's teeth, usually in children less than nine years old. Mottling, also known as dental fluorosis, may include brown staining and/or pitting of the teeth, and occurs only in the developing teeth before they erupt from the gums.

You do not need to use an alternative water supply. However, if you have health concerns you may want to talk to your doctor to get more information about how this may affect you.

The City of Wilson has inquired about getting a Reverse Osmosis plant to deal with this problem and without the help from grants this system has been too costly to put in at this time. The City is also looking for alternative water supply sources.
