Fire Descroys Home Here

A home in the 2100 block of North 4th Street was destroyed in a fire Friday evening, but family members who were home at the time escaped uninjured.

The owner of the home, Virginia Campanale, was inside with one of her two small grandchildren, when the other. grandchild ran inside and reported smoke from behind the garage, according to information from City Fire Marshall Jerry Ford. Ms. Campanale called the fire department and escaped outside with her grandchildren to await the arrival of the Tahoka Volunteer Fire Department, who responded to the call at approximately 5:30 p.m.

Flames quickly engulfed the storage area and garage and spread to the rafters of the home as firefighters fought to douse the blaze and keep it from spreading to neighboring homes. Ford said firefighters believe the fire possibly started from an electrical short of some type in the storage area where stacks of newspapers were stored. The newspapers quickly caught fire and spread to the garage and home.

Ford said Ms. Campanale's insurance company totalled the home from fire and smoke damage. She and her grandchildren reportedly stayed with a neighbor the first night following the fire, and Red Cross assisted with housing the family at a local motel for a couple of nights, before she made other arrangements with her insurance com-

The Tahoka Volunteer Fire Department remained on site for approximately two hours to ensure the fire was completely put out, Ford said.

"This is our opportunity to show people why we love Tahoka, and what makes our town a great place to live," said Retha Pittman, Tahoka City Secretary, who is working closely with the Channel 11 team to prepare for the event. "Our city motto is 'Where Family Values and Community Spirit Reside,' and we want people to see that Tahoka truly is a wonderful place, in which to raise our families," she added.

Lynn Co. Hospital **Tobacco Settlement Funds Up From '05**

Distribution of tobacco settlement funds to some cities, counties and hospital districts in Texas increased by 43 per cent this year over the previous year, according to a release from Texas Comptroller Carole Keeton Strayhorn.

She reported that \$72.1 million has been distributed to three cities, 158 counties and 131 hospital districts from the Tobacco Settlement Permanent Trust Account. "These funds provide a shot-in-the-arm for hospitals that are burdened with the responsibility of treating patients who cannot afford health care," she stated.

The trust fund provides annual distributions each year to hospital districts to help offset the cost of providing mandatory health care for persons who cannot pay, and the amounts are based partially on how much unpaid care the hospital provided in the previous year.

Lynn County Hospital this year received \$30,267 from the program.







Stray Dog Hurts Woman's Pet

Dear Editor,

I think something needs to be done about all the stray dogs in Tahoka. I have a very small Chihuahua that I care for very much, and he was hurt very badly by a stray dog. On July 5th around 3:45 p.m. we were outside and I heard a lady screaming "stop, stop!" and I didn't see my dog, Tucker. I took off running and saw the stray dog had Tucker completely in his mouth and was shaking him violently. He finally let Tucker go and my puppy took off for my house, hurt and whimpering. The lady who had yelled came over to check on him and said the stray dog did not belong to her but just stays around their house all the time, but he won't let anyone near him. Then the stray dog came over to my yard and was still trying to get Tucker, who was hurt very badly.

I took my puppy to Dr. Brillhart where he stayed in the pet hospital for two days, costing me \$265. The stray dog had bit Tucker nearly completely around his body, and he had to have drain tubes put in.

I went to report the incident on July 6th to the City Manager. He also said the dog did not belong to the lady and that they had tried before but the stray wouldn't let them rear him. He said he would look into it. It has been six days and the dog is still roaming around. It could have easily been a child on a bike that





Two Traffic Accidents SPJST District 4 Youth **Reported In Tahoka**

Two traffic accidents were reported in Tahoka during the last week. On Wednesday, July 5, a 2001 Suzuki 650 motorcycle ridden by Rev. Carl Lynn Long struck a curb and threw off the rider, who was wearing a helmet. He was taken to Lynn County Hospital by EMS ambulance for treatment of apparent minor injuries.

On the same day, at Main and Lockwood, a collision occurred between a 2004 Ford F250 pickup driven by Clarence T. Bronaugh. 66, of League City TX and a 1997 Ford F150 pickup driven by Donald R. Devore, 67, of Midland. There were no injuries.

Police also were called to the scenes of several fights and domestic disputes.

Twenty people were arrested and jailed during the last week. bringing the total count of inmates at Lynn County jail to 47 as of early this week, with five of these each held for Lubbock and Gaines counties, three for Dawson and two for Garza County.

fraudulent use in possession of identification . ormation, Lubbock warrants on theft, criminal mischief and burglary of a habitation, grand jury indictments for reckless driving and evading arrest and another person indicted for DWI second offense or more, application to revoke probation on conviction of burglary of a habitation, driving while license invalid,

possession of a controlled substance plus tampering with physical evidence, DWI first offense plus driving while license invalid, assault causing bodily injury and public intoxication.

Road Closure Draws Attention At City Council Meeting Monday

City Hall regarding a request to a vote of 3-1 with one council close a portion of Ave. E in the member abstaining from voting. south part of Tahoka near the Voting for the motion were councemetery drew public attention, cil members Ray Box, Amy with several guests present for the hearing.

Mr. and Mrs. Ascencion Gonzales presented a petition protesting the road closure to city officials at the meeting, which included six pages of handwritten signatures. Property owner Roddy Gandy, who had requested the road closure, was also present for the hearing held Monday night at the City Council meeting.

City attorney Cal Huffaker explained to the group that after conducting some research it was discovered that Ave. E was originally platted to end at South 9th, according to the city map. The road, however, continues to the the property and blade the road. That portion of the road, however, does not belong to the city or county, and in fact is on privately-owned property, now owned by Roddy Gandy, according to the city attorney.

City officials consulted with county officials to request rerouting Ave. E off the private property to run through county property to continue to allow access to the cemetery road. County attorney Brian Kingston and County Commissioner Mike Braddock were both present at the meeting for the discussion.

A motion to reroute Ave. E on county-owned property to continue on to cemetery road was

A public hearing at Tahoka approved by the city council with Preston and Jeff Martin. Voting against was Clara Calvillo, and abstaining from voting was councilman Rudy Fuentes.

In other business, council members voted 4-1 to revise Chapter 12, Section 12-03 in the City of Tahoka Personnel Policies and Procedures Manual, regarding use of civy vehicles by non-appointed employees, including police department and water/sewer department employees. In the past, personal use of city-owned vehicles by these employees was allowed within the city limits during off-duty hours. The council voted to discontinue personal use of vehicles cemetery road apparently because except to allow the vehicles to be in years past the property owner parked at the employee's home allowed the county to come onto and driven back to work when the employee returns to work. The motion passed 4-1, with Preston, Martin, Calvillo and Fuentes voting for the motion and Ray Box voting against.

The council voted to submit a grant application to the Office of Rural Community Affairs to begin the process of possible grant funding for future city projects. Police Chief Doyle Lee presented report on the police department's activities for the month, and monthly bills were approved.

Present at the meeting were all five council members, Mayor. Mike Mensch, City Administrator Jerry Webster, City Attorney Cal Huffaker, and others.






