Man Dies After Wreck On Hwy 87

William Walker, 50, of Fort Worth, died early Thursday in a Lubbock hospital several hours after he was airlifted to Lubbock following a one-vehicle rollover Wednesday afternoon in a construction zone 3-1/2 miles south of Tahoka on Hwy. 87.

Investigating DPS officer Quintin Kingman said Walker was a worker for the Austin firm which is doing the highway construction at that location, and had been headed to Lubbock in his Ford F250° pickup. He was wearing a seatbelt.


Sheriff's deputies this week were seeking a 22-year-old Wilson man in connection with two separate incidents. A Wilson school official had advised that the man was on the school campus and had threatened two students. The next day, the suspect's girl friend, a 25-year-old Slaton resident, filed an assault complaint against the man, saying he struck her with his fists. He has been charged with terroristic threats in the school incident, but deputies were unable to locate him as of

Rewards totaling \$1,500 have been offered for information leading to the arrest and conviction of whoever shot out the windows and damaged cabs of two trucks owned by Lynn Cook, while they were at his property south of the Tahoka cemetery on Aug. 22. The sheriff's report said \$3,000 worth of damage was done by a shotgun, and involved a Ford F350 pickup and a Ford F500 truck/water well drilling rig.

I'll huff and I'll puff, and I'll blow your house down

... It wasn't the big bad wolf, but mother nature blew a mighty wind that left a trail of destruction Saturday. This picture looks perfectly normal, until one realizes that where the two golf carts are parked there were cart houses around them, and the square sections on the ground delineate where the walls are no longer standing. Five cart houses in this row were blown away by storm winds at T-Bar Golf Course, and left these two carts sitting where they belonged. Storm Winds Rip Cart Houses Away At T-Bar Golf Course Saturday

High winds in an afternoon thunderstorm wreaked havoc at T-Bar Golf Course west of Tahoka Saturday, interrupting the Club Championship Tournament and ripping five sheet-metai golf cart houses from their moorings. Five cart houses were completely demolished and many others suffered other damage, including several roofs torn off the top of the cart houses, and storm debris was strewn across the nine-hole course.

The storm sent golfers in the tournament scrambling for refuge at the clubhouse, with frequent lightning accompanying the sudden downburst of rain that deluged the Tahoka area. When the storm passed, several golfers retrieved their carts and drove around the corner to the put their carts up, only to discover a row of five cart houses were gone, on the east end of row four.

The cart houses belonged to Murray Kieth, Steve Miller, O'Donnell High School, and two houses belonged to Joe Calvillo.

Electrical power went off at the clubhouse and at many of the cart houses, and tree limbs and other debris were scattered on the course. Tournament play was postponed until Sunday. afternoon, and members were busy Sunday morning picking up debris to enable golfers to tee off at 1:30, although the tournament-was by necessity shortened to an 18-hole scoring system, instead of the traditional 36hole event

"There are six rows of cart houses, and we had some type of storm damage on every row," said Cherry Gandy, manager at T-Bar Golf Course. "Several had roofs missing or the metal sides were torn, and we are still assessing which houses are still without electrical power," she said Tuesday after-

No golf carts were reported damaged, although some equipment was lost in the cart houses that were destroyed.

Clint Walker Honored On Retirement From FNB Board

The Board of Directors of First National Bank of Tahoka honored Tahoka native Clint Walker last week, upon his retirement from the board after 35 years of serving as a director. On Wednesday, Aug. 26. Chairman of the Board Fred Hegi Jr. presented a plaque of appreciation to Walker that expressed the bank's appreciation for his solid leadership and support, and noted that Walker's knowledge. experience and community focus have been invaluable assets to the bank

Walker was elected to the FNB Board of Directors in 1971. serving until August 2006.

We will certainly miss Clint on the board," said John Krey, FNB President and Chief Executive Officer. "He has enabled the bank to provide outstanding service to this community. His years of dedication and experience have been invaluable to First National Bank.

Walker was born and reared in Tahoka. leaving his hometown to serve in the U.S. Navy on Dec. 5, 1941. He was a combat and test pilot during World War II, flying 60 missions in the South Pacific. He married his sweetheart, Lottie Jo Townes of Tahoka, upon his discharge from the Navv

I had been sent to Miami for discharge, and we were supposed to get married the next day. The preacher told us that there was a category-3 hurricane headed straight for Miami the next day, and if we wanted to get married we'd better get it done that day, so we decided to get married that night. Sure enough. the hurricane hit the next day, but we weathered it out." he remembers with a smile.

They returned to Tahoka and he served as Commander of

the American Legion for four years. He began his business career as an administrative officer of the federal farm program in Tahoka and in the early 1950s he went into the insurance and real estate business, opening the Clint Walker Agency in 1952. In the mid 1970s Walker partnered with Jim Solomon, and the business became known as the Walker-Solomon Insurance Agency. Today, both Walker, and Solomon have retired from the business, but the company name still endures under new leadership.

Walker has long been known as a man who gives back to his community, volunteering his time and services in a myriad of organizations. He has been a member of the Tahoka Rotary Club for 67 years, and the club honored him with a Paul Harris Fellowship in 1996. He actually joined the club as a youth, recruited by club members to play for the club softball team in the

city softball league. "At that time, most of the members of the club were olderthey didn't have young members back then; and they needed some boys on their softball team. They recruited me and another fellow. and I just stayed on as a member ever since," Walker said. He is still an active member of the

He was instrumental in bringing the T-Bar Country Club and golf course to completion in the early 1950s, and was a charter member of the club. "Since I had been Commander of the American Legion I had a little bit of pull, so we went and got some old army barracks for the clubhouse," he remembers. He served as President of T-Bar Golf for several terms.

Many Tahoka football fans have fond memories of Clint

Walker as "The Voice of the Bulldogs," as he volunteered to announce the home football games for nearly four decades. His distinctive deep voice commandeered the speakers for many a Friday night ballgame at Kelley Field, and he was an avid supporter of the Bulldogs. "One of my most enjoyable activities was being the public address announcer for the Tahoka Bulldogs for 39 years," he says. In 1970 the Tahoka High School student body honored him by dedicating the yearbook to Walker, and he has been honored as the Tahoka Citizen of the Year

He was also sought after to emcee many local activities, and he graciously offered his publicspeaking abilities for these events. He has been the Mayor of Tahoka. President of the Tahoka ISD Board of Trustees, secretary of the Chamber of Commerce. March of Dimes chairman for 10 years, and a director on the Canadian River Authority and Brazos River Authority boards, as well as the Regional Educational Service Center board.

He was one of the driving forces in building the Lynn County Hospital and was a board member when Lynn County Hospital was built. He was active in organizing Little League. and he is a longtime member of First United Methodist Church of Tahoka, serving many years in various capacities including the Administrative Board and as a Sunday school teacher for the junior high department.

Victim airlifted after one-vehicle rollover ... The driver of a pickup was airlifted by AeroCare to a Lubbock hospital after his vehicle plunged off the road 3-1/2 miles south of Tahoka last Wednesday evening at about 5 p.m. William Walker of Fort Worth died a few hours later from his injuries. His truck ended up in the ditch (visible behind the helicopter) after rolling down the steep shoulder in the northbound lane of Hwy. 87. Uneven lanes in the current construction project on the highway may have played a factor in the incident, and motorists are cautioned to be careful when traveling the road between Tahoka and O'Donnell, where the shoulder drops steeply at the pavement edge. 

OISD Board Approves New Tax Rate, Budget

O'Donnell Independent School District Board of Trustees met last Thursday, Aug. 24, conducting a public hearing on the proposed tax rate and budget prior to their regular meeting, where they approved a total tax rate of \$1.38630 for 2006-07. Trustees unanimously approved the tax rate, which includes \$1.28130 in Maintenance and Operating (M&O) and \$0.10500 for Interest and Sinking (I&S) to pay debt service.

"The I&S tax rate increased from \$0.10 to \$0.105 because our property values increased from \$66,341,917 in 2005 to \$75,968,115 in 2006," said Rodney Schneider, Superintendent. "Normally an increase in property values would result in a decrease in I&S tax rate because it takes fewer pennies to raise the necessary revenue to pay debt obligations. However, because we receive aid from the state for our debt in the form of existing debt allotment (EDA) the norm does not remain true. Our annual debt obligation is approximately \$127,500 per year. Of that \$127,500, we received EDA from the state of approximately \$63,400 (2005-2006). The difference between the \$63,521 and the \$127,500 is the amount of local revenue we need to raise in the form of I&S tax. Despite the fact that our property values increased in 2006, our I&S rate increased one-half a penny. Because our values increased, the state reduced the percentage of revenue we received from the state in the form of EDA. Our EDA revenue from the state decreased from \$63,521 in 2005-2006 to \$53,644 in 2006-2007. As a result of the lower EDA allotment, the district had to make up the difference between the debt obligation and the EDA payment. Our portion of the debt obligation increased from \$63,979 in 2005-2006 to

\$73,856 in 2006-2007. Basically the state says as you become increasingly wealthy, you receive less debt assistance. Therefore, we have a higher I&S rate then we did in 2005," he explained.

The Board unanimously approved the 2006-2007 budget as presented. The budget approved by the Board contained only three funds: maintenance and operations fund, food service fund, and debt service fund. In the maintenance and operation fund, school officials projected revenue of \$3,951,065 and budgeted appropriations of \$3,951,065. The food service fund contained revenue projections of \$213,469 and budgeted appropriations of \$213,469. Debt service fund contained revenue projections of \$127;500 and budgeted appropriations of \$127,750, according to the superintendent.

The Board unanimously approved amendments to the 2005-2006 budget as presented. All three primary funds (maintenance and operations fund, food service fund, and debt service fund) were amended.

"The reason we needed to make these amendments was because there were discrepancies between the original budgeted appropriations (August 2005) and the final actual expenditures (August 2006)," said Supt. Schneider. "Originally (August 2005) the 05-06 budgeted was approved with appropriations of \$2,829,168. As of August 24, 2006 we had actually spent \$3,414,273, and we are projecting final expenditures to be approximately \$3,513,287. I cannot explain why the original 05-06 budget was under-appropriated. The resulting difference between approximated final expenditures and original appropriations must be reconciled prior to closing the year, thus, the reason for the aforementioned

amendments," he added. Fund 199 (maintenance and operation) was amended \$752,000, fund 101 (food service) was amended \$50,000, and fund 511 (debt service) was amended \$62,700. The final amended budget for fund 199 was \$3,581,688, for 101 was \$204,650, and for 511 was \$127,500.

The Board unanimously approved a 5% salary increase for auxiliary personnel (Ms. Bessire and Ms. Summers). For the 2006-2007 school year, all professional employees received at least the minimum state raise or better, and all auxiliary personnel received at least a 3% raise or better.

The superintendent reported that first day enrollment was 331 compared to 347 at the end of last year at OISD. Elementary enrolled 168, junior high 57, and high school 106. Current enrollment as of Thursday, August 24, was 337 students, with elementary reported at 172 (+4), junior high 59 (+2), and high school 106 (even).

The next board meeting was set for 7 p.m. Tuesday, Sept. 19.

City Officials Propose 5-Cent Tax Increase

City of Tahoka officials are proposing a 5-cent tax rate increase for 2006-07, and holding a public hearing on Aug. 31 at 12noon at City Hall to hear public input. If approved, the new tax rate would be 74.7031 cents per \$100 of property value.

Currently, the city tax rate is 69.5-cents per \$100 of property value, the same rate it has been since 2003 when the city increased taxes by only a penny. The tax rate was 68.5 cents for four years, from 1999 until 2003, and was 69.5 cents for the next three years.

For an average residence homestead appraised at \$35,201 last year, and at \$35,298 this year, the proposed five-cent rate increase would put an additional \$19.04 on a homeowner's tax bill.

According to City Administrator Jerry Webster, the nickel increase will only generate \$28,324 for city coffers. Unlike other taxing entities within the county, the city tax base has not increased significantly, with total taxable value of all property up only \$451,230 from last year's figures. Total taxable value of all property in the preceding tax year was \$50,821,490 compared to \$51,272,720 in the current tax year. Other taxing entities, such as school districts and the county, are seeing significant increases mostly in ag property values, but the city does not incorporate any ag property.

The proposed budget for the City of Tahoka is \$1,784,653 for total predicted expenditures, which includes a three percent increase across the board for city employees. Webster said that fuel costs and products related to the petroleum industry have doubled, which has had a significant impact on the budget.

"We're not really adding anything new, it is just that costs have gone up and unfortunately it is going to take a tax increase to fund the budget," Webster said. A penny in the tax rate generates between \$4,000 and \$4,500 for the city, he explained.

City officials are also considering raising the basic water rate \$2.00, from \$15.25 to \$17.25 for the first 5.000 gallons of water, which would take affect Oct. 1. This rate increase is expected to fund the 2005 additional water rights project of the Canadian River Municipal Water Authority, where Tahoka gets its water supply.

"Canadian River Authority officials told us that this project would secure water to last 100 years." Webster told *The News*. He said the rate increase would also fund a \$30,000 capital improvements project for replacing all the old black fire hydrants in the city. There are approximately 20 hydrants that need to be replaced, at a cost of \$1500 each.

Other city fees for sewer and garbage collection are expected to remain the same, he said.

Fahoka City Council is expected to vote on the tax rate and budget at their Sept. 11 meeting.

Voting Box 5 (Draw) will vote with Box 1 (South Tahoka): Voting Box 8 (Hackberry) will vote with Box 2 (Wilson); Voting Box 10 (New Moore) will vote with Box 3 (O'Donnell); Voting Box 11 (Lakeview) and Box 13 (North Lynn County) will vote with Box 4 (New Home); and Voting Box 7 (Grassland) will vote with Box 14 (East Tahoka).



Troopers Target Drunk Drivers For Labor Day

Texans who drive while in toxicated should expect extra attention during the Labor Day weekend. All available Texas Department of Public Safety troopers will be on the lookout for speeders, seat belt violators and drunk drivers from Friday, September 1 through Monday. September 4.

"It's against the law to drive when your blood alcohol content is 0.08 or above, and you should ow that Texas Highway Patrol troopers will be looking for you," said Col. Thomas A. Davis Jr., director of the DPS. "In addition to the criminal penalties, it's important to remember that there is a \$1,000 per year surcharge for three years that is assessed on drivers who are convicted of driving while intoxicated.'

DPS supports the "Over the Limit. Under Arrest" campaign, a nationwide anti-DWI effort aimed at reducing alcohol-related deaths and injuries during the Labor Day holiday period. DPS also is a participant in Operation CARE-Combined Accident Reduction Effort-a nationwide effort by police agencies to reduce fatalities on major interstate highways during holiday


First offense: a fine not to exceed \$2,000 and/or a jail term of 72 hours to 180 days; participation in an alcohol education and treatment program even if probation is granted; license suspension from 3 months to 1 year

Second Offense: Fine up to \$4,000 and/or jail term of 30 days to one year; mandatory 72 hours in jail even if probation is granted: license suspension from six months to two years.


Third Offense: Fine not to exceed \$10,000; prison term of two years to 10 years; mandatory jail term of 10 days even if probation is granted; license suspension from six months to 2

Intoxication manslaughter: fine of up to \$10,000, prison term of two to 20 years, license





Animal Rabies Reported In Northern Texas

Eight cases of animal rabies have been documented in counties in the northern part of Texas. according to information released by the Texas Dept. of State Health Services, including one bat in Lubbock County, one bat in Randall County, one skunk each in Collingsworth and Hall counties, and three skunks and a cat in Ochiltree County.

Animal control officers. county officials, veterinarians and other officials have been notified in all cases.

In Sherman County, which is located at the northern edge of Texas, surveillance has determined that plague is present in the prairie dog population, and large prairie-dog die-off is being experienced in western. Moore and Sherman counties. While plague is suspected as the cause of the die-off, only the one sample has been confirmed. People living, working or hunting in or near prairie dog towns should assume plague may be present and take appropriate precautions.

To report a suspected or confirmed case of plague, contact the Texas Dept. of State Health Services' Zoonosis Control Group at 806-655-7151 in Canyon, or 806-767-0427 in Lubbock, during normal business hours, or the Texas Dept. of State Health Services at 1-888-847-6892.

Plague is a zoonotic disease caused by the bacterium Yersinia pestis and is transmitted from rodent to rodent by infected fleas. The bacteria cycles through the wild rodent population in the western United States and periodically produces outbreaks with high death rates in infected rodents. Rodents typically involved in plague include rock and ground squirrels, prairie dogs, wood rats, and chipmunks. In domestic pets, cats are much more susceptible to plague than dogs.

Plague is transmitted through the bite of an infected flea, entry through a break in the skin by direct contact with the tissues or body fluids of an infected animal, or by inhaling infected droplets from an infected person or animal (especially cats) with pneumonic plague. The incubation period for bubonic plague in humans is 2 to 6 days after exposure. Initial signs include fever, headache, and general illness followed by the development of a very painful, hot to the touch, swollen regional lymph node.

Primary prevention is directed toward reducing the threat of infection to humans in highrisk areas, by eliminating food and shelter for rodents around homes and buildings by removing brush, rock piles, junk and food sources from the property. Use appropriate safe insecticides to kill fleas on property. and people expecting to be out in the brush where they may be exposed to rodent fleas should apply repellent (DEET-containing products). Wear gloves when handling potentially infected animals, and treat pets with longacting flea control products.

Hospital Sets Increased Budget, Lower Tax Rate

Lynn County Hospital directors Tuesday night set a budget for next year higher than the current fiscal year ending Oct. 31, but lowered the tax rate more than one cent per \$100 valuation. The proposed tax rate will be exactly 28 cents per \$100 valuation, compared to this year's rate of 29.384 cents.

Because of increased property values in the hospital district this year, the district still should make about \$34,000 more in tax revenues than last year, when \$624.666.06 was levied. It was voted to put the extra \$34,000 into a capital improvements fund to pay for some needed repairs and renovations at the hospital which previously have not been budgeted.

Votes on the budget and proposed lower tax rate were unanimous. The budget calls for \$4,312,504, or about \$114,000 Knox and Billy Tomlinson.

more than will be spent this fiscal year. It was noted that if revenue and expense projections are close, the hospital should show a profit of about \$394,000 next year. Hospital directors will have a public hearing on the proposed tax rate on Sept. 7

It also was pointed out again that taxes account for only about one-seventh of the income of the hospital; most of the money comes from patient revenue.

Administrator Jim Morris discussed pending legislation in Congress which he said should be supported by the hospital board and patrons, and reported that Lynnwood Assisted Living Center has 21 residents, with no vacant rooms at this time.






