Polls To Open Saturday For May 12 Elections

Polling sites for the May 12 elections will open from 7 a.m. until 7 p.m. Saturday at four locations in Lynn County for voting in the statewide Constitutional Amendment Election as well as for several local city/school

Voting will be conducted in Tahoka at the Life Enrichment Center, 1717 Main Street; in Wilson at the Green Building; in O'Donnell at O'Donnell High School Commons Area; and in New Home at New Home

A special Constitutional Amendment Election is being held statewide, with only one amendment on the ballot, regarding reduction of property taxes on homesteads of elderly/disabled whose taxes were frozen at a higher rate than the 2006-07 tax years.

Additionally, four local entities have scheduled elections for trustees or council members, including Tahoka ISD, Wilson ISD, and O'Donnell city and school district.

The Tahoka ISD election is for the Precinct 2 seat, with only those registered voters residing within the Precinct 2 area eligible to vote in the election (a precinct map is available at the TISD business office at the Harvick Building on Main Street, or at the polling site). Two candidates are seeking the term, including incumbent Joe Calvillo and challenger Carlos

Four trustee positions are on the Wilson ISD ballot, including three regular-term positions, and a one-year unexpired term. Candidates for the full terms include incumbent Janie Rios, Casey Donald, Cody Donald, and write-in candidate Israel Ramirez. A write-in candidate, Danny Mendez, has also filed for the one-year unexpired

In O'Donnell, five candidates have filed for three city council seats, including incumbents Wayne Mott, Willie Luera and Roger Doss, and challengers Jesse Ray Perez and Paul Houston.

O'Donnell ISD also has five candidates on their ballot for three school board positions. Five candidates have filed for three regular terms as school trustees, including three incumbents, Mark Roye, Ben Franklin and Kirby Williams, and challengers Cody Furlow and Liz Luera.

Live Hand Grenade Found In Tahoka

A hand grenade fell out of some steel tubing being moved at Hernandez Tire Shop in Tahoka last Thursday, and it later was determined that it was a live grenade

David Hernandez, one of the shop owners, said that workers at the shop in the 1600-block of Ave. C passed the grenade around and looked at it after it came out of the recently-acquired lengths of tubing, and he decided to call the sheriff's office to determine if possession of a hand grenade was legal.

Deputy Abraham Vega said he advised Hernandez to put it down, get away from it, and someone would be out to the scene quickly. The bomb squad of the Lubbock County Sheriff's Dept. was contacted, and two men from that squad came out and took possession of the grenade, which they x-rayed on the spot and determined that it was live. The bomb squad duo first taped the firing pin on the grenade to assure that it wouldn't come out, officers said.

The bomb squad later advised the Lynn County Sheriff's Dept. that the grenade appeared to be a Vietnam-era weapon of the U.S. military, and that it appeared to be primarily an incendiary bomb, meaning that it could cause more damage from fire than from the explosion itself.

Lynn County officers were told that the bomb squad plans to detonate the renade within a week or so as part of a bomb squad training exercise.

Hernandez told officers the steel tubing had been obtained from Noonie Rogers of Tahoka. Rogers, who deals in scrap metals, later reportedly told officers he had no idea how or when the grenade got into the tubing. The bomb squad searched through the rest of the tubing at the Hernandez shop and found no other devices.

Tahoka Police during the week also investigated one traffic accident in which there were no injuries, theft of a lawn mower, burglary of a vehicle, domestic disturbances and made arrests for public intoxication and war-

Last Thursday at Main and N. 4th St. a collision occurred between a 1990 Buick Park Avenue driven by Ethel H. Philpot, 92, and a 2007 Chevrolet pickup driven by Norman Jacob Kelln

On Monday Rita Arrigo Quintanilla of Tahoka told police that someone had broken out the passenger side window of her 1992 Daihats Charade and took a Samsung Ipod with a 2inch screen, and a Pioneer CD player. Total loss including damage to the vehicle was estimated at \$500. The victim told police she didn't understand why a thief would break out the window of the vehicle, as it was not locked.

Cleto H. Saldana told police someone stole a Craftsman 22-inch lawn mower from his garage in the 1800block of S. 8th St, Sunday night or early Monday. The mower was valued at

Police are seeking a 27-year-old Lubbock man who ran and escaped after he was stopped for possible public intoxication Saturday.

Police also arrested two teenagers, a 17-year-old Tahoka male and a 16year-old Lorenzo male, for fighting in the 2100-block of N. 4th St. Sunday.

For the fourth straight week, Lynn County jail was filled to near maximum capacity with 54 in jail as of Monday, including 14 held for Garza, four for Lubbock, three for Gaines and one for Dawson County.

Those most recently jailed were charged with driving while license suspended, warrant for speeding plus failure to appear, grand jury indictment for possession of a controlled substance, furnishing alcohol to a minor, driving under influence by a minor, public intoxication, no liability insurance and Dawson County warrant for fugitive/ failure to identify to a peace officer.

Dispatchers at Lynn County Sheriff's Dept. processed 245 calls during April, including 106 for the county, 99 for Tahoka Police, 16 for O'Donnell Police, and 24 ambulance

"Dissolve a milk of magnesia tablet in a quart of club soda overnight. Pour the mixture into a pan large enough for the flattened newspaper clipping. Next, soak the clipping for one hour; remove completely before moving again. This method can make newspaper articles last up to 200

Gee. I had heard that there was some kind of solution which would preserve newspaper clippings, but I didn't know what. And I'm not too sure about that 200 years part. How would they know that?

Moves Forward Over the past several weeks, the House Agriculture Committee and its six subcommittees have held a large number of hearings regarding the 2007 Farm Bill. The committee has heard testimony on crop insurance and commodity programs, and subcommittee hearings are scheduled this week on the topics of agricultural research and USDA trade and food ing good progress with its hear-

ings as well. With these hearings nearly completed, our work on the committee will now move onto the "writing" phase of the Farm Bill

I expect Chairman Colin Peterson to submit his draft Farm Bill proposal later this month. After he presents his draft, each subcommittee will then begin to focus on its area of expertise. The subcommittees I serve on will be responsible for commodity and crop insurance policy, as well as nutrition programs and fruit and vegetable crops. The current commodity programs have worked very well for agriculture producers. This should make our work in the subcommittee much as easier this time around, as - in my aid programs. 


