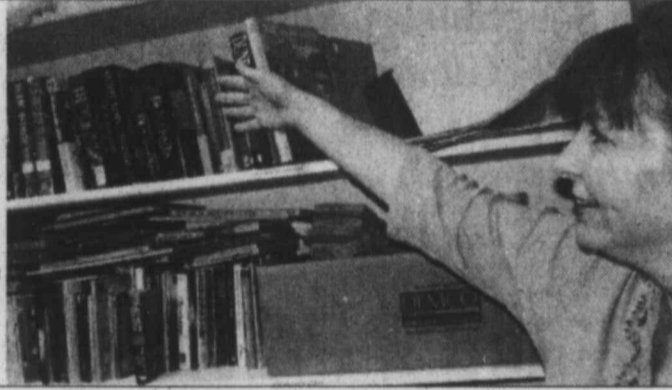

# Book Sale To Offer 1200 Volumes Here

It's going to be the biggest book sale the City/County Library in Tahoka has ever offered - more than 1200 books, audio books, and VHS tapes will be for sale at prices ranging from a mere 25-cents to \$5. The book sale will be held in the small classroom at the Life Enrichment Center, 1717 Main Street, during the library's regular business hours next week, Oct. 15-20. The library is open 9 a.m.-6 p.m. (closed 1-2 p.m. for lunch) Monday through Friday, and from 9 a.m. until noon on Saturdays.

Library Director Claudia Guin shows just a few of the books that will be in the Book Sale, Oct. 15-20.



Claudia Guin, Library Director, says that with the help of a West Texas Library System representative, she has pulling 700 volumes from the shelves for the book sale, and library patrons have donated an additional 500 books that will also be in the sale. All proceeds benefit the library, and will mostly be used for purchasing new books, augmenting the library's \$4,000 per year book-purchasing budget.

"It is very difficult to weed books from our shelves, but we simply are running out of room," said Ms. Guin. "We do use criteria from the Texas State Library and Archives Commission to pull books for the sale - called 'weeding' - and those standards are followed here," she added.

Generally speaking, weeding library books involves checking the copyright date of the book (the numbers of years since the latest copyright date), circulation figures (how many times the book has been checked out, and the latest date of checkout), and the general condition of the book.

"I pulled one book with a first checkout date of 1958 - if a book is that old, the condition has deteriorated, with yellowed pages and a musty odor, and it needs to be pulled. Of course if it is considered a classic, we simply replace it with a newer printed version," she explained. "Gone With The Wind, or The Grapes of Wrath, and other classics that were copyrighted many years ago are going to be replaced with newer printed versions," she added.

She admits that a small selection of books were in such poor condition that they are not even going to be offered in the book sale, but disposed of. "We have some books that have been chewed on by dogs (or babies), or food or drink was spilled on the pages, and just obviously in such bad condition that no one is going to want them - but those are very few in number," she said.

It won't be just outdated books that are in the book sale however. Lots of like-new books, hardback and paperback, have been donated to the library but in many cases the same books were already in the library shelves.

"I order books months ahead of when the new releases are available in book stores - in many cases when a patron wants to donate a new book because they didn't see it on the shelves, it may have already been ordered and just not delivered yet," Guin said.

Guin says that through the Texas State Library System the City/County Library can order new books at almost

half the price of what they cost in a bookstore. Patrons who want to support the library by adding books may consider simply offering a monetary donation for the purchase of new volumes, rather than purchasing the book themselves and then donating it to the library. Many of the newer volumes in the library have a dedication tag printed on the inside of the first page, noting a donation in memory of someone. "But we are glad to accept book donations too," said Guin. "We are happy to accept any kind of donation that benefits our local library."

And if library patrons are worried that selling 1200 books will deplete the library shelves - look again. Even after pulling 700 volumes, Guin says the library has more than 9300 books on the shelves, and space is needed for the steady influx of new books arriving throughout the year.

"The library has been weeded of old books in the past, but perhaps not to this degree. We just simply must make space for our new volumes coming in, in order to provide the most up-to-date selections for our patrons," said Guin.

She says the most popular volumes are mysteries and romance novels, but that the library's audio book section checkout rates have increased by a hundred percent in the last two years, due to extensive updating of books on CD and an increase in selection.

Realistically, the lower shelf and uppermost shelf on the bookcases are not easily accessible to library patrons, and Guin says weeding 700 volumes will allow for better placement of the remaining books.

"Nobody wants to sit on the floor to try to read the title of a book - unless it's a child in the children's reading section," said Guin with a smile.

Since moving 10 years ago to its present location inside the Life Enrichment Center, the City/County Library also offers three computer stations for public use, and Guin says those computers get considerable usage.

"I have funding to purchase two more computers, and would like to supplement the three we already have. I just don't have space for more. I will end up replacing two of the older computers by the end of 2008," she said. "The number of computer users are continually increasing - our most recent statistics showed an average of 47 computer users per week at the library," she explained.

Total circulation figures in 2006 - that's printed books, audio books, and video tapes/CDs - showed 11,188 items checked out from the local library. And, since 2005, the City/County Library has signed up 561 new patrons.

The book sale on Oct. 15-20 will not only help with the removal of books to allow space for newer volumes, but will greatly benefit the library's funds for purchasing the new books. Guin says that three book sales during the past two years garnered about \$800 for the library, a figure that significantly increases the library's book budget.

There were no injuries in a minor collision on the U.S. Post Office parking lot in Tahoka Tuesday where a 2007 Cadillac driven by Harold Green, 84, of Tahoka and a 1994 Mercury

Cougar driven by Fern Childress, 71, of Tahoka, were involved.

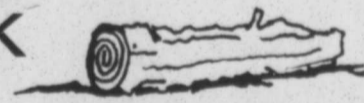
Sheriff's officers are investigating a report from Allsup's in O'Donnell that a check in the amount of \$69.57 was passed on Aug. 31, and came back marked "account closed" because the Lubbock woman whose signature was forged on the check had reported the checks stolen earlier and closed the account.

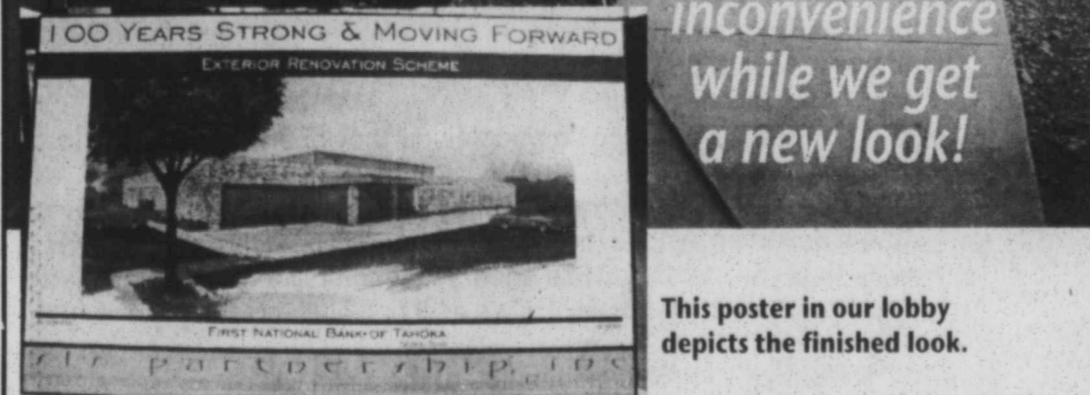
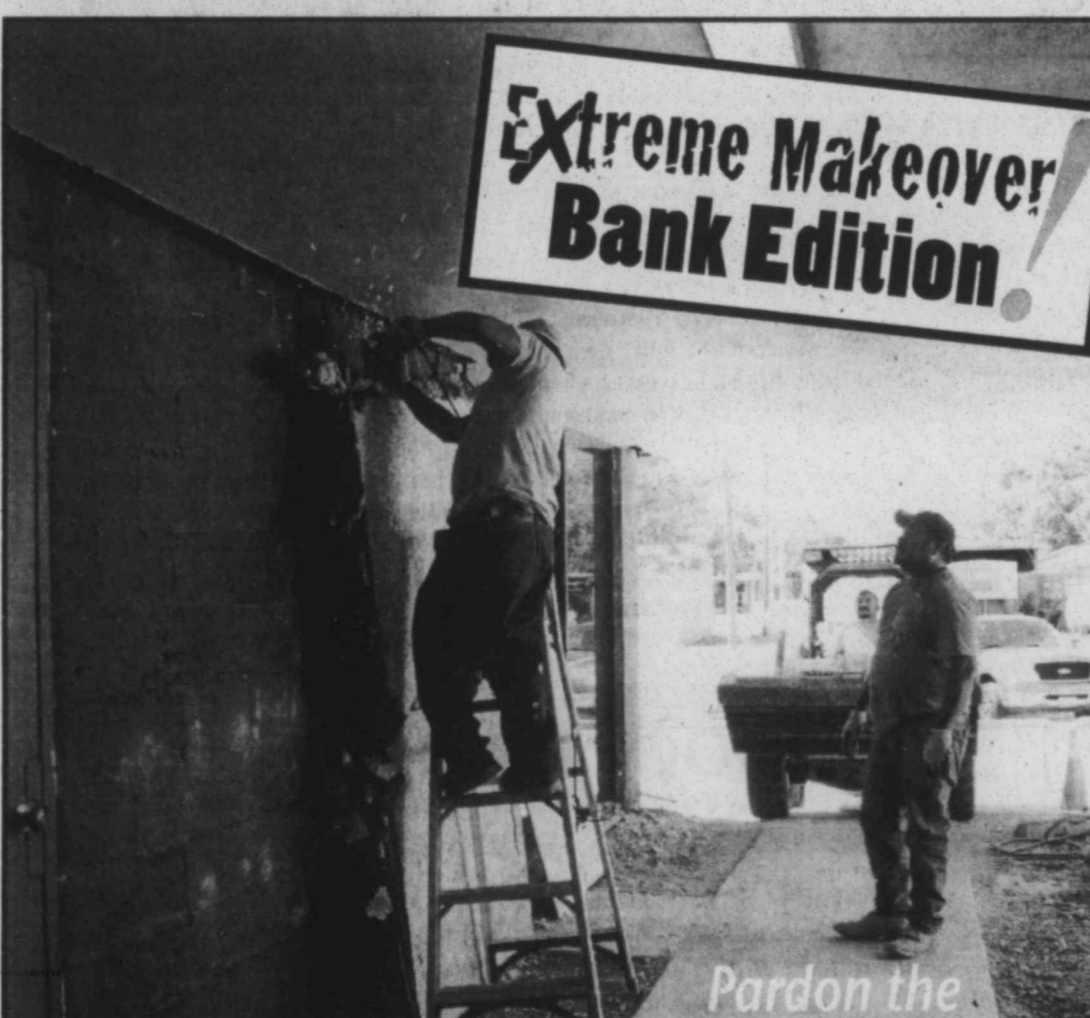

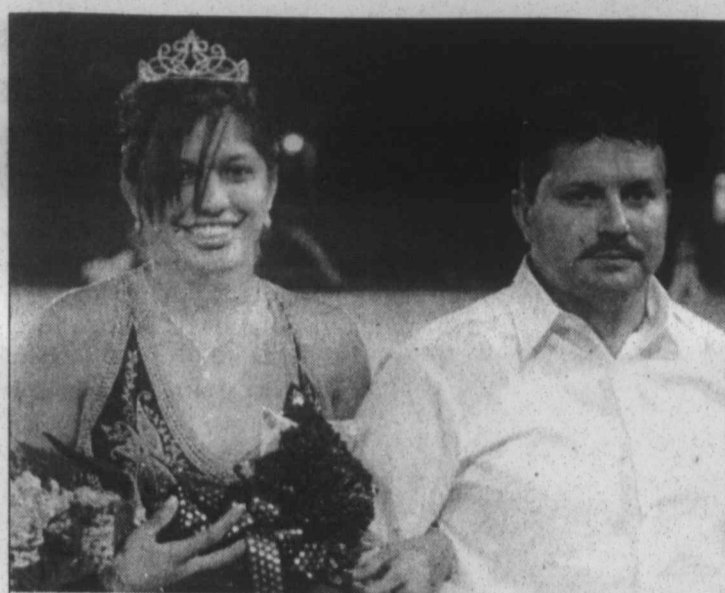

The Draw United Methodist Church opened its doors in 1907 with the Rev. J.O. Gore from the Tahoka Methodist Church filling the pulpit. He preached his first sermon to Mr. and Mrs. W.A. Waller, their daughters, Emily, Sadie, and Willie; Mrs. Kittie LeMond, and Mrs. R.A. Duckworth. Sunday school was organized with 18 regular attendees and 30 members listed.

100 years later, the grandsons of Draw settlers have worked faithfully to keep the doors open to celebrate the 100th jubilee on October 14, 2007.

Milton Williams, the great-grandson of T.J. Williams, and Ricky Barnes, the grandson of Walter Caswell, have put in many hours of hard work on the plumbing, the floors, the cemetery and grounds around the church.

"I could not be prouder of this little church and what it means to Draw and really everyone in the area. There are many people who live in O'Donnell, Tahoka, Grassland, Post, and Lamesa now that grew up in the Draw Methodist Church," said Williams. "We're 100 years old and it's going to be a great day Sunday."

Milton and his wife, Billie Bairrington Williams of Post, replumbed the bathroom and worked diligently on the wooden floors and pews. Milton's mother Cedaelia Williams, is another dedicated Draw Methodist who drives from Tahoka to attend Sunday services.

Church members will register guests and serve donuts and coffee beginning at 8:30 a.m. Sunday, October 14. United Methodist Church Bishop Max Whitfield will begin services at 9:15 a.m. Following the Bishop's sermon, several descendants from old settler families will give their church family histories. There will also be a time for congregation members to speak about their memories of the Draw church.

"This will be probably the happiest day in the life of this church. I know my Mama is looking forward to it," said Barnes of his mother, Fern Barnes. Ricky and Robert Costa keep the church cemetery and grounds mowed and manicured.

Fern has been attending the Draw Methodist Church for 81 years and has served as church treasurer/secretary for more years than she can remember. After the service, the congregation is invited to attend a luncheon at the O'Donnell Community Center.

Bobby Mack Furlow, Robby Furlow, and Draw-O'Donnell Methodist Pastor Larry Gaumond have painted and cleaned the interior of the sanctuary in preparation

for the big event. Bobby Mack is Fern's son-in-law. The Furlow's dad, A.B. Furlow, joined the Draw Church before he became ill and passed away several years ago. Both A.B. Furlow and Alma Furlow are buried in the Draw Cemetery.

"I also want to point out the veterans' memorial that was commissioned by Jimmie and Ebb Crawford. There are names of those who served their country in the armed forces from the Draw-Redwine area. The names are on the front and back of the memorial, so please be sure and walk around it," said Mrs. Barnes.

While the day will be a happy one, there are many who will be missed that attended regularly - Boyd Barnes, Walter Lee Williams, Robert Williams, and Gus and Mary V. Sherrill, to name a few. Mary V. taught Sunday School, Vacation Bible School, and Bible studies at Draw from the time she was 18 years old until she became too ill to attend church in 2004. Boyd led singing for over 40 years and helped teach Sunday school when more people attended church at Draw.

"We all want to thank those of you who have sent in donations and prayed for our little church. We received over \$6,000 in donations and have put on a new roof and painted the interior of the sanctuary," said Mrs. Barnes. "Our hearts are very humble at the support we've received from former members of the church, their families, and the public in general. So many people who may have never visited our church have sent in donations. Thank you all."

## Lynn County Jail Passes Surprise Inspection

Lynn County Jail passed a surprise inspection last week from state inspection officials. Sheriff Jerry D. Franklin informed Lynn County Commissioners at their meeting Tuesday morning.

"Usually we get a 30-day notice of a pending inspection, but this time the inspectors gave us a surprise visit - we passed it, with just a couple of small corrections noted about sinks and showers," Sheriff Franklin told commissioners.

He also informed commissioners of the death that morning of one of the county deputies, Danny Randall, who succumbed to an illness.

In other business, commissioners declared November as Home Care and Hospice Month, approving a proclamation to that effect. The proclamation notes that home care services provide high quality and compassionate health care services to those in

need, especially at times of community or personal health care crisis, and that home care is the most preferred method of health care delivery among disabled, elderly, and chronically ill individuals who desire to live independently in their own homes. Hospice care provides humane and comforting support for terminally ill patients and their families.

County funds designated for the Lynn County Pioneers Senior Citizens Center will now be designated as grant funding for the Senior Citizens Center, which will enable the center to qualify for additional funds from USDA for their home-delivered meals. Lynn County designates \$4,000 per year to the local senior citizens center, which offers nutritious meals for Lynn County senior citizens.

Discussions for a new motor grader for Precinct 4 prompted commissioners to choose a different method of considering bids for the new equipment. They chose to use a state-authorized Buy Board, which solicits bids from equipment providers throughout the state, instead of advertising for bids. Bid selection for the new equipment will be considered at the next regular meeting.

The county's interlocal agreement was renewed with Texas Association of Counties Risk Management Pool, and the retirement rate for 2008 was kept at the same rate of 3%. A budget amendment was made to reflect the Reserve Fund.

County Judge H.G. Franklin led the meeting, with commissioners Don Blair, Mike Braddock and Brad Hammonds present, and commissioner Don Morton absent.

**Classes Offered Here To Help People  
With Diabetes Plan Healthful Meals**

For people with diabetes, maintaining healthy blood glucose levels is a matter of life and death. One way for people to better control their glucose levels is to eat healthful meals and snacks at regular times each day.

To help learn how to plan and prepare meals that can be enjoyed by people with and without diabetes, Texas Cooperative Extension - Lynn County is planning a four-part series of cooking classes called *Cooking Well with Diabetes*. The classes will be held at 6:30 p.m., October 16, 23, 30, and November 6, 2007, at the Center for Housing and Community Development in Tahoka. A one-time fee of \$8.00 per person or \$12 per couple (any couple) covers the four part series.

The series will include cooking demonstrations as well as discussions of research findings on diabetes. Recent research has shown that people with diabetes can enjoy a wide range of foods \* including sugars \* in moderation. Moderate consumption of sugars and fats can still be part of a healthful diet for people with diabetes, as long as they keep their blood glucose at healthy levels.

Carbohydrates are found in grains, pasta, cereals, dairy products and vegetables, particularly starch vegetables such as beans, corn, peas, potatoes, and winter squash. Protein foods such as meat, fish, and poultry do not contain carbohydrates, unless other ingredients such as breading are added to those dishes. Many carbohydrate foods also contain fiber, which can help reduce blood cholesterol and blood glucose levels. Carbohydrate foods that contain high levels of dietary fiber include whole grains, fruits, and vegetables.

Because the body quickly absorbs the glucose from sugary and high-starch foods, eating large amounts of them can cause blood sugar levels to skyrocket. People

with diabetes should consume some starchy or sugary foods including breads, potatoes, desserts and fruit juices only in moderation, experts say. Instead of abstaining from sugars and starches altogether, they should consume a balance of different kinds of carbohydrates, such as more whole grains, nonstarchy vegetables and whole fruits, and less starchy and sugary foods.

One way to keep a check on the amount of sugars in the foods you buy and eat is to read the nutrition labels on food packages carefully. Sugar is sometimes listed as sucrose, glucose, fructose, high fructose corn syrup, honey, lactose, maltose, dextrose, and sugar alcohols such as sorbitol or mannitol.

Another way to reduce your sugar intake is to modify your recipes. Mary K. Bielamowicz, an Extension nutrition specialist, recommends:

- When baking, reduce the amount of sugar by one-quarter to one-third.
  - In cookies, bars, or cakes, replace one-quarter of the sugar with nonfat dry milk. This cuts calories while increasing the calcium and protein in the finished product.
  - Add extra flavorings or spices.
  - Use unsweetened frozen fruit juice or fruit canned in its own juice instead of fruit canned in syrup.
  - Replace some of the sugar in a recipe with fruit juices or purees.
- Bielamowicz added that because diabetes is a problem of carbohydrate metabolism (how the body uses carbohydrates), eating about the same amount of carbohydrates at each meal will help maintain blood glucose levels throughout the day.
