Judges Unanimous With 1's for Tahoka! THS Band Advances To Area at Marching Contest

Last-Saturday at the Region 16 UIL Marching Contest at Lubbock Lowrey Field, the Tahoka High School 3-D Band with the support of over 200+ fans earned straight I's with their outstanding performance, thus qualifying them for the Area A Marching Contest this Saturday, at Lowrey Field in Lubbock at 1:30 p.m.

"The Tahoka fans are the best supporters of any around," stated directors Carroll Rhodes and Johnathan Smith. "They continually come through with their support and enthusiasm for the 3-D Band.

Directors add that the fan support will be really needed as the 3-D Band competes against 21 other bands for one of the four spots that advance to the UIL State Marching Contest, which will be November 5 in San Antonio at the Alamodome. The preliminary competition starts this Saturday at 10 a.m. with Dimmitt and ends at 4:30 p.m. with Tulia. Each band is judged by five judges, three on music and two

on marching, who rank them through a point system. The ten bands with the highest scores will draw for positions in the finals which start at 6:30 p.m. and conclude at 9:15 p.m. At 9:30 p.m., there will be a drum major retreat where the finalist awards will be presented and the four state advancing bands will be announced.

"We need the Tahoka fans to come

out and support the Tahoka 3-D Band again this Saturday at 1:30 p.m. at Lowrey Field," said Rhodes. Tickets are \$5 for adults and \$3 for students, with pre-school children being free. "With their ticket stub they can leave after the 3-D Band performs and then come back for the finals, when that time is announced at 4:45 p.m.," Rhodes

Tahoka Man Found **Guilty Of Indecency**

George Norwood, 68, of Tahoka was found guilty of a charge of indecency with a child by a jury in 106th District court here last week, with a sentence of seven years in prison assessed by the jury last Thursday.

Norwood was accused of an act of indecency with a girl a few years ago when the victim was a minor. The girl, no longer a minor, testified in the trial which was prosecuted by assistant district attorney Sammy McCreary. The jury deliberated about three hours last Wednesday before finding Norwood guilty of one count of indecency. Norwood had been tried on two charges of indecency and one charge of attempted sexual assault, and was found not guilty of the sexual assault charge and not guilty of one of the indecency charges.

The trial was presided over by Dist. Judge Carter Schildknecht. Representing Norwood in the trial were attorneys Laurie Key and Kelly Clark of Lubbock.

No probation was ordered on the prison term for Norwood.

Police and sheriff's officers investigated several new incidents this week, including a theft of parts off a module builder which resulted in a \$500 reward being offered.

Robert Smith told sheriff's officers that someone took about \$1,000 worth of parts off his module builder while it was located about 2.5 miles east of Tahoka near U.S. 380, sometime in the last several months. The theft was discovered Oct. 7 when he prepared to use the equipment for the first time since 2006. Anyone who calls the sheriff's office with information leading to the arrest and conviction of persons responsible may qualify for the reward offered by the victim.

On Monday deputies were advised that a diesel tank at Eddins-Walcher in New Home had ruptured because someone had removed a vent pipe. Total loss was not estimated.

Tahoka Police Sunday arrested a 21-year-old Mexican National for drunk driving and he also was jailed as a possible illegal immigrant. Police also went to the scene of one domestic

disturbance last week. In jail during the week were nine new inmates, and after the usual weekly releases, total jail population here was at 48 early this week. Thirteen of those were being held for Garza County, and two each for Lubbock and Gaines counties.

Offenses bringing arrests during the last week were child support (Lamb County), two warrants on DWI, driving while license invalid plus no liability insurance, sexual assault, theft (Hale County), DWI with child passenger plus DWLI, theft (Lubbock County), DWI with open container.

IT WAS ON ONE of those days which tend to keep lightweight people indoors last week that I noticed the condition of the U.S. flag flying outside our house. That is to say, the wind was blowing pretty briskly, not as bad as it gets sometimes, when pieces of Brownfield can be seen flying down the streets here on their way to Post, but still it was blowing enough to be classified a bad hair day, for those of you who still have hair.

Anyway, I noticed the flag on our pole was not standing straight out and flying proudly like we prefer, but the outside bottom edge appeared to be attached to the pole as well as the inside edge. So I lowered it and discovered a puzzle: somehow the outside edge of the flag had whipped back over the top of the pole and now the pole went right through a hole in the flag.

I fooled with it a little bit and realized there was no way to get it untangled. Finally I had to take a knife and cut it loose. Of course, the wind already had ripped the flag pretty well, and after I freed the outside edge, it did fly properly, but it now looks a lot like the same one which was still flying over Fort McHenry after that night in September, 1814, when Francis Scott Key wrote his poem describing how proudly the stars and stripes stayed up there despite a nightlong bombardment from an offshore British warship.

Our flag still is flying, too. It looks like it has been through a war, but it's sort of neat up there for now, until I replace it, which I plan to do pretty soon. I am very proud to be an American, and I appreciate all those who fly the flag at their homes and businesses. I have made brief visits to some other countries in the world, and believe me, just a few days in any other country will make you glad you are an American.

Incidentally, there are ways to dispose of a U.S. flag which needs to be taken out of service. You can burn it, but only if you first locate an Arab terrorist and wrap him in it. If you can't do that, you can give it to the Boy Scouts, who know the proper (and less violent) procedure for disposal.

WE VISITED Caprock Canyon State Park and its new visitor center up at Quitaque last week, and were treated to a guided tour of the canyon/park facilities. It is really scenic with some impressive canyon walls, and I was a little surprised that a lot of folks seem to be camping out up there. The guide mentioned that there is quite a large area of the canyon on east of there that is not used because it's not accessible by vehicle. Commissioners Issue Burn Ban For County

Lynn County Commissioners this week issued a burn ban effective immediately in the county, due to public safety hazards. The order prohibits all outdoor burning in unincorporated (rural) areas of the county for 90 days, unless the burning is related to public health and safety that is authorized by the Texas Commission on Environmental Quality for (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting of agricultural crops; or (4) burns that are conducted by a prescribed burn manager certified under Section 153.048. Natural Resources Code, and meet the standards of Sections 153.047, Natural Resources Code.

Lynn County Sheriff Jerry D. Franklin said the sheriff's department would appreciate advance notification of any prescribed agricultural burns, as they do receive calls from citizens regarding these fires and that public safety officials need to be aware of all prescribed

Violation of the burn ban can result in a fine up to \$500. The burn ban was adopted on Oct. 22 in a unanimous vote by all commissioners, and will be effective through mid-January.

Commissioners also approved a fireworks ban for certain fireworks, due to the fire hazards. The order prohibits the sale of, or use of, fireworks such as "skyrockets with sticks, or missiles with fins," but does not

small in size that are classified as Class C explosives, or large fireworks designed primarily to produce visible or audible effects by combustion that are classified as Class B explosives. The fireworks ban is in effect for 90 days, through mid-January.

In other business, street signs for the new Willow Ridge subdivision in Precinct 4 were discussed. Janette Brosche from SPAG presented information regarding the naming of the streets, and Pct. 4 Commissioner Brad Hammonds said he would place the signs for the new roads. There was also some discussion pertaining to water drainage issues near county roads in the subdivision, but no decisions were made

Abel Castro and Stan Gill, representing First Bank & Trust, visited with commissioners regarding a contract with Kansas* Bankers Surety Co. to write a surety bond for Lynn County fund deposits with FB&T. Castro said that FB&T will pay the premiums for the insurance coverage, which will give Lynn County public funds more security. A representative from Kansas Bankers Surety Co. was also present. Commissioners voted unanimously to approve the insurance coverage.

Commissioners approved the purchase of a new motor grader for Precinct 4 from Warren Cat for \$44,000, and commissioners approved a resolution for the Lynn County Indigent Defense grant program, for prohibit common fireworks, eligibility to receive grants,





Lynn County parents who must provide both a physical address and mailing address, as well as a contact phone number. Each family must file their own application.

Early Voting Continues For Nov. 6 Election

Early voting for the Nov. 6 Constitutional Amendments election began Monday at the Lynn County Clerk's Office and continues through Nov. 2. Early voting is conducted during regular business hours, from 8 a.m.-5 p.m. Monday through Friday, at the county courthouse.

There are 16 proposed amendments for voters to consider statewide, and in the New Home Independent School District voters will also have a school tax rate to consider in a rollback election held in conjunction with the amendment election. The Lynn County News published brief explanatory statements about the 16 proposed amendments in both the Sept. 13 and Sept. 20 issues.

New Home ISD voters will have an opportunity to vote for or against a proposal setting the New Home ISD tax rate at \$1.25668, which is a 20-cent reduction from the previous year's tax rate of \$1.45668.

The reason for the rollback election is that New Home ISD officials are asking voters to approve a tax rate that is 15-cents above the rollback rate of \$1.10 in the school district. The \$1.25668 tax rate includes a Maintenance & Operating (M&O) rate of \$1.17 and an additional \$.08668 rate for Interest & Sinking (I&S) to pay bonded indebtedness. If voters do not approve the tax rate, then the New Home ISD tax rate will automatically drop to the rollback rate of \$1.106745 for both M&O and I&S.

Because the New Home ISD tax rate will not be determined until after the Nov. 6 election, property tax statements for New Home ISD will be mailed following the election results.



Letter To The Editor

Happy To Call Tahoka "Hometown" Dear Editor

I recently purchased a home in Tahoka and I am happy to call this my hometown. Several times I have been asked "Why would I move all the way from California (Fresno) to Tahoka?" I usually reply with "why not?" I grew up in rural and small towns in Missouri, I have lived in Iowa, (one snow storm and I had enough of it), Kentucky, Ohio, and of course California. I have been in 48 of our 50 states. Of all of these I am proud to call Tahoka my home! There is a lot going for this community that I felt I had to point out from a newcomer's point of

I have had Tahoka described as a "sleepy," "dying," and a place that has "nothing to offer." I agree that the town is quiet – no gun shots all night long from gang violence, no cars at every stop light with blaring music from their stereos, not even the long whistle

from freight trains to disturb the quiet. The Internet says that Lynn County has had a 6% loss of population, but it is far from dead. I have been told that everyone shops in Lubbock, as for it having nothing to offer, as far as I am concerned, it is quite the contrary. Most of the major department stores are located in Lubbock; however, I don't care to keep up with the major trends in clothing and spending, so department stores or malls are not my first choice for entertainment. Tahoka's small restaurants, grocery, pharmacy, and Dollar General store provide most of the items needed on a daily basis with their service the best I have ever encountered.

Since I have been in Tahoka, I have met more sincere helpful people who have greeted me with a smile than anywhere I have ever been. This is a great community. I love reading the positive news weekly in the Lynn county newspaper. We have a great hospital and health services located just a couple of minutes away. In the past year. I have been to the hospital's fundraiser, the Harvest Festival, the fireman's fish fry, a parade, and bingo on Thursday night. Not once at any function was I checked at the door for weapons (like the county fairs in California), nor have I seen armed police officers roaming the crowd for gang outbreaks or guarding entrances, and not once did I have to pay for entry or parking and walk a minimum of four blocks to get to a function.

Our Post Office personnel are great. The last person I spoke to at the Post office in Fresno, California (this was after I had to pull a paper number from a dispenser and waited for it to be called – approximately 10 minutes) was so exasperating that I clenched my teeth, gave her my best smile, replied "Thank God for Texas!" and left,

Tahoka doesn't have nightclubs with drinking and dancing, no movie theaters, no mall for shopping, no bowling alleys, or such. But then again, it doesn't have rush hour traffic, violent gangs, noise pollution, or unhealthy air pollution, dirty trashstrewn streets, people speaking with filthy language on a everyday basis, walls and stores covered with graffiti, fences topped with razor wire, houses with security bars, homeless people sleeping under bushes and underpasses, people stopping you for handouts, or drug deals openly on street cor-

We have a fire department and police that actually serve and protect the community, sheriff, state patrol officers, a beautiful courthouse, and a city hall with water, sewer, and garbage pickup service. About 20 years ago I met a lady from Brownsville, Texas that became a good friend. She believed that no matter how long she lived in Fresno, her home would always be in Brownsville, "The Great State of Texas." My sister, after only living here a short few months, felt that Tahoka, and the Great State of Texas was our true

To sum up the reason I moved to Tahoka - I was able to buy a house in a small town where the community is made up of some of the greatest people I have ever met.

2007 May Be "Great" Year For County Cotton Production

Harvest for the 2007 cotton crop is in full swing in Lynn County and so far things look good. No doubt this year's crop will be much better than 2006 when the lack of rainfall had a disastrous effect on cotton production.

"What a difference a year makes. Rainfall in excess of 20 inches and fall temperatures that everyone hoped for have set up the 2007 crop to be one of the best ever," said Bryan Reynolds, Lynn County Extension Agent.

"Right now the crop is about

15-20 percent harvested for the county which planted 290,000 acres for 2007," said Reynolds. "Yields look excellent with many of the dryland fields yielding one to two bales per acre and some have topped the two bale mark. Irrigated fields also are yielding very well with two to three plus bales per acre being harvested," he added.

It is probably too early to make any predictions as to where this crop will rank in comparison to the two largest crops in history, in 2004 and 2005. The 2004 crop saw Lynn County produce 354,500 bales of cotton on 285,400 acres for 596 pounds per acre yield. In 2005 things were even better when producers harvested 292,900 acres with a 703 pound per acre yield for a total of 429,000 bales produced. In both of those years Lynn County was number one in the United States for non-irrigated upland cotton production, the county agent said.

Even though 2007 looks like another great year in terms of production, some acres suffered from the rough weather early in the growing season. The western portion of the county was hit hardest, particularly the West Point area, where several severe storms destroyed the crop in June.

"Some producers had to replant either cotton or other crops such as grain sorghum after wind, hail and hard rains destroyed their crop," stated Reynolds. The young, replanted T

The Lynn County News encourages you to attend church this Sunday! cotton struggled for the biggest part of the growing season with below normal temperatures that kept the crop behind in terms of development. We stayed about 10 to 12 percent behind normal for heat units through most of August.

However, no one could have predicted the weather for September and October. "September and October are what saved this crop and will help put it in the record books if producers can get it to the gin," said Reynolds. "Our weather for those two months has been well above normal with 427 heat units for September, which is 28% above normal. October is even higher with 228 heat units accumulated through October 21, which is an astounding 109% above normal," he added.

The warm temperatures pushed boll development along and also allowed for the harvest aids to work rapidly once they were applied. Some producers with the young cotton have not applied harvest aids and will wait on a freeze to go ahead and finish the crop and open the bolls.


