How did we rate?

County Courthouse Project Grant Application Analyzed

by JUANELL JONES

The Lynn County Courthouse restoration project grant did not make the final cut in a recent funding round for the Texas Historic Courthouse Preservation Program Grant Application Round V, but just how far did the project miss getting approved? Lynn County officials received information recently from Komatsu Architecture, the firm the county is working with in the planning stages of the restoration project, who provided an analysis of the process.

The Texas Legislature awarded \$56,706,071 for courthouse restoration projects in 14 counties in Round V funding, from among 47 counties who had submitted applications. Each of the 47 applications was awarded points based on certain criteria, and the top 14 applications with the most points received funding. The Lynn County application was at #21 on the list, with a total of 171 points - just 10 points below the cutoff line. Those counties

surmising the backlog was such that the THC needed to go ahead and move forth with construction on the projects which had already been funded for plans and specs. With the exception of Lavaca County, all of the major awards (i.e. high scoring counties) already had plans and specs and received 10 additional points in Category 20, Plans and Specs," said the Komatsu representa-

"In looking at the scoring categories, we believe the majority of Lynn's scores are sound and do not offer significant room for improvement. There are a few categories that may offer an opportunity to gain points, however," she added. Komatsu identified five categories in which they believed Lynn County might gain points, with the following explanations:

Category 4 - Significance (scored 6 out of 14 points)

This category pertains to the historical significance of the building. All courthouses are seen as significant in

who received funding had points ranging from 181to 200 points.

The counties whose projects did not receive funding may apply again in the Round VI funding process in 2009, for funding that may be appropriated by

the 81st Legislature. "The grant cut-off point was La Salle County which had 181 points. We were so excited to see that Lynn scored 171 points and is just seven down from La Salle!" said Kelli Dilday in a letter from Komatsu Architecture, who analyzed the grant applications from the Texas Historic Commission (THC). "Looking at the current field, Lynn could really stand a chance for plans and specs funding in Round VI, because there are already three counties ahead of you that have plans and specs complete, essentially putting the county five down on the list for plans

and specs," she explained. Most of the counties who received funding in this round already had planning grants and specs, and were asking for the construction grant portion. "Differing from previous rounds, the Texas Historic Commission chose to award mostly construction grants along with the typical couple of emergency grants for those buildings that are in a dire state of disrepair. We are

relation to being centers of government and early town planning, etc. The THC bases scores on evidence of events and individuals associated with the current building with a focus on noteworthy jurists, trials, sheriffs, community gatherings, and events. The score is heightened based on relationships drawn on local, state and national levels. The court provided us with excellent information to support this category. However, if there would be an additional opportunity for gathering local documentation via county staff, local historical commission members or volunteers, at least four points could be gained in this category.

Category 6 - Integrity (scored 10

This category is based on original integrity in the application and reflects the original architectural integrity of the building. Issues that come into play here are alterations which have modified the original design. Highest scores are attributed to those courthouses which have retained the elements of original design and materials to the highest degree. More points are given to buildings that have original features that are visible and have not been concealed. Lynn is exceptional in the



EVERYBODY knows there are some things you are not allowed to mail, like bombs, firearms and dead skunks, but only last week did I learn that there are specific items you can't legally mail to some countries, because they have notified the U.S. Postal Service that they won't accept them.

Some of the restrictions other nations put on what can be mailed are pretty weird, and the postal bulletin I read didn't explain them; it just listed them. Here are some of them:

Costa Rica will not accept blank invoices. I can't imagine why. You may not mail hay or straw, or items made of straw, to Ireland. I wonder if it's okay to mail to Ireland a copy of the film The Wizard of

Oz, partially about a straw man. Lavia will allow no live animals, except bees and leeches. Who would want to mail a leech, even to Latvia?

Tunisia does not allow playing cards to be sent through the mail. That's the law; deal with it.

A complete list of restricted and prohibited items by nations is published by the Universal Postal Union at upu.int.

I thought for awhile a couple of months back that there must be some kind of law against mailing cracker jacks to Dallas. Some people from Dallas were visiting in Tahoka at Thanksgiving and liked my wife's homemade crackerjacks so well they ordered a big batch of the things to be mailed to them before Christmas, so they could use them as gifts.

They were mailed about a week before Christmas, but didn't get there until 10 days later. I strongly suspected somebody in the post office smelled them, ripped them open and ate them. But they did show up in Dallas, after Christmas.

I would have taken them down to Dallas myself, but I could not be trusted to get there with all the goodies intact.

Dallas is about 320 miles. With an open container of crackerjacks next to me on a trip, I get only about ten miles to a gallon of crackerjacks.

HEART HEALTH

This week we are continuing our discussion on American Heart Health Month. We are concentrating on our younger readers today. Recent studies are showing that adults aren't the only ones at risk for heart disease, stroke and other cardiovascular diseases; increasingly, the young are at risk too. Autopsies were done on 425 young people who died from accidents, suicide and murder and found most had clogged arteries, 8 % had significant disease and 83 % had the beginnings of coronary artery disease. The study, done at the Mayo Clinic cited the introduction of computers and a more sedentary lifestyle, the growth of fast-food and larger portion sizes. reduced physical education in schools and increased consumption of high-fructose corn syrup has led to this explosion of obesity.

So what can be done to reverse this trend? Once again the American Heart Association is working to help kids and families live hearthealthy lives. The website www.americanheart.org has many links to information from making fast food friendlier to how to motivate your child to step away from the computer game. There is also a link to dietary guidelines for children that help you make the right choices for your child.

Below is information on the top ten ways to help your child develop healthy habits taken from the American Heart Association's

1. Be a positive role model. You must practice healthy habits yourself.

2. Get the whole family acfive. Plan times for everyone to get moving together. Take walks, ride

bikes, go swimming or just play outside together

3. Limit TV, video game and computer time. These habits can lead to the sedentary lifestyle and excessive snacking which increase risks for obesity and cardiovascular

4. Encourage physical activities that your children enjoy. Every child is different. They will stick with something they enjoy longer.

5. Be Supportive. Help children and teens develop a good self-

6. Set specific goals and limits. Such as one hour of physical activity a day or two desserts per week other than fruit. Chances for success are better if goals are clear.

7. Don't reward children with food. Candy and snacks as a reward encourage bad habits.

8. Make dinnertime a family

time. When families eat together children are less likely to eat the wrong foods or too much. 9. Make a game of reading food labels. Learn what to look for

and teach them to your children. Avoid high-fructose corn syrup as much as possible. 10. Stay involved. Insist on good food choices at your child's

daycare or school. Work in your community to educate all on better heart health. Something has to be done if we

are going to stop this trend, start by picking a few of these habits and adding them to your lifestyle. Then add a few more, and soon you will have a happier healthier child that will grow up to be a happier healthier adult without many of the risk factors for heart disease, stroke and other cardiovascular diseases.



Texas A&M Testing Oral Contraceptives For Animals

COLLEGE STATION - If you're a land owner and animals such as coyotes or wild pigs are driving you hog wild, help may soon be on the way to control their numbers in a humane way in the form of a birth control pill for animals being developed at Texas A&M University's College of Veterinary Medicine & Biomedical Sciences. The concept would be to get it to wild animals through baited food, researchers say.

Researchers are testing oral contraceptives - used in much the same way as in humans - and the results are promising, says Duane Kraemer, a professor in veterinary physiology and pharmacology and a world leader in embryo transfer who has been involved in cloning four different species in recent years.

Kraemer, one of the pill's creators, and other members of the research team are testing the contraceptive for use on wild animals, but the applications could most likely be used in pets, he believes.

"No one method will be useful in all situations," he stresses. "This approach inhibits maturation of the egg and therefore prevents fertilization. The animals continue to cycle, so it will not yet be ideal for many pet owners. But there is an advantage for use in wild and feral animals."

Kraemer says the research team has recently started tests on domestic models for predators animals such as feral pigs and cougars - but if successful, it could be used on a wide variety of animals, including dogs and cats, he explains. The team also has submitted grant applications for similar projects on coyotes

"A spinoff of this contraceptive could probably be used on many different species," he

The \$90,000 project is being funded by the U.S. Department of Agriculture and private dona-

The pill works by inhibiting the maturation of the egg, not the entire cycle, Kraemer says. The technical name for the drug is called a phosphodiesterase 3 inhibitor, and it is one member of a family of drugs being tested.

Similar compounds have been tested in laboratories elsewhere in mice and monkeys, and similar results have been obtained by in vitro (in laboratory) methods in cattle and humans.

The compound can be mixed with animal feed and must be eaten daily during the critical

time. It may also be encapsulated to decrease the frequency it has to be consumed, Kraemer says.

'We believe we are the first to test this compound for this specific purpose," Kraemer notes. "We're trying new uses for this previously approved compound.'

When perfected, the pill could eventually be used as an oral contraceptive for pets, but that may be a bit in the future, Kraemer says. In dogs, for example, the ovulation process is especially complex, but researchers are confident such a birth control pill can one day be successfully developed.

The need is apparent: According to the American Humane Society, about 7 million dogs and cats are euthanized each year at animal shelters. One female cat can lead to the production of 420,000 offspring in her lifetime.

In Texas, feral hogs have become a severe nuisance to farmers and ranchers, and the state has an estimated 3-4 million feral hogs, by far the most in the country. Deer are also becoming a problem to more communities each year because of overpopulation of deer herds.

Other species such as coyotes and even wild horses also need sufficient management control, experts note.

"The need for such an animal contraceptive is certainly there," Kraemer adds. "We are confident we can develop this pill in the not too distant future, but we still have plenty of tests to complete. It's an exciting and muchneeded project, but more funds will be needed, especially since deer and wild pigs are consumed by humans. One of the more interesting challenges will be to develop methods for feeding it to the target animals without affecting other species."

Amarillo Man Tells Experiences On Gail-Tahoka Mail Hack Drives

James H. Parker of Amarillo, one of the old mail hack drivers from Gail to Tahoka 55 years ago, and wife were here Saturday for the [Pioneer] reunion and said he saw a lot of old friends.

Horace Hale was the contractor on the route which operated from the time Tahoka was established in 1903 until being discontinued on July 1, 1910, or soon after the Santa Fe railroad was built into Tahoka.

Mr. Parker drove the mail from late in 1908 until May, 1910. Some of the other drivers he recalls were Bob Rusk, C.M. Rector, and Jim Weatherford. The 86-mile run then return, by a somewhat indirect route, was a

fairly efficient operation, especially for those days. There were six different teams used on each trip, tough little Spanish mules beingused mostly, but also horses. They pulled the hack in almost a dead run from one station to the next. There were two stations between Gail At one time, Parker says, there were 17 gates to open on the route,


and this was a bit bad when the weather was extremely cold and the ground covered with snow. The driver had a foot warmer, but this was The hack line hauled mail, of course, passengers, and light freight

much as did the stage coaches of an earlier day. Beer was shipped by the keg and whiskey came in gallon jugs.

Once Jim Weatherford had an old maid school teacher for a passenger, got out near Redwine to open a gate, failed to put on the brakes, the Spanish mules darted through the gap for Tahoka; and left Jim behind. He had to walk all the way to the J.S. Wells farm to hitch a ride to town. The old maid had gone on to Lubbock when he got here. Jim often wondered what a wild ride she must have had from that gate to Tahoka.

Mr. Parker still owns a farm in the extreme northwest part of Borden county, and he visited his old friends, Mr. and Mrs. L.B. Jones of Draw and Mr. and Mrs. Tom Hale of Tahoka while here.

Rising Sun Goes Down — Long War Ends General MacArthur Named To Head Occupation Forces: Mild Celebration Of Conflict's End Is Held In Tahoka

Tahoka was closed up tight all day Wednesday in celebration of the victorious conclusion of the war. Practically every business in town, including filling stations, drug stores, and even most of the cafes were

At 6:00 o'clock Tuesday evening, President Truman had announced that Japan had accepted the terms of surrender recently laid down by the three great powers, the United States, Great Britain, and Russia, fully and unconditionally, and that he had ordered the American forces to cease from further offensive action. He also announced that General MacArthur had been designated to represent the United States in receiving from the Japs their signed acceptance of these terms and to enforce compliance therewith.

Immediately following this announcement, the people of Tahoka began to celebrate in a mild way, chiefly by the sounding of automobile horns, and fire siren. At 9:00 o'clock, the Texas State Guard staged a brief drill and fired salutes to celebrate the end of the conflict. There was really no wild demonstration, for the end had been

expected for several days and there was no element of surprise in the peace announcement. It was received rather with grim satisfaction, and the joy of the people was restrained and sobered by the knowledge that many of our sons who had gone overseas to win this victory would never

There was a large turnout at the church service at the revival meeting that night at the Baptist Church, the Assembly of God and possibly other churches, and prayers of thanks for the successful termination of the war were offered. Other churches were open throughout the day Wednesday where any who desired might resort for thanksgiving and worship.



been retained and maintained in original condition. The significant alterations have been the addition of the jail structure, modification to the square layout, exterior door and window replacements, steel structural shoring at the exterior basement entrances, and various dropped ceilings throughout the interior.

Category 15 - County Support (scored 1 out of 2)

County support refers to local support of the application and points to examples given of county incentives for historic preservation and how the county government supports the county historical commission and other local preservation efforts including the courthouse and courthouse grounds. The courthouse restoration and the \$500 annual budget to the local historical commission with provision of a courthouse meeting spot were listed in Lynn's application. If additional incentives could be identified, an additional point could be gained.

Category 16 - Local Resources (scored 2 out of 4)

This category refers to examples given of efforts to enhance surrounding historic resources, commercial buildings which are adjacent to the courthouse, additional adjacent county structures, local preservation ordinances and Main Street initiatives. Various resources were listed in this section, but any additional information supplied by the county could improve the scoring here. The information should reflect an overall sense of support for the project and illustrate examples already in place in Tahoka which would protect and further en-

amount of historic fabric that has hance an allocation and invest-

ment to restore the courthouse. Category 19 - Overmatch (scored 1 out of 8)

Overmatch refers to the pledge of funds beyond the required 15%. Projects which were funded in this round gained anywhere from 0 to 8 points for overmatch, with the majority having 1 point in this category. Should counties have the funding in place, overmatching is yet another way to edge out competition, as every point helps the scoring.

"Overall we were extremely pleased by Lynn's scoring and hope the Commissioners Court is encouraged by the outcome of this first application," said the Komatsu representative.

Lyman Labry, Lynn County's liaison in the Texas Historic Courthouse Preservation Program, was encouraging about Lynn County's chances in the next round of funding.

"Lynn County scored well relative to the many county applications our agency received. County officials and the community should be commended for their dedication and commitment to this effort. Unfortunately, there are many counties competing for limited funds," said Labry.

"While we can't guarantee state funding in the next round. the legislature has acknowledged the value of the courthouse preservation program by awarding money in every session since the program's inception in 1999. We believe Lynn County is doing everything it can at this time to be in the best possible position for the next biennium," Labry added.

The following excerpts were taken from past issues of THE LYNN COUNTY NEWS.

Three Killed In Lynn County Tornado Draw Community Is Scene Of Disaster

Three people are dead and more than a score of others were injured by a tornado which swept across the northern portion of Dawson County and the southeastern portion of Lynn County about six o'clock Tuesday afternoon

The dead all resided in the vicinity of Draw in Lynn County about 18 miles southeast of Tahoka. A number of those who were severely injured also resided in that community.

Scenes of horror marked the path of the tornado, which made its " approach undetected by its victims until it was hard upon them.

Houses were reduced to splinters, automobiles were torn to pieces and scattered over the landscape or were twisted into almost unrecognizable masses, while some of the injured were hurled high into the air. and carried many feet from the place where they were picked up by the terrific twister.

Apparently the twister first struck in the OK Community or a few miles west of that place in northern Dawson County, eight or ten miles southwest of O'Donnell. The store at OK was demolished and a number of houses destroyed. It moved in a northeasterly direction, passing within two miles southeast of O'Donnell, a residence about two miles south of O'Donnell being destroyed and some of the inmates injured. Little damage was done in the Joe Bailey Community except the destruction of outhouses and feed stacks, but the tornado struck again with full force

The first residence struck and demolished was that of Allen Moore, but the family had fled from the house and were scurrying to the storm cellar when the house crashed.

There were seven persons in the McKay house when the storm struck. Mrs. McKay, it is said, ran from the house toward a storm cellar with her twins in her arms, but she was thrown down. The babies were torn from her clasp and one of them was very seriously injured. The other miraculously escaped serious injury...

Excerpts from a follow-up story on the same tornado. A half-mile east of the Gary house was the four-room residence of E. Vandivere. His roof was gone and walls of the house so badly damaged that they planned to rebuild the entire structure. Mr. Vandivere said his wife kept telling him to look at the terrible storm cloud approaching, "but there wasn't any use to look," he said facetiously, "for we had no storm cellar." Finally, he ran out to cut off the windmill and as he turned back toward the house he was compelled to see the storm - a black wall of sand hard upon them. "Before I got to the house, car sheds and chicken houses were passing me but I managed to dodge

them," he said. "I met my boy coming out the door to see about Daddy. I grabbed him and hurried into the house. My wife grabbed my hand, I think it was the first time we had held hands in 30 years. She was praying while I was holding the front door, which didn't need holding. And then two or three windows blew in and the roof went, and there we were. But luckily none of us were hurt. The main part of the twister was to the north May 6, 1938
