City Officials Accept Donation Of Property

Tahoka City Council accepted a donation of property on the town square at their Monday night meeting, acting on a request by the heirs of D.C. Hubbard to donate a building (the old shoe shop) and adjacent vacant lots at 1515 S. 2nd Street, across the street south from the county courthouse and located next door to the Briteway Cleaners facility.

"We plan to tear down the dilapidated building and clean up the lots, and then we discussed the possibility of having a community service project by school students to plant flowers/landscaping plants to improve the site. Also brought up was the possibility of using this space during the annual Harvest Festival's car show," City Administrator Jerry Webster told *The News*.

Council members accepted a bid of \$126,749 from Joe Marts Construction of Post to build another Type 1 trash cell at the city landfill, as the first cell is nearly full. Webster explained that the landfill, which opened last spring, was designed to hold more than 20 cells.

"This first cell filled up quickly because the city contracted with Duncan Disposal for dumping Type 1 garbage (household garbage typically picked up from alley dumpsters), not only for disposing of our city trash but

for other areas that they serve. This first eight months we have been open we have probably accepted what amounts to two years worth of garbage - and during the first six months we were operating without a compactor, so that has greatly improved capacity now. Each Type 1 cell was originally projected to last 1-2 years, and we believe we are now operating at that level," Webster explained. "This facility was designed to last 50-60 years," he added.

Lynn County officials were present at the meeting seeking permission to place a container at the city landfill site for county residents to put burn barrels. County Judge H.G. Franklin, Commissioner Mike Braddock, and County Attorney Donnis Scott attended the council session. The issue was tabled pending further information regarding TCEQ regulations.

In other business, the council approved final closure of a portion of Ave. E in Tahoka, which is a dirt road by the cemetery that is now on personal property.

Four of five council members were present at the meeting, including Amy Preston, Rudy Fuentes, Jeff Martin and Ray Box, with councilwoman Clara Calvillo absent. Mayor Mike Mensch presided.



Bicycle Safety is important ... Donovan Vasquez of O'Donnell, one of the participants at the Bike Rodeo held in Tahoka last week, learned last year that bicycle safety is a very important issue. The third grader was seriously injured in a bicycle accident in O'Donnell, either in late April or early May last year, and was airlifted to a Lubbock hospital for treatment for a head injury. He was riding his bicycle on the sidewalk and looked down to check his shoe, and when he did that he pulled the bike out into the roadway and struck a car head on. The car saw him coming and had nearly slowed to a stop when they hit and he rolled up on the hood, breaking the car's windshield, but Donovan was not wearing a helmet and sustained a head injury. He has since recovered, and was a willing participant in the Bike Rodeo held this year.

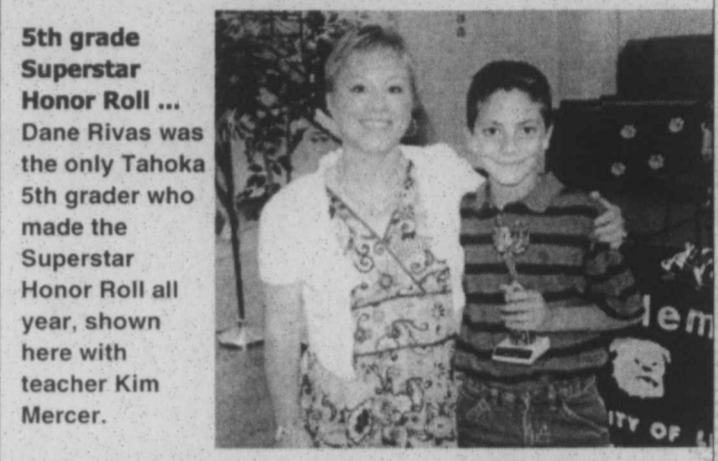

IT'S MOSQUITO SEASON - BE PREPARED!

Last week we looked at DEET as protection from insect bites here are a few more options to complete our article.

Picaridin (KBR 3023). Studies show that picaridin works as well as low concentrations of DEET and that no serious toxicity occurs to those who use it. Unlike DEET, picaridin is odorless, does not feel greasy or sticky, is less likely to irritate the skin, and does not damage plastics or fabrics.

The American Academy of Pediatrics (AAP) recommends not using picaridin on children younger than 2 months.

P-menthane 3,8-diol. This repellent is commonly known as lemon eucalyptus oil. When oil of lemon eucalyptus was tested against mosquitoes found in the U.S., it provided protection similar to repellents with low concentrations of DEET. It provides up to 2 hours of protection against mosquito bites. Do not apply more than twice per day, and do not use this product on children younger than 3 years.

Permethrin. This insecticide works on contact to kill mosquitoes. You spray it on clothing and other fabrics, such as mosquito netting and tent walls. Permethrin should not be applied directly to the skin. Several studies have found that using the combination of permethrin on clothing and DEET on the skin provides a much higher level of protection from mosquitoes than either permethrin or DEET alone.

Soybean oil. Insect repellents that contain 2% soybean oil provide 1 to 4 hours of protection from mosquitoes when applied to the skin. Soybean oil is safe to use on infants and children.

Products that do not provide protection against bites for long periods of time:

Citronella oil. Citronella as an insect repellent is not as safe or effective as products that contain DEET. Citronella applied to the skin provides between 30 minutes to 2 hours protection from mosquitoes. People may develop skin rashes or itchiness because they must be reapplied often. Do not use citronella skin products on children younger than 2 years.

Other plant oils. Other plant oils, such as lavender and geranium, provide less than 30 minutes of protection against mosquitoes. Therefore, these products are not recommended.

Products sold as repellents that do not work well to prevent bites:

- Electronic (sometimes called ultrasonic) devices.
- Electrocuting devices, which are often called "bug zappers."
- Mosquito traps.
- Geranium house plants
- Citronella candles.
- Taking thiamine (vitamin B1) supplements.
- Skin moisturizers that do not contain approved insect repellents.
- Wrist, ankle, and neck bands that contain repellents, such as DEET or citronella.

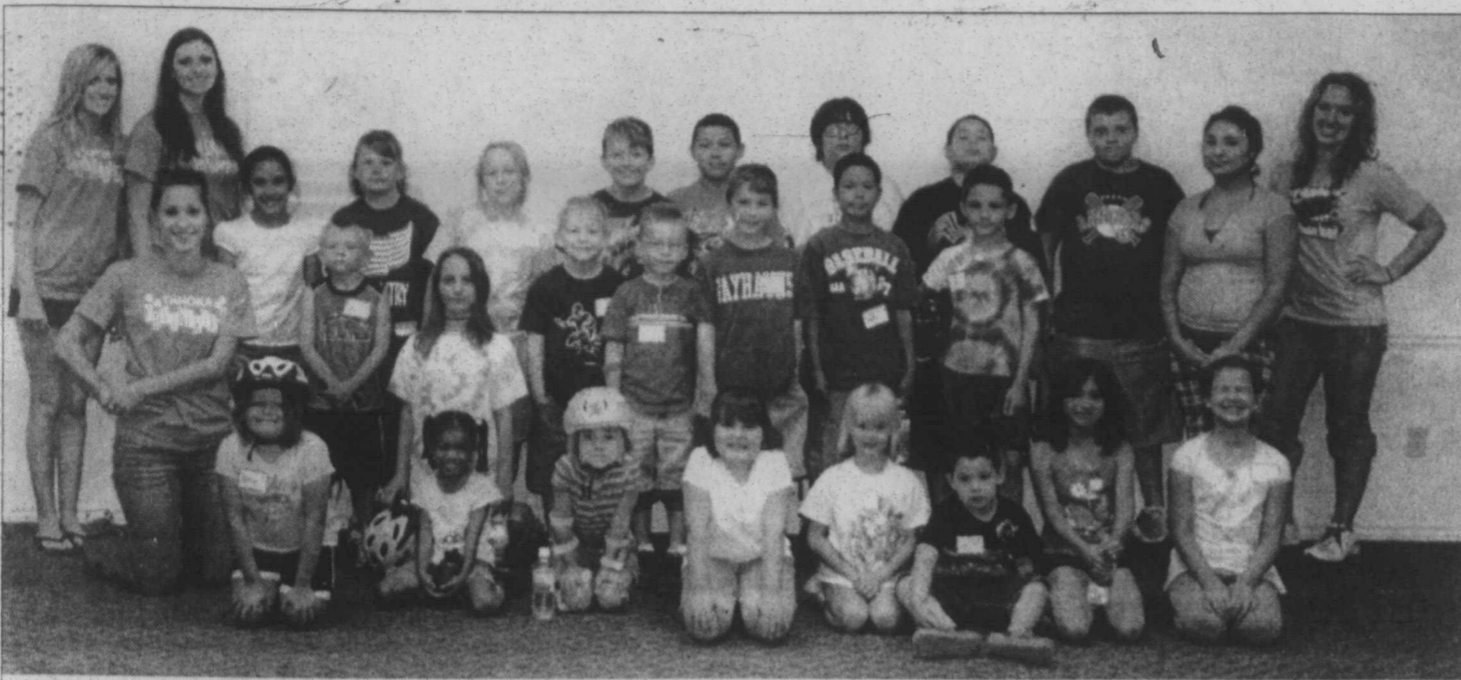

July 18 is Deadline For Livestock Program

Rodney Schoppa, Executive Director for USDA's Farm Service Agency in Lynn County, announces that livestock producers have until July 18, 2008, to enroll in the 2005-2007 Livestock Compensation Program (LCP) and Livestock Indemnity Program (LIP). Signup began on Sept. 10, 2007, for the two programs that provide aid to livestock producers who suffered eligible livestock or livestock feed losses between Jan. 1, 2005, and Dec. 30, 2007, because of a natural disaster.

The LIP provides payments to eligible livestock owners and contract growers who incurred the death of livestock because of a natural disaster. The LCP provides payments to eligible livestock owners and cash lessees who suffered feed losses or increased feed costs because of a natural disaster.

Wilson Trustees Approve Bid For Classroom Construction

The Wilson Independent School District Board of Trustees held their regular monthly meeting on Monday, June 9, at 7:00 p.m. in the school library. Trustees Clyde Wilke, Janie Rios, Oscar Ortega, Ricky Cross, Casey Donald, and Josh Isham were present. Trustee Israel Ramirez was not present. Administrators present were Mike Jones, Superintendent, Michael Norman, Principal, and Tami Bolyard, Business Manager.

Superintendent Jones gave the invocation and guests were welcomed. Danny Scott with Knox, Gailey, and Meador Construction was present, and Ed Stiles, a partner with Stiles Wallace and Associates Architects, was in attendance as well.

The board met in closed session for a brief personnel discussion.

Trustees considered a construction bid submitted by Knox, Gailey, and Meador for \$436,030.53 to rebuild two junior high classrooms and to add restrooms and a walk-in refrigerator/freezer to the school cafeteria. Upon reviewing the architectural drawings and more discussion about the total cost of the project the board unanimously approved the construction bid. Construction should begin in the next two weeks and the two classrooms are scheduled to be ready by August 25, 2008 when the 2008-2009 school year begins.

Neugebauer Announces New Assistant In Washington Office

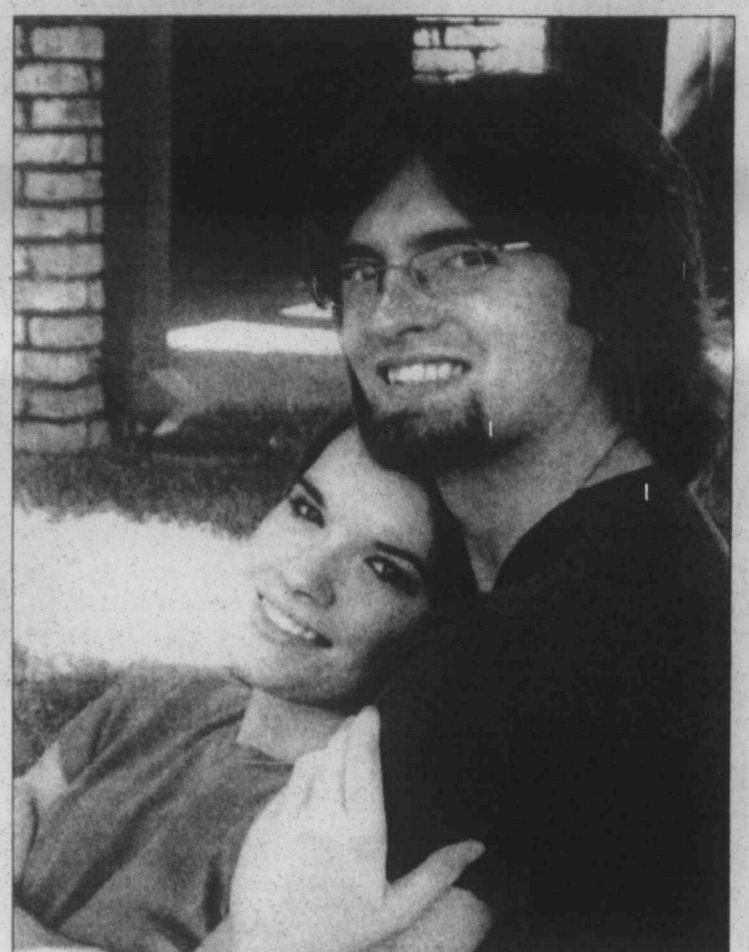
Ms. Geiger's previous work experience includes working at the United States Department of Agriculture, The College of Agriculture at Kansas State University and most recently at the National Cattlemen's Beef Association.

Trustees elected Clyde Wilke, Board President, to be the delegate to the Texas Association of School Boards (TASB) convention to be held in Dallas in September. The board took no action after discussing increasing food costs and the possibility of raising meal prices for 2008-2009 school year. Trustees discussed school finance from the state and the need for possibly calling for a Rollback Election to balance the 2008-2009 school budget. Better projections will become available in late July when district property values are certified. Superintendent Jones reviewed the increasing utility and fuel costs for 2008 and the need to increase teacher salaries and hourly and paraprofessional salary schedules, which have not been increased since 2003, as the primary reasons to consider a rollback election.

"For every dollar we raise with an increase in our local tax rate the state will add approximately two dollars," said Supt. Jones. He estimated a 13-cent local tax increase would bring in approximately \$49,000 in local tax revenue with another \$90,000-\$100,000 being added from the state. The board also approved a school safety audit report, adopted Energy Management Reduction Plan Goals for the school facilities, and discussed rules in the student handbook as they relate to graduation speaking roles.

Supt. Jones reported one staff resignation, from Special Education teacher Angela Burton. In administrative reports, new school principal Michael Norman reported on year end student failures and student retention for 2008-2009. Supt. Jones reviewed the state testing results showing Wilson students meeting or exceeding the state average on 17 of 25 grades and subjects tested. Revenue estimates for the 2008-2009 school year were discussed with little more expected from the state than the current year state aid estimate of \$975,000.

The next school board meeting is scheduled for July 10, at 7:00 p.m. in the school library. The public is invited to attend.

Commissioners Hear Software Proposal

Lynn County Commissioners met in regular session Tuesday morning at the county courthouse to conduct routine business. Present at the meeting was Tom Keyes, Gaines County Judge, who presented information regarding a proposal for a new software package that he is asking counties to consider.

CIRA (County Information Resource Association), which is associated with Texas Association of Counties, is forming an integrated software package that Judge Keyes told county officials should create efficiency and save money for county governments across Texas. Judge Keyes asked the county to support this project in its first phase by signing a resolution and committing funds toward the project. The first project would be in the county justice departments. When in place, the program would work with all county departments and all Texas counties, Keyes explained.

Commissioners did not take any action on the software proposal at this time, but said they would consider the issue during upcoming budget work sessions.

In other business, a decision was tabled regarding setting a date to close the county landfill site, and commissioners also did not take any action on internet service considerations, property for sale in O'Donnell, or applying for an emergency grant for electrical work on the courthouse. Monthly bills were approved as presented, and Sheriff Jerry D. Franklin reported on his department's activities.

Some budget issues were considered, and there will be further workshops on the budget for county officials.

County Judge H.G. Franklin presided at the meeting, with all four commissioners present including Keith Wied, Don Blair, Brad Hammonds and Mike Braddock.

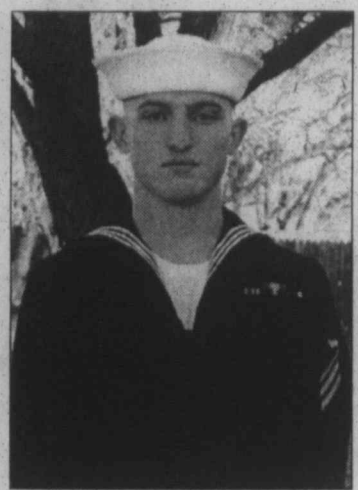

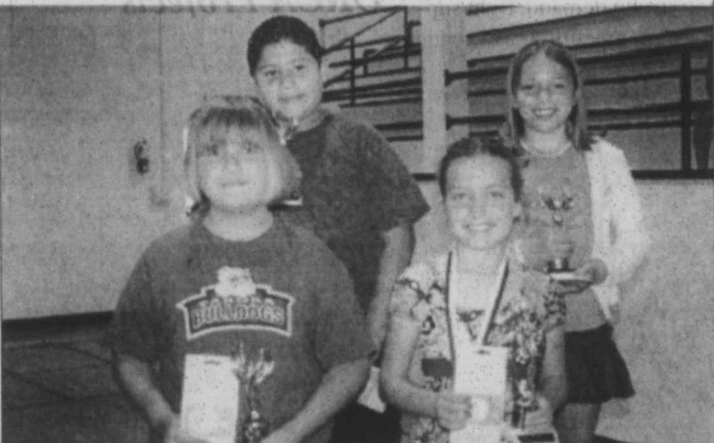

FSA County Committee Nominations Start June 15

Rodney Schoppa, Executive Director for USDA's Farm Service Agency in Lynn County recently announced farmer and rancher candidate nominations begin June 15 for local Farm Service Agency (FSA) county committees. The nomination period continues through Aug. 1, 2008. Elections take place this fall.

"I encourage all producers to participate in the county committee election process by nominating candidates by the August 1 deadline," said Schoppa. "We are counting on as much participation as possible, because county committees are an important link between the agriculture community and the U.S. Department of Agriculture. We have seen a trend in recent years of increased nominations of minority and women producers and we hope that trend will continue."

Between 2003 and 2006, the number of minority and women farmers and ranchers nominated as candidates to FSA county committees nationwide increased 35

CRP Allowed For Livestock Feed Needs

Rodney Schoppa, Executive Director of USDA's Farm Service Agency in Lynn County announced recently that USDA has authorized certain acreage enrolled under the Conservation Reserve Program (CRP) to be available for hay and forage after the primary nesting season ends for grass-nesting birds.

"This action will provide much needed feed and forage while maintaining the conservation benefits from the nation's premier conservation program," said Schoppa. "Eligible farmers and ranchers will be able to plan for harvest of forage after the end of the primary nesting season this summer."

Prices for most field crops have advanced to record or near record levels in recent months, reflecting strong demand, tight supplies and competition for acres. The increased demand for commodities and resulting higher prices has impacted the livestock industry in particular.

More than 24 million acres of land enrolled in CRP will be eligible for this critical feed use program. USDA estimates that this program will make available up to 18 million tons of forage worth \$1.2 billion.

"In authorizing this critical use of CRP acres for forage, USDA is also taking strong measures to preserve CRP's environmental benefits," said Schoppa.

Eligible land may not be hayed or grazed until after the end of the primary nesting season.

Also, some of the eligible land or forage of the land must be reserved for wildlife and any land that is used under this authority must have a conservation plan. In many instances, the removal of some of the grass cover will increase the diversity of the stand and provide long-term benefits for wildlife. Further, the most environmentally-sensitive land enrolled in CRP will not be eligible. The land will be subject to a site inspection to ensure compliance with the conservation plan. No rental payment reduction will be assessed on contracts being utilized for this critical use. However, a \$75 fee will be charged to process the required contract modification.

Signup for interested CRP participants began June 2, 2008, at local Farm Service Agency (FSA) offices. This modification for critical feed use is only for 2008. All forage use must be completed no later than November 10, 2008.

Under CRP, farmers and ranchers enroll eligible land in 10- to 15-year contracts with USDA's Commodity Credit Corporation (CCC). FSA administers CRP on behalf of CCC. Participants plant appropriate cover such as grasses and trees in crop fields and along streams. These plantings help prevent soil and nutrients from running into regional waterways and affecting water quality. The long-term vegetative cover also improves wildlife habitat and soil quality.

percent. Additionally, the number of African American producers nominated as candidates tripled during the same period.

To be eligible to serve on an FSA county committee, a person must participate or cooperate in a program administered by FSA, be eligible to vote in a county committee election and reside in the local administrative area in which the person is a candidate.

Producers may also nominate themselves, and organizations representing minority and women can nominate candidates. To become a nominee, eligible individuals must sign form FSA-669A. The form and other valuable information about FSA county committee elections are available online at: <http://www.fsa.usda.gov>; click on News & Events, then County Committee Elections. Nomination forms for the 2008 election must be post-marked or received in the local USDA Service Center by close of business on Aug. 1, 2008.

FSA county committee members make decisions on disaster and conservation programs, emergency programs, commodity price support loan programs and other important agricultural issues. Committee members serve three-year terms. Nationwide, there are more than 7,800 farmers and ranchers serving on FSA county committees. Committees consist of 3-5 members who are elected by eligible local producers.

FSA will mail ballots to producers beginning Nov. 3. The voted ballots are due back to the local county office either via mail or in person by Dec. 1.

Newly elected committee members and alternates take office Jan. 1, 2009.

Heflin Announces Grant Funding For ORCA Projects

These grants are to be used to remediate water supply, storage, and pressure problems, and to replace sewer lines that have deteriorated.

Thanking ORCA for the grants which will help these towns and counties provide better service to their residents, Representative Heflin said, "These grants will go far to help these cities and counties ensure that their citizens have clean, safe water. Our water is a precious commodity and we must do whatever we can to insure the delivery of good, safe water."

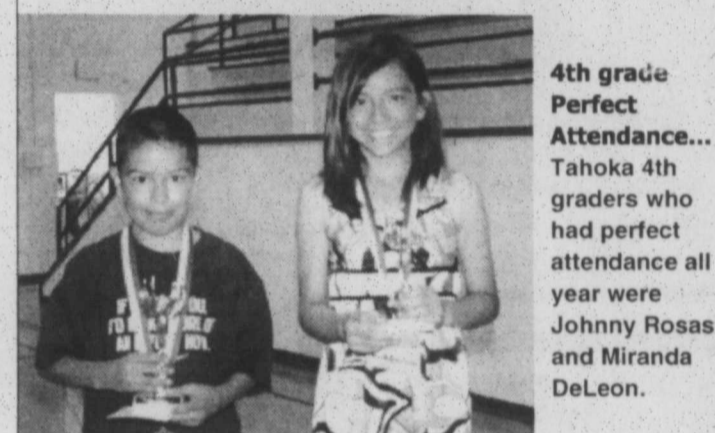
