The Bulldogs led 18-7 after the first

quarter, and held Springlake-Earth scoreless in the second period while adding another 11 points to lead 29-7 at the half.

The Tahoka squad tossed in another 12 points in the third period while the Wolvermes only managed 2, \* trailing 41-9 to the Lady Bulldogs going into the final quarter, and Tahoka finished with a 57-17 win to claim the Bi-District trophy.

Kyra Helm led the Bulldogs with 19 points that included a couple of 3-pointers, and Kalee Wuensche also hit the boards with double digits, adding 13 points to the Bulldog tab. Brittney Hair tossed in 8 points, and Cori Vega added 7, while Kaitlyn Reno had a 3-pointer. and adding 2 points each were Stormee Martin, Samantha Pridmore and Morgan Lockaby, and Sabrina Moralez added 1 more with a free throw.

### **Three Charged** After High **Speed Chase**

Lynn County sheriff's deputies joined officers from about nine other. jurisdictions Feb. 10 in chasing three men in a black Lexus who were spotted by neighbors while engaged in a daylight burglary of the home of John G. White, west of New Home.

After a high-speed chase with speeds up to 130 miles an hour, the suspects were captured in Lubbock County. Lubbock officers believe the three were responsible for 35 burglaries in four counties this year, and that the suspects had stolen more than \$52,000 worth of property, including numerous firearms. The suspects were caught after they went into a ditch on U.S. 87 to avoid spike strips placed on the highway.



New Home had seven 3-point shots, to 6 for Petersburg. The Lady Leopards shot 34.8 per cent from the floor (16 of 46), while Petersburg hit 17 of 39 for 43.6 per cent.



Should teens use teeth whiteners? It's easy to be lured by ads telling people they need gleaming white teeth. But these ads are really targeted to older people. The truth is that most teens don't need tooth whitening because teeth usually yellow as a person gets older. If you think your teeth aren't white enough, though, talk to your dentist before you try any over-the-counter whitening products. Your dentist may be able to offer you professional treatment, which will be suited to your unique needs and will work better than over-the-counter products.

Be careful when buying over-the-counter whitening products. Some bleaching agents may damage your gums and mouth. So always follow the instructions on any whitening product you use. If the product states to only use every 6 months only use it every 6 months or you may damage your teeth beyond care. Some bleaching agents may damage your gums and mouth.

The Nutrition Connection: Eating sugar, as you probably already know, is a major cause of tooth decay. But it's not just how much sugar you eat when and how you eat it can be just as important to keeping teeth healthy.

When you eat sugary foods or drink sodas frequently throughout the day, the enamel that protects your teeth is constantly exposed to acids. Hard candies, cough drops, and breath mints that contain sugar are especially harmful because they dissolve slowly in your mouth. Many experts suggest that you take a 3-hour break between eating foods containing sugar.

Sugary or starchy foods eaten with a meal are less harmful to your teeth than when they're eaten alone, possibly because the production of saliva, which washes away the sugar and bacteria, is increased. Eating sugary foods before you go to bed can be the most damaging (especially if you don't brush your teeth afterward) because you don't produce as much sa-

liva when you sleep. As a teen you need to remember that the teeth you have right now will have to last you your whole life...70 to 80 years or more so you need to develop good eating and health habits that will last that lifetime. Going to the dentist every 6 months to a year will help prevent many troubles but brushing and flossing on a daily basis is your best protection in keeping those teeth healthy.

#### **TISD Administrative Contracts Renewed at Current Salaries**

District Board of Trustees met night, considering administrative contracts and other business. A list of five administrative positions was considered, and trustees approved a motion for one-year extensions on administrative contracts at their current salaries. Voting for the motion were trustees Jimmy Dorman, Tony Garcia, John Hawthorne, Kent Kahl and Joe Calvillo, with trustee Frank McLelland abstaining from voting and trustee Jimmie Bing-

ham absent from the meeting. Current salaries for TISD administrators include \$65,000 for the high school principal, \$61,000 for the middle school principal, \$59,000 for the elementary principal, \$55,000 for the athletic director, and \$59,000 for the curriculum/testing director. No administrator, including the school superintendent, received salary increases for the upcoming school year, most likely due to the fact that the school tax election failed in November and the district is searching for ways to cut back on financial issues.

In other business, trustees set a school trustee election for May 9 for two at-large places, and approved election judges including Jackie Stevens as election judge, Donna Brooks as alternate judge, and Susan Tipton as early voting judge. Early voting will be conducted April 27-May 5 at the county clerk's office. The filing period for candidates is currently underway, ending March 9. No candidates have filed to date. Trustees whose terms are expiring are Jimmy Dorman, currently serving as board president, and John Hawthorne.

A change in the high school cheerleading policy was approved, to include a clause that says any cheerleader who quits the squad cannot try out again for one calendar year after quitting. Trustees also renewed an interlocal agreement with West Texas Food Service Cooperative for purchasing food for the school cafeteria, and approved a staff development waiver for three staff development days in 2009-10.





# Non-Insured Crop Disaster Assistance Program Offered

Podney Schoppa, Executive Director of USDA's Farm Service Agency (FSA) in Lynn County, reminds agricultural producers of the need for insurance coverage for crops in order to be eligible for the agency's Disaster Assistance Programs. Application closing date for coverage in Lynn County is March 15 for the following crops: Beans, Squash, Guar, Korean Melon, Millet, Okra, Peas, Pecans, Sorghum Forage, and Sunflowers.

Producers must purchase at least catastrophic (CAT) level of insurance for all insurable crops and/or FSA's Noninsured Crop Assistance Program (NAP) coverage for noninsurable crops to be eligible for the USDA Farm Service Agency Disaster Assistance Programs.

"Crop insurance is an important risk management tool for farmers, but it's not available for all crops. That's why NAP is so important," said Schoppa.

NAP is a federally funded program that provides coverage to producers for non-insurable crops when low yields, loss of inventory or prevented planting occurs due to natural disasters.

Crops eligible for NAP coverage are those for which crop, insurance is not available, including but not limited to fruits and vegetables, aquaculture, pecans, turf grass and forage crops. However, crops that FCIC deems as ineligible due to practice or yield are not covered by NAP.

"Producers must apply for coverage before a disaster strikes," said Schoppa "Like regular crop insurance, once an application period closes, the opportunity to obtain coverage is gone."

NAP applications for coverage must be filed using Form CCC-471 and service fees must be paid by the sales closing date. Application sales closing dates vary by crop.



#### Over 5,000 Calls Logged in 2008 **For County Emergency Services**

By JUANELL JONES

The Lynn County Law Enforcement Center, who answers calls for city and county law enforcement, EMS, fire department, and 9-1-1 calls in Lynn County, answered 5,678 calls during the 2008 year, according to information released from Lt. Luis Vasquez, Communications Supervisor. That number included 2,431 calls to the 9-1-1 emergency system, but more than half of those were the calls were either hangups or calls mistakenly dialed by

According to the call log sheets, there were 892 actual emergency calls to 9-1-1 in 2008, but there were 1,539 additional calls made to 9-1-1 that were miscellaneous hangups or mistakenly dialed, or someone dials 9-1-1 to seek information that is not emergency-related. That's a lot of calls to filter through the 9-1-1 system. For instance, in August, there were 93 actual emergency calls to 9-1-1, but there were 191 mistakenly dialed 9-1-1 calls the same month.

Vasquez says that he and his staff must treat any 9-1-1 call as an emergency, which means a hangup means a call back from his staff to make sure there is no actual emergency. In one instance, Vasquez says he received about 20 calls to 9-1-1 in quick succession from a cell phone, and he could hear what sounded like a classroom of

principal here and asked him to check it out," says Vasquez. "Turns out, it was a student's cell phone in his backpack, and when he leaned on the backpack it was hitting the 9-1-1 speed dial on the phone. It was entirely by accident, but we have to check everything out," he said.

If a person accidentally dials 9-1-1, it is best to go ahead and speak to the person who answers and explain that it is a mistake, rather than to hang not actual emergencies - that is, up without any explanation. In averages 74 legitimate calls each month, but averages 128 mistaken 9-1-1 calls per month. Some of those mistaken 9-1-1 calls were dialed on purpose, but for non-emergency reasons that should not go to the 9-1-1-

Any call seeking nonemergency information should actually go to the Sheriff's Office regular phone number, which is 806-561-4505. Any emergency requiring law enforcement, EMS/ambulance service, or fire departments is a legitimate 9-1-1 call. The communications specialists who answer the 9-1-1 calls will dispatch the appropriate local emergency response personnel to assist in the emergency.

The Communications staff headed by Vasquez includes Felicia Garcia, Amber Gomez, Rebeca Pando and Lena Cloe. They answered 1,496 calls for county law enforcement, 1,257 calls for Tahoka Police Dept., and 149 calls for O'Donnell Police Dept. during 2008. There were 235 calls for EMS during the year, and 110 calls for fire departments in the county.

PARA PEDIR UNA AUDIENCIA ADMINISTRATIVA DE LO CONTEN-CIOSO, USTED DEBE INCLUIR EN SU PEDIDO LOS SIGUIENTES DATOS: su nombre; dirección; teléfono; nombre del solicitante y número del permiso; la ubicación y la distancia de su propiedad/actividad con respecto a la instalación; una descripción especifica de la forma cómo usted sería afectado adversamente por el sitio de una manera no común al público en general; y la declaración "[Yo/nosotros] solicito/solicitamos. un/a audiencia administrative de lo contencioso." Si presenta por partede un grupo o asociación el pedido para una audiencia administrative de lo contencioso, debe identificar el nombre y la dirección de una persona que representa al grupo para recibir correspondencia en el futuro; debe identificar un miembro del grupo que sería afectado adversamente por la planta o la actividad propuesta; debe proveer la información ya indicada anteriormente con respecto a la ubicación del miembro afectado y la distancia de la planta o actividad propuesta; debe explicar como y porqué el miembro sería afectado y como los intereses que el grupo desea protegerson pertinentes al propósito del grupo.

Después del cierre de los periodos para los pedidos y comentarios, el Director Ejecutivo enviará la solicitud y los pedidos para reconsideración o por una audiencia administrative de lo contenciosos a los Comisionados de la TCEQ para su consideración en una reunion programada de la Comisión.

La Comisión otorgará solamente un audiencia administrative de lo contencioso sobre los hechos reales disputados del caso que son pertinentes y esenciales para la decistori de la Comisión sobre la solicitud. Además, la Comisión solo otorgará un a audiencia administrative de lo contencioso sobre los asuntos que fueron presentados antes del plazo de vencimiento y que no fueron retirados posteriormente. Si ciertos criterios se cumplen, la TCEQ puede actuar sobre una solicitud para renovar un permiso sin proveer una opotunidad de una audiencia administrative de lo cotencioso.

Si somete comentarios públicos, un pedido para una audiencia administrative de lo contencioso o una reconsideración de la decision del Director Riscutivo, la Oficina del Secretario Principal enventa por correo los avisos públicos en relación con la solicitud.
