## **Burglaries**, tire slashing reported

TAHOKA, LYNN COUNTY, TEXAS

Four burglaries in the county and one incident of criminal mischief were investigated by Lynn County sheriff's officers during the last week, and an incident of tire slashing was reported to Tahoka police.

Several guns and electronic items were stolen from the residence of Kenneth Heathington on FM 2053 at O'Donnell, according to a report filed March 13. Shotguns, rifles and handguns were on a long list of stolen items, with no total amount of loss immediately available. Heathington is offering a \$1000 reward and Crime Line is offering an additional \$500 reward for information leading to the arrest and conviction of any persons involved in the burglary of the Heathington residence. 

Collection of the half-cent 4B Sales Tax in the city of Tahoka will begin April 1, 2010, according to information from the Texas Comptroller, who has mailed notices to Tahoka businesses. The Lynn County News received its notice from the State Comptroller's office last Thursday to begin collecting the additional half-cent sales tax on April 1, making a total sales tax rate

The Tahoka Economic Development Board (originally designated as the 4B Sales Tax steering committee) will decide how the funds should be used for economic development, following stringent state guidelines as to

ON TELEVISION, you get to see a lot of advertising, because it costs a lot of money to produce those shows, although a lot of them make you wonder why they ever bothered to make them. And mixed in the ads for all those other products are quite a few ads for prescription medications.

What the drug manufacturers are trying to do, of course, is sell drugs. They want you to ask your doctor to prescribe what they are pushing, which is supposed to cure some ailment you have. But federal law requires them to list all the possible side effects, and that's where the ads get scary.

They name their drug (Cialis, Vitalis, Enerax, Eurax, Anthrax or whatever) and tell you what great things it could do for you. But something really awful could happen if you take it, should you have heart trouble, diabetes, headaches, cold sores, schizophrenia, bunions, unruly children or any of 37 other problems.

By the time they list all the ways the medicine could kill you, you wonder why anyone would ever take that stuff at all. Some of those ads give you the feeling that you might be better off taking your chances on getting better without the featured drug.

That reminds me of a journalistic blooper I read once, where a newspaper reported that "Funeral services are scheduled here Tuesday for prominent local leader Mrs. Gretchen Goonberg, who suffered a heart attack about noon Saturday at a downtown intersection, where she died without medical assistance."


## Six Lady Bulldogs named to **All-District, All-State honors**

### Neugebauer votes "No" on healthcare bill

Congressman Randy Neugebauer released the following statement Monday evening after voting "no" on President Obama and Speaker Pelosi's government takeover of health care in the form of the Senate health care bill and "reconciliation" legislation making changes to the Senate bill, which the House passed by votes of 219 to 212 and 220 to 211 respectively:

"Tonight, my Republican colleagues and I stood with the American people. Like the many residents of the 19th District who contacted me during the past week, I am extremely disappointed in the Democrats for voting to pass such misguided, flawed legislation.

"I opposed this legislation because I believe Americans should be allowed to choose the doctor, hospital, and health care plan of their choice. This government takeover of one sixth of the economy is not the right answer. It will not lower the cost of health care, but instead will add layers of bureaucracy and confusion to the existing system.

"The 19th District doesn't understand why the House leadership insists on going down the road of trying to enact a government takeover of health care that our nation can't afford and that will not improve their health care. They don't understand why leaders in Congress refuse to listen to the American people.

"This legislation increases government spending by \$1.2 trillion and increases taxes by \$569 billion. Rather than lowering health care premiums for families by up to \$2,500, as the Republican plan would do, this legislation does nothing to help contain rising health care costs and will result in higher insurance premiums compared with passing no bill.

"At a time when the federal deficit is \$1.5 trillion, and the national debt is projected to triple by 2020, it is completely irresponsible for Congress to add more unsustainable government spending to the tab that our children and grandchildren will have to pick up.

"We can make health care more affordable, available and accessible for everyone without nationalizing the system, raising taxes, assaulting the unborn and piling on more debt. We need to sit down, in a bi-partisan way, and work on real reform that will help American families. That's what the American people want and what they deserve."

#### **Bicycle Safety**

It's that time again, with the warm weather kids are starting to ride their bikes. Although riding is fun and good for their health (heart wise); it can also be dangerous. Statistics state that every 6 hours a bicyclist is killed in the United States. 300,000 children are brought into emergency rooms from bicycle accidents yearly. We want to ensure that our children do not become part of these statistics. We have to teach them the

safe way to ride. Children under the age of 12 need supervision and should not ride on the streets. Children under the age of 12 have not fully developed depth perception; therefore, they are not able to safely maneuver on public roads.

Here are a few safety guidelines we need to teach and fol-

Bicyclist need to wear safety helmets. Nearly 75% of all serious bicycle injuries and deaths involve head injuries.

· It is recommended that bicyclists wear light colored/reflective clothing at night or during low visibility conditions.

• Put reflectors on the frame and wheels of the bike.

· Make sure the size of the bike fits the child. They should be able to reach the ground, peddles, handle bars and hand brakes with ease.

· Make sure the bike is in good working condition. Regular maintenance is needed; such as checking tire air pressure, checking the brakes, oiling the chain, and replacing broken re-

· Never let your child ride the bike in sandals.

· Don't ride with your IPod on. You need to be able to hear oncoming traffic.

· Texas law requires bike riders to follow the same rules as motorists. Bicyclists should always ride with the traffic.

As drivers we must all keep a watchful eye out for bicyclists. Between us all I wish for a safe and healthy Spring and Summer.



"The area where the pet was bitten will swell up very quickly," states Stickney "Just because there is no visible puncture wound does not mean that your pet did not get

things worse if the pet vomits so it

If you think your pet was bitten by a snake, stay calm and take it to the vet immediately. Do not put a tourniquet on the pet as this will limit the blood flow too much and cause more harm than good.

"If you are able to kill the snake take it to the veterinarian with you. If they can identify the snake they will have a better idea of how harmful the bite is," recommends Stickney.

It's not uncommon that a dog or cat will suffer a traumatic event such as getting hit by a car, bike, or other vehicle. While the animal might look ok it is good to have it checked out by the veterinarian

"Trauma can be very deceiving. Most of the time it looks better than it actually is and there is usually a lot of damaged tissue on the inside," explains Stickney

The first thing to do if your pet has been injured and is bleeding is the blood flow. Hurt dogs tend to bite so it is a good idea to have a muzzle on hand to use in this type of situation.

"Your pet might be your best friend, but when dogs are hurt they may not remember that," notes Stickney. "If you have a big dog, I would also recommend that you have a dog stretcher. They make it much easier to move large injured animals."

Less severe incidences such as minor cuts and scrapes are fairly common and can be handled much like you would treat yourself.

"Make sure that the cut is as clean as possible," states Stickney. "I would not recommend putting antibiotic cream anywhere your pet can lick it off. This just causes more germs to get in the wound. If the cut is on an area they can't lick than something like Neosporin will be fine."

While there are a lot of ways that you can help your pet with simple first aid techniques, you will probably never have to use CPR.

"The reality is that the chance that CPR will help your pet is very low," says Stickney. "The good news is that this means there is very little reason you would have to put your dogs face in your mouth.'



Did you know stroke is the third leading cause of death for Americans behind cardiovascular disease and cancer? Or that 700,000 people each year in the United States will suffer a

Those are sobering statistics from the U.S. Centers for Disease Control and Prevention, especially when you consider many factors resulting in stroke are preventable - smoking, obesity, uncontrolled high blood pressure and uncontrolled dia-

"A stroke is a sudden loss of blood flow to an area in the brain due to plaque, a blood clot or hemorrhage," said Cynthia M. Stoughton, M.S., C.C.R.N., adjunct professor in the Texas A&M Health Science Center College, of Nursing. "There also are transient ischemic attacks (TIAs) that can be a strong stroke predictor even though they are shorter and without lasting effects. A person who

According to Stoughton, some risk factors are modifiable. For example, smoking can increase blood pressure, thicken blood and damage the vascular system. High blood pressure can weaken or thicken artery vessel walls and cause plaque to break away from vessels, blocking blood flow to the brain.

"Obesity and physical inactivity are risk factors for stroke, as they lead to high blood pressure, diabetes and high cholesterol," Stoughton said. "A poor diet is another risk, and most individuals with diabetes have high blood pressure, cholesterol or are obese." ply put, to reduce the risk of stroke, stop smoking, regulate your blood pressure and diabetes, and eat a sensible diet.

"A brisk walk for 30 minutes three times a week can not only reduce your weight but also decrease your blood pressure and help control your diabetes and cholesterol," Stoughton said. "Strive to eat five to seven servings of fruits and vegetables daily, along with eight glasses of water, and limit your carbohydrates and fats. "Research shows chewing gum after a meal reduces acid reflux, and chewing sugarless gum specifically with xylitol also prevents cavities," said Dr. William Wathen, associate professor in general dentistry at Texas A&M Health Science Center Baylor College of Dentistry. As for chewable antacid tablets, he recommends using only the sugarless

### A variety of homestead exemptions could lower your property taxes!

A homestead exemption lowers the property taxes on your home by lowering its taxable value. If your home is valued at \$50,000 and you receive a \$15,000 homestead exemption, your home will be taxed as if it were worth \$35,000.

#### Who qualifies for an exemption?

Anyone who owns a home on Jan. 1 and uses it as a primary residence on that date is entitled to a \$15,000 homestead exemption to lower school taxes this year...and it doesn't matter if your home is a house, condominium or mobile home. Counties, cities and special taxing districts may also offer homestead exemptions.

#### Are other exemptions available?

If you're disabled—or if you're 65 years old or older—you are entitled to an additional \$10,000 school tax exemption on your home. And if you qualify for the 65 or older or disabled exemption, you're also entitled to a permanent, locked-in "ceiling" on the school property taxes on your home. (The county, city or junior college may adopt a tax ceiling to lock in 2010 taxes as the highest amount for 65 and older or disabled homeowners.) The age 65 or older homeowners school tax ceiling transfers to the surviving spouse, if the spouse is 55 years of age or older at the time of spouse, if the spouse is 55 years of age or older at the time of death and lives in and owns the home. The age 65 or older homeowners (or their surviving spouses 55 years of age or older) also may transfer the percentage of school tax paid, based on their former home's school tax ceiling, to a new home.

If you're a disabled veteran who receives from the Veterans Affairs (VA)—(1) 100 percent disability compensation due to a service connected disability and (2) a rating of 100 percent disabled or a determination of individual unemployability, you are entitled to an exemption from taxation of the total appraised value of your resident homestead. A surviving spouse does not qualify.

#### Do I have to apply each year?

No. If you had a homestead exemption on your home in 2009, you won't need to reapply for 2010 unless your chief appraiser requires it. However, if you haven't received an exemption on your present home—or if you've moved to a new home—you'il need to file for an exemption for 2010. If you are 65 this year, you may file for the age 65 or older exemption up to one year after the date you turned 65. And if you became disabled, you need to file for the disabled person's exemption.



## "Productivity appraisal" may lower the property taxes on your farm, ranch or timberland!

Texas law allows farmers, ranchers and timber growers to pay property taxes based upon the "productivity value" of their land rather than on market value. This means qualified land is taxed based on its ability to produce crops, livestock or timber—not on its value on the real estate market. And it can mean substantial property tax savings.

#### When is the application deadline?

If your land has never had a productivity appraisal or you are a new owner, you must apply to your local appraisal district by April 30 to take advantage of this benefit on your 2010 property taxes. You may get up to 60 extra days if you have a good reason and ask for it by April 30. If you miss this deadline, you may still be able to apply, but you will pay a penalty. Check with your appraisal district office.

#### Do you need to reapply annually?

If your land already receives agricultural or timber productivity appraisal, you normally don't need to reapply unless the chief appraiser requires you to do so. If a new application is required, the appraisal district will notify you by mail.

# SPCAA award to assist migrant farmworkers in Lynn, other counties

(AUSTIN) — The Texas Department of Housing and Community, Affairs (TDHCA) has announced a \$125,000 funding award to a Levelland-based regional nonprofit organization working to reduce the number of migrant farmworker households living in poverty and helping them transition to-

ward greater self-sufficiency.

The South Plains Community Action Association (SP-CAA) will use the award to develop outreach activities with local organizations to increase the awareness among migrant farmworkers of services available through SPCAA, including child care, transportation, medical referrals and related services. SPCAA serves low income clients living in Bailey, Cochran, Garza, Hockley, Lamb, Lynn, Terry, and Yoakum counties

"Helping Texans achieve self-sufficiency is the first priority of the Community Services Block Grant (CSBG) Program and a critical component of the Department's charge," said Michael Gerber, TDHCA Executive Director. "To achieve this, we will work closely with South Plains to address the unique needs of migrant farmworkers, while seeking creative ways to further our shared mission of reducing poverty and helping

more individuals achieve independence."

The award was part a special \$955,000 discretionary fund award under the CSBG Program and represents a portion of the state's \$30 million annual allocation from the federal government. In addition to SPCAA, other entities receiving an award were Hidalgo County; three regional nonprofit organizations serving Dallas/Fort Worth, South Central Texas, and far West Texas; and three statewide organizations providing homelessness services or assisting other nonprofit agencies through training and research.

The CSBG Program assists households earning no more than 200 percent of the federal poverty guideline, which equals an annual income of \$44,100 for a family of four. Funding for the program comes from the U.S. Department of Health and Human Services and supports a variety of direct services in addition to helping maintain the core administrative elements of

Unlike most of the Department's funding programs, CSBG Program awards are not made through a competitive allocation process. Eligible entities are designated by the Governor to provide a broad range of services designed to eliminate poverty and foster self-sufficiency within a specific service region, and each agency receives a direct allocation from TDHCA based on a distribution formula.

However, the \$955,000 in discretionary awards were made through a competitive process open to all CSBG eligible entities in Texas, with the Department selecting the eight strongest applications for funding.

# State to begin accepting reservations April 5 for "Texas Trade Up" appliance rebate program

Texas Comptroller Susan Combs encourages consumers to sign up early to receive rebates on selected Energy Star appliances purchased during the Texas Trade Up appliance rebate program April 16-25. Approximately \$23 million in federal stimulus funds are available for the rebate program.

Beginning April 5, a toll-free phone number and an online reservation system will be available for Texans to reserve an appliance rebate. When all of the guaranteed rebates are reserved, consumers may continue to sign up for a waiting list to receive rebates on a first-comefirst-served basis. Consumers must give their name, address and appliance type when making a reservation.

Consumers must be on the guaranteed rebate reservation list or the waiting list to be able to print or receive the forms they will mail in to claim rebates. To be eligible for a rebate, a qualifying appliance must be purchased between April 16 and April 25. Consumers will have 60 days from the reservation date to install appliances and submit their paperwork for the rebate. Appliances must be purchased by Texas residents at stores located in Texas.

As further details on the reservation and mail-in rebate systems are finalized in the next few weeks, a new Web site, www.texaspowerfulsmart. org, will become the one-stop resource for information and reservations.

Flat rebates will be available for consumers who buy certain Energy Star certified appliances and replace the same type of functional old appliance, with an additional \$75 rebate for recycling the old appliance.
