Fire does damage ... Cause of the fire was undetermined, according to the City Fire Marshal.

New houses under construction will be free for homeowners

Two new houses currently being constructed in Tahoka will be free to the homeowners when finished, through a grant program sponsored by South Plains Community Action and the Texas Community Development Block Grant program through the Texas Department of Housing and Community Affairs. Lucy Zuniga and

Gregoria Paniagua are the lucky homeowners who will be getting the new houses, at a cost that few homeowners ever get: absolutely free.

Four homeowners in Tahoka have qualified to date for the new housing projects, and city officials anticipate one more house will be approved if the homeowner can meet requirements.

"The City of Tahoka facilitated

the TCDB grant projects, but they are administered through SPAG, and the homeowners who applied must meet strict criteria guidelines," said City Administrator Jerry Webster. "SPAG hosted the initial meeting that homeowners who were interested in the program could attend to learn about how the program works. Criteria included age requirements (elderly), low income homeowners who lived in substandard housing but owned their homes out-

right and were current on all taxes, as (See NEW HOUSES, page 5)

Good News: **Tahoka gets** nuisance rating

City officials received word this week that the Texas Water Development Board (TWDB) field investigation of Tahoka city water lines last week has prompted a "nuisance" rating that is good news for Tahoka - whose citizens already knew that the city waterlines were a nuisance.

"This is terrific news for Tahoka," Mayor John Baker told The News. "I received word from the project leader that the 'nuisance' rating means that we would get 100% of grant funding for the planning, acquisition and design portion of the project," he explained.

Mireya F. Loewe, EDAP (Economically Depressed Area Programs) Project Lead for the Texas Water Development Board, notified Baker that she would like to present the city's grant application at the May 3 board meeting, at which time the board will vote on whether to approve the grant.

Baker said that representatives from the TWDB visited Tahoka last Wednesday and Thursday, inspecting all city pump stations, in-ground storage facilities, and other aspects of the city's antiquated water system.

"We covered the entire city, so they could get an overall impression of the entire system and evaluate the inadequacy of the loop system here," said Baker. "They saw the problems with the water pressure that could cause lack of fire protection for the city, and basically they evaluated the entire system. It was a thorough investigation," he added.

The city has applied for a \$2.7 million grant through the EDAP program to reconstruct new water lines throughout the city.

"We are very hopeful that the board will approve the city's grant request, especially with the 'nuisance' rating that will help our project proposal," said the mayor.





THIS SUNDAY at 2 a.m. everybody is supposed to reset all their clocks an hour later (to 3 a.m.) and then you can finally go to bed. Actually, most people will set their clocks forward Saturday night and go on to bed at their usual time.

This happens twice a year, in March (Spring forward), and again in November (Fall back-time to set the clocks back an hour).

Daylight time is one of the dumbest things we observe, and we should stop it. The whole concept started in World War I and was renewed during World War II, with the idea that it would save energy for war production by taking advantage of the later hours of daylight between April and October (that period has now been extended on both ends to March and November). Between the wars and after WWII, states chose whether or not to observe Daylight Saving Time.

The whole idea of DST is to save costs of fuel and energy by reducing use of power by businesses during daylight hours. However, nobody has ever been able to show that any costs were saved.

There are five U.S. states or provinces that do not observe Daylight Saving Time. They are Arizona, Hawaii, Puerto Rico, the Virgin Islands and American Samoa. These places should be commended for not messing with the clock.

I wish Texas would opt out of the time change every six months or so. Just decide on standard or daylight time and stay there. Or, if people can't agree on which one, just compromise and split the difference, setting all Texas clocks a half hour ahead of standard time and leaving it that way forever.

That way, nobody would ever know what time it is, and we could all have excuses for being late or early.

Three more file for local elections

Three more candidates added their names to election lists during the past week, as the deadline approaches on Monday for the May 14 city, school and hospital district elections. Candidates have until the close of business on Monday, March 14 to file. No races are contested as yet, and only three of eight entities have full slates of candidates for the terms up for election.

During the past week, Sharon Isham filed as the first candidate for two seats on the Lynn County Hospital District Board of Directors, Shannon Ash Frankl filed for a council seat with the City of O'Donnell, and Helen Stephenson filed for reelection to the Wilson City Council, the only candidate in that election to date, with three council seats up for election. With Frankl filing in the O'Donnell City election, there is now a full slate of candidates for three council seats in O'Donnell.

Tahoka ISD has three candidates for three positions on the Board of Trustees, and the Tahoka city election is also full with a mayor and two council members seeking reelection.

O'Donnell ISD has only one candidate to date for two trustee

No information was available from Wilson ISD as to whether any candidates have filed for two school board positions. No candidates have filed in New Home for the two councilmen and mayor position in the City of New Home.

4JL Raider Run set here April 2





Driving violations result in jail time

Several persons were jailed during the last week on violations related to driving, including one arrest made by Tahoka Police who stopped a vehicle with an expired inspection sticker. They then learned that the driver, a 34-year-old Lubbock man, had his license suspended, and also had no liability insurance on the vehicle.

On March 3, a Wilson woman told sheriff's officers that a 20-year-old Slaton man had threatened her daughter and grandchild with a firearm. Deputies then learned that the man was in jail in Lubbock on another charge. Investigation is continuing.

On Sunday a 38-year-old Wilson man was arrested on a warrant for assault and jailed on a total of six charges, including resisting arrest and giving false information, and possession of marijuana and drug paraphernalia.

Of the total of 21 persons in Lynn County jail early this week, 17 were jailed in the last week, on these charges: Two for driving while license invalid, and two others for driving without a license, with one of those also charged with no liability insurance and family violence/ assault causing bodily injury. Other charges bringing arrests included criminal trespass, possession of marijuana and drug paraphernalia, criminal non-support, failure to change vehicle registration, public intoxication, bail jumping and failure to appear, theft by check, three persons for bad checks, two counts of speeding plus two counts of failure to appear, truancy, unapproved glass coating, assault plus evading and resisting arrest plus failure to identify fugitive, and failure to identify giving false information.


Tahoka ISD hosts golf tournament

Comparing crop profits workshop slated March 15

Comparing projected profits from various crops will be the focus of a Texas AgriLife Extension Service workshop slated for 9 a.m. until 3 p.m. on Tuesday, March 15th, at Lubbock at the Texas AgriLife Research and Extension Center located at 1102 East FM 1294.

"Our objective is to provide producers the tools, data and skills to evaluate the potential profitability of alternative crops," said Dr. Jackie Smith, AgriLife Extension economist at Lubbock.

Printed workshop proceedings, crop budgets and a CD of Excel crop budgets, break-even tables, reference files and Internet links will go to workshop participants.

"We have designed the support material so producers can use the spreadsheet on their own computers," Smith said. "We urge producers with laptops to bring them to the workshop."

Smith said the Excel spreadsheet also allows users to examine the impact of different
crop-share rental or cash-lease
arrangements on the landlord
and renter's net income. Other
topics will include input price
trends and projections for 2011
along with basis, cash contracts
and forward-pricing tools using
futures and options. The workshop is funded by a grant from
the Texas State Cotton Support
Committee.


"Once we close on the paperwork, we submit it back to the state and then it takes the state about 30 days to give the final approval," said Webster.

"We don't start demolishing their old homes until we get final approval from the state," he

Once the homes are finished, the homeowners must meet other requirements, such as keeping taxes current and providing proof of insurance for at least five years, Webster said. After five years, the home is theirs free and clear.

"These two ladies whose homes are currently being built are very excited, and their families are too," said Webster. "I think it is great that they will finally have nice homes to live in, homes that should also have lower utility bills since they will be energy efficient.

"This is really a great program, and one that we will apply for as many times as we can," said the City Administrator. "Tahoka has a lot of elderly homeowners that meet the requirements, and this is just too good of a program not to take advantage of."



August 18, 1922

Bathing of Both Sexes Stopped at Brownfield

Brownfield, Tx, Aug. 27 --A mass meeting was held Saturday to protest against the use of a bathing pool by men and women at the same tine. A committee had previously conferred with the proprietor on the matter, and he agreed that if the majority of the citizens wanted separate days for the sexes, he would agree to place the rule in force; otherwise he would continue as before.

Eighty citizens attended the meeting, and voted almost unanimously for the change...

Old Stokes Hotel Destroyed By Fire

Fire broke out in the Lynn Hotel in Tahoka Sunday afternoon, and the building and contents were a total loss. The hotel was owned and conducted by C.A. Miller, and valued at \$7500.00; insurance \$4000.00.

The fire originated in a bedroom on the second floor and the flames quickly spread to the roof, which made it hard for the fire department to fight. The wind was in the east and this was in favor of the firemen in keeping the flames from spreading to adjoining buildings.

Craft's Tailor Shop, which is located on the lots north adjoining the hotel, was badly damaged and it looked for a time that it too would go up in smoke, also the Anchor Filling Station was in danger of being destroyed for a time, although both of these buildings were stucco structures

A few weeks ago [in 1930] our columns carried a news story about the car of District Attorney T.L. Price becoming

ignited and burning up on the highway a few miles this side of Seagraves.

But another story, which we did not get at the time, has leaked out and Price has "fessed up" to the whole af-

It seems that exercising

the right given him by the law and the precaution which a wise man should take in these days of hi-jackers, Price had slipped a big .44 into the side pocket of the new Buick. When he discovered that the car was afire, he jumped out of it and began jerking off one of the front tires in an effort to save as many of the accessories as possible, keeping one eye skinned in the direction of the gas tank in the meantime with a view to absconding as soon as an explosion might seem imminent. "Bang! bang!," went the

gun, and a bullet or two whizzed by Price's left ear. He "lit out" across the terrain in a seeming effort to overtake the bullet. When he came to himself he was over behind a sand bank 30 or 40 yards from the burning vehicle. Hearing no further report, he finally decided to peep over the sand bank and find out what was doing. He had scarcely gone over the top when that .44 got busy again. Price says he doesn't know how many shells exploded but it sounded to him like a regular bombardment from the whole Hindenburg line, or some such battlefront. Not having a speedometer attached to his person he doesn't know just how many miles per he made during the next few seconds, but when he again regained consciousness he found that it was a long, long walk back to the ruins of his car.

He finally recovered the gun, but had to catch a ride back to Tahoka.

"The High Plains Water District has used water well-spacing as a means of managing groundwater since the 1950s. However, dwindling surface water levels in area reservoirs and other contributing factors have caused more dependence upon groundwater in our region. Because of this, the district cannot rely on well spacing alone-it must move forward with implementation of its "50/50" groundwater management goal of having 50 percent of the saturated thickness of the Ogallala Aquifer in 2010 available in 2060 to conserve the resource," said Jim Conkwright, High Plains Water District manager.

The Board of Directors strongly encourages residents to attend these meetings and provide input on proposed rules impacting future groundwater production within the district. Persons may provide oral comments at meetings or submit written comments to the High Plains Water District office, 2930 Avenue Q, Lubbock, TX 79411-2499. Deadline for written comments is 5:00 p.m. on



Direct and countercyclical payment signup ends June 1

Rodney Schoppa, Executive Director of USDA's Farm Service Agency in Lynn County reminds producers that the deadline to sign up for the 2011 Direct and Counter-cyclical Payment (DCP) program is June

Payments are calculated using base acres and payment yields established for each farm. Eligible producers receive direct payments at rates established by statute regardless of market prices. Advance payments of 22 percent on the 2011 DCP program will be available starting December 1, 2010. The remaining 78 percent of the DCP payment will be issued after October 1, 2011.

Counter-cyclical payments vary depending on market prices, and are issued only when the effective price for a commodity is below its target price (which takes into account the direct payment rate, market price and loan rate).

"It is important that producers submit their DCP contracts before June 1, 2011 because applications will not be approved after this date," said Schoppa.

Producers can fill out a DCP contract at any USDA Service Center or online. To access the online service, producers must have an active USDA eAuthentication Level 2 account. To get a Level 2 account, producers must complete an online registration form at http://www.eauth.egov. usda.gov and then visit the local USDA Service Center to verify their identity.


