

The Texas Legislature has ignored my suggestion for several years, so I doubt they will do anything so sensible any time soon. But it would sure be nice not to have to mess with our clocks twice a year for no valid reason that I can think of. It originally was set up to save daylight time (and, I suppose, more electric power) during World War II, an ancient conflict fought during the youth of people now mostly deceased or writing newspaper columns.

I just wish they would leave it alone, and I don't really care if it stays on standard or daylight time. An alternative would be to move to Arizona, which stays on the same time all year.

Actually, I wish some kind of law would be passed allowing everyone (who wants the option) to set the clock back 40 years, when life was better for most of us (at least health-wise), except maybe for those who would not yet be born.

Okay, so we had our chance and mostly blew it. But I still wish the government would leave our clocks alone.

I may ask the Lynn County commissioners to pass an ordinance making the official time in the county just 30 minutes earlier than it was before last Sunday.

That kind of ordinance would probably get us mentioned on Good Morning America.

now set for Nov. 28-Dec. 15

The filing period for candidates interested in filing for the Republican and Democratic Primaries, including six Lynn County offices, has been delayed from the original opening date of Nov. 12, and is now set to open on Monday, Nov. 28, according to information received this week from the Lynn County Clerk's Office. Not only is the filing date delayed (originally set Nov. 12-Dec. 12), but the time period is actually shortened by about a week, now set for Nov. 28-Dec. 15.

The filing date was changed last Friday, Nov. 4, when a three-judge panel in San Antonio issued an order that significantly alters deadlines for candidate filing and other county election procedures for the upcoming March 2012 primary elections.

Although the court order is the result of legal challenges to Texas' legislative and congressional redistricting plans adopted by the 82nd Legislature earlier this year, it affects county offices as well. There are numerous plaintiffs in the ongoing case, Shannon Perez et al. vs. State of Texas.

Local county offices on the ballot in the March Primary elections include the positions of Sheriff, County Attorney, Tax Assessor/Collector, and Commissioners for Precincts 1 and 3, as well as the unexpired term for County Treasurer. Filing fee is \$750. Potential candidates must first come to the Lynn County Clerk's office to file their appointment of a campaign treasurer, and then must file as a candidate for the office with the respective county party chairman of the party in which they choose to run. The Lynn County Republican Party Chairman is John Baker, phone 789-1257, and the Lynn County Democratic Party Chairman is Rosalinda Guiterrez, phone 561-2233 or 559-5258. Terms of office for county offices are for four years, and the unexpired term for treasurer is for two years.


Additionally, the office of District Attorney for the 106th Judicial District, which includes Lynn, Gaines, Garza and Dawson counties, will be on the March Primary ballot. Candidates interested in filing for the DA office must file with the State.

Primary elections will be held March 6, 2012, and the General Election will be held in November 2012.


FBC youth group seeks odd jobs to raise funds







In Lynn County, 9.4 percent of all income comes from Social Security, says experts

Academy of Social Insurance. If Lynn County residents didn't receive their monthly payments from the Social Security Administration, 9.4 percent of total personal income in the county would be lost, a total of \$15,490,952 in 2009.

Lynn County is more dependent on Social Security payments than is the rest of the country. Nationally, 5.5 percent of total personal income in 2009 came from

mist at the University of Missouri, explained that Social Security payments help generate the sales that keep a rural business afloat.

"We find that Social Security income can be the difference between success and failure for some local businesses," Stallmann said. "If you took away, say, 10 percent of the demand, would that local business be able to remain open? Often it's that 10 percent that keeps them going. Social Security is providing that margin."

Social Security payments go to those over the age of 62 who have filed for benefits, to survivors of insured workers and to those with disabilities. The program is mainly funded by payroll taxes. In Lynn County, 69.4 per-

are being discussed in Congress, which is looking for ways to balance the larger federal budget. If benefits are cut - or if the eligibility age is increased - rural counties and small cities would be disproportionately affected, according to Peter Nelson.

"Cuts would have a bigger negative impact on rural places, absolutely," Middlebury's Professor Nelson said. "They are more dependent on Social Security."







Non-insurable Crop Disaster Program deadline nears

Lynn County USDA Farm Service Agency (FSA) Executive Director, Rodney Schoppa urges producers who want to purchase coverage through the Non-insurable Crop Disaster Assistance Program (NAP) to do so before the sales closing date of December 1, 2011.

NAP provides financial assistance to producers of non-insurable crops when low yields/ grazing loss, loss of inventory or prevented planting occur due to normal disasters.

The following crops have a NAP application closing date of Dec. 1, 2011: grazing and forage/hay on native and improved grass, honey, potatoes, radishes, grapes and cranberries.

"Purchasing a crop insurance policy is an easy way for producers to practice risk management," said Schoppa. "The 2011 crop year has proved that natural disasters can directly affect the profitability and recovery of ag operations," he said.

In order to meet eligibility requirements for NAP, crops must be non-insurable, commercially-produced agricultural commodity crops for which the catastrophic risk protection level of crop insurance is not available. In the event of a natural disaster, NAP covers the amount of loss greater than 50 percent of the expected production based on the approved yield and reported acreage.

Eligible producers can apply for coverage using form CCC-471, "Application for Coverage." Producers must file the application and service fee by the Dec. 1st deadline. The service fee is the lesser of \$250 per crop or \$750 per producer per administrative county, not to exceed a total of \$1,875 for a producer with farming interests in multiple counties.

TxDOT removing nighttime/ truck speed limit signs

The Texas Department of Transportation (TxDOT) has begun work to remove the 65mile per hour nighttime speed limit and all truck speed limit signs on Lubbock District road-

ways. House Bill 1353, which took effect on September 1, eliminated the 65-mile per hour nighttime speed limit and all truck speed limits on Texas roadways. TxDOT awarded maintenance contracts in August for the removal of the signs.

"Recently, contractors began removing 950 nighttime and 1050 truck and truck nighttime speed signs in the Lubbock District's 17 county area," said Doug Eichorst, P.E., Lubbock District Engineer. "This should be a relatively fast moving operation and we anticipate that it will take approximately four weeks to remove all the signs in

our district."

Work crews began the sign removals in the district's northern counties (Hale, Swisher and Castro) and will work their way south. Motorists are asked to drive with caution through the various work zones, be on the lookout for workers and avoid distractions for their own safety and the safety of the workers, Eichorst added.

HB 1353 legislation has also allowed TxDOT to create a 75-mile per hour speed limit on any state highway found to be reasonable and safe through a speed study. TxDOT will be reviewing existing 70-mile per hour speed limits to determine where a 75-mile per hour speed limit may be safely posted. The complete evaluation of the state

Sudden infant death syndrome (SIDS) is the silent killer : that haunts every parent's nightmare. Fortunately, since 1992, research shows there's been a 50% decline in the rate of SIDS cases due to heightened awareness of the need for babies to sleep on their backs rather than on their stomachs. Unfortunately, there are still about 4,500 babies under age 1 who die unexpectedly in their sleep each year.

The most shocking part? Most of the babies who die of-SIDS have no apparent health problems, says Katie Sanders, M.S.N., RN, assistant professor of nursing at Texas A&M Health Science Center.



Book recounts life experiences of former Tahokan, Lisa Ramirez

A new book is currently available at the City/County Library in Tahoka, which recounts the life experiences of Dr. Lisa R. Ramirez, a former Tahoka resident and TISD teacher/asst. principal who is now the national director of the Office of Migrant Education in Washington, D.C.

"Dulcified: Sweetened by the Education of Life" by Lisa R. Ramirez, Ed.D., is an autobiographical account of her life, from her experiences as a child with a family who followed migratory work in the fields and how she overcame the obstacles of life.

"This beautiful book offers an autobiographical account of extreme resiliency, as Dr. Lisa Ramirez recounts her early childhood experiences facing brutal instances of neglect and abuse at the hands of those that should have offered love, comfort and protection. Further, she shares her own failed attempts at pursuing a basic education, while lacking the bare necessities of a home, food, and positive relationships-all supposed requisites for survival and thriving in an educational setting," said Rachel Crawford, Ph.D., Educational Research and Policy Analysis, who wrote a forward in the book. "As you read her narrative,

you will come to understand why hers is indeed a beautiful story. You will gain a deeper understanding of resiliency, and the major difference that educators (and all of us as human beings, for that matter) can make in the lives of children, even through seemingly insignificant actions. You will learn that Dr. Ramirez does not disclose her life's story simply to titillate the reader, attract attention or expose perpetrators. Rather, her motivation is one of compassion, as she attempts to illustrate

for others (young and old) who might be suffering and mired in dismal situations, how life can be dulcified through God's mercy, the compassion of others, and a competent education," added Crawford.

Dr. Ramirez started attending Tahoka schools when she was in fifth grade but left and returned numerous times due to migratory work. She graduated from Slaton High School in 1988. After earning a degree, she taught at Tahoka ISD from January 1993-May 1996, and Slaton from 1996-1999. She was assistant principal at TISD from July 1999 through June 2003.

Family members in the Tahoka area include the late Amalia Arausa, the late Mike and Janie Arausa, Jesse Arausa, the Dan and Lupe Garcia family, Melissa, Cynthia, and Edward Ramirez, and Margie Ruiz. Dr. Ramirez is currently

assigned to the United States Department of Education in the Office of Elementary and Secondary Education as the national director of the Office of Migrant Education in Washington, D.C. She is also a private speaker, consultant, and educator.

Her experiences include working with high-risk populations that include minority, EL, economically disadvantaged, special education and migrant students. Dr. Ramirez received her doctorate in Educational Leadership from Texas Tech University and her certifications include English, Spanish, English as a Second Language, Mid-Management and Superintendent. She is also an alumnus of the John F. Kennedy School of Government at Harvard University.

Her presentations have been made nationwide to a variety of audiences that include: universities, school board associations, teacher organizations, school districts, school campuses, youth groups, parent groups, leadership summits, service organizations, cultural competency workgroups, church and community organizations, atrisk retreats and research associations.


