Polls to open Saturday for City/School elections

Voting polls for the Saturday, May 12 city and school board elections will be open from 7 a.m. until 7 p.m. at various locations, depending on the election. Early voting ended May 8 for all elections.

Both the City of Tahoka and Tahoka ISD elections will have one polling location, at the Life Enrichment Center at 1717 Main Street. The city election is for residents who live in District 2 only, but the Tahoka ISD election is for all registered voters in the school district, for two at-large trustee seats.

The City of Tahoka has one contested race on the ballot, with incumbent Ronny Jolly and Max Mendieta III seeking the District 2 city council seat, and there are four candidates for two at-large seats on the Tahoka ISD Board of Trustees. Incumbents John Hawthorne and Cathy Box are challenged by candidates Heath Brewer and Aaron McCleskey for the two school board positions.

The Wilson ISD election will be held at Wilson City Hall, but the City of Wilson canceled their election with no contested races. Three candidates are vying for two seats on the Wilson ISD Board of Trustees, including incumbents April Moore and Daniel Clark, and candidate Anissa Purswell.

No election will be held for the City of O'Donnell due to uncontested races, but O'Donnell ISD has a contested race, and polls will be open at the O'Donnell High School Commons area. Four candidates for two seats will be on the O'Donnell ISD ballot, including incumbent Monty Hancock and candidates Mandy Stidham, Jessie Perez and Norma J Mecalco.

Lynn County Hospital District and the City of New Home also cancelled their election due to uncontested races. All candidates in the cancelled elections will be declared elected after May 12.

Early voting starts Monday for Primary elections

Early voting begins Monday, May 14 and continues through May 25 for the 2012 Primary Election. In Lynn County, early voting for both the Republican and Democratic Primaries will be conducted at one location, at the Lynn County Courthouse basement courtroom, during regular business hours. The courthouse is open 8 a.m.-12 noon and 1-5 p.m. Monday through Friday.

Voters must choose to vote in either the Republican Primary or the Democratic Primary, and should bring their voter registration cards which were recently mailed out (see related article on page 8 about possible problems with

Locally, there are two contested races, for 106th Judicial District Attorney, and for Lynn County Tax Assessor/Collector, and both will be decided in the Republican Primary. Incumbent Brian Kingston is challenged by Michael Munk for the DA seat that serves Lynn, Dawson, Gaines and Garza counties. Two candidates are vying for the Lynn County Tax Assessor/Collector seat, including Donna Willis and

Quaydene Caswell.

Other elections for county positions are all uncontested, and mostly on the Republican ticket, including Donnis Scott for County Attorney, Amy Schuknecht for County Treasurer, Keith Wied for Pct. 1 Commissioner, and Tom Mandry for County Precinct #4 Chairman. Sheriff Jerry D. Franklin is uncontested in his bid for reelection as Sheriff, on the Democratic Primary ballot.

The biggest issue on the 2012 ballots is, of course, the presidential election. Several state and national races are also on the ballots. On the Democratic Primary ballot, President Barack Obama is challenged by three other candidates, and there are eight candidates listed in the presidential race on the Republican Primary ballot.

The 2012 Texas Primary Election will be held May 29, and a runoff date (if needed) is scheduled for July 31. The General Election will be held in November 2012.

Dr. Steven Bonner, project coordinator, said that many of the finishing details inside the home were being completed early this week, including wood flooring, carpet installation, electrical/gas and insulation work. Brick work was completed last weekend, and it is anticipated that landscaping projects will begin next weekend. The interior of the home, however, is finished to the point that the Duran family can actually move in and begin getting their new home in order.

"We want to invite the community, and especially all who volunteered in any way in this project, to come to Sunday's ceremony to see how this project has come together," said Bonner.

Louis and Sylvia Duran, daughter Charlie and son Mikey, will live in the house. The project is named Butterfly Blessings for Laela Marie Duran in honor and memory of their 8-year-old daughter who died in a tragic house fire here in November 2011.





Tahoka Drug installing new light fixtures





June 1 is deadline for applications for 100-year family farms

AUSTIN - In continuing a proud tradition of honoring hardworking generations of Texas farmers and ranchers, Agriculture Commissioner Todd Staples has extended the deadline for families to apply for the Texas Department of Agriculture's Family Land Heritage (FLH) Program. The program recognizes family farms and ranches that have been in continuous agricultural production by the same family for at least 100 years. Applications are now due June 1, 2012.

"Through generations of hard work, perseverance and love of the land, these families have operated their farms and ranches for 100 years or more, making Texas a powerhouse of agricultural productivity," Commissioner Staples said. "This commitment to the land is the foundation on which Texas agriculture is built, and thanks to these families and their ancestors, the Lone Star State today stands as a recognized producer of the finest food and fiber in the world."

This year's Family Land Heritage ceremony will be held in the fall at the Texas Capitol in Austin and will recognize farms and ranches established in 1912 or earlier.

Eligible farms and ranches must still be owned and operated by the descendants of the founder, either through blood, marriage or adoption. At least 10 acres of the land must be in continuous agricultural production for the past 100 years or more. There is no cost to apply for the recognition.

To date, TDA has recognized more than 4,500 properties in 237 counties across Texas. Fayette County, with 151 family operations honored, has been recognized more than any other county since the FLH program began.

The Texas Department of Public Safety (DPS) is advising residents to avoid the summer rush at driver license offices across the state by renewing their license or identification card early or online. Residents can beat the rush and avoid longer lines during the summer the busiest time of year at driver license offices - by renewing their driver license or identification card before the summer begins. Residents who are eligible can skip the trip to the office completely by renewing their license or identification card online - or changing their address

- atTexas.gov. "Summertime is the busiest time of year at our driver license offices with more residents than usual renewing their driver license or identification card," said DPS Director Steven Mc-Craw. "These busy months typically lead to longer wait times for customers, so we're encouraging Texans to come in early to beat the rush or they can skip the trip to the office altogether by renewing online."

To be eligible to renew online, the expiration date on the card must be within one year. When a resident renews their card, the expiration date on the new card will be six years after the current card's expiration date, whether customers renew early or not.

Additionally, in order to renew online, the card cannot have been expired for more than two years. Requirements for renewing online are available at Texas.gov, the official website of the State of Texas. (Licenses must be renewed in person every 12 years, so an updated photo can be taken and eyesight tested.)

The renewal fee is the same for online, in-person, and telephone renewals.

Through Texas.gov, residents can also renew their vehicle registration, apply for a concealed handgun license, request a copy of their birth certificate or driving record, and link to additionalofficial state government websites. Customers may obtain a replacement driver license or identification card online if they are able to provide the 20-character code on the front of their current license or card.





Ag values are going up here's why

Property owners in Lynn County will receive notices of appraised value soon, and owners of agricultural land will most likely see an increase in ag values, according to information this week from Lynn County Appraisal District. LCAD is mailing appraisal notices on Friday, May 11, to all property owners in the county.

"Most taxpayers who own agricultural land will see an increase in ag values - that's the biggest change this year," said Marquita Scott, Chief Appraiser at LCAD. "Ag values are based on a five-year time period, and even though 2011 was a disastrous crop year, it will not be calculated in the ag schedule until the 2013 tax year," she explained.

The 5-year average for the 2012 tax year consists of 2006-2010. "The good news is, next year ag values will drop, and they will probably drop considerably, because the 2011 crop year will be added into the calculation," said Scott.

In Texas, the appraised value of agricultural land is based on a uniform appraisal method in which a land classification system is developed for each county using an average of the productivity value in that county for the previous five years. The appraised agricultural value is not calculated using a specific piece of property's actual productivity value; rather, specific pieces of property are put into categories within the classification system and given an appraised value based on that category.

The State Comptroller proyides each appraisal district with an appraisal manual that outlines the mandatory method for appraising agricultural land.

This manual, which has been adopted by the State Property Tax Board, states that "because appraisers cannot appraise each individual tract of land, they shall follow the provided method to determine the appraised valuation of land designated as agricultural land."

The appraised value of agricultural land is based on the classification of land and an average of productivity for the county, and not on individual productivity or individual characteristics of specific tracts of land. It would be impractical, if not impossible, to calculate the appraised value based on each specific land owner's productivity and/or other individual fac-

LCAD contracts with Pritchard & Abbott, Inc. to calculate Lynn County's agricultural land values. P&A uses several sources of information to calculate values, including the National Agricultural Statistical Service, USDA, Texas AgriLife Extension Service, FSA, NRCS, Federal Crop Insurance Corporation, Local Ag Advisory Board, and Lynn County Producer Surveys.

"Information is used to develop a Crop Budget using what is typical in Lynn County for each year in the study," explains Larry Womble, RPA with Pritchard & Abbott. "The Net to Land is developed by using the average gross income for a crop, less the variable expenses typically shared by a land owner and the fixed expenses (management, taxes, etc.) to determine the Net to Land each year," he

The Net to Land for the categories of Irrigated Crops, Dryland Crops, and Pasture Land is the 5-year average of the years

in the study.

"The Net to Land changes each year due to the adding of a year and dropping a year out of the study. For example for the 2012 tax year one of the best crop years and best prices in history is being added to the average, and the result is that the average Net to Land is higher. The result is higher productivity values for the 2012 tax year," said Womble.

Locally, Scott said, she cannot change ag values on individual farms, unless there is an error regarding the designation or classification of the land (such as dryland or irrigated land, pasture, or CRP land) or if acreage numbers differ from those reported.

'We just want land owners to know, up front, that when they receive their appraisal notices they are going to see an increase in their ag values for the 2012 tax year, and to understand why those values have gone up," said Scott.

She said that there are minor changes on real estate values, with some value changes in certain classifications of property, but nothing as significant as the increase in ag values. However, she indicated that mineral values will increase significantly due to the oil/gas drilling production in the county.

"The mineral values will increase significantly, which will impact the taxing entities in Lynn County," said Scott. "I did some quick figures that indicate an increase of at least 40% in mineral values for Lynn County, which will impact the effective tax rate."



Primary election affected:

Problem discovered with county's redistricting map; new revisions change some voting box precincts

A county official who discovered a problem with the newly approved Lynn County redistricting map may have saved the day for Lynn County voters.

New voter registration cards were mailed to Lynn County residents recently, after delays caused waiting for approval for new redistricting lines drawn for county commissioner precincts but now there is a problem. The map meets federal requirements but is incorrect according to state law. Some voter registration cards now have the wrong voting box number because some

research and options were considered, the new Lynn County precincts map was drawn, with the focus on meeting federal requirements for commissioner precinct lines, not on voting box precinct lines, which after the changes in commissioner precinct lines did not match up as before. Confused yet? The demographer and attorneys approved it. The citizens committee appointed to select the map approved it. County commissioners and the county judge approved it for submission to the justice department, who had the final authority. The U.S. Attorney General's Department of Justice approved it.

Now, with the Texas Primary coming up, and early voting starting next week, it has been discovered by county officials that a portion of the map is inconsistent with state law. The discrepancies are between commissioner precinct lines and voting box precincts, and that violates state law.

Apparently, the federal guidelines were met regarding population demographic constraints, but a state law that essentially says two county commissioner precincts can not be in one voting box precinct, was overlooked when the new boundsioner precinct. And in each voting box precinct, there has to be a location available for a polling place - a business location that allows access to voters. The map that was pre-

viously approved inadvertently had commissioner precinct lines overlapping in voting precinct boxes number 1, 6 and 9, and no one noticed until last

"This can't be blamed on any one person," said Lynn County Clerk Susan Tipton, whose office is in charge of elections in

noticed the discrepancy on the map. "Even the Department of Justice overlooked it and approved the map. But if we had not the problem at this point, and used those voting box precinct lines previously drawn, is possible

that the ballots in Lynn County could have

lenged, and I don't even want to think about the problems that would have caused," she added. "Now we just need to get it fixed, and fast!" she said.

A special meeting for Lynn County Commissioners was held Monday morning to adopt new election boundaries to coincide with redistricting for commissioner precincts, and commissioners unanimously approved resubmitting the revised map to the Justice Department for approval. The county's attorneys are working with the U.S. Attorney General's Dept. Of Justice, who has agreed to expedite the review process due to the upcoming primary election.

"The gist of it is, we had to redistrict commissioner precincts to comply with federal laws (regarding population figures), and that has been approved and is not changing," County Attorney Donnis Scott told The News. "But now the voting box precinct lines have been realigned to comply with state law, and that is what we are resubmitting. I don't anticipate any problems with the new map, because the Dept. of Justice has previously approved the commissioner precinct lines

ary lines were drawn within the city limits of Tahoka. An alert county official discovered last week that Voting Boxes 1, 6 and 9 incorrectly had precinct boundaries that included more than one commissioner precinct, which would have created problems with issuing the correct ballot to voters. She immediately contacted other county officials, attorneys and demographers involved in the redistricting process.

Here's the problem: There are 4 commissioner precincts, and 10 voting box precincts in the county. Those precinct lines have to converge at some point, to allow for each voting box pre-

New voter registration cards

Anyone whose card lists them in Voting Prec. No. 1 or 14 will need to visit with election officials to ascertain whether they remain in that voting precinct or if their address falls into a new voting precinct number.

> for portions of Voting Boxes 1 and 14 will be reissued as soon as possible, but won't be issued before early voting starts Monday. However, the new cards should be sent before the May 29 election day. Voter Registrar Sherry Pearce said that only a few residents in Tahoka (who reside between S. 2nd and N. 3rd in the area between Main Street and Ave. O) will receive another voter registration card

in the mail, and when they do they should dispose of the first card and keep the newly-mailed card. No changes will be made in voter registration cards outside that small area inside the city of Tahoka.

Tipton said that voters may bring their current voter registration cards to cast ballots in early voting, and that anyone whose card lists them in Voting Prec.

No. 1 or 14 (in the section below the Gender box on the left side of the card) will need to visit with election officials to

ascertain whether they remain in that voting precinct or if their address falls into a new voting precinct number. They will still be allowed to vote, but on election day may be directed to a different polling location if their number has changed.

To avoid delays, voters are encouraged to vote during the early voting period at the courthouse (May 14-25) to allow election officials time to check precinct numbers, and also because early voting for all voting precincts is at one location, at the courthouse basement courtroom.

"The county's attorneys are working with the DOJ to get the revised map approved in coming days. We want to assure Lynn County's registered voters that they will still be able to vote, and that the election process will be conducted according to all state and federal laws. But please have patience with election officials who may need to check your information to make sure which voting box precinct is correct," added Tipton.

At Monday's special session; commissioners also approved moving a couple of voting box locations for election day on May 29, moving polling place 6 from the TISD Gardner Building to the TISD Business Office at 2129 Main, and moving polling place 12 from the Tahoka Activity Center to the Trinity Church fellowship hall at 1929 Lockwood. A complete list of polling locations will be printed in The News prior to election day.

Lynn County Appraisal District Provides Public Information and ASSISTANCE

This is the time of year the Lynn County Appraisal District sends notices of appraised value. Lynn County notices will be mailed by May 11, 2012. Property owners will be mailed a notice as a result of any of the following circumstances affecting real property: if the 2012 proposed value is at least \$1000 more than the 2011 certified value; if the property owner has filed a timely rendition; if 2012 is the first year the property is listed in the appraisal records; if the property changed ownership during 2011; or if the property is a producing mineral interest. Notices will also be mailed to owners of taxable furniture, fixtures, machinery, equipment, vehicles, and inventory used in a trade or business.

Property owners who have questions, or want to discuss the value placed on their property should contact the appraisal district office. The legal deadline for filing a timely protest is thirty days from the date of your notice. Those who receive a notice in Lynn County have until June 11, 2012 to file a protest. If you believe the proposed market value of your property is incorrect, be sure to contact the appraisal district prior to your deadline. It is important to ask questions or call to our attention unusual facts about your property as soon as possible. In the case of value questions, property owners are urged to present conclusive evidence regarding the true market value of their property. Such evidence consists of closing statements, listing agreements, fee appraisals, income and expense statements, pictures, and surveys. Our goal is to treat all property owners in a fair and equitable manner; and this can best be accomplished when you provide evidence to us about your property as soon as possible.

The following publication is required by Section 41.70 of the Texas Property Tax Code.

Property Tax Protest and Appeal Procedures

The law gives property owners the right to protest actions concerning their property tax appraisals. You may follow these appeal procedures if you have

· the market or appraised value of your property

· the unequal appraisal of your property • the inclusion of your property on the appraisal roll

· any exemptions that may apply to you · the qualification for an agricultural or timber

appraisal

• the taxable status of your property • the local governments which should be taxing your property

· the ownership of property

· the change of use of land receiving special

any action taken by the chief appraiser, appraisal district or appraisal review board that applies to

and adversely affects you. INFORMAL REVIEW You may call (806) 561-5477 to discuss your protest with a CAD employee and try to come to a

settlement without meeting with the ARB. **REVIEW BY THE APPRAISAL REVIEW BOARD** If you can't resolve your problem informally with

the county appraisal district (CAD) staff, you may have your case heard by the appraisal review board

The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the CAD to make the necessary changes to solve problems. If you file a written request for an ARB hearing (called a notice of protest) before the deadline, the ARB will set your case for a hearing. You'll receive written notice of the time, date and place of the hearing. If necessary, you may request a hearing in the evening or on a Saturday or Sunday. Prior to your hearing, you may ask to review the evidence the CAD plans to introduce at the hearing to establish any matter at issue. The CAD might ask you for a copy of the evidence you plan to present. The law provides that before a hearing on a protest or immediately after the hearing begins, you or your agent and the CAD shall each provide the other with a copy of any written material intended to be offered or submitted to the ARB at the hearing. To the greatest extent practicable, the hearing will be informal. You or a designated agent may appear in person to present evidence or you may send notarized evidence for

the ARB to review at your hearing. The CAD representative will present evidence about your case. You may cross-examine the CAD representative. The ARB will make its decision based on the evidence presented. In most cases, the CAD has the burden of establishing the property's value by a preponderance of the evidence presented. In certain protests where the owner has submitted an independent appraisal before the hearing, the chief appraiser has the burden of proving the property's value by clear and convincing evidence. You can get a copy of a protest form from the appraisal district office at 1615 Main Street, Tahoka, Texas.

Note: You shouldn't try to contact ARB members outside of the hearing. The law requires ARB members to sign an affidavit saying that they haven't talked about your case before the ARB hears it.

REVIEW BY THE DISTRICT COURT OR AN ARBITRATOR OR SOAH

After it decides your case, the ARB must send you a copy of its order by certified mail. If you're not satisfied with the decision, you have the right to appeal. If you choose to go to court, you must start the process by filing a petition within 60 days of the date you receive the ARB's order. In certain cases, as an alternative to filing an appeal in district court, you may file, not later than the 45th day after you receive notice of the ARB order, a request for binding arbitration with the county appraisal district. In certain cases originating in certain counties, as an alternative to filing an appeal in district court, you may appeal to the State Office of Administrative Hearings (SOAH). An appeal to SOAH is initiated by, not later than the 30th day after you receive notice of the ARB's order, filing with the chief appraiser of the county appraisal district a notice of appeal with the applicable filing fee.

TAX PAYMENT You must pay either the amount of taxes due on the portion of the taxable value not in dispute or the amount of taxes due on the property under the order from which the appeal is taken. MORE INFORMATION


