

Lynn County Area Gins **BALE COUNT**

Area gins begin processing cotton

Lynn County area gins began processing cotton in October, as harvest season gets underway. Texas Star Gin, with plants in Wilson and Union, reported the first bale ginned on Oct. 2, from Lynn County producer Richard Bednarz, and this week reported a total bale count of 3,344 bales from the two plants. The News will begin reporting the weekly bale count this week, from eight area gins.

Serving Lynn County since 1903

New Home Coop-Lakeview gin officials reported their first bale on Oct. 10, from cotton brought in by the Clem Family, and a bale count this week of 479. Wells Coop Gin reported their first bale processed on Oct. 11, from cotton produced by Manuel Macias in Terry County, and on Oct. 12 Matt Taylor of Lynn County brought in cotton for the first bale processed at Farmers Coop Assn. #1 in Tahoka.

Last Thursday, Oct. 17, Close City Gin near Post and Grassland Coop

Gin processed their first bales of cotton. Ty Stark, a Lynn County producer, brought in the cotton to Grassland Coop Gin, and Garza County producer Ronnie Dunn was Close City Gin's first customer.

In O'Donnell, Woolam Gin reported Craig Taylor brought in cotton for the first bale processed on Oct. 18. Farmers Coop Gin in O'Donnell expects to begin ginning next week.

Lynn County growers planted over 334,000 acres of cotton this year, which would rank among the largest acreage of cotton for any county in the U.S. However, more than 153,000 acres were failed due to the drought and storms. With that large number of failed acres, many producers replanted to grain sorghum. This year there are more than 67,000 acres of grain sorghum in Lynn County, according to county agent Bryan Reynolds with Texas AgriLife Extension Service.

The South Plains Honor Flight is an opportunity for South Plains veterans to fly to Washington DC and see first hand the memorials built in their honor; some of them for the first time and sadly, some of them for the last time. Robbie Gill, a former longtime New Home area resident, now lives in Lubbock with his wife Wanda. His family encouraged him to join the Honor Flight for the opportunity to join with other veterans in ceremonies honoring their service to their country.

Gill's sons, Stan and Stacy, flew on a separate flight to accompany their father in the nation's capitol for the Oct. 16-18 event honoring veterans and their families who attended. They took part in wreath-laying ceremonies, including at the State of Texas station at the Atlantic Theatre of the WWII War Memorial, shortly following the wreath laying ceremony on Oct. 16. Robbie was among Veterans who assisted in the ceremony honoring those who died serving in the Western European theatre.

And most of my other fishing efforts were about that much fun, too.







Sundown hands Tahoka second district loss, 33-12

The visiting Sundown Roughnecks roughed up Tahoka last Friday, 33-12, the second straight loss in district play for the Bulldogs, who now are 3-5 for the year and 0-2 in district, with this week off before heading to Hale Center next week.

Sundown opened scoring last Friday in the second quarter when Chad Hodge ran 68 yards, but that feat was more than matched about 3 minutes later when Bulldog QB Trystan Hilger and receiver Isiah Vega teamed up on a sparkling 84-yard touchdown pass play.

There were three more touchdowns in the last 2 minutes of the wild second quarter as Sundown built a 20-6 lead and the Hilger-Vega combination clicked again for a 10-yard touchdown with just 4 seconds left in the half.

Tahoka did not score in the second half, and Sundown added two touchdowns in the fourth period to win the game.

Hilger completed 6 of 20 passes for two touchdowns, both to Vega, and 179 yards. He also was Tahoka's leading rusher, with 60 yards on 15 carries. Ke'Shawn Hood gained 43 yards on 12 carries.





A tailgunner aboard a B-17 bomber in World War II, he was the only survivor from a midair collision that took the lives of the rest of his crew during a mission on July 28, 1944 - Day 52 after 'Day Zero' as the troops re-

Robbie Gill of Lubbock never forgets a World War II B-17 bomber and the mission date of July 28, 1944. It is still vivid in his memory.

"We inherited the plane after we got over there," he remembers of the four-engine bomber that took off from England seven weeks after D-Day as part of the 8th Air Force Division's 350th Squadron.

Gill was the nine-man crew's

"Most of the 8th Air Force planes started home with very few casualties. But our route back was across Holland, and then the North Sea," Gill said.

'We began our descent and had reached 10,000 feet," he remembers.

The pilots, flying the bombers in formation, were ordered to reduce speed. The danger of enemy territory was behind.

He was told later by a crewman who was watching from another plane that his B-17 overflew the plane that was ahead and to the right. When they collided, the lower plane rolled, striking Gill's craft in the midsection with a devastating blow, and he was knocked unconscious.

"When I came to, there was absolutely no noise. No plane noise. It was deadly quiet," he recalls. Struggling to regain his senses, he removed himself from a pile of ammunition belts.

"I found my parachute, put it on and opened the escape hatch in the tail section." Gill looked down and could see a large fire on the water below. It was his plane's wreckage and that of the other plane they had collided with

The tail section he had been riding in had broken completely free from the rest of the plane. He dived out head first and burned his face with the shroud lines when the parachute opened.
