

staff, and community.



'The Ten Commandments' now faces O'Donnell ISD as community shows their faith with 7-foot tall sign

n O'Donnell, a community of less than 1,000 souls, there is a movement, initiated by school youth, of putting faith first in their lives. They wanted The Ten Commandments to be displayed at their school, but when the school was attacked with legal barbs aimed at removing the display, the students fought back. Not with anger, and not with lawyers of their own. Their weapon of choice was faith, and they used that weapon with love and a steadfast commitment to showing the world that they were strong in their beliefs. Hallways lined with hand-written scriptures on sticky notes, fervent posts on social media, and impassioned speeches at a public forum showed the O'Donnell community that their youth do, indeed, have strong beliefs for which they are willing to stand.

Last week, the adults in the community followed up with their own show of support of the students. A seven-foot-tall lighted sign bearing "God's Ten Commandments" was erected on private property facing the school, with unveiling ceremonies held just after school released on Wednesday after-

O'Donnell First Baptist Church's youth pastor, Casey Flynt, and pastor Taylor Wood. presided at the dedication ceremonies in front of OISD students, staff and community members.

Pastor Wood spoke about how the students and community were blindsided by an attack on the school's display of The Ten Commandments, and praised the youth for the way in which they faced the onslaught of media attention that followed.

"Our students responded with grace, hu-

mility and steadfast resolve of purpose," said the pastor. "They showed that although the words on the wall could be removed, you cannot remove their faith from their hearts," he added.

Flynt thanked the community for showing their support of the students by erecting the sign. "We also want to thank Tommy Woolam, who has really been the brains behind this endeavor, and John and Sharon Wells for allowing the sign on their property," said Flynt.

O'Donnell ISD had painted The Ten Commandments on a wall in their newly-renovated school, but a media fervor began over the issue after school officials received a letter in early September from the Freedom From Religion Foundation protesting the display.

The letter from the Freedom From Religion Foundation stated that "O'Donnell ISD (See A SIGN OF FAITH, page 6)





Criminal mischief, drug arrests made

Tahoka Police Department investigated reports of domestic violence and criminal mischief this week, and officers arrested two for possession of narcotics after a traffic stop for speeding.

On Sunday night, at about 10:45 p.m., Officer Josh Parrish was monitoring traffic on US 87 just south of Tahoka, and stopped a black Infiniti G35 sedan travelling northbound clocked at speeds of 86 mph in a 65 mph zone. During the stop, the officer noticed an odor of marijuana and a search of the vehicle revealed the drugs and drug paraphernalia. The male driver, 28, of Aspermont, was arrested on charges of possession of marijuana and possession of drug paraphernalia. A male passenger, 29, of Sweetwater, was found to have an active warrant out of Nolan County, and was also charged with possession of drugs and drug paraphernalia.

A Tahoka woman, 18 called police last Thursday afternoon, stating that someone had stolen some of her clothing and damaged a red 2002 Ford pickup that belonged to a friend that was temporarily parked at her home. She told officers that someone had apparently forced entry through the front door of her residence on Ave. E and stole all of her clothing that had been laying on the couch. The Ford F150 pickup, owned by Eloy Salas, 33, of Anthony, NM. was reported to have a broken front windshield and passenger side window. This investigation continues.

Last Friday, Tahoka Police responded to a report of an assault/domestic violence at a residence on Lockwood Street. A 19-year-old woman told offices that she was struck on her face by her boyfriend, 38, during an argument over child support, but did not want to press



Texas Tech edged Kansas State University by just three


points, 4,878-4,875, to claim the win. Oklahoma State University was third, followed by the University of Nebraska and Texas A&M University





infringes on its students' constitutionally protected religious freedom. By endorsing a religious message, the school district violates the Establishment Clause of the First Amendment. The Ten Commandments and bible (sic) verse must be removed ... To keep the display is to invite an avoidable lawsuit that the District cannot possibly win." The letter ended by requesting OISD to inform the foundation in writing of what action the District would take "to protect the right of conscience of its students and to respect our Constitution."

While school officials debated how to handle the situation, a large U.S. Flag was liung over The Ten Commandments display. Within a couple of weeks, however, school officials decided not to light the issue and painted over the display. Students, while understanding the legality of the controversy, remained dedicated to preserving their rights as well, voicing their protest of the removal of the biblical display.

This is absolutely student driven - this all came about because the students took the initiative and put up sticky notes with scriptures and The Ten Commandments on the walls of their school. And this is what has inspired the adults in our community to get this done," said Tommy Woolam, owner of Woolam Gin in O'Donnell and one of the leaders behind the

The idea for the sign actually began from a discussion between Woolam and some of the farmers visiting at Woolam Gin.

"We were sitting around drinking coffee in the gin office and discussing the Ten Commandments issue, and one of my farmers - Pat Childress said, 'Well, they may can stop us from showing it on school property, but they can't stop it on private property.' And that is really what got the ball going," Woolam told The News.

it' - it was a gut reaction, and we had nothing to back it up with really ... except, maybe, some faith," he stated.

Woolam said they commissioned the sign from a crew of Mennonites that had just finished a building project for

Woolam Gin. "The contractor on this sign project, John Siemens from Seminole, has been very gracious, letting us pay him as the money comes in - all the checks are written straight to him. He has an excellent crew of workers who are very talented - really, they are all artists at their work in my opinion - and we have been very impressed with these people," said Woolam.

The sign is approximately 7-feet tall by 4-feet wide, in black with gold letters in a powder-coated finish that won't rust, and lit with solar lights that have a battery with an inverter to provide very bright lights that stay on all night.

The sign was placed on private property across the street (west) from the high school parking lot, and it will be very visible to school students and staff as they come and go from school property.

"We had permission to place the sign in another location, but found another location that is are allowing us to place the sign there. We had a crew cleaning up the property before the sign was placed, and hopefully we may eventually tear down the house and build a small park there," Woolam explained.

There have been no fundraisers, no community dinners, no actual projects that raised the funds for the sign that cost \$8,000 to create. Instead, it has all been done from voluntary donations by word of mouth, and Woolam says he has been surprised at how quickly the word spread.

"I've had calls from out of the blue - from people as far away as Odessa and the Houston area," said Woolam. "One guy from Pasadena said he heard about it, and asked, 'How can I send a check? I am coming back to O'Donnell at Thanksgiving and I want to see that sign.' Another guy from Odessa called and said, 'I want to help with this ... I'll put in \$1,000.' I have been amazed, really.

"One of our guys here at the gin said, 'You know Tommy, you may have to put in more than you realize to get this done,' but I just had a gut feeling that yeah, we could do this. We have about \$4,000 already collected, and I feel sure we'll get there," said Woolam.

"So, now we've taken a negative situation and the school and community has turned it into a very definite positive," Woolam said. "I have not heard one negative word about this project - it's all been very positive. This whole deal is to tell people that we can do this if we want to - maybe not at school, but we can darn sure do it on private property where it can
