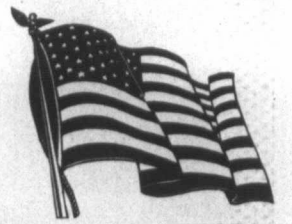

It's moving week! Lynn County Courthouse offices are moving out of the courthouse this week

All of the offices inside the Lynn County Courthouse are moving out this week, as the \$8.2 million restoration/renovation project for the historical building is beginning full-scale in April. The County Judge, County Attorney, District Clerk, County Clerk, County Treasurer and Probation Office are all in the process of relocating to new temporary offices for the duration of the project, estimated to be 18-24 months before completion. The entire courthouse building must be evacuated for the extensive renovation project.

Two offices – the County Judge and the Lynn County Attorney – are relocating to 1524 Harper Street, just one block north of the courthouse building. Their temporary offices will be located inside the former Jimmy Wright law office building, at the corner of Main and Harper St.

Three offices – the County Clerk, County Treasurer and Probation Office – are relocating to 1627 Ave. K, which is the former Huffaker & Green/James Craig law office building. The building is on the corner of Lockwood and Ave. K, across the street (south) from the First Baptist Church.

The District Clerk is temporarily moving in with the Lynn County Tax Assessor, in the county annex build-

ing at 1521 Ave. J, on the west side of the courthouse square.

"We are in the process of moving this week, and some of the offices may be closed at times later this week during the moving process," said County Judge Mike Braddock. "We hope to be open for business at our new locations on Monday, April 3," he added.

Lynn County Commissioners Court will be held at the County Judge's new office. However, the county has made an agreement with the Tahoka Housing Authority to have all sessions for District Court, County Court, Children's Protective Services court, and Attorney General court, to be held at the Tahoka Housing Authority center, at 1400 Ave. K. Anyone re-

ceiving notices of these sessions will also be notified of the new location.

It is anticipated that temporary security fencing will be placed around the courthouse during the renovation project, as work gets underway for restoring both the exterior and interior of the 101-year-old building. In addition, a new geothermal heating/air system is going to be installed for the courthouse, which will require the drilling of 64-85 wells on the courthouse grounds, mostly on the east and south sides. The courthouse will no longer be heated by the antiquated boiler in

the courthouse basement, although the boiler itself will be left in place as a historical artifact, and many of the original steel radiators will be left in the public areas of the courthouse for their aesthetic value. The geothermal system, which uses water in an underground pipe system, is expected to be much more energy-efficient for heating and cooling the courthouse.

Geothermal heating and cooling systems take advantage of the stable temperature underground using a piping system, commonly referred to as a

Fire destroys O'Donnell family's home

An O'Donnell family lost their home to a fire on Saturday, March 25. O'Donnell Volunteer Fire Department responded to a call at 4:33 a.m. to 514 1st Street. Mela Moralez and her three children reportedly escaped the home unharmed, but lost two pets in the fire, and the home and all of their belongings were completely destroyed. Red Cross was called to assist the family. According to representatives of the O'Donnell VFD, the cause of the fire was undetermined but believed to have been electrical. Thirteen members of the VFD worked the fire for approximately 5-1/2 hours, and returned again Sunday for smoldering debris.

"The O'Donnell VFD would like to remind citizens to please check your smoke alarms to make sure they are working, and if you don't have one we can install one for you," said a member of the department.

A benefit lunch for the Moralez family is being hosted this Saturday at the Nueva Vida Iglesia Bautista church at 702 Baldrige in O'Donnell, starting at 12 noon. Brisket dinners will be served. According to the O'Donnell VFD, the home was not insured.

The Lynn County Sheriff's Dept. received a call at 8:20 p.m. Saturday reporting that someone had been injured at the Llano Estacado gun range and had been transported to a Lubbock hospital for treatment. The gun range is privately-owned, located at 582 CR 1. According to the call sheet, the victim was reportedly hit with small shrapnel that bounced back off a target and hit the shooter.

A sexual assault was reported at 10:38 p.m. Sunday, involving an adult female. The Lynn County Sheriff's Office is still investigating this case.

At 6:27 a.m. Monday, the Sheriff's Office received a report of an armed person at a rural residence on Hwy 87, with a report of someone pulling a gun on another person. No injuries were

reported, and the gunman had already left the residence when officers arrived.

Monday afternoon, a caller reported that someone had butchered wild hogs and left the remains on his property and left other evidence of trespassing, at property located approximately 7 miles west of US 87 on FM 1317.

Last Tuesday at 2:25 p.m., a caller reported that a tractor hit a pole and powerlines were down, three miles east of Tahoka on Hwy. 380. Lyntegar Electric Cooperative was called to repair the powerline.

Tahoka Police arrested a 23-year-old Lubbock man at 2:53 a.m. Sunday after observing a white sedan driving erratically on Lockwood and failing to stop at a stop sign. When the officer pulled him over, the man told police that he was "highly intoxicated," and in fact was "that drunk to the point that he had left a bar in the depot dis-

trict in Lubbock and while attempting to travel to his residence in northwest Lubbock, ended up here." When the officer questioned him about where he was, the driver was unable to specify. He failed a battery of field sobriety tasks, and was arrested for Driving While Intoxicated, and issued two citations, for Disregarding Stop Sign, and Open Container. An inventory of the vehicle showed several items of drug paraphernalia, and an open bottle of liquor.

Police investigated two reports of criminal mischief during the week. Last Wednesday at 9:15 p.m. Gene Ingle reported that a vehicle had damaged his mailbox at 2117 Lockwood. The police report said the mailbox, which should have been on the west side of the driveway, was lying in the yard on the east side approximately 30 yards from where it had been mount-

ed. The hubcap cover to a vehicle was also nearby. A neighbor said he witnessed the incident, describing a dark colored older-model Oldsmobile traveling eastbound down Lockwood, that popped up on the curb, hit the mailbox with the right side of its front end, and continued eastbound along Lockwood without stopping.

A local woman told police that someone had damaged the back door of her residence at 2005 N. 6th St. sometime between 1:15 a.m. and 1:38 a.m. last Wednesday when she had left the residence. Nothing was reported taken from the residence.

Lynn County Jail held 42 inmates during the past week, including 19 for Lynn County and 23 for Ector County. Local charges included one for driving while intoxicated, one for possession of marijuana, and one for evading arrest/detention.

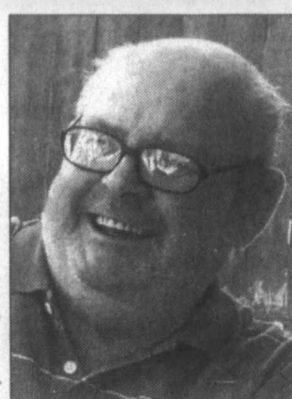

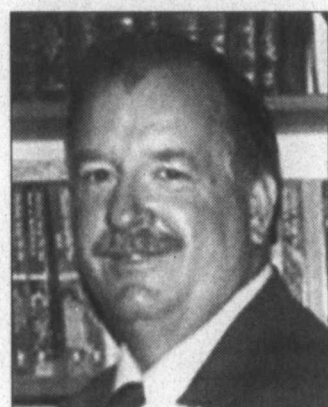
He was preceded in death by his parents and one sister, Beverly Carlisle.

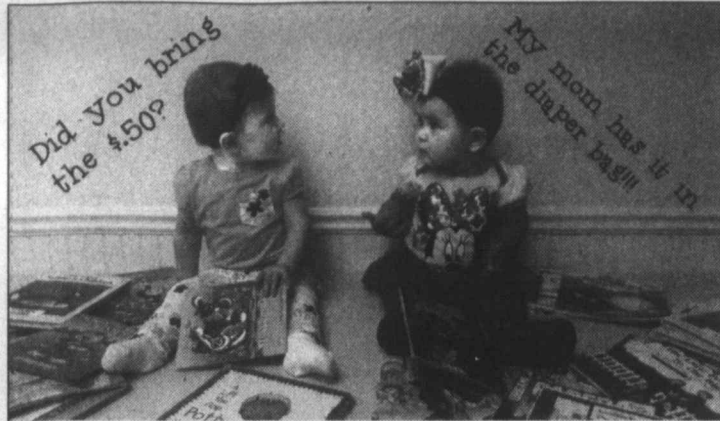

"loop." Water circulates in the loop to exchange heat between the building structure, the ground source heat pump, and the earth, providing geothermal heating, cooling, and hot water at what is considered remarkably high efficiencies.

Lynn County was awarded grant funding of \$4,878,857 through the Texas Historical Commission's (THC) Texas Historic Courthouse Preservation Program (THCPP) for the renovation project. The partial-matching grant requires Lynn County to provide additional funding as well.

As part of the grant application process, Lynn County officials had set aside nearly \$1 million in matching funds for the anticipated funding award, but the \$4.8 million grant is only 90% of the amount that the county requested, which means that the county needed some additional funds for the completion of the project. County Commissioners authorized the issuance of \$1,750,000 in Certificates of Obligation (COs) for the additional funding. The total cost for the project is anticipated at \$8.2 million.

The county contracted with Komatsu Architects to head the project, under the strict guidelines of the Texas Historical Commission. J.C. Stoddard Construction Co., a firm based in San Antonio, was named as Construction Manager At Risk (CMR) for the project, and subcontractor proposals are being considered next week. Actual construction work should begin in mid April.

The 1916 Lynn County Courthouse was designed by Amarillo architect William M. Rice in the Classical Revival style. The courthouse appearance has been significantly altered in the subsequent years

with numerous renovations, mostly in the interior. The project will restore the courthouse to its 1916 appearance, but will include important modernizations to address problems including an outdated electrical system and safety hazards posed by water intrusion. Important improvements and upgrades will be made throughout the entire building for security, accessibility, and code compliance.

To complement the restoration, Lynn County negotiated with the Texas Department of Transportation to return a segment of the courthouse square, completing the county's Re-square the Square campaign. This means that Main Street, which currently curves around the west side of the courthouse and turns into Ave. J when Main meets South 2nd Street, would end at South 1st Street at the north entry to the courthouse, thereby enabling the original courthouse square to include the grounds where the Armed Forces Memorial now stands.

The next Einstein?

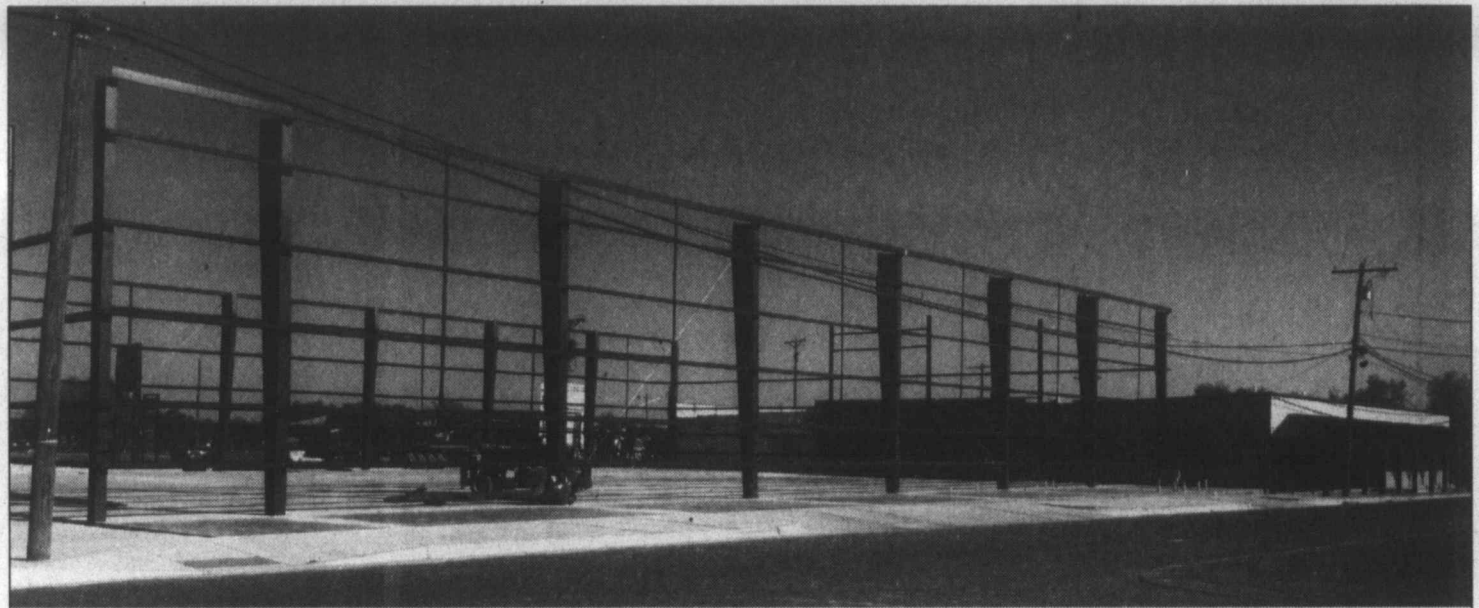

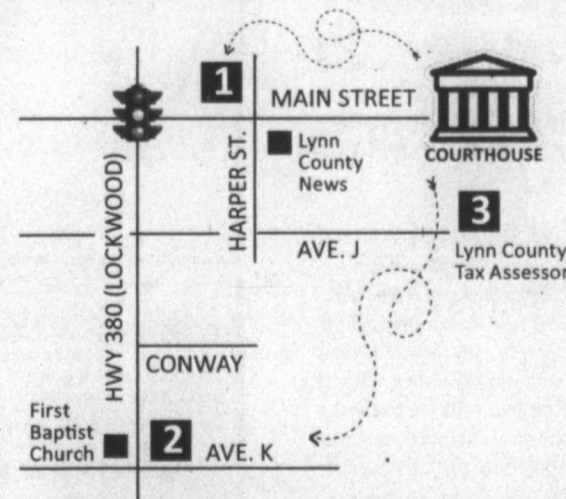

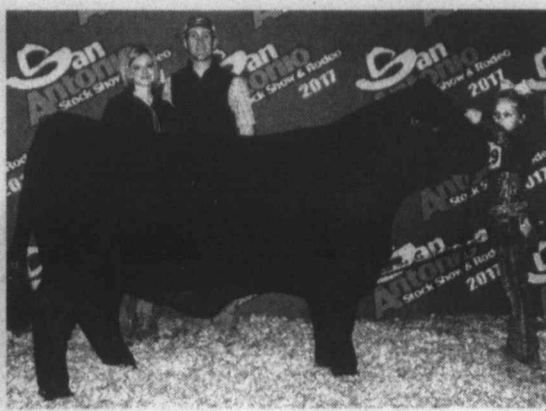

 Taxable property renditions are due April 15.

Does this apply to you?
 If you own tangible personal property that is used to produce income, such as the equipment or inventory owned by a business, it does.

What is a rendition?
 A rendition is a report to your county appraisal district that lists all of the taxable property that you owned or controlled on Jan. 1 of this year. This often applies to furniture, fixtures, equipment or inventory owned by a business.

What are the advantages of filing?

- You give your opinion of your property's value.
- You record your correct mailing address so your tax bills will go to the right address.
- If your property's value depreciated, you can file a report of decreased value.

What is the deadline?

- The last day for filing renditions is April 15.
- An automatic extension to May 15 is available if requested in writing by the April 15 deadline.
- The chief appraiser may grant an additional 15 days to an owner who shows good cause in writing.

REMEMBER!!
 Filing is your responsibility. If you render late, don't render, or file an incomplete or false rendition, you may face a 10 to 50 percent penalty.
