Gary Harrell named Interim Superintendent; Construction update given on bond project

Tahoka Independent School District met Monday night, with newly-elected trustee Blanda Watt taking the oath of office, and the Board of Trustees named Gary Harrell as interim Superintendent for TISD while the board conducts a superintendent search to replace Dr. George McFarland, who has officially resigned to accept a position elsewhere. A construction update on the bond project was also presented at the meeting.

It was a busy night for the TISD Board. Mrs. Watt was administered the oath of office, taking the seat vacated by Jim Bingham for Precinct 3. Clay Taylor, acting Board President (due to the resignation of Dr. Cathy Box, who resigned her position last month), presented Mrs. Watt with her Certification of Election.

Trustees heard presentations from Mark Holcomb and Phil Warren, representing the Superintendent Search Assistant Services from Education Service Center (ESC) 17, as well as a presentation regarding a construction update on the bond project for the school district.

Warren informed the Board that the ESC 17 Superintendent Search Assistant Services were free, provided through the Education Service Center, and he outlined how the program could assist the board in their search for a new superintendent. In action taken later during the meeting, the TISD Board voted to approve an agreement with ESC 17 to use their search consultants for their search. The board will meet on Monday, June 22 at 6:00 pm for a special called board meeting to determine the qualifications and characteristics they will list in their search for the next superintendent.

In a presentation by Scott Reed, with Parkhill, Smith and Cooper, Architects, the timeline for the construction project indicated that the plan called for new construction to begin in July 2017, with the new middle school building and new auditorium to be built by May 2018. The last phase of the \$9-million bond project will be the demolition of the original three-story high school building, which currently houses the middle school classrooms for grades 6-7-8. The upcoming 2017-18 school year is expected to be the last year for students to attend classes in the 90-year-old building.

"Also, the asbestos abatement numbers came in really good, so that allowed us to get the district everything you needed, and then some. I got a good price on the boilers, and I am glad we were able to do that for the school," he added.

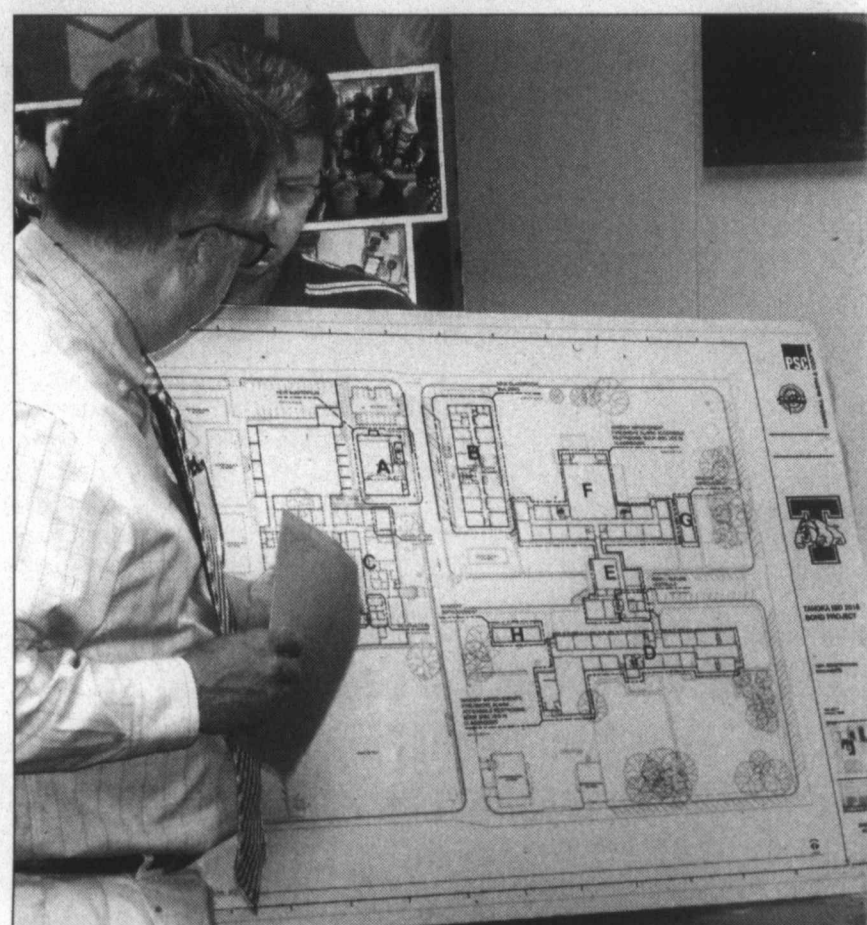

"We have gone out for bids, and I believe I have some good news for you. Basically, you are getting everything we were going to do, plus some ... some additional paving for parking areas has been incorporated into the plan, and new boilers will be purchased for the high school building instead of refurbishing the current boilers."

The plan, which may be seen at the district's Harvick Educational Building on Main Street, indicates that the new auditorium will be built on the high school campus, directly in front of the gymnasium, facing Ave. P. The middle school facility will be across the street on the corner of N. 4th and Ave. P, also facing Ave. P. After the

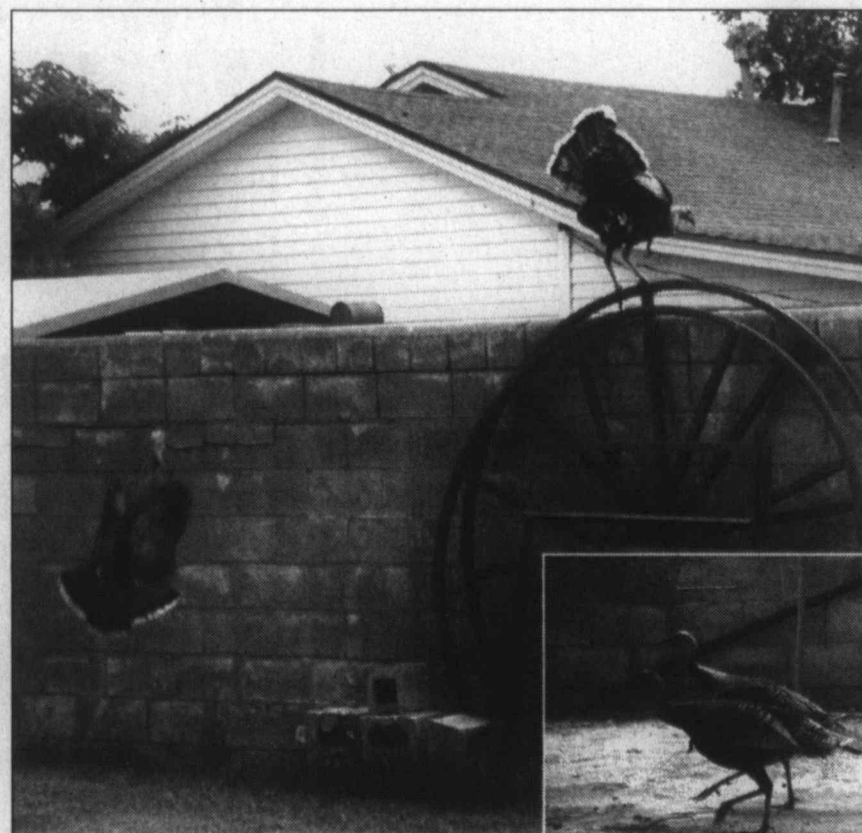

Turkeys come to town ... Carissa Nevill took these photos of the turkeys coming to town, and lots of people in the northwest residential area have seen the wild birds. Aaron Sims, Game Warden for Lynn County, said, "Unless the turkeys start clawing hoods of cars or cause some other nuisance, let's just let them be. If they become a problem, just create a loud noise and that should send them on their way," he said. Lynn County does have a season for shooting wild turkeys, but the spring season ended May 15, and Sims notes that there are fines for shooting turkeys out of season.

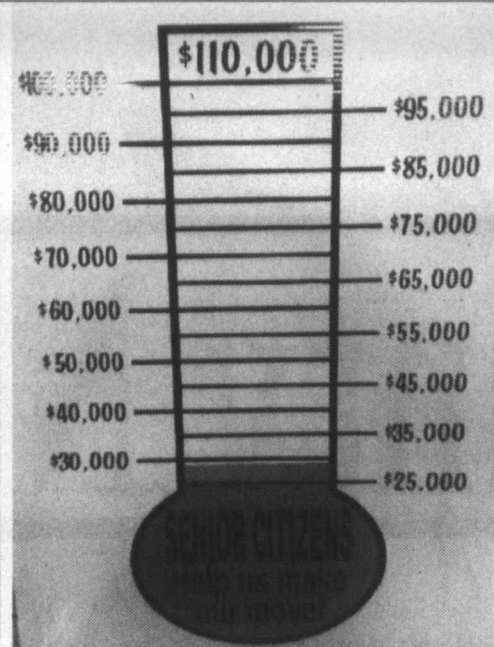

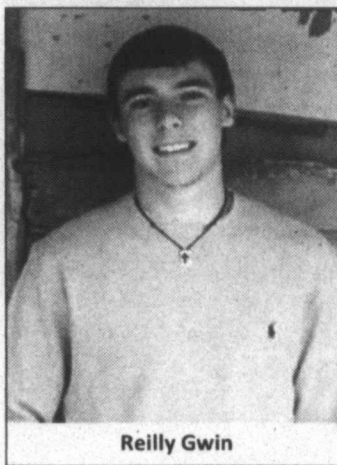

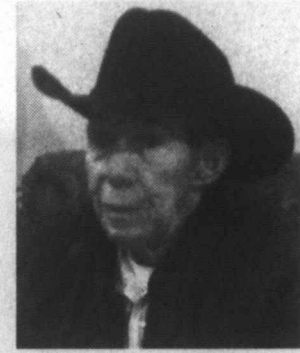
will be accepted, instead of a set amount per plate. Carry-out orders will be offered as well.

NO DOGS ON CHAINS ...

City ordinance prohibits pets from being confined by chain, tethering

Pet owners in Tahoka should be aware that, effective June 1, 2017, a Tahoka City Ordinance will be enforced that prohibits dogs from being confined by fixed point tethering or chaining, for any reason, and also prohibits wrapping a chain or tether directly around a dog's neck. The penalty for violating this ordinance is a fine of \$500 for each violation.

Lynn County Animal Control Director Lee Mary Rodriguez says that although this city ordinance was approved in 2007, it has not been enforced. Beginning June 1, she says, the ordinance regarding chaining and tethering of dogs will be strictly enforced.

According to Article 2.600 (Dogs: Enclosures and Chaining), every dog confined within a fenced yard must have adequate space for exercise based on a dimension of at least 100 square feet. Further, where dogs are kept or housed on property without a fenced yard, the owner of such dogs or person having custody of such dogs shall provide an enclosure for such dogs meeting the minimum 100-square-foot dimension per dog. Such enclosure shall be constructed of chain link or similar type material with all four sides enclosed. The enclosure shall be of sufficient height to prevent any dog from escaping from such enclosure. The top of the enclosure shall be covered with materials to provide shade and protection from the elements.

Fixed point tethering or chaining of dogs is prohibited. Temporary tethering or chaining of a dog under certain situations (i.e., lawful animal event, veterinary treatment, grooming, training, or law enforcement activity) to protect the safety or welfare of a person or the dog is allowed. In all of these cases, the dog's owner or handler must be present during the period of restraint.

A person restraining a dog with a chain or tether shall attach the chain or tether to a properly fitting collar or harness worn by the dog. A person may not wrap a chain or tether directly around a dog's neck. A person may not restrain a dog with a chain or tether that weighs more than 1/18 of the dog's body weight. A chain or tether used to retain a dog must, by design and placement, be unlikely to become entangled. A person may not restrain a dog in a manner that does not allow the dog to have access to necessary shelter and water.

The City of Tahoka may impose a fine not to exceed \$500 for each violation of this ordinance.



In Tahoka, NO dogs may be on a chain, tied down or on a tie-run, according to Lynn County Animal Control Director Lee Mary Rodriguez. All dogs must be in a fenced yard or a kennel. Pet owners who do not comply with this city ordinance may be fined at \$500 per violation. If not corrected to comply with the city ordinance, the pet may be confiscated by Animal Control.

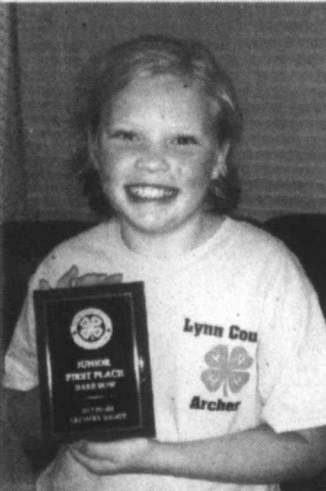

demolition of the three-story building and old auditorium, more paved parking will be added to that area where the building stood, and the parking area between the practice field and football field will be paved.

Trustees approved a GMP (Guaranteed Maximum Price) for the construction part of the project at \$8,040,482, with Parkhill, Smith & Cooper and Lee Lewis Construction. Two representatives from the construction firm, Kirk Hughlett and Neil Easter, were also present at the meeting.

In other business, the board voted to reorganize in the following manner: President- Clay Taylor; Vice president- Drew Stone; Secretary- Doug Green. The board accepted the resignation of Superintendent Dr. George McFarland which becomes effective at the end of the day May 31, and named Gary Harrell as the interim superintendent to begin June 1, 2017. Harrell has served as interim superintendent for TISD in the past, and trustees were pleased to have him serve the district in this capacity again.

Other resignations for the 2016-17 school year include the following teachers: Miranda Underwood (MS ELA), Crystal Gutierrez (MS ELA/Girls' Coach), Lisa Hawthorne (elementary), Angela McFarland (Elementary), Jason Josselett (Head Boys' Basketball), and Lauren Josselett (HS ELA). Judy Sanders (Elementary) is

retiring this year.

The board approved probationary teaching contracts for Crystal Gutierrez (MS English); Mallory Flores (SSA Speech Pathologist); and Katie Read (SSA Teacher).

A contract with Covenant Medical Group for athletic training services for the 2017-18 school year was approved, and the board renewed the Four-County Shared Services Agreement.

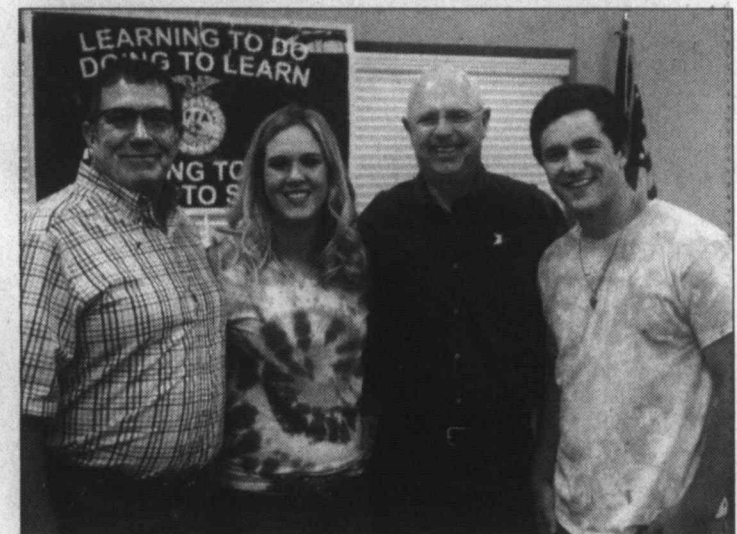

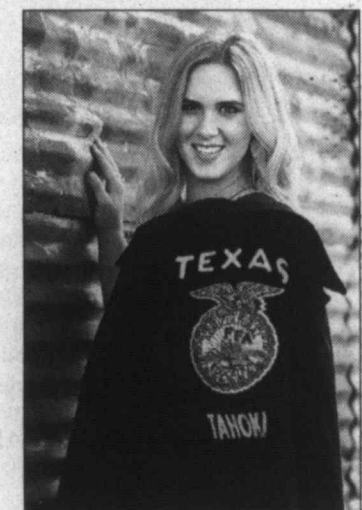
Olivia Hammonds selected to serve as FFA Foundation Ambassador

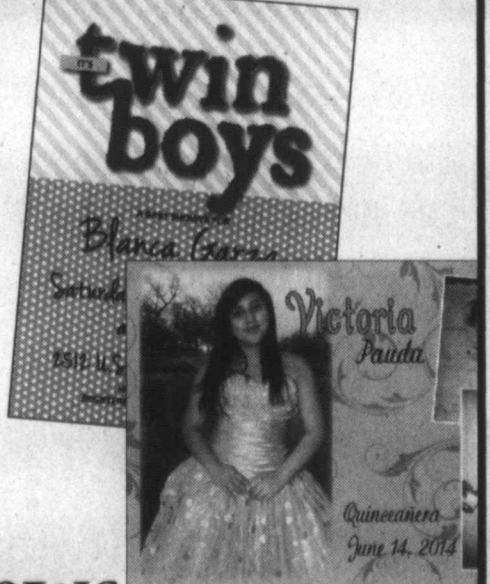

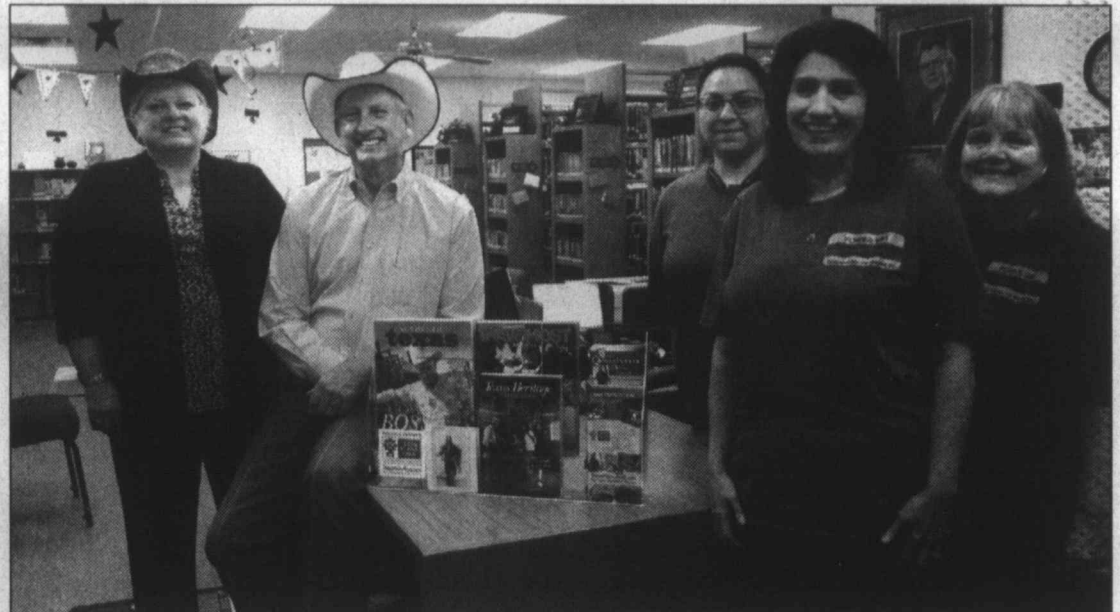

At 12:55 p.m. last Monday an accident occurred 3 miles north of Tahoka on US 87, but Lynn County Sheriff's Office had no other information on the incident, as it was handled by Lubbock DPS.

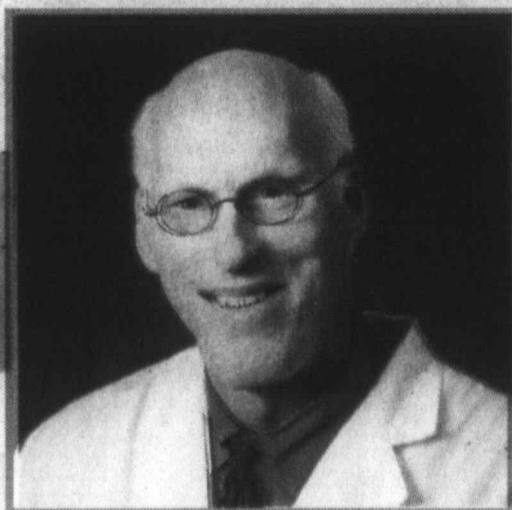
