# Days gone by ... Vintage home to be open for touring here Sunday

ne of the original homes built in Tahoka will be open for touring on New Year's Eve day, for citizens to get a glimpse of days gone by. The home, owned by Leslie and Maxine Paris of Tahoka, is located at 2001 Main Street. It has been furnished with vintage antique furnishings, or reproduction antiques, down to the tiny details including a checkbook from Tahoka's early days on a table in the large den, and a wall calendar from 1956 in mint condition that looks like it was printed yesterday. Area citizens are invited to come and tour the two-story home from 5:00-7:00 p.m. Sunday. There is no charge for admission, but donations will be accepted for the Lynn County Pioneers Senior Citizens Center.

For the past nine years, Maxine Paris has painstakingly restored the home to its original condition, and making some improvements along the way. Original wood floors were stripped, buffed and shined to a warm golden glow, crown moulding was added along the ceilings, and the unique, original front door and windows still grace the exterior of the home. A new kitchen that fit the design of the vintage home was added, and tin ceiling tile from another original building in Tahoka was brought in for the ceiling in the large den at the rear of the home.

"My mother spent many, many hours, and we don't even want to add up how much was spent, in restoring this home during the past nine years," said daughter Kellie Craig, who has played a large part in helping furnish the home with antiques and other



#### Annual groundwater level measurements begin Jan. 2

ter Conservation District (HPWD) personnel will begin making water level measurements to determine the effect of 2017 pumping on groundwater levels in aquifers within the district.

These annual measurements are made in a network of more than 1,370 privatelyowned wells. These observation wells are spaced at a density of approximately one well per nine square miles throughout the District's 16-county service area.

"We want the public to be aware that our staff will be visiting observation well sites from early January until completion of this work effort. They will be driving white pickup trucks that are clearly identified as Water District vehicles," said General Manager Jason Coleman.

These water level data are made available to the public

Plains Underground Wa- on the HPWD website (map. trict staff will accommodate hpwd.org). Persons may access annual observation well data, annual supplemental well data, and daily water level data in select wells using this feature.

> "Since its debut in 2013, the interactive map has grown in popularity each year. Most persons now utilize this feature to obtain depth-to-water and saturated thickness information. Because of this, HPWD is discontinuing the printed water level measurement report starting this year," Coleman said. The formal migration to the online data eliminates the cost of printing and mailing the report, and saves HPWD residents considerable money.

vintage finds.

Both mother and daughter are avid antique treasure hunters, enjoying going to estate sales, trade days, and other venues where the perfect vintage artifact may be found. Those artifacts are showcased beautifully in the home on Main Street, which was once considered the prime location for homes in Tahoka's early days.

The home was one of two featured in the Moonlight Madness tour of homes held earlier this month, but the homeowners wanted to give a second opportunity for visitors to view the vintage home. Family members spent hundreds of hours preparing the home for viewing, searching for just the right

pieces to highlight the home's unique features.

The front door opens into a small foyer, with graceful living areas to the left and bedrooms to the right, and a staircase leads to the upper levels. Be sure to look for the vintage chandeliers and other lighting fixtures in every room, and look at the furnishings and other details that will surprise you with their authenticity. If Maxine or Kellie are nearby, ask them, and they can tell you where each piece came from - many are from estate sales of former residents here, and all have meaning to the homeowners.

An entire wall of shelving in the den features vintage radios collected by the family, and a large world map is featured on one of the walls that Kellie believes may have been original to the home.

She believes the home was built in 1912. Throughout the years, the home was remodeled to allow for a separate entrance to the upstairs area, which was converted to a small apartment including a small kitchen area. That outside entrance is no longer a part of the house, but the upstairs kitchen remains, and Maxine has added whimsical vintage kitchen utensils and other memorabilia, including a box of flour (empty inside) that looks brand new that is from days gone by.

The other upstairs rooms have been furnished as bedrooms, and each room features a different look, including a little girl's bedroom showcasing a collection of Raggedy Ann dolls. Downstairs, one bedroom is cowboy style and the others all have different styles as well, and include antique bed frames and small collectibles.

It is a home that is a delight to tour, and Sunday will be a unique opportunity for area citizens to get a glimpse of days gone by.

The Apaches and the Comanche who ruled the plains for 800 years were accustomed to the mournful yip of the prairie wolves. For the Indians it was nature's "lullaby."

The Spanish Conquistadors were greeted by these evening serenades as they explored the plains searching for fortunes of gold and silver.

The Comancheros (Mexi-

can traders) left Santa Fe, NM and yentured out on the plains with trade goods to barter with the Indians. Those phantoms of the evening circled their camps and sang their mournful song.

The Texas cowboys trailing their herds to northern markets shook out their bedrolls and went to sleep on the prairie listening to the familiar yelp of the coyote.

The sodbusters who came on the heels of the ranchers built their shanties and turned the sod. They sat by the cabin door in the cool of the evening and listened to the music of the plains performed by nature herself.

Why would the howl of a coyote be reassuring? I am listening to the same sound that my ancestors, the pioneers and the Indians listened to.

The appearance of the plains has changed dramatically. Tall buildings rise where cactus once grew. Four-lane highways stretch to the horizon

where trails used to be. Cotton and corn have replaced the endless prairie. Cities cover areas that were once prairie dog towns.

But the one thing that has not changed, and remained constant, is the howl of the coyote. It is truly "music to my ears"

# What is SS "full retirement age"

"Full retirement age" refers to the age when a person can claim their Social Security benefits without any reduction, even if they are still working part or full time. In other words, you don't actually need to retire from your work to claim your full benefits. Also note that waiting until you're 70, if you can, will bring you a higher monthly benefit. The choices you make will affect any benefit your spouse or children can receive on your record, too. If you claim benefits early, it will reduce their potential benefit as well as yours.

For people who attain age 62 in 2017 (i.e., those born between January 2, 1955 and January 1, 1956), full retirement age is 66 and two months.

Full retirement age was age 65 for many years. However, due to a law passed by Congress in 1983, it has been gradually increasing, beginning with people born in 1938 or later, until it reaches 67 for people born after 1950.
