

"grossly unjust" recent action the Commissioners' Court in educing the ex-officio salary of Sheriff to \$1.00 per month, Sheriff Mart Clifton this week issued a statement to the people of Haskell county outlining what he termed the preliminaries leading to the action of the Court. His statement follows:

"On Monday, September 13, 1948, the Commissioners Court of Haskell County, in regular session, cut the ex-officio salary of the Sheriff's Office from \$200.00 per month to \$1.00 per month. This action was presumably a consequence of my refusal to pay e of \$2,198.67 the County a ba claimed by the auditor and Commissioners Court to be due to the County from excess fees paid to the Sheriff's Department in 1947 by the County and State. "Since I consider this action not only grossly unjust but a very serious detriment to my character as a citizen as well as your sheriff, I have taken this means of explaining to the citizens the preliminaries leading up to the action as stated above. "First, I am in possession of two audits for the year 1947. Audit No. 1 was presented to me by the Haskell County Auditor, O. S. Burkett, on or about April 1, 1948, as a final audit for 1947. Subsequent to this date an audit was presented to the Commissoiners Court as a final audit. by O. S. Burkett, audit No. 2 for the year 1947, of which I obtained a certified copy. Audit No. 1 and Audit No. 2 are now in my Comparison of the possession. two audits will show in one

single item alone, a difference of \$800, and in another single item a difference of over \$500.00 Comparing the two audits as a whole they do not appear to apply even to the same year. The differences are so apparent and so great. Yet, the Commissioners Court demanded that I repay the County on the basis of Audit No. 2 and my subsequent refusal re-

S. census estimate, about 97 per cent now have electricity available, and 94 per cent are actually taking service, Mr Acker said. Although saturation n this field seems near at hand new construction of homes and continued population growth will provide continuous increases in the number of customers during the coming years.

Of the 40-million customers taking electric service, about 32million or over 82 per cent of the total, are customers of the business-managed electric companies.
