Commissioners adopted the placed. budget and set the county tax generate funds for the Fiscal Other bids will be forthcoming. Year 1986 budget of \$5,536,000.

Prayer-Communication with God

very much"; "I like to pray" -for others: "I don't pray. I've at least working at. tried and don't get anywhere. I don't seem to accomplish anything.'

Prayer, an event of a person's presence and communication with God, has been a source of joy and difficulty for us as well as generations before us.

Here are a few insights that may help in this personal contact with our good God. I've found them helpful and others have also. Hopefully, they may be beneficial for those reading this article.

First: Prayer has been described as "wasting time with the Lord. "I like this approach. In our busy day, about so many things, things important for self, spouse, family, job or community, we give God 20 minutes or so just for Him. For Him to talk to us. For Him to communicate His will... His security, His peace, to us. We are awaiting Him, like the psalmist..."waiting upon the Lord" or like the prophets response "Speak Lord, your

servant heareth." (I Samuel 3:9). To others, this seems like a waste of time. When there are so many other "important and For some folks: "I enjoy prayer necessary" things that one "can and should" be accomplishing or

> That's where the idea of wasting time with the Lord comes in. But to the person in prayer -it is really not a waste, even though when they finish, they feel that they have not spiritually accomplished anything - on the contrary; they have given that particular time to God...to be used at His disposal. And that gift itself is an accomplishment... pleasing to God.

Second: Prayer is more God's work than ours. He is the real initiator. He invites, we respond. He is more interested in us, than we in Him. He has a hundred more important things to tell us than what we have to tell Him. He is more eager to communicate with us. He wishes to communicate Himself and His goodness, love, peace, wisdom, confidence, than doing our wishes. Most of the time, as it is said, that whenever we get what we want, we always come out the loser; because He had something much

interested in life, and keep them involved, not just in class, but also in learning in general," Debbi Porter, new junior high history and girls' assistant basketball and track coach said recently.







Enrollement wrap-up

Crockett County public schools had a total first day enrollment of 1,017 students.

At the Ozona Primary School, there were 29 pre-kindergarten students (this is a new program which began this year); 102 kindergarten students; 87 first graders; and 75 second graders, for a total at the primary school of 293 students. This compares with a 1984 enrollment total of 247.

In the Ozona Intermediate School, there were 67 third graders; 72 fourth graders and 104 fifth graders (this is the largest class, overall), for a total of 243 students, down from the 249 students enrolled in 1984.

The Ozona Junior High registered 70 sixth graders; 84 seventh graders and 67 eighth graders, for a total enrollment figure of 221 students. This figure is roughly the same as in 1984.

In the high school, there are 78 freshmen, 77 sophomores, 58 juniors and 47 seniors, for a total of 260 students. The 1984 enrollment total at the high school in 1984 was 258 students.





The Federal Trade Commission notes that the Mail Order Rule, which states when products should be shipped and when you have the right to a refund, applies only to merchandise that is ordered by mail.

More and more people are shopping by mail and phone today as a way to save time. But that also means more complaints and questions about mail order companies. "The more I run, the more I want to set age division records." says Bobby Aycock, an organizer with Pete Maldonado, of the West Texas Masters track meet. Aycock recently learned that he is ranked sixth nationally in the 45-49 year old classification in the

The Masters Track Meet circuit is primarily for men and women 30 and older, but the meets have open divisions which include younger people. Those younger than 30 are not ranked or listed in the competition.

The attraction of the Masters

Aycock said he suffered from high blood pressure and felt exercise would be good for it. "Medication did not control the blood pressure. Also, I am very competitive with anything, and the physical part attracted me." When Aycock attended the 4A

Alice school as a student, he ran track for one year. "I was small and thin and did not do well," he said.

circuit is for the many persons who enjoy running and competing, but do not enjoy the long marathon distances.

The Masters circuit has been held for many years in Texas. Aycock and Maldonado first became interested in holding a meet in Ozona, which has over the past few years attracted the largest number of participants of any meet in Texas, after learning that Ozona athletes had to go to Eldorado to compete in the meet held there.

The National Masters newspaper posts all upcoming meets and issues rankings for 'the various age divisions, Aycock explained.

He competed in 11 events in 1983, and won medals in all but one event. Originally, he hoped to just win medals, but after having achieved those goals, Aycock now wants to set as many age division records as possible. Most of the meets are held in the summer, but some indoor meets start in September. He participates in four to five outdoor meets a year.

Track is a family affair for the Aycocks. His oldest son, Bo, a student at Sul Ross, participated in the 1984 West Texas Masters. Aycock's father, C. N. Aycock, 72, won first place in the shot put. Mrs. Aycock attends many of the meets with her husband, and their youngest son also attends some of the meets. He is not old enough to participate.

Aycock starts his serious training in late February for the summer meets. He does weight lifting and runs intervals -"When training for a 100 meter dash, I run 200 meters; when training for a 200 meter run, I run 300 meters" - to build up his endurance. A knee injury has temporarily slowed Aycock, but after seeing a doctor, he hopes to resume his full training schedule.

"Most serious athletes run year round. For those interested in entering into competition, it is best to visit with several who have competed," advises Aycock. "Try each event and see what you do best in. Each event has a different training schedule."

Aycock has participated in the high hurdles, pole vault, long jump, 100-meter dash along with Danny Sewell. "I now hold nine different age division records in nine different events.

Conflicts with his job at Fesco, Inc. are rare. "I take no hours away from work to run." Aycock, who first came to Ozona in 1976 as district manager for Fesco, has two weekends off each month, and schedules his participation for those weekends.

Alice, is a petroleum engineering service company. "We are specialists in a certain type of testing of gas and oil wells through surface and subsurface tests.

Many oil related service companies are closing down, but Fesco is able to keep its door open becuase "we do a good job at the lowest possible cost to our clients," Aycock explained. "No two wells are the same, and this makes the work exciting." A certain amount of tests are required, and "we are here to do them. Aycock predicts that the oil and

gas industry will remain sta-tionary for six to eight more years. The oil portion is coming back a little, but the comeback is insignificant. The gas industry has dropped so much, and the comeback for that industry is not in the foreseeable future. Incorrect political decisions by

past administrations have hurt the oil and gas industry, Aycock said. OPEC has little or no effect on the oil and gas industry here, but the Mexican and Canadian imports do effect the industry. Deregulation has not had a significant impact according to Aycock.

Aycock does not believe there will be another boom like in the 1960's. "The industry might be on an even keel maybe in six to

eight years. "I want to give the customers the best service for the least amount," says the Fesco manager. Fesco had to increase its prices about five percent for the first time since 1981."

Athletically, Aycock wants to do a better job each time he competes. He has reduced the number of events in which he participates to set the records he cherishes. "I love the people you meet. They are generous, polite,

mature and unselfish.' This too, is true of Bobby Aycock, the athlete and the oil industry professional.



Scatter gun regulations change

ditionally don't get too excited about dove season, and this year appears to be no exception says Game Warden Rod Chalmers. "Regardless of whether it's a lack of droves of doves blackening the skies, or the persistent heat wave stifling enthusiasm, fact remains we did rather quietly open mourning dove season Sunday, September 1, and we can keep it open through October 30 in the Central Zone. (By the way, the boundary between the Central and South Zones is US 90, not Interstate 10.) And if it's still too hot for you in October, you can through the 13th.

"Shooting hours are from 30 minutes before sunrise to sunset. Some hunters get hung-up on this sunset thing; and if you want to be exact, look up the tables in some thick newspaper. But folks, realistically speaking, most State Game Wardens you meet in the field won't go digging out ticket books for late shooting until the sun has dropped below the horizon. If you're hunting on the east side of a high hill, better put the ole' blunderbuss away when the sun goes out of sight, or refer to a sunset table. Wardens generally recognize an honest attempt by the hunter to be legal.

"As of September 1, 1985, persons hunting small game (including doves) in their county of residence are not exempt from needing a current hunting license. This is a change from

Crockett County folks tra- years past. The State of Texas and the Texas Parks and Wildlife Commission have decided and rightfully so, that all hunters who engage in the sport should help support the sport; or, pay their dues, so to speak. Those under 17 or 65 or over and disabled veterans can hunt under a Resident Exempt Hunting License. Your Resident Hunting (\$10.00) or Combination Hunting/Fishing (\$15.00) license will suffice anywhere in the state, but don't forget a Whitewing Dove Stamp (\$6.00) if there's any chance of taking one by mistake while mourning dove hunting. wait till January 4 and hunt Also, while on the subject of stamps, waterfowl hunters also need the state and federal waterfowl stamps, signed and attached to your hunting license. Don't grumble, just buy it - it goes to a good cause! "We're allowed 12 mourning

doves per day this year, and the possession limit is the maximum number of birds that can be legally taken in two days. Obviously, the possession limit on opening day of any season is the daily bag limit. No person may possess more than one day's limit while in the field or returning from the field. This daily limit of 12 doves can include up to two "mistake" whitewings and up to two white-fronted doves (very uncommon in this area), but the total per person is 12 in the aggregate. However, remember to have a Whitewing Dove Stamp on the back of your license to

cover those mistake birds. Most hunters are aware that the whitewing season was cancelled this year, but the stamps weren't. By the way, we do have some whitewings in Crockett County down along the Pecos River, mostly."

Things you never wanted to know and don't care to ask about Newspapers:

Q. What is a "legal" newspaper?

A. A "legal" newspaper is one which

1. has been published regularly and continuously for not less than twelve months

2. holds a second-class postal permit in the county where it is published

3. devotes not less than twenty-five percent of its total column lineage to the carrying of items of general interest.

Material required by law (legal) to be published must be published in a "legal" newspaper.
