




Spring Spring women's golf tournament in Abilene April 29


Elsie Mae Hutchins




all the government gobbley-gook and seems to bring a breath of fresh air.

"Memories of December 27, 2005"

A little over two months have passed since the huge calamity of the firestorm that raged in and around Cross Plains. It was Tuesday, December 27, 2005. Once the news media hit with the disastrous and devastating firestorm on the national news, the word really spread fast. My telephone began to ring with people calling to check on Marvin and also to inquire whether our home was burned or saved.

I received phone calls from Ft. Payne, Alabama; Chicago, Illinois; Auburn, California and from all points of Texas. We are very fortunate that we did not lose our home or belongings in the firestorm.

Our two daughters and our three grandchildren were visiting us. They arrived the day before from Lubbock. It was Dec, 26th. They arrived about 2:30 p.m. I also had time off from the nursing home for 72 hours. I arrived that morning, and when the kids got there we had our Christmas tree and gift exchange. We had a great time and our Christmas dinner that night. My grandson, age 18 and my two little granddaughters, age 8 1/2 (now 9) kept us all entertained.

The next day was Tuesday, December 27th. We were visiting and looking at pictures, etc. Marvin and Melody went to Brownwood to do errands. My grandson went with them. My two granddaughters went to play with a little girl who was visiting a neighbor on the block. Allison and I had lunch and then I went to bed and took a nap. While I was asleep, the girls came back, and not long after that the others returned.

When I woke up, I guess it was

Marvin and Allison went back outside and helped Delores

Garrett get ready to go, then she was helping the elderly residents evacuate from the other apartments. Dolores was ready to go and she said my two granddaughters and I could go with her, along with another elderly lady.

The plan was to go toward Brownwood Lake and Marvin, Melody, and my grandson would follow us. We waited a good 20-30 mins., but they weren't ready yet and were still waiting for my grandson to return. Meanwhile the smoke was getting thicker and blacker, so I told Delores we'd better just go ahead and leave. We both depend on oxygen. The girls had Paige's puppy, Schyler on a leash, and were already starting to cry because their mother wasn't ready to go.

We drove out on the Brownwood Hwy. a-ways and parked. We stayed there for hours. Once in a while we'd drive back toward town. My family never came. About 8 p.m. Delores said, "Well they're not going to let us go back home." I suggested a motel, but she felt she needed to go to the Brownwood Hospital. So we decided to take me and the girls to the Nursing Home in Rising Star. I knew I'd be taken care of there. First we stopped at Reba's in Rising Star to use her cell phone to call Marvin. (She is our home health caregiver). We couldn't reach him at all.

We then went to the nursing home. Johnnie was gracious and allowed the girls to spend the night with me. They were so upset and didn't know where their mother or granddad was. The nursing home fixed us up with sandwiches and drinks. I wanted to watch the news, but knew it would upset the girls. They got to pick out movies to watch and they were all for that.





869,265 Texans now enrolled in Medicare prescription drug plans

AUSTIN, TX-Some 869,265 Texans are now enrolled in prescription drug plans through Medicare, according to numbers recently released by the federal government. This number includes those signed up for standalone prescription drug plans plans that include prescription coverage.

Of the 2,570,082 Medicare beneficiaries in Texas, some 60 percent (1,530,619 beneficiaries) now have some kind of drug coverage. "The savings that the new Medicare drug plans offer are real and worth the time and effort to understand," says Nona Bear, a nationally known advocate for seniors.

The Medicare Rx Access Network of Texas is calling on stilleligible Texans to learn about the program. Medicare expanded its benefits to include prescription drug coverage on January 1, 2006. This was the biggest expansion of Medicare benefits in the program's fourdecade history. Medicare beneficiaries have until May 15 to enroll in a Medicare prescription drug plan to choose the lowest premiums and best savings.

"Reaching out to eligible beneficiaries in Texas about the new coverage has been no small task," says Bear. "Seniors should know there is still time to enroll, and that there is help available for selecting a plan that's right for them.

Prescription drug coverage is available to everyone in Medicare, regardless of income or how they get their Medicare coverage. In Texas, some 20 organizations offer stand-alone prescription drug plans, and at least 10 organizations offer Medicare managed care plans that include prescription coverage. Extra assistance is available to people in Medicare with limited incomes and resources.

Beneficiaries and their family members with enrollment and coverage questions can get assistance through a number of local, state and federal resources. Help is available by calling 1-800-MEDICARE or by calling 1-800-252-9240 to conand for Medicare managed care nect with local Area Agencies on Aging. Beneficiaries can also visit www.Medicare.gov.

TDA awards \$500,000 for feral hog research

AUSTIN-The Texas Department of Agriculture has awarded \$500,000 in grants to Texas A&M University and Texas Tech University to launch research efforts on the state's feral hog problem. Funds for the pilot program were appropriated to TDA by the Texas Legislature during the 79th legislative session in 2005

"Texas has the dubious distinction of being the feral hog capital of the United States, with an estimated 1.5 million to 2 million hogs. This is a serious problem, with the hogs destroying pastures and spreading disease to livestock statewide," said Agriculture Commissioner Susan Combs. "I am pleased that A&M and Texas Tech will be tackling this issue head-on and using their research to formulate possible statewide solutions.

Attorney General Abbott warns Texans about recent bank scams to tap personal accounts

Texas Attorney General Greg Abbott today sent out an urgent message for all Texans to be on the lookout for official-looking e-mails purporting to originate from major financial institutions asking for personal account information.


In the latest series of so-called "phishing" scams, the e-mail sender claims to represent financial institutions such as Comerica, Chase or others. The message instructs the "account holder" to submit personal account information because "bank officials" have reason to believe his or her account may have been accessed by an unauthorized party.

"I cannot emphasize this enough-Texans who receive such e-mails should immediately delete them because these tactics are used to trick


bank's Web site, then log in using their user ID and password in order to inspect their account for recent activities. At that point, the ID and password are stolen and used for purposes of identify theft.

Attorney General Abbott urges consumers who receive such e-mails to visit their personal bank's Web site and access account information the usual way. Banks and credit unions never sent unsolicited emails to their clients in this manner, so it is always wise to avoid these e-mails and clickable links that can expose a consumer to fraud.

Financial institutions request consumers whose account information may have been compromised to immediately contact their fraud investigators. Many have established special e-mail addresses for consumers to forward phony e-mails and "phishing" attempts. Consumers who believe they may gave received such bogus e-mails may file complaint with the Attorney General's Office by calling toll-free (800) 252-8011 or accessing the agency's Web site at www.oag.state.tx.us.
