HOBBY'S MAJORITY OVER 200,000.

Sweeps State From "Center to Circumference"---Opponent Carries Less **Than Fifteen Counties**

As was expected Hobby for Governor swept the State in the primary last Saturday. Returns up to yesterday showed that he had a lead of 203,670 and his gain was increasing as reports came in. Both conntry and city vote favored Hobby practically two to one in all sections of the state. His opponent has carried probable less than fifteen counties in the entire state.

For Lieutenant Governor Davidson is leading with Johnson a close second. For Attorney Gen eral Cureton is leading by 50,000, with Woods second. Lattimore is leading for Associate Justice Court Criminal Appeals by 65.000, with Pierson second. It appears that Gilmore will have a clear majority over both his opponents, and it may be possible that Terrell will win out by a clear majority.

Government is Asked to Raise Immi gration Ban on Mexican Labor: Mexican Editors Entertained.

Food Administrator Peden has re urned from San Antonio, where he vas present at a conference on the abor situation, the result of which vas a message to William B. Wilson. secretary of labor, uring that for a period of 90 days the immigration laws is to Mexican labor be immediately uspended and the bars be let down scept as to the health requirements. The conference brought out the fact hat a small group of Texans in Southrn Texas alone required 40,000 Mexian laborers in addition to those they lready have, and that the need is anifold over the entire State

As an interesting climax to the re uest that the present restrictions on Mexican labor be removed, Mr. Peden had an opportunity to address the Mexican editors who were recently received in Washington by President Wilson. These editors were in San Antonio on their way back to Mexico after a tour of the United States. In his address following a luncheon at the Gunter Hotel Mr. Peden read the message from the provost marshal general of the army to the Food Administration with reference to Mexiexemptions.

ers of military age: "Provost marshal general of war department rules as follows:

Mexican citizens of military age who have not been residents of the United States and who temporarily come into this country after this date are not required to register and are consequently not hable to military service. A Mexican citizen of military age who has previously resided in the Unit-ed States, but who has not registered and who returns to the Unit-ed States, is required to register, but the selective service law and regulations provide for his com-plete exemption from performing military duty unless he waives his right thereto.""

Under a ruling of June 20 Mexicans an be brought into the United States or agricultural purposes for the period of the war. The head tax is sus-pended as well as the illiteracy test. Applications for the importation of Mexican labor should be made to the United States Employment Bureau or the Immigration Bureau.

The laborers must be provided with bousing and sanitation as provided by the State law. In the absence of State law the housing and sanitary conditions must be approved by the United States Department of Labor. Further information in this connection can be secured from W. E. 

EAT PEACHES, IT WILL SAVE SUGAR, SAYS PEDEN.

It requires approximately 15,000,000 pounds of sugar a month to feed the 5,000,000 people of Texas, based on the ration of three pounds per person per month. The three pounds ration is based on sufficient to maintain strength and health. In the Elberta peach crop of East Texas, now being shipped to market, there is approxi-mately 5,775,000 pounds of saccharine, or sugar not matured. If the people of Texas were to consume this one fruit grop alone they would save over a third of a month's ration.

In 1916 the Texas peach crop amounted to 2,860,000 bushels; in 1917, to 2,352,000 bushels; while the crop for 1918 is estimated at 3,000,000 bushels. The crop is bringing an average of \$3 a bushel, or enriching the trens-ary of Texas by \$6,000,000. The price is better this year than in either 1316 or 1917.

The peach crop in 1916 represented a value of \$2,850,000 and for 1917 \$3, 998,400.

It is also interesting to know that the tomato season in Texas for 1916 showed shipment of 721,000 crates and 1917 of 1,152,009 crates. The 1918 grop is a little short of 1917. The value of the tomato grop for 1916 was \$553,700, and for 1917, \$1,036,000, so it can be reasonably estimated that the 1918 to-mato grop will bring in at least \$1,000, and

In the matter of icing and securin quick transportation of the peach and the tomato crop the Federal Food Administration has given the growers every assistance within its power, and the results are that the distribution has been up to the expectation of the ohipper in all things.

PROFIT MARGIN SET FOR SALE OF WHEAT FLOUR AND SUGAR.

Wheat flour and sugar are two com modities over which the Federal government has complete control. Failure to observe the margins of profit set by the United States Food Administration cost Jacob Kulla, a wholesale flour dealer of New York City, recently a fine of \$25,600 to be paid the American Red Cross. Kulls was charged with selling large quantities of flour at profits in excess of the mar-gins set by the Food Administration. The trial disclosed that he sold flour at margins of from 75 cents to \$1.65 a barrel. The margin allowed by the Food Administration for flour handled by the wholesaler and jobber per barby the wholesaler and jobber per bar-rel is 50 to 75 cents. The retailer is allowed from \$0 cents to \$1.20 a barrel profit and 1 cent a pound on broken

packages. This flour must be bought with an equal amount of substitutes and the prevailing retail price is .07 to .071/2 cents.

of providing for their families and seeding, the farmers should sell their surplus to their neighbors for seeding purposes exclusively, thereby putting more farmers in a position to produce their own bread for the coming year.

"It is the policy of the Food Administration," states Administrator Peden. "to have all farmers, wherever possi-ble, plant sufficient wheat for their own consumption and those dependent

upon them. If there is any other im-pression it should be corrected at "The public may rest assured that the United States Food Administration will do everything it possibly can for the farmer producing wheat for home consumption, and the only reason they

were restricted in the use of wheat last year was that the crop was so short that it was absolutely necessary to get every grain of wheat to the mills in order that this government could take care of the obligations in the army, navy and allied countries.

"Because of the fact that there would be a considerable waste and spoilage if the quantity retained on farms were ground at once, the Food Administra tion requires that out of the 1918 wheat crop only sufficient wheat of the 12-pound per person per month allotment be ground to last until Octo-ber 1. When that period has passed additional grinding is in order.

"Both the commercial wheat producer and the small producer for fam ily use and seeding operate on the same plan so far as the 12 pounds per person a month goes. The exception is only in that the small producer may distribute his surplus among his neighbors for seed.

CONSUMPTION OF glasses ICE TO BE REDUCED

FOOD ADMINISTRATION TELLS OF WAYS PRODUCT IS WASTED.

Re-Icing of Ice Cream by Maker May Be Forbidden-Cracked Ice Should Not Be Used With Drinks.

There are many ice economics that the householder should practice in the of ice, announces the conservation Federal Food Administrator for Texas, should be kept clean and doors kept tight and the driptrap kept in place. The door of the refrigerator should never be opened except when neces sary, and then for the shortest possible space of time; no hot foods should be placed in the refrigerator.

Cracked ice' should not be put in glasses to cool drinking water and other beverages. A bottle of water kept in the refrigerator or water drawn from the water cooler will furnish a sufficiently cool drink.

Crushed ice should not be used in rerving fruits, saiad, seafoods, rad-iahes, celery, tomatoes and so forth. These articles will be found perfectly palatable when chilled to the temperature of the refrigerator.

The greatest waste in the use of ice, the Food Administration has discover ed, is among those concerns using the greatest quantity of ice. They have naturally been able to buy at the lowest price and their employes (forgetful of ice value) have generally most wasteful in their handling of this perishable article.

Saving Ice Urged.

A reduction in the use of ice by ice cream manufacturers naturally follows from the diminished production brought about by the restrictions on the use of sugar. But a further very considerable saving of ice can be effected by certain economics, which the Food Administration insists upon.

It has been the observation of the Food Administration that ice cream manufacturers generally carry great quantities of crushed ice on their delivery wagons; they sometimes go so far as to mix sait with the ice, which increases the meltage several fold. This crushed ice and salt is used to repack the ice cream of their custom-ers. The ice in the wagon is not protected, is carelessly handled in the distribution and is not conserved by the customer because it costs him nothing It is sometimes found that the ice cream wagons on returning to the factory will make no attempt to put the returned ice in a protected place, but will allow it to melt in the wagon or be swept into the yard.

ARMY HAS OWN WAY OF BUYING CANNED GOODS; HOME CAN-NERS SHOULD NOT SEEK TRADE

The army and navy are at times em barrassed by offers of canned goods, vegetables and so forth by good-intentioned housewives and other citisons. In some instances such supplies are effered to the army for sale or to be dis tributed gratis to soldiers in the cantonments.

Administrator Peden is advised that neither the army nor navy has the privilege of accepting these gifts, aer are they in a position to purchase them, in view of the fact that their purchases must be made according to specification and inspection. This esplanation is made, not to discourage home canning and preserving of foods, but that the public may understand that purchases made by the army and navy must be through the proper chanaels.

DAIRYMEN NO LONGER REQUIRED TO PAY 500 MINIMUM CHARGE.

Shippers of milk and cream throughout the country were relieved of the minimum charge of 50 cents on each shipment, established June 25 by the Railroad Administration when a genoral increase of 25 per cent in rates went into effect.

This was effected through the co-operation of the Food Administration with the Railroad Administration, which had received protests from dairymen that the minimum, which had to be paid on shipments even so small as a single can of milk, no matter how short the haul, would work a hardship, particularly in suburban ter ritory near large cities.

The minimum will be done away with entirely as soon as the tariffe can be amended so far as milk and cream are concerned, but the general increase will stand.
