Welding Short Course Offered Here By Schools

A&M Welding Specialist To Teach Course Dec. 5-9

A ranch farm welding short course for adult ranchers & farmers will be held Dec. 5 through 9, 7:00 to 10:00 p. m., under the sponsorship of the Ozona High School Vocational Agriculture Department, according to L. B. T. Sikes, Superintendent and M. A. Barber, teacher of vocational agriculture.

C. B. Edwards, welding specialist with the Vocational Agriculture Division of the Texas Education Agency and the Department of Agricultural Engineering at Texas A&M College, will do the instructing in the course. He is headquartered at Texas A&M College.

Mr. Edwards holds two college degrees; a B. S. in Agricultural Education from Texas A&M and an M. S. in Agricultural Education-Animal Husbandry from Oklahoma A&M, and in addition, has several graduate hours at the University of Texas. Mr. Edwards has had experience as a vocational agriculture teacher and as supervisor of state schools. He has organized T&I programs and supervised the operation of several shops. Mr. Edwards has been with the Adult Specialist Program since its' initiation in 1958.

"Many welding short courses in various parts of the state have been taught by Mr. Edwards and all have met with outstanding success", according to Mr. Clemon Montgomery, area supervisor of vocational agriculture, Big Spring, Texas. Arrangements for the adult education short course in welding and in other fields are made through Mr. Montgomery's office.

The short courses at Ozona is scheduled to begin Dec. 5 at 7:00 p. m. in the vocational agriculture building. Other meetings in the series of 5 will be held Dec. 6th, 7th, 8th, and 9th. During the dates the short course is in progress, Mr. Edwards will be available to assist ranchers with individual problems and to provide on-the-ranch instruction, according to Mr. Barber. Maximum enrollment has already been reached in the short course.

Mr. Edwards states that the short course will be adjusted to wishes and interests of ranchers enrolled but that he expects to cover such subjects as safety in welding factors controlled by the operator in running a bead, striking an arc, types of electrodes, preparation of joints, distortion, cutting, hardsurfacing, and pipe welding.

Expensive Scaffolding Required For Repairs To Courthouse Dome

Work is currently under way on the county courthouse to repair leaks and replace some rotted timbers in the central dome of the building.

Ozona residents have been interested for some time now in the extensive scaffolding required for the operation which will require extensive work to carry out.

The leaks and resultant damage was caused in part by age and to repairs in the roof in the past which failed to seal the dome as it was originally. The dome, which is something of a characteristic of buildings built in the 1890's and the early 1900's entailed a good bit of intricate work, an element not often found in modern day structures and therefore rather difficult to repair correctly.

The Crockett County Commissioners approved the work at their last meeting this month.

Schools, Exploration Crews Suffer Heavy Losses From Not-So-Funny Pranksters Nite of Deflating Tires on Trucks, Buses And Individual Vehicles

Pranksters whose activities turned to vandalism over the school holiday week-end disrupted a great deal of the rolling equipment in Ozona early this week by letting the air out of an uncounted number of tires.

The action on the part of the not-so-funny jokers cost car owners, the schools and a doodle bug crew hundreds of dollars to get equipment back into action after the incident and caused one School bus route to the El Paso Camp to be skipped Monday.

The rather bold pranksters entered some car ports to let the air out of tires on cars parked at home and a large number of automobiles praked around the picture show and the hotel were victims of the tire deflating.

One school bus, with tubeless tires, could not be repaired as the seal on the tires was broken and equipment required to re-inflate the tires could not be found in Ozona.

The doodle bug crew was delayed for several hours in getting its equipment into the field causing the company to have to pay a rather considerable amount of wages and expense without getting the service of its equipment or personnel.

The Crockett County sheriff's department is investigating the matter with the possibility of prosecution for damages for the culprits.

State Winners Appear On Convention Program Wednesday

Three Crockett County 4-H Club members will be honored by the Texas Sheep & Goat Raiser's Association in their annual convention at San Angelo next week. The three, Bill Williams, state winner of the 4-H range management program in 1959; P. L. Childress, III, 1960 state winner; and Pam Jones, 1960 state winner of the Texas Sheep and Wool, Goat and Mohair Program, will appear on the Wednesday morning program of the association. The sheep and goat association sponsors the 4-H programs in which these 4-H members were named state winners.

Two of the winners, Pam Jones and Bill Williams, will give reports to the association. Ozona Girl Cagers Squeak By Rankin For Season Opening Win

Two free throws and a field goal in an overtime period gave the Ozona High School girls a 30 to 28 win over Rankin in the season opener for both teams Monday night in Ozona.

Janie Lara and Beverly Alford each contributed two points in the overtime as the Ozona girls climaxed an uphill surge to win their first opening game since girls basketball was revived three years ago.

The Ozona rally came largely on the shooting of Beverly Alford who was Ozona's top scorer and who tied with Rankin's Joy Braden for high point honors in the game with 14.

The Ozona team jumped into an 8 to 3 lead in the first quarter but Rankin rallied and finally pulled ahead 12 to 11 early in the second quarter not to be overhauled until late in the fourth period.

While Alford and Braden cancelled each other out with 14 points each, Janie Lara picked up 12 points which with Don Nell Carnes' 4 was just enough to give the felines their first win of the season.

Glenda Friend, even though playing most of the game with a personal foul handicap, led the Ozona defense and rebounded strongly to help offset some of Ozona's short comings both in passing and on defense.

In a B game the Rankin girls had a rather easy time with Ozona's green reserves winning 21 to 9. Gail Johnigan lead the Ozonsans with five points, but Mary Lou Zunker proved to be the reserves strongest threat on defense.

Dawn Love of Rankin was the game's high point maker with 13 points.

Postoffice Dept. Asks Bids For New Postoffice Here

Bidder To Contract Building For Lease To Department

Postmaster J. F. Hokit said today he has been advised by the Office of Postmaster General Arthur E. Summerfield that the Post Office Department is now asking for bids to build and lease to the Department a new building for the Post Office at Ozona. Advertising will be posted from December 5, 1960 to February 6, 1961.

Specifications call for a structure containing approximately 3-, 384 square feet of floor space with an outside loading platform and adequate space for parking and truck maneuvering.

The new Post Office will be located at the corner of Avenue "F" and 12th Street.

Postmaster Hokit said the Post Office Department will enter into a lease agreement with the successful bidder which will run for ten years, with four consecutive 5-year renewal options.

Bids should be submitted, the Postmaster advised, to Real Estate Office, V. E. Bell, Post Office Box 1386, Lubbock, Texas. The Real Estate Officer will supply information with regard to bidding forms, building specifications, lease provisions, etc.

Ozona AFS Defenders Meet Houston 6-Man Team Here Sun. 2 p. m.

Mrs. Ora P. Shipley, Early Day Teacher Here, Dies in Floydada

Mrs. Ora Parker Shipley, widow of the late Dan D. Shipley, an early day teacher in Ozona schools and a sister of the late Mrs. L. B. Cox, Sr. of Ozona, died Sept. 19 at her home in Floydada, according to word received here by her nephew, L. B. Cox, Jr., and family.

Mrs. Shipley, familiarly known to old timers here as Miss Ora, was 91 years of age at the time of her death. She was born in Gonzales county and married in 1907. The family lived in Plainview for a time while Mr. Shipley operated a grain elevator. In 1916 the family moved to Floydada where they operated a farm. Mr. Shipley died in 1934.

Mrs. Shipley is survived by a son, Parker Shipley of Corpus Christi, and two step-sons, John Shipley of Floydada and Frank Shipley of Clovis, N. M., eight grandchildren and 11 great grandchildren.

TIME TO TALK BACK

Since it was published "for private circulation" among those gifted students of government who will delineate President Kennedy's "New Frontiers" for him, you may Arthur Schlesinger's pamphlet, "The Big Decision — Private Indulgence or National Power."

But you very definitely should know about it, since the National Associated Businessmen — America's voice of small business — sees in it the blueprint for the take-over of business by Government.

Professor Schlesinger calmly regards "our national wealth and talent" as properly belonging, not to those who created the wealth, or to those who developed and employed the talents that God gave them, but to the Government. He complains that the Eisenhower Administration spends "a smaller share of our gross national product (a phony yardstick if there ever was one) on public services and facilities today than . . . a decade ago." We have failed dismally, in the Schlesinger view, to expand our "social overhead," under which the lists "education, medical care, housing, slum clearance, urban and suburban planning, social security, provision for the sick and the aging, roads, recreation, water, assistance to distressed classes and areas, resources and energy development."

To remedy the deplorable situation in which a timid Federal Government has failed to completely absorb state and local prerogatives and responsibilities and has allowed the misguided citizenry to retain some of its earnings only to spend them foolishly on "tailfins and television," Schlesinger & Co., would simply revive the "allocation of resources". In plain English, since business and individuals are so stupid and selfish about handling their own money, the Government will have to do it for them.

Throughout his pamphlet, the professor refers to the people of the US not as citizens or taxpayers, but as "consumers". Obviously, he seeks to create the impression that we are all victims of a monster called "business". He overlooks completely the fact that ours is a business nation, that these consumers — unless they are doctors, lawyers, dentists or on a government payroll — themselves constitute the business community. It is therefore especially interesting that Dr. Schlesinger's initial suggestion for increasing Federal revenues is a tax on advertising. That his first effort should be to deaden the nerve that energizes the American economic system should be significant not only to the National Associated Businessmen, but to every last one of us who believes that Government must be our servant, not our master.

Nobody elected this Schlesinger to anything. But he speaks on high — and we had better start talking back.

WE'VE GOT HOMEWORK

Advised by the latest report on the election returns that President-elect Kennedy will be the twelfth American President to be elected with less than a majority of the popular vote, we are reminded once more that our Electoral College system is not what it was set up to be.

Maybe it worked alright when there were 13 states. But it is certainly all wrong when victory in half that many can establish the winner in all 50.

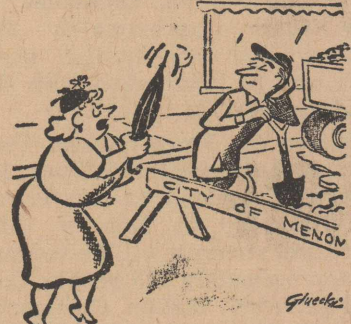

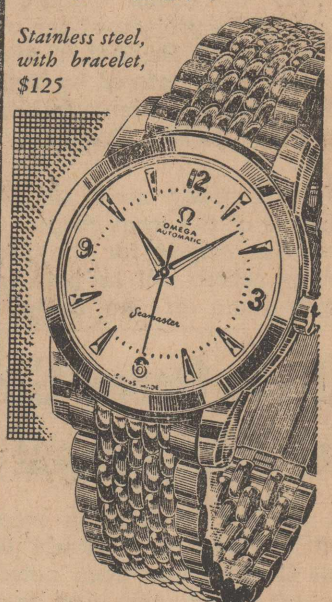

Tax statements have been mailed from the Collector's Office to all Crockett County tax payers for 1960 taxes.

Taxes are payable beginning October 1 and until Feb. 1 without penalty. However, early payment will earn you a discount on state and county taxes.

1% Discount For Payment in Dec.

NO DISCOUNT ON SCHOOL TAXES

If you desire, you can pay your taxes in two payments — First Half in October or November and the last half by June 30 without penalty.

No discount on first half payment but on last half payments 3% discount if paid before April 1; 2% if paid before May 1; and 1% if paid before May 31.

Graduated penalty and interest applies on taxes that become delinquent.

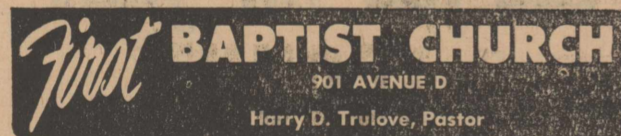

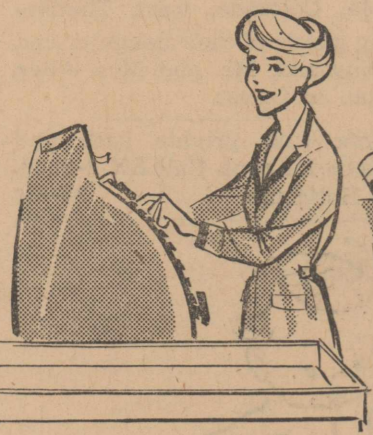

1918-1919

Mrs. C. W. Connery, president of the Texas Federation of Women's Club, urged Texas Clubs to remain organized but to correlate their work with war service. Ozona women responded immediately. No yearbooks were printed because of paper shortage, business meetings were curtailed, but all reports relating to Federation matters were sent to State and District officers. The 1917-1919 yearbook of the State Federation carried the following information: Ozona Woman's Club, membership 52, President Mrs. Frank Friend, corresponding Secretary Mrs. Joe Blakney and chairman of Music Department, Mrs. W. E. Newton.

A few concrete examples, are suggestive of the quality and quantity of service rendered by the Ozona Club women. They made bread of rice flour and corn meals; planted gardens, and canned food; knitted socks, mufflers and sweaters for the men in the service; made and furnished Army Kits; made surgical dressings and hospital garments; talked and bought stamps and bonds; encouraged the ranchmen husbands in their efforts to increase production of wool and meat; smiled and sang "Over there" while their hearts were a-fraid and sad; "Kept The Home Fires Burning" and celebrated on November 11, 1918, though darkness was brewing at home.

An epidemic of influenza hit Ozona soon after the Armistice was signed. Club women joined Crockett County officials, doctors and other citizens using every precaution — yet cooking and nursing for those where whole families were ill, but the melody was

highly contagious, deadly severe, and usually ran its course wherever it struck. In years to come, names and dates chiseled on gravestones will be a grim reminder of this episode in Crockett County history.

Mrs. Friend was an ardent and faithful club member. No office was too important or too unimportant for her to assume, as long as she lived in Ozona, or after her family mover to San Angelo. She held many District offices, chairman of Forestry, of Literature, and State Chairman Pageantry. In 1927 she was elected second vice-president of State and was presented by The Ozona Woman's Club while Mrs. W. E. Smith was president; and by the Child Welfare Club with Mrs. Hugh Childress as President. She was also first vice-president under Mrs. Volney Taylor of Brownsville. In 1936 she with other TFWC officers participated in the opening ceremonies of the Texas Centennial in Dallas, and was a guest at the luncheon honoring Mrs. Franklin D. Roosevelt.

"Miss Ollie" was always interested in the welfare of her community, she belonged to the Methodist Church, acted as steward, teacher, educational chairman and

president of the Women's Missionary Society. She worked with PTA for better schools, was Worthy Matron of Ozona Chapter of the Eastern Star, and Noble Grand Matron of Ozona Rebekah Lodge.

She became interested in the Big Bend Park and was chairman of the Citizens Committees of Highway Beautification of the Park.

She was a native of Crockett County — being the daughter of Mr. and Mrs. B. F. Byrd, early day pioneers, and was married to Mr. Frank F. Friend, the son of Joseph Warren and Martha Coates Friend who were also early day settlers. They were the parents of two daughters, Floy, (Mrs. Redman Hume) and Hazel (Mrs. Early W. Suddreth.) The Friends now reside in San Angelo.

Her hobby is poetry, the San Angelo Poetry Society was organized in her home. She has had many prize winning poems and published at least one book of poems "Yucca Lilies" under her pen name of Byrd Friend.

She obtained her schooling in the Ozona and Kerrville High Schools, later attended Southwestern University, and taught for four years. She had national executive ability and was a well rounded scholar and an influential speaker.

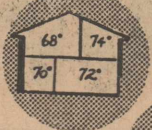

Notes From The County Agent's Office

By Pete W. Jacoby

Feeds which supply low cost protein and low cost energy are matters of real concern to beef producers. Grain is considered the cheapest energy source, and protein supplements should be chosen on the basis of their protein content and cost. U. D. Thompson, extension animal husbandman, says that anyone considering the purchase of a supplemental protein feed for beef cattle should note the price per 100 pounds, the percentage of crude protein supplied by the oil seed protein meals, percentage of equivalent protein from non-protein nitrogen, and the crude fat and fiber content. The higher fiber content feeds should be cheaper than others.

Determine cost of crude protein on a per pound basis, says Thompson. Divide price per cwt. by percent protein: as cotton-seed meal 41 percent @ \$3.50 cwt.; \$3.50 divided by 41 equal \$.085 per pound, Urea 262 percent equivalent protein @ \$5.50 per cwt.; \$5.50 divided by 262 equal \$.021 per pound.

Other factors should also be considered when choosing a supplement. Mixtures containing ingredients which limit consumption have the advantage of saving labor and distributing herd consumption more evenly. Mixtures of salt land cottonseed meal have had extensive use for this type of feeding, but Thompson warns that water must be readily available when excessive amounts of salt are consumed.

The amount and quality of roughages fed may also influence selection of a supplement. More feed is needed where forage is limited, thus a feed supplement which includes both protein and grain may be more useful than a straight protein supplement. The possibility of vitamin deficiency also has a bearing on the choice of feed supplements.

No one has yet found a supplement that fills all needs and is economical to all beef producers. Thompson says that individual feeders must decide what supplement to feed in their particular operation. He concludes by suggesting a conference with the county agent before deciding on any one feed supplement.

Early Christmas Mailing Sought By Postoffice Force As Cramped Quarters Pose Problems For Efficient Handling of Expected Holiday Volume

Early Christmas mailing and general consideration by the public is once again being sought this Christmas season by local postal employees, according to Ozona Postmaster Floyd Hokit.

Mailing of out-of-state mail in advance of December the 10th and of local greeting cards by not later than December 16th would greatly aid the local Post Office in handling the Christmas rush in the presently cramped quarters, the postmaster said.

Even though not a problem at Christmas time alone, the proper and legible addressing of all mail posted is of great benefit both to clerks in handling the mail properly, and also to you in getting prompt and accurate delivery of your parcels or cards.

As has been the case for the past several years, mail sacks will be placed in the lobby and it is requested that you separate your local, out of town, and out of state mail, tying each bundle securely before placing it in the proper sack.

Written matter may be included in packages but should be properly noted on the outside so as to allow correct postage payment. The use of zone numbers, when known, can also be of great aid in speeding your mail to its destination as quickly as possible.

Elsewhere in this paper is a notice to bidders on a new Post Office in Ozona, but in the meantime Ozonans can greatly relieve the congestion in the present office by frequent checks of your boxes, since it will not be possible for the office to work the bulk of mail and put up the package slips on the same schedule that is followed through the year. Your prompt claim on parcels, the arrival of which you have been notified by slips in your box, can do much to relieve the great shortage of space which will develop as the mail rush gets heavier in December.

The early purchase of stamps for the mailing of cards will also aid clerks in giving prompt attention to your needs and also relieve you

of the necessity of long waiting for service later on.

In general your cooperation at this time is sought and will be greatly appreciated, postmaster Hokit underlined.

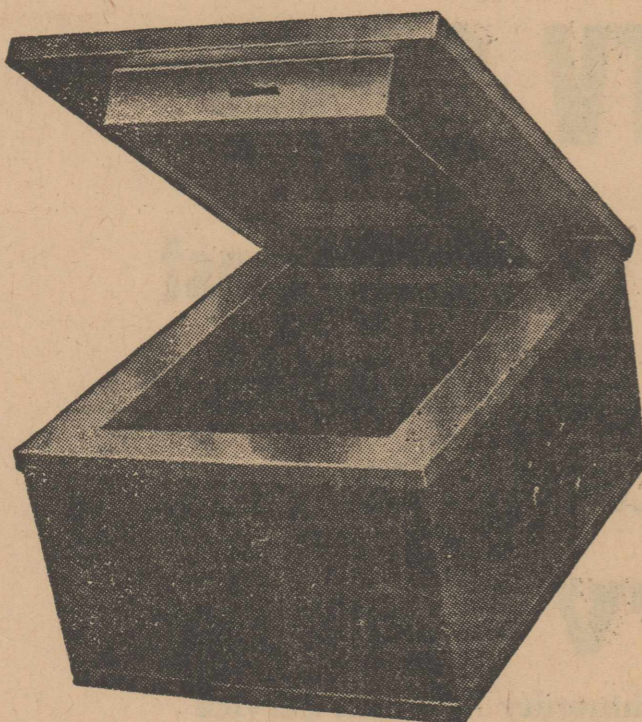
