Ozona's official Little League season opened Thursday night with a tremendous crowd on hand to see the Ozona Oilers down the B&B Grocers with a score of 3-1 in the first game and the Flying W Ranchers trounce the Moore Oilers to the tune of 18-6 in the second game. In Monday night's double header, the Ranchers beat the Ozona Oilers in a close one, 15-14, taking the league lead. The first game saw the luckless Moore Oil team downed by the B&B crew 12-5.

Moore Oil and Ozona Oil looked pretty evenly matched till the third inning when the Ozona Oilers picked up 2 runs. Pete Ybarra hit a home run in the fifth for Moore Oil's only score in the game, and Ruben Tambunga came on in the sixth to homer for the Ozona Oilers. Tambunga went all the way on the mound for Ozona Oil. Robert Lee Daniel started for the Grocers and was relieved in the fourth by Ybarra.

In the second game, Flying W gave up two runs on errors in the first inning to Moore Oil. Going into the fourth the Oilers held a 1 run lead when the Ranchers got hot with their bats and went ahead 9-4. The Oilers added 2 more in the fourth and the Ranchers broke loose in the sixth with everybody collecting hits and scored 9 runs to end the game 18-6. Judge Bernice Jones Forced Into Run-Off With Williams For Judge; Sutton, Young Battle In Prec. 4

Funds Assured For Ft. Lancaster Work and Care

A financial campaign conducted by R. A. Harrell on behalf of Fort Lancaster development plans has assured the necessary funds to assist in the exploratory excavation work to be done this summer under the supervision of Dr. Edward B. Jelks of the SMU department of Anthropology, and to provide a caretaker service at the site for the balance of this calendar year.

Harrell has secured donations totalling \$1,177 plus pledges totalling \$50 per month for one year to go toward caretaker salary.

Dr. Jelks and Dr. Curtis Tunnell, state archeologist, who visited the Ft. Lancaster site recently, had estimated that the extra labor expense necessary to do the summer work at the Fort would reach \$600 and this amount was pledged by the Crockett County Historical Survey Committee, headed by Mrs. R. A. Harrell. The \$600 has been paid to SMU which in turn will carry all liability insurance on workmen employed on the project. The balance will be apportioned to paying the caretaker's salary until the first of the year.

The local committee is making efforts to find a trailer house to be used as a residence by the caretaker on a temporary basis. The committee is interested in receiving the use of a trailer house as a donation or on a rental basis.

Dr. Jelks will arrive late this month and expects to work through June 18. He plans to have the works open all day the 18th so that persons attending the Ozona Diamond Jubilee may tour the site to view the work accomplished. The Permian Basin Historical Society plans to hold its quarterly meeting in Ozona for the first time the last of the Jubilee week, and members will tour the fort site.

Vocational Nursing School Planned By Crockett Hospital

Applications for enrollment in a School of Vocational Nursing will be received at the Crockett County Hospital the next two weeks. Plans are to start the school June 6.

Applicants must be 18 to 55 years of age; show proof of 10th grade education; be a citizen of the US or have declared intention to become a citizen; furnish hospitalization insurance; submit to an interview; pass a pre-entrance exam and have a physical examination.

The hospital board will select students from the list of applicants. The cost of the 12-month course will be approximately \$100 to the student, payable on the installment plan. Students must be able to devote full time to the school.

All persons interested in enrolling in the school are asked to contact N. L. Olson, administrator, or Mrs. A. K. Johnston, director of the school.

A record breaking 1,281 voters went to the polls Saturday in the Democratic Primary to select their nominees for the general election coming up in November for state district and county offices.

Judge Bernice Bailey Jones in her bid for a first elective term, was forced into a run-off with Troy Williams. Judge Jones led the ticket with 433 votes, followed by Williams with 384. Carl Conklin was close behind Williams with 338 and W. W. (Woody) Mason trailed with 107 votes. Jones and Williams will vie for the 445 votes cast for the other two candidates in a run-off election to be held June 4.

Diamond Jubilee division heads, committee chairmen and others connected with the Jubilee will meet Monday night at the Civic Center at 7:30 for a progress report. Mel Eckerstrom, Rogers Company representative, will arrive in Ozona Sunday afternoon to stay until after the Jubilee. He will be present at Monday night's meeting.

The nominee for commissioner of precinct 4 will also be determined in the June 4 run-off. Glenn D. Sutton, incumbent, polled 121 votes, forcing him into a run-off with Jake Young, who polled 83. Other candidates and vote counts included Al Ramirez, 34, Bekie Diaz, 26 and Basil Dunlap, 22.

In the commissioner's race for precinct 2, Rex Halydier, the incumbent, won easily over his three opponents with 178 votes. J. P. Pogue followed with 65 votes, Richard Flowers, 31 and Tom Montgomery, 20.

Other county officials, who were up for re-election, were uncontested in the primary. At the state level Crockett County voters gave Governor Connally a lead of 837 votes over his nearest opponent, Stanley Woods. Connally received 1,000 votes to Wood's 163 and Johnnie Mae Hackworth's 33. For Lieutenant Governor, the incumbent, Preston Smith received 947 votes to Bill Hollowell's 181.

For United States Senator Waggoner Carr with 936 votes won over Jack Willoughby, who polled 203 votes. Carr won the nomination state-wide and will oppose Republican Senator John Tower in November's general election.

Crockett County voters went along with the remainder of the state in their choice of nominees for Attorney General, by forcing Franklin Spears and Crawford C. Martin into the June run-off election. Voters here gave Spears 398, Galloway Calhoun 190 and Martin led the ticket with 542.

For Commissioner of General Land Office, the incumbent, Jerry Sadler got 609 to Fred Williams 526. In this race the vote over the remainder of the state was heavily in favor of Sadler. Byron Tunnel carried Crockett County as well as the rest of the state and will be returned to the office of Railroad Commissioner providing he wins in the general election this fall. Tunnel polled 840 votes here with Haring getting 161 and Ervin trailing with 107. (Continued on Last Page)

Recipe of the Week

From Kitty's Kitchen

Correction in last week's gingerbread recipe; add enough brown sugar to molasses to measure 1 cup, not sugar. It will not work with white sugar. I hope no one has tried it yet.

Cherry Crown Cake

2 cups (7 oz.) packaged grated coconut
2 1/4 cups flour
1-1/2 cups sugar
1 tablespoon baking powder
1 teaspoon salt
1/2 cup butter
1 cup milk
1 teas. almond extract
2 eggs
1/2 cup pecans
1 — 1 lb. 5 oz. can prepared cherry pie filling, chilled.

Preheat oven to 350 degrees, grease 2 nine-inch layer pans and sprinkle two-thirds cup coconut in each of two pans. Combine in mixing bowl, flour, sugar, baking powder and salt. Add butter and milk and blend at low speed. Beat at low speed 1 1/2 minutes, add almond extract and eggs and beat 1 1/2 minutes at low speed. Blend in pecans and spoon batter carefully over coconut in two pans. Sprinkle one-third cup coconut over batter in each pan. Bake 35 to 40 minutes or until cake springs back when touched. Cool on wire rack. Fill and top with cherry pie filling, spreading to within one inch of edge of top layer. Frost sides and top edge with butter cream frosting below:
Butter Creme Frosting
2 tablespoons flour

1/2 cup milk
1/2 cup butter
1 cup sifted confectioner's sugar
1/2 teaspoon almond extract

Combine flour with milk in a small saucepan and stir until smooth. Cook over low heat, stirring constantly, until very thick, cool completely. Cream butter and powdered sugar along with almond extract until light and fluffy. Beat in flour mixture until smooth. After frosting cake, refrigerate.

This is a most elegant cake and truly 'fit for a king', however, its full of calories and very rich so if you are a weight watcher, you'll want to pass this one up.



Mrs. Ted White Retires After 29 Years Of Teaching

Mrs. Ted White, a teacher in Ozona public schools for 23 years, and presently junior high English teacher, has tendered her resignation from the teaching profession effective the end of the current school session. She has taught a total of 29 years.

Mrs. White began teaching in Brown County in 1926. She taught in Donna and Sonora before coming to Ozona Junior High in 1934, where she taught social studies, art and girls p. e. until 1939.

Crockett Gains Location And New Canyon Producer

Crockett County drew location for a wildcat and a confirmation was completed.

Greathouse, Pierce & Davis Midland, will drill the No. 1 Augustine, an 8,500-foot wildcat, in Crockett County, 10 miles northeast of Ozona, 3 1/2 miles southwest of the same operator's No. 1 Bailey, Canyon sand discovery 1 1/2 miles southwest of a northeast extension area of the Ozona (Canyon) field.

Location is 1,320 feet from the south and west line of 24-GH-GC&SF.

It is also 1 1/2 miles northeast of Tucker Drilling Co., Inc., No. 1 Bailey, an 8,015-foot wildcat failure, abandoned Aug. 28, 1964.

The DePaul multipay field of Crockett County gained its fourth lower Canyon producer and a one-mile northeast extension to that pay with completion to that pay with completion of Delta Drilling Co. and Pauley Petroleum Inc. No. 1 Scheuber, 8 1/2 miles southeast of Ozona.

It was finalized for a calculated, absolute open flow of 3.3 million cubic feet of gas

per day, with gas-liquid ratio of 66,700-1. Production was through perforations between 7,815-8,052 feet, which had been fractured with 173,000 gallons and 160,000 pounds of sand.

Drilled to 9,256 feet, 5 1/2-inch casing was set at that depth.

Location is 660 feet from the south and 1,260 feet from the west lines of 33-KL-GC&SF.

The field has one Strawn producer, which is dually completed from the lower Canyon.

PABLO DIAZ ENDS OHS YEARS IN MAY







Johnson. Hokit pointed out that no new accounts can be opened and no deposits accepted and that interest will end on the anniversary date of each certificate.

For convenience, all certificates held by a depositor may be cashed at the same time and interest will be paid for each full month they

have been outstanding beyond three months from interest date.

Unpaid deposits remaining in the Post Office beyond June 30, 1967, will be transferred to the Treasury Department in a trust fund and will be available for payment with out time limitation when proper claims are received.
