

## Rotarians Entertained With Talk And Pictures Of Africa Presented By Roy Harrell, US Envoy to Chad

Time passed much too fast for Ozona Rotarians and their guests at their Tuesday noon luncheon when they were treated to a brief talk and presentation of slides of scenes in Africa by Roy A. Harrell, recently returned from more than three years of service for the U. S. State Department, assigned to the U. S. Embassy in Chad, Africa.

Mr. Harrell and his family are here spending a vacation with his parents, Mr. and Mrs. R. A. Harrell, while awaiting a re-assignment by Washington. He was expecting a call momentarily at midweek advising him that his "vacation is at an end and time to go back to work"

The color picture slides were excellent photographically and fascinating in subject matter. Harrell, an accomplished photographer, showed only a small group of his collection of pictures taken in his travels over many areas of Africa. He was able to get some excellent pictures of wild animals, lions, various types of antelope, a rare picture of a group of elephants, with several young in the herd, at a watering, a menacing looking rhino, hippos, giraffe, etc. and some closeups of natives in their colorful dress, hairdos and face paint.

The selected group of pictures showed some of the native villages, the arid areas in the north and the lush tropical areas to the south, the modern cities

with modern buildings, parking meters and paved streets. Chad, a former French controlled area, is an independent country about 550,000 square miles in size.

"Africa is a big continent," Harrell said. "You could set

## Arrest Made In Roadside Murder Case Near Here

Albert Cecil Taylor, Jr., arrested in Arroyo Grande, California, following an investigation extending from Ozona to New Orleans and back again to California, has been charged in Justice of the Peace A. O. Fields' court with the murder of Ray C. Lahey.

Lahey's body was found March 27 fifteen miles west of Ozona. He had been shot three times and apparently robbed. His body was found on a ranch road just off Hwy 290. His car, a late model Volkswagen, was found the next day in Fort Stockton near the bus terminal.

District Attorney Dixon Mahon said investigation locally, in Houston and New Orleans, which was Lahey's home, led to Taylor's identification.

Principal investigators in the case were District Attorney Mahon, Sheriff Billy Mills, deputies Von Parker, Bob Caldwell and Clarence Lange and Department of Public Safety officer James Cumby.

#### YARBOROUGH TURNS HIS BACK ON TEXAS

Ralph Yarborough has again shown his loyalty is not to Texas but to the AFL-CIO, the NAACP and the Northern ultra-liberals.

Yarborough should be retired in this year's election—whether by Democrat Lloyd Bentsen or Republican George Bush or Robert Morris. His vote last week with the AFL-CIO and NAACP dominated Senate majority to refuse confirmation of Southerner and conservative G. Harrold Carswell to the Supreme Court should definitely brand him as anti-South and anti-Texas in the minds of every right-thinking Texan.

#### TRUTH Or CONSEQUENCES

Add to the disgraceful crime picture in our Nation's Capital one more black eye. It has just been revealed that Washington now has the highest syphilis incidence rate in the nation, and is in fourth highest position for other venereal diseases. The statistics were compiled by the American Social Health Association in cooperation with six leading public health and medical organizations, including the American Medical Association.

Of the various diseases loosely termed "VD", syphilis is the deadliest and most horrifying killer of them all. Because syphilis is almost entirely contracted by immoral or sexual contact, it is seldom mentioned. People die from heart attack, cancer, or TB — but when did you ever see a death notice "Died from VD"?

Within a matter of hours after sexual contact, the deadly spirochete enters the bloodstream and spreads throughout the body. It may take from ten days to ten weeks for any visible sign of the death-dealing germ to appear. Because it is painless, it is easy to miss, but unless destroyed by medical treatment, it will remain alive longer than the victim.

The second stage symptoms begin to appear in about six weeks — headaches, pains in bones and joints, sore throat and/or a barely detectable skin rash.

Now, the spirochete is ready to strike — to incapacitate or kill. The microbe may attack the spinal cord, the nerves, the heart, the brain, the eyes, the bones, or a combination of them. Doctors bluntly state: "The prognosis of cardiovascular

syphilis is poor, and sudden death is not uncommon." In plain language, if syphilis hits your heart, chances are you are dead brother. But maybe those who die quickly are the lucky ones. Syphilis literally destroys the brain, bringing about insanity, loss of memory, delusions, deafness, blindness, convulsions, extreme and/or continual pain.

THERE IS NO CURE. Even if quick action is taken and the microbe is killed by medical treatment, there is no cure to any damage already done to the body and mind—that is permanent.

The only sensible solution is to teach our young people and others through legitimate sex education that pre-marital and extra-marital sex is wrong — and if they are not strong enough to resist it, they may have to pay the consequences; a living horror for the rest of their lives.

JUDGE CARSWELL. After the Senate, aided by 13 Republican rebels, voted 51 to 45 against confirmation of Judge Carswell, an astute capitol observer said: "Well, that's twice the U. S. 





## Crockett Draws Wildcat, 3 New Pay Prospects

A wildcat was scheduled in Crockett County, a prospective pay opener was swabbing oil and water, a confirmation was indicated in another field and an extender completed in still another were reported during the past week.

Wallen Production Co., Midland, will drill the No. 2 Wallen-Helbing as an 8,600-foot Simpson wildcat and as a project in the Ozona (Canyon sand) gas field, five miles south of Ozona and 18 miles east-northeast of Ozona, Southwest (upper and lower Simpson and Strawn gas) field.

Location, on a 640-acre lease, is 1,320 feet from the north and west lines of 8-MN-GC&SF.

Texas Crude Oil Co., Midland, No. 1-35 University, in 35-7-University, re-entered former Ellenburger opener and lone producer from that pay and prospective Strawn pay re-opener in the World multipay field, 13 miles southwest of Big Lake, pumped 24.84 barrels of oil and 81 barrels of water in 48 hours from the Strawn.

Recovery was through perforations at 8,014-022 feet. Testing continued. Original completion was Nov. 11, 1966, was by B. L. McFarland, Inc. for 221 barrels of 42.1 gravity oil, no water, through a 14-64-inch choke and Ellenburger perforations at 8,050-70 feet.

Third 7,890-foot Pennsylvanian producer and a 5/8 mile west-southwest extension to that pay was assured in the Davidson Ranch multipay field with the flowing of 60 barrels of load in 24 hours, plus gas at the rate of 3 million cubic feet daily, at Texaco Inc. No. 2-D A. R. Kincaid Trust, in 6-KL-GC&SF, four miles southeast of Ozona.

Flow was through a 1/4 inch choke and perforations at 7,879-951 feet, with tubing pressure of 1,650 pounds. Testing continued.

The field has one 8,606-foot detrital gas and two 6,200-foot Canyon gas producers.

The Ozona (Canyon sand gas) field gained a 1/2-mile west and north extension with completion of Ormand Industries, Inc., formerly Ryan Consolidated Petroleum Corp., Odessa, No. 2 Cox 20 miles southwest of Ozona, for a calculated, absolute open flow potential of 210,000 cubic feet of gas per day, with gas-liquid ratio and gravity of the liquid unreported.

Production was through perforations at 6,691-7,082 feet and 7,041-046 feet, which had been acidized with 3,500 gallons and fractured with 60,000 gallons and 60,000 pounds of sand.

Location is 1,800 feet from the south and 1,320 feet from the west lines of 22-2-I&GN.

## Todd Deep Field Test Shows Oil

J. S. Abercrombie Mineral Co., Inc., Houston, No. 1 J. S. Todd, in 17-YZ-EL&RR, Crockett County wildcat 18 miles west-northwest of Ozona, eight miles west of the Todd Deep (Crinoidal and Ellenburger) field and 2 1/2 miles west-northwest of the Todd, Southwest (Grayburg and San Andres) field, recovered oil on two of four drillstem tests.

Recovery was 10 feet of drilling fluid on a 45-minute drillstem test at 5,425-512 feet in an unidentified zone, probably Wolfcamp. Flowing pressure was 43-57 pounds; 30-minute initial shut-in pressure, 71 pounds; 60-minute final shut-in pressure, 57 pounds.

A test, unreported time, at 6,798-818 feet, identified as the Crinoidal, recovered 20 barrels of 43 gravity oil and 2 1/2 barrels of salt water, gas surfaced in 15 minutes, no gauges. Flowing pressure was 118-295 pounds and 265-610 pounds; initial shut-in pressure, 2,911 pounds; final shut-in pressure, 2,986 pounds.

## St. Augustine Lawns Threatened By Virus Disease

"If you have noticed your St. Augustine grass dying in spots, more that likely, it has the new virus disease," Coon Chandler, local horticulturist says.

"The disease 'St. Augustine Decline' has been spreading in Texas for the past three years," Chandler said, and added that grass farms in the lower Rio Grande Valley have been quarantined since the disease made its appearance, and the nurseries have quit selling it.

According to Chandler, last year residents of the city of Corpus Christi lost nearly all their lawn from the disease. There is no cure for the virus.

Chandler said the disease usually appears as a round dead spot in the grass which keeps spreading. He said if you dig under the grass you will find that the roots are dead and have a molded look. He believes he has found the disease in several Ozona yards and when the grass gets greener, he expects the conditions to become more noticeable.

"When the grass is green," he said, "the disease is easily discernible by yellow spots on the blades of grass." Since there is no cure for

the virus, Chandler recommends the following precautions for healthy yards:

Keep yard fertilized well and watered well.

Don't use any garden tools except your own, such as, lawn mowers, carts, etc. The virus is easily spread from one yard to another by tools.





### No Restrictions On Use Of 2,4,5-T On Pasturelands

State headquarters of the U. S. Soil Conservation Service at Tyler has sent an advisory to all area conservationists and conservation districts in response to many inquiries received on the use of the herbicide 2,4,5-T. Clitis H. Sinclair, Ozona SCS conservationist, reports.

"The State Office has not received any official correspondence on restricting use of 2,4,5-T on lands supporting perennial plants grazed by domestic livestock and big game animals," the advisory said. The Texas chairman of Brush Control committee has received a letter from the President's Office of Science and Technology on the use of 2,4,5-T, the advisory said. A quote from the letter reads as follows, "The present regulatory actions under consideration deal explicitly with food crops - not pasture or forage."

"Unless the oil Conservation Service in Texas receives official notification restricting use of 2,4,5-T, the present policy of assisting operators effectively use 2,4,5-T in control of undesirable plants on lands in perennial vegetation will continue," the letter said. "In the past very limited use of 2,4,5-T has been made on cropland."

The usual warnings against improper use of the herbicide and the possible damage to crops from aerial spray drift was included.



the United States and Canada down on Africa and have Africa sticking-out on all sides," he said.

A touch of West Texas was introduced by this West Texan to Africans — the windmill. In the face of vehement French protests that the windmill would not work in Africa the U. S., under Harrell's supervision, installed several mills over existing wells and along known cattle drives. They worked fine but the French still protested they wouldn't work — because they wouldn't work in France, for lack of wind. The windmill waterings resulted in considerable weight saving on cattle drives because the cattle could be watered often enough to prevent shrink.

Harrell does not know what his next assignment will be — he will report to Washington when ordered and receive his assignment there. He has applied for overseas service again, he said.
