

# **DOWNPOUR GOOD THING.**

Much Benefit to the Range in West Texas and to Wheat in Northern Portion of the State.

Weimar, Colorado County, Texas, Nov. 3.-Light showers of rain fell here last Friday and on Saturday, but yesterday there was a downpour, sufficient to fill the streams and furnish water for stock generally throughout this section, and it still continues. The weather is warm and vegetation is as green as in springtime. Grazing for all kinds of stock is better here now than for any year past at this season within the recollection of any old citizen. Stock in prime condition and raisers think they will go into the winter with the certainty of living through without the use of much grain, which

is not in abundant supply here, and the prices are high for all sorts. Corpus Christi, Nueces County .-- A fine shower of rain from the northwest fell here, and in the adjoining country last night about 6 o'clock, and is still on, with good prospects of a

downpour. Cabbage and other crops are in fine condition now and the rain will prove of inestimable value. La Grange, Fayette County .-- A very heavy rain, lasting over two hours, fell at this place this afternoon. This rain will benefit fall gardens and will also

benefit the farmers by filling their tanks with stock water and making the grass revive and put on a new growth.

# AN INHUMAN FATHER.

He Kicked His Little Boy to Death and May Be Lynched.

Inez, Ky., Nov. 3 .-- Pleasant Sprading, held for killing his 4-year-old son, and his 15-year-old daughter, is threatened with lynching. Sprading's family consisted of his wife, three daughters, and a son. With his daughters and boy the father was herding sheep last Friday. The boy was unable to keep up with the others. The father placed him on a stone beside a spring, telling him to wait until his return. The boy. becoming tired, began to peel the locse bark off a tree overhanging the spring. Presently his father returned, and noticing the bark a state boy who had done it. The boy replied that he bad.

"I would rather have you dead than raise you to destroy everything on the farm," is the reply the fater is said to have made, and then, it is charged, he picked up a stone and struck the boy on the head, knocking him down. Then, it is alleged, he kicked the prostrate boy in the head until he had killed him, and turning to his daughters threatened them with a like fate if they ever told what had occurred.

Afterward he went home and said the boy, while chasing sheep, had run against a tree and killed himself.

Becoming alarmed he took his eldest daughter and went to the mountains. His wife hired neighbors to bury the body of the child and then went to the home of Judge R: Hensley. She told him of the death of her son and said she suspected her husband and added that at different times he had threatened to kill the whole family. The judge took her with her two younger daughters to his home and presented the case to the grand jury. One of the little girls told the judge that her father kicked the boy to death. Shortly afterwards a posse captured Sprading in the mountains, but his eldest daughter is not with him. The posse is still searching for her, while he is held on the charge
