



He believes that many of the annoying and embarrassing features now attending the search of baggage brought from abroad may be done away with, to the advantage of the service and without involving risk of loss to the government, Passengers on incoming ocean steamers, says Troy (N. Y.) Times, will no longer be "rounded up" in the cabin at the end of the voyage and be obliged to swear to the contents of their trunks, bags and suit cases, but blanks will be distributed early in the voyage and there will be opportunity for a leisurely preparation of a list of foreign articles. The statements will be placed in the hands of responsible. officers, and each passenger will receive a coupon with a corresponding number. This coupon, handed to an inspector on the dock, will be the voucher for the passenger's good faith. There will be no swearing as to dutiable or nondutiable articles, and much time will be saved and inconvenience avoided. Of course the new system will not exempt anyone from penalties for smuggling. The government simbly gives the passenger courteous treatment, expecting compliance with the laws in return.

MAN AND THE BETTING GAME.

#### He Who "Plays a System" at the Race Track Certain to Quit Loser.

Here is an interesting letter: "I play the nags once in awhile. 1 think I have a pretty fair system and was just thinking of trying it when I ran across an article which caused me to hesitate. If a man sticks to his system, has control of himself and is not a hog, but satisfied with a modest wager, is there no chance of success? Do you think it impossible to win by a system? Is there any reason why a man cannot keep decent and still play the game?" Ever since Diomed won the first

derby in England system after system has been devised for "beating the races.". No system-not a single one -has ever succeeded in the long run. It has been figured out that there are 27 chances to one against you always in a field of ten horses. The best system ever known is at the mercy of the betting ring. There are not bookmakers enough in the United States to lay against a system. Several years ago a man started with a five-dollar bet, doubled it after each loss and returned to the original five dollars after" each winning. For awhile he prospered amazingly, playing nothing but the favorite, but in the end he went broke.

If a man with a system could bet against the United States treasury he could win. At Sheepshead Bay 14 favorites lost in succession. The fifteenth started at odds of three to one and was an easy winner. Now, figure out the predicament of the man with the system. Starting with five dollars and doubling after each loss he found it necessary to go into the ring and bet the sum of \$81,920. He stood then a loser of \$81,945. If he could have bet on the fifteenth favorite he would have had at issue over \$163,000. Now, anybody who knows the betting ring knows that it would be utterly impossible for a dozen Joe Vendigs to place practically \$82,000 at three to one. But-if it could have been placed the system man would have won \$246,000.







ASHINGTON .- Apply at the recruiting office early and avoid the rush.

A move is on foot to increase the pay of United States soldiers and sailors, which was fixed more than 50 years ago, and it was expected that when the increase is granted there will be a rush of recruits.

It has been generally assumed that Uncle Sam's soldiers were by far the best paid in the world, and that belief has in large part been the cause of the failure of attempts made in the past to secure increases in pay.

But now, in connection with the systematic preparations that are being made to lay the subject of "something wrong in the army" before congress at the next session it has been discovered that this belief is founded in error and that several nations are much more liberal in the treatment of their soldiers than is the United States.

The fact will be brought to the attention of congress in connection with the subject of a general increase in the salaries of both army paid to the soldier compared with the and navy.
