## **DRAWS 25 YEARS** FOR WIFE MURDER

Winnie Anderson, an I.-G. N. locomotive engineer, was given 25 years in the penitentiary for.

Crockett, having been an engineer on fraight trains through Crockett before taking a passenger run between Palestine and Longview. He and his wife were both reared in Palestine.

Anderson was 44 years of age and leaves a son 22 years old. Quarreling with his wife at night, he arose early the next morning, struck her on the head with his pistol and continued kitchen, got a butcher knife, came back and cut his wife's' throat from ear to ear. Returning to the kitchen, he prepared his breakfast, after which he went out on his passenger run to Longview, but returned to graph that his wife had been


## **CROCKETT BEATS** HOUSTON OILERS
