**OWNERSHIP OF ANIMALS:** Exhibitors must have owned their pigs, lambs, feeder steers and heifers and have them in later than Decen

than two of one six. 2. Each exhibitor may enter 3 hogs which may be barrows. gilts or any combination of the

3. Each exhibitor may enter 3 sheep which may be ewes, wethers, or any combination of the same

#### **DIVISION RULES** BEEF:

1. Beef division is open to purebred and crossbred heifers and steers.

2. Animals must be carrying milk teeth the dy of the show, with no permanent teeth in view. Heifers may have one set of permanent teeth and shall not have calved.

3. Steers must weigh 725 pounds and over and will be weighed and divided into three equal classes of light, medium and heavy weight.



### **Baby Returned** To Parents Safely

At 10:40 a.m. Tuesday morning, just four days after their infant son was kidnapped from their home in Albuquerque, Mr. and Mrs. Edward Norris rushed into the lobby of West Plains Medical Center in Muleshoe for a tearful but happy reunion with their baby boy. The reunion took place in Hospital Administrator Marshall Cook's office.

"Thank God," was all Edward Norris could say, when he received the call telling him the baby had been located unharmed in Muleshoe. "The worst part was the waiting and not hearing anything, and not knowing what she wanted with him," replied Mrs. Norris when she was interviewed by the news media at the local hospital Tuesday morning. Asked how she felt now, Mrs.

### **Bullock** Names Back Sales Tax Judgments

AUSTIN -- Comptroller Bob 6,500 persons with sales tax Bullock released the names judgments against them totaling Wednesday of 231 delinquents \$12.5 million. in his Lubbock district against

The Comptroller said he is sending every newspaper, television and radio station in the state a list of those delinquents in their area who have state judgments against them. The information is all public record, he said.

"They didn't start owing this yesterday, either," he said. This is money we spent months trying to collect before going to court.

"Sure, it's going to embarrass

some folks and make them mad," Bullock said. "But I'd rather have 6,500 red-faced delinquents coming into our district offices to pay up, grumbling all the while, than to have the other 11 million citizens of this state mad at me for letting this debt to them continue to gather dust.

He said many of the judgments are more than a decade old, and the delinquents named may have left the state. "But many of them are still living in their communities, ignoring our de-Cont. on Page 3, Col 2

### Texas Beef Conference Is Slated

AMARILLO -- The eight cosponsors of the fourth annual Texas Beef Conference announced today (January 28) that the event will be held in Amarillo's Villa Inn Convention

The day-long meeting will feature spokesmen for the West Texas State University, Texas Tech and Texas A&M agricultural schools and research organizations and representatives of various segments of beef feeding, procession and marketing groups.

A conference search committee is now in the process of contacting a list of potential speakers with the hope of securing a national news-maker for the annual T-Bone Club steak feed that will cap the convention. Plans for credentials and registration procedures are being finalized by conference officials now. Last year, nearly 400 representatives of the beef industry attended the conference. **Must Waive** 

Claims AgainstUSDA

A change in federal regulations will require cattle owners to waive all claims against the federal government when their cattle are treated for scabies. reports the U.S. Department of Agriculture (USDA). Officials of USDA's Animal

and Plant Health Inspection Service (APHIS) explained that cattle infested with or exposed to scabies mites are routinely treated with a USDA-permitted pesticide dip. This must be done under APHIS supervision or control, before the animals can be certified for interstate shipment

Occasionally, when losses result from such treatments cattle owners have filed damage claims against the government. The new regulation conforms to a similar waiver provision covering cattle treated for fever ticks - a provision that has long been in effect, APHIS officials said.

The change announced covering scabies treatments was first proposed in the October 22. 1975. Federal Register. The public was allowed 32 days to comment on the proposal, recluded Cont on Page 3, Col 5



At a special news conference today, Jim Reese, former threeterm Mayor of Odessa, announced his candidacy as a Republican for the U.S. House of Representatives, 19th Dis-

In making his announcement Reese said, "I am convinced that the people of this district -and this country -- are fed-up with the big spending by the Congress. just plan to lead a normal life now with the return of their son but would be more protective from now on.

The nightmare for the Norris family began on Friday when a woman in her thirtys, posing as a florist making a delivery entered the home and forced Mrs. Norris and her mother-inlaw into a back bedroom at gunpoint. She tied the women up and took the baby. The kidnapper was wearing a frosted wig and was described as about 5-2, 125 pounds. She told the mother she would receive a telephone call Friday night, but no call was made.

Albuquerque police said Monday the young woman who kidnapped the week-old baby Friday, may have been attracted to the boy and decided to take him for her own.

Police checked out many tips from persons who had seen an artist's sketch of the kidnapper or were suspicious about someone they had seen who had a small child.

It wasn't until Sunday, February 1, that local law enforcement officials learned that there was the possibility that the woman who kidnapped the Norris infant might be a local woman.

According to Muleshoe Police Chief Buddy Black Eileen Lowe of this city, separated from her husband since last August had led members of his family to believe that she was pregnant. On Sunday, January 25, 1976, Gene Lowe, her ex-father-in-law came to the Chief's office and told him that on Saturday, January 24, Eileen Lowe had caught a plane for Oklahoma City that left Lubbock at 10 p.m. She called back to Muleshoe prior to 12 midnight saying she had given birth to a four-pound boy. Gene Lowe had told Chief Black the same day, she had tried to get admitted into the West Plains Medical Center here but they would not admit her because she could not come up with the money for a deposit. Eileen also told her father-inlaw that one of the doctors had given her some pills to hold off

the pain and the baby. Lowe told Chief Black that he learned that Mrs. Lowe had come back to Muleshoe Friday night, January 30, 1976 with a baby. Sunday morning he read in a Colvis paper where a baby had been stolen in Albuquerque, N.M. The description of the woman that stole the baby made him more suspicious. According to the Chief, Mrs. Lowe had been seen in Church

that day (Sunday) with the baby. After talking to some of the

Black and Carpenter, the FBI was again contacted Monday. At noon Monday, a description of the missing baby was received at the Law Enforcement Center as well as a description of the suspect. The descriptions closely resembled the ones connected with the Albuquerque

Bailey County Sheriff Dee Clements said Lowe came to see him Sunday night with a copy of the Amarillo paper and showed him the article about the baby who was kidnapped in Albuquerque. Clements said he and Lowe talked for about an hour. "I told him I didn't know what we could do, that we would have to get information on the baby. but that we would do something," stated the sheriff. Clements said a local minister came to see him with some additional nformation and he then called

The Norris baby was picked up Monday night and taken to West Plains Medical Center until his parents arrived in Muleshoe to take him home. The child was taken to the hospital by FBI Agent Frank Haynes.

Eileen Lowe, 30, of Muleshoe was arrested at her home and transferred to Lubbock County Jail Tuesday. Her father-in-law (Gene Lowe) noticed her with a baby and contacted Sheriff Clements who contacted the FBI. A \$10,000 reward was offered by friends of the Edwards family, for the safe return of the

The baby, John Paul Norris was the only child the Norris' had. "He is our only child and had. "He is our only child and we may not be able to have another. He means so much to us," said the father. "We've been told we couldn't ever have a child. We had this child and he is so important to us. My wife went through years of treatment to be able to have him." The Norris', after having time

to be reunited with their son, and compose themselves then graciously allowed all the time desired by the news media to take pictures and interview them, before returning to their Albuquerque home.

### Grow Your Own Poinsettia Plant

**COLLEGE STATION** -- With a little luck and plenty of tender loving care, that poinsettia plant you received for Christmas can be brought into flower for Christmas, 1976.

"The plant you produce won't be quite the same quality plant as the one you received, but it can be a rewarding experience to produce attractive poinsettias for next Christmas," says Everett Janne, landscape horticulturist for the Texas Agricultural Extension Service.

After the colorful bracts of the poinsettia are no longer attractive, gradually reduce watering until the soil is dry, explains the horticulturist. Supply just enough water to prevent the stems from shriveling. Store the dormant plant in a cool, well ventilated place at 60 degrees F. potting mix - one made up of

two parts soil, one part peat moss, and one part perlite by Water the plant thoroughly water."

and place in a sunny window, keeping it at 70 to 75 degrees F. When the new growth begins, fertilize the poinsettia every two weeks with a water soluble, complete fertilizer. Use the rate recommended for pot plants on the label of the fertilizer con-

"Once the danger of frost is past, move the plant outdoors where it will receive moderate shade in mid-afternoon," points out the Texas A&M University System specialist. "As growth develops, cut or pinch back the top, leaving three or four leaves on each shoot. Repeat this procedure each time the plant sends out new shoots until mid-August. Then bring the plant indoors and set it near a sunny window where the temperature will remain between 65 requires less moisture indoors. As the plant puts on new growth, it will require additional



To have the plant in full bloom by Christmas, keep it in complete darkness from 5 p.m. to 8 a.m. starting the first week in October and continuing until Thanksgiving, advises Janne. Flowering will be delayed if the plant receives any light during these hours because the poinsettia will set flower buds aout 10 weeks after daylight time drops to 11 hours or less per day. In the daytime the plant must be near a sunny window for maximum growth and development of bracts and flowers. Continue to apply fertilizer until mid-December, then reduce applications to one-half the normal amount.

"The greatest mistake made by most people in caring for poinsettias is not providing them with enough sunlight at the right time, watering incorrectly and not cutting back the stems at the proper time," points out the horticulturist.
