Advertisement in England. Has recently

taken a step forward. Sir Chas. W. Dil-

lance, a member of the House of Commons, made

a very radical speech in a very large audi-

ence, which was very enthusiastically re-

ceived. Mr. Dilke dealt in facts and fig-

ures, and exposed the absurdities of the

Government's policy.

He closed his remarkable speech with a

warning to the Government to put its

house in order, and expressed the conviction

that the establishment of a Republic in

England, was a question of time and

education. The meeting concluded with a

petition in favor of a more equal represen-

tation, and a vote of thanks to the speaker.
