OF THE
UNITED STATES,
Passed at the Second Session of
the Forty-Second Congress.
[GENERAL NATURE—No. 102.]
AN ACT further regulating the construction of bridges across the Mississippi river.
Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That all bridges hereafter constructed over and across the Mississippi river under authority of any act of the Senate and House of Representatives, and in compliance with the terms, restrictions, and requirements contained in the fifth section of an act entitled "An act to authorize the construction of a bridge across the Mississippi river, at or near the town of Clinton, in the State of Iowa, and other bridges across said river, and to establish them as post-roads," approved April first, eighteen hundred and seventy-two; and in letting any such bridge the Secretary of War shall have regard to the security and convenience of navigation, to the convenience of access, and to the wants of all railways and highways crossing said river.
Approved, June 4, 1872.

[GENERAL NATURE—No. 103.]
AN ACT to establish a western judicial district of North Carolina.
Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That all territory hereafter to be included in the western district of North Carolina, comprising the counties of Mecklenburg, Cabarrus, Stanly, Montgomery, Richmond, Davie, Davidson, Randolph, Guilford, Rockingham, Stokes, Forsyth, Union, Anson, Caswell, Person, Alamance, Orange, Chatham, Moore, Clay, Cherokee, Swain, Macon, Jackson, Graham, Haywood, Transylvania, Henderson, Buncombe, Madison, Yancey, Mitchell, Watson, Ashe, Alleghany, Caldwell, Burke, McDowell, Rutherford, Polk, Cleveland, Gaston, Lincoln, Catawba, Alexander, Wilkes, Surry, Iredell, Yadkin, and Rowan, and all territory embraced therein which may hereafter be created into new counties, shall hereafter constitute a new judicial district to be called the western district of North Carolina; and the circuit and district courts of the United States for said western district of North Carolina shall be held in the town of Statesville, Asheville, and Greensboro', within said district.
Sec. 2. That two terms of the circuit and district courts of the United States for said western district of North Carolina shall be held at the following times and places in each year, to wit: At Greensboro', beginning on the first Monday in April and in October; at Statesville, beginning on the third Monday in April and in October; at Asheville, beginning on the first Monday in May and in November.
Sec. 3. That the district of North Carolina shall hereafter consist of the counties not named in this act, and shall be called the eastern district of North Carolina, and shall be held in the town of Statesville, Asheville, and Greensboro', within said district.
Sec. 4. That the said circuit and district courts for either of said districts may, in their discretion, order special terms thereof in cases of criminal and civil cases, as such terms and places as they may designate in said districts, and order a grand jury and a petit jury, or both, to attend the same, by an order to be entered of record thirty days before the day at which said special terms shall be held in each case; and said courts, respectively, at such special terms shall have all the powers that they have at the regular terms appointed by law: Provided, however, that no grand jury shall be ordered to attend either district shall be appointed except by and with the concurrence and consent of the circuit judge.
Sec. 5. That all suits and other proceedings of whatever name or nature, now pending in the circuit or district court of the United States for the district of North Carolina, except as hereinafter provided, shall be tried and disposed of in the circuit and district courts, respectively, for said eastern district, and the same words shall be construed as if said suits, actions, and proceedings were pending in the district court of the United States for the district of North Carolina, and the clerk of the circuit and district courts of the present district of North Carolina shall be held in each of the places hereafter appointed, and to do and perform all the duties appertaining to the said offices, respectively, within the limits of each of the places hereafter appointed, and to do and perform all the duties appertaining to the said offices, respectively, within the limits of each of the places hereafter appointed, and to do and perform all the duties appertaining to the said offices, respectively, within the limits of each of the places hereafter appointed.
Sec. 6. That upon application of any party to any suit or proceeding, civil or criminal, now pending in the present circuit or district court of the United States for the present district of North Carolina, which should have been commenced in the proper court for the western district of North Carolina if this act had been in force at the time of its commencement, such suit or other proceedings shall be removed for further proceedings to the proper court for said western district, and thereupon the clerk shall transmit the original papers, and copies of all orders made therein to the clerk of the court in which said suit or proceedings shall be removed for trial or other proceedings therein as if originally been commenced therein; the district attorney of said western district to designate the court to which all suits and proceedings, and judgments and criminal proceedings, where the United States is plaintiff, shall be removed, and the plaintiff, or his attorney, in all other suits to designate the court to which they shall be removed; and no suit, judgment, or criminal proceeding, where the defendant is the plaintiff, shall be transferred until proper bail is given for him to appear accordingly: Provided, That all suits and other proceedings, not criminal, and not now pending in the Cape Fear district court of the United States, at Salisbury, with all the original papers therein, shall be transferred for trial or other proceedings as if the said district of North Carolina for said western district of North Carolina, to be held at Salisbury, beginning on the second Monday in August, D. eighteen hundred and seventy-two and all suits and proceedings, and judgments and criminal proceedings, shall be removed, then finally disposed of, shall, with the original papers therein, be transferred to the district court of said western district at Greensboro' or Statesville, as the party may order; and all necessary and proper proceedings shall be taken to remove the said suits and proceedings to the

[GENERAL NATURE—No. 104.]
AN ACT amendatory of an act entitled "An act constituting public lands to the several States and Territories which may provide colleges for the benefit of agricultural and mechanical arts," passed July second, eighteen hundred and sixty-two, and acts amendatory thereto, and to amend said acts.
Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the lands granted, to the State of Oregon, for the establishment of an agricultural college, by act of Congress of July second, eighteen hundred and sixty-two, and acts amendatory thereto, may be selected by said State from any lands within said State subject to homestead or pre-emption entry under the laws of the United States; and in any case where land is selected by the State, the price which is fixed by law at the double minimum of two dollars and fifty cents per acre, such land shall be counted as double the quantity toward satisfying the grant.
Sec. 2. That as such selections already made by said State, and the State fully filed in the proper district land-office, be, and the same are hereby, confirmed, except so far as may conflict with any adverse legal right existing at the passage of this act; and the lands so selected, and which do not receive more than ninety thousand acres, the quantity granted by the act of July second eighteen hundred and sixty-two; Provided also, That such lands shall not be sold by said State for less than two dollars per acre; and where settlement is made upon the same, preference in all cases shall be given to actual settlers at the price for which said lands may be selected.

[GENERAL NATURE—No. 105.]
AN ACT to make away the circuit court jurisdiction of the district court of Georgia, to create a circuit court in said district; and for other purposes.
Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That as much as any act or acts of Congress in force in the district court of the United States for the northern district of Georgia, and the same is hereby, repealed; and there shall hereafter be a circuit court, to be held in said district, provided over by the circuit court now in, or hereafter may be, in the northern district.
Sec. 2. That all actions, suits, executions, claims, pleas, progers, and other proceedings relative to any cause, civil or criminal, which might have been brought and would have been brought and would have been originally cognizable in a circuit or removed thereunder any act of Congress, pending in or returned to the district court of the United States for the northern district of Georgia, at the time appointed for holding the next term thereof, are hereby deemed to be transferred and made returnable to the circuit court constituted by this act, to be held within said district, and shall be heard, tried, and determined therein, in the same manner as if originally instituted in or removed to such circuit court. And the said circuit court shall be governed by the same general laws and regulations as apply to other circuit courts of the United States, and the clerk of said circuit shall perform the same duties and shall be entitled to receive the same fees and emoluments which are by law established for the clerks of the United States and shall be appointed by the circuit judge of circuit: Provided, That the present clerk of the district court for said northern district shall be clerk of the circuit court of said district until another appointment be made in his place or he be otherwise removed.

PROCLAMATION By the Governor of the State of Texas. TWO ALL TO WHOM THESE PRESENTS SHALL COME. Whereas, it is provided by section thirty-seven (37) of article (3) of the constitution of this State, that at the first general election after the acceptance of the Constitution by the Congress of the United States, an election shall be held to elect permanently the seat of government of the State of Texas. Now, therefore, I, EDMUND J. DAVIS, Governor of Texas, by virtue of the authority vested in me by the Constitution and laws of this State, do hereby order and direct that said election for the permanent seat of government of the State of Texas shall be held on the 16th day of July, A. D. 1872, and continuing four consecutive days, viz: the fifth, sixth, seventh and eighth days of November, A. D. 1872. The returns of said election shall be transmitted to the Governor and other returning officers in accordance with law. The attention of officers of the law, voters and others is called to provisions of the law of this State and the United States, enacted to secure the free exercise of the rights of suffrage, and the punishment of those who may in any manner attempt to interfere with this franchise. In testimony whereof, I have hereunto signed my name and have caused [L. S.] the great seal of the State to be affixed, at the city of Austin, this 16th day of July, A. D. 1872. EDMUND J. DAVIS, Governor. JAMES F. NEWCOMB, Secretary of State. 1-8-72-w/1d.
