THE GERMAN STUDENT DUEL.

A Custom More Honored in the Breach than in the Observance.

A correspondent of the London Standard, writing from Bonn, gives the following interesting description of a German student duel:

"I will endeavor to describe a duel that I witnessed lately. I was told by one of my student friends that an entertainment of an unusually interesting nature would take place that afternoon within a short distance of the town. Accordingly, about 3 o'clock I called a fly, and told the driver to drive me out to the place where the students were going to fight; and without hesitation he at once took me there. Nominally there is a good deal of mystery connected with these duels, as a fact there is scarcely a flyman in the town who does not know all about them. They are forbidden by law, and interdicted by the police; practically, however, probably the very last thing that a police agent would dream of doing would be to interfere with one of them. I asked one of the chief police officers what his views were on the subject. He replied: 'Oh, it does those young fellows good to lose a little blood; they have often too much of it.' On coming near the scene of action I perceived two processions of carriages advancing by different roads from Bonn. These were filled with the students of the rival corps and their friends. Each side had its attendant doctor, who appeared to be provided with lint, bandages, and other surgical apparatus sufficient to dress the wounds of a regiment going into action. The defensive armor, moreover, of both the principals and their seconds was by no means inconsiderable.

The first pair selected to fight were very different as regards both age and appearance; one was a fair haired, good looking boy of about eighteen summers; the other a bloated looking man, who might have been thirty or more, his face marked with innumerable scars of former duels, and his general bearing traces of much beer and dissipation. Before beginning, the younger of the two duelists came up to me and asked whether we had similar duels at our universities. I replied that we had not, and that when I was at Cambridge we found other means of amusing ourselves besides hacking each other's faces. Apparently somewhat nettled, he remarked that English faces were too good looking to be disfigured by scars. I replied at the time, that on the contrary, we were so ugly in the first instance that if we allowed our faces to be marked no lady would look at us. The formalities of the duel were arranged with considerable solemnity, a judge was appointed, who read out the conditions and stood as umpire. It was settled that the fight was to last for 15 minutes, and that they were to use bandages but no caps. The weapons were two long swords without points, but extremely sharp, and double edged at the points. The defensive armor of the combatants was both ponderous and complicated, iron cases protected the eyes, a huge leather bandage protected the throat, an equally safe covering defended the sword arm and shoulder; the upper part of

the chest was left bare, but from the lungs down to below the hips a mass of leather and wadding sheltered the vital parts of the body from damage.

The seconds were almost as fully encased in leather and bandages to prevent any glancing blow hurting them. Each stood beside his principal, sword in hand, and intercepted any unfair strokes of the adversary, or, in case his principal was wounded, stopped the fight. As the sword side is fully protected by the bandages, and the sword arm, if the latter is raised high enough, the great object of each combatant appeared to be to cut over the guard of his opponent on the opposite side. Thus nearly all German students are scarred on their left cheeks, those that are left handed on the right. In the present instance the elder of the two, although by far the most experienced and by repute the best swordsman, had his cheek laid open by so serious a cut that he was at once pronounced *hors de combat*; he bled profusely, and, perhaps to add to the excitement, his friends began to look on the ground for the piece of his cheek which was supposed to be cut out of it, but without success. Two other encounters of a similar kind followed; in each instance either or both of the combatants had to retire with the face covered and streaming with blood, and was handed over to the tender mercies of the attendant-doctors, whose needles, lint, and bandages were brought into requisition. Al together I can not say that I was impressed either by the civilization or manliness of this amusement; there is undoubtedly a certain element of danger, which possibly is the great attraction. To be a really good swordsman a man must possess a quickness of eye and wrist, combined with a moderate allowance of courage and determination; but these qualities are developed to an infinitely greater extent by the various sports in which young Englishmen are in the habit of indulging.

Fancy an English university situated on a river magnificent as the Rhine, and its members never venturing on it in any boat lighter than a steamer; still, such is the case here. I have many other duels in addition to those I have described. In some instances representatives of other German universities came here to have a friendly match with one of the corps of students belonging to the place. Whenever there was such an inter-university match the excitement was always greater, while the joy of the victors and the annoyance of the defeated were proportionately more acute. As a rule the duel continues until one of the players has received so severe a cut on his face that he can not go on. Strange to say these scars and marks, to our eyes so unsightly and disfiguring, are regarded with the greatest pride by their possessors, and are, it is said, envied by those who are so unfortunate as not to possess them. It will be remarked that comparatively few German officers have any of these student scars on their faces; those who have, received them before they became officers, since the military authorities strictly forbid any such encounters, and rigidly enforce obedience of their orders.

THE NEW INFERNAL MACHINE.

(From the Birmingham (Eng.) Post.)

We mentioned the other day that the French Minister of Marine had sent out a circular warning ship-owners, captains, and insurance agents against the new "infernal machine," intended for the destruction of vessels which, for fraudulent purposes, it is desired to destroy. But for the respectable authority on which the warning was given, the alleged invention might have been regarded as a hoax, and, indeed, we suggested as much. It is an irregular-shaped piece of metal, about six inches long, by three broad, and two and a half deep; and it is so constructed as exactly to resemble a small block of steam coal. Indeed, the specimen we have is evidently modeled from an actual piece of coal, and is colored a bright black so skillfully that on casual inspection it would readily pass muster for coal, and so might be put into the coal-bunkers of a vessel without exciting the least suspicion. The interior is hollowed so as to admit of the introduction of a detonating compound, and a mechanical contrivance is arranged in the hollow part so as to insure explosion at a desired moment. We have also an exact description of the materials employed to fill the shell—for such it may be called—but these, for obvious reasons, we decline to publish. There is only one thing at all satisfactory in reference to this diabolical invention—that it is not of English make.

A good paper is like the pure air—it imparts health and purity wherever it goes. THE GERMAN STUDENT DUEL.

A Custom More Honored in the Breach than in the Observance.

A correspondent of the London Standard, writing from Bonn, gives the following interesting description of a German student duel:

"I will endeavor to describe a duel that I witnessed lately. I was told by one of my student friends that an entertainment of an unusually interesting nature would take place that afternoon within a short distance of the town. Accordingly, about 3 o'clock I called a fly, and told the driver to drive me out to the place where the students were going to fight; and without hesitation he at once took me there. Nominally there is a good deal of mystery connected with these duels, as a fact there is scarcely a flyman in the town who does not know all about them. They are forbidden by law, and interdicted by the police; practically, however, probably the very last thing that a police agent would dream of doing would be to interfere with one of them. I asked one of the chief police officers what his views were on the subject. He replied: 'Oh, it does those young fellows good to lose a little blood; they have often too much of it.' On coming near the scene of action I perceived two processions of carriages advancing by different roads from Bonn. These were filled with the students of the rival corps and their friends. Each side had its attendant doctor, who appeared to be provided with lint, bandages, and other surgical apparatus sufficient to dress the wounds of a regiment going into action. The defensive armor, moreover, of both the principals and their seconds was by no means inconsiderable.

The first pair selected to fight were very different as regards both age and appearance; one was a fair haired, good looking boy of about eighteen summers; the other a bloated looking man, who might have been thirty or more, his face marked with innumerable scars of former duels, and his general bearing traces of much beer and dissipation.
