An Interesting Discussion.

A subject which seems to deserve the most earnest attention of the citizens of San Antonio, is under rather passionate discussion among Saint Louis papers. It is the question of the introduction of the German language into the public schools. We follow the contest with intense interest, since the same problem will probably soon be presented to us, for practical solution.

It is not our intention to too roughly enter into the pros and cons now, but we cannot refrain from presenting a few salient points to our readers.

The most comprehensive charge brought against the advocates of the measure is, "German know-nothingism." Nothing is easier and cheaper than the hurling of snoring epithets of abuse at the head of an opponent; to logically sustain a charge, is quite another thing.

There are some Germans in this State who feel exceedingly tender-footed in regard to anything that may seem to be in the least tinged with "German know-nothingism."

They sometimes carry their mistaken delusion in this matter to the very verge of absurdity. On the other hand, we utterly refuse to argue with a man, who is so decidedly impervious to the force of arguments, that he cannot see anything good, outside of "Old Germany;" we address our remarks to persons of average good sense.

The term know-nothingism seems to always involve the idea of oppression of the class less strong than the oppressors, a deprivation of some natural and civil rights.

However, even a small minority of citizens, no matter how strongly and compactly they may act in concert, in advocacy of certain interests and policies, be justly charged with know-nothingism!

WASHINGTON.
