Pay of Church Choirs.
 As a class of men and women,
 church singers and musicians in
 New York are fairly paid. Some
 claim even that they are paid too
 highly, and that too much atten-
 tion is devoted by some to the mere
 money they receive, and that to a
 certain extent the religious charac-
 ter of their services is entirely ig-
 nored. These views were expressed
 to a representative of the *Herald*
 by a prominent musician, himself a
 church organist and musical direct-
 or. On the other side, a gentleman
 equally prominent in church music
 expressed the opinion that church
 music was in a lower status than it
 should be, simply because the sala-
 ries paid were too small to command
 the best talent. The figures are
 these: Church organists receive sala-
 ries from \$1,000 upwards, one or-
 ganist receiving as high as
 \$2,500. Soprano receive from \$800
 to \$1,500 per annum—cases have
 been known in which they have
 been paid as high as \$2,000. Ten-
 or receive about \$1,000 per an-
 num; contralto from \$700 a year up-
 wards. A bass voice is well paid,
 some cases receiving as high as \$1,
 200 to \$1,500 per annum. These fig-
 ures seem "fair" when it is consid-
 ered, on one hand, that a high or-
 der of musical ability and culture
 is required, and, on the other hand,
 that the positions require but one
 day's service during the week and
 not more than one night's average
 rehearsal. Sometimes the organist
 is entrusted with the entire "approp-
 riation" for the music of the church,
 and makes all engagements and
 pays salaries. Sometimes the mat-
 ter is in the hands of a committee,
 and the organist himself ranks mere-
 ly as one of the musicians. In one
 case in this city, an organist has
 undertaken to "job out" the music
 of several churches, taking the "approp-
 riation" of them all, and out of it
 securing musicians by the whole
 sale. To this course the musicians
 themselves generally object.—*New
 York Herald.*

A Personal Description of Mrs. Titton.
 [From the New York Graphic, July 23.]
 Mrs. Elizabeth R. Titton, whose
 name has become unfortunately con-
 spicuous in connection with the
 great Brooklyn scandal, is a lady of
 about forty years of age. She is
 under medium height, with black
 hair and eyes, a face that is inter-
 esting though not beautiful, with
 an expression that indicates unusu-
 al sensibility and sentimentality
 rather than intellectual force or refine-
 ment. Her appearance is modest
 and her air peculiarly sincere and
 confiding. Her manners are easy
 and natural, with a simple grace
 which is more pleasing than what
 passes for elegance in polite society.
 Her prevailing mood is profoundly
 serious, lit up with occasional gleams
 of joy and sometimes breaking into
 a beautiful playfulness. At times,
 when her feelings are pleasantly
 excited and her face glows with ex-
 pression, she appears really hand-
 some; at other times, when depressed
 or wearied or unexcited, her eye
 is lustreless and her face is dull and
 unattractive. She is a good house-
 keeper and an excellent mother, de-
 votedly fond of her children, and
 doing more for them and spending
 more time in reading to them and
 talking with them than most moth-
 ers. Her tastes and habits are do-
 mestic, sentimental and religious
 rather than aesthetic or literary; her
 reading has not been extensive, and
 her favorite pictures are valuable
 for their sentiment rather than ar-
 tistic excellence or imaginative
 power. She has had seven children,
 four of whom are living. The el-
 dest is a daughter of more than or-
 dinary maturity of mind and force
 of character. She resembles her
 father much more than the other
 children—so much that she would
 be recognized as his daughter by
 those who are familiar with his fea-
 tures. Her home, on Livingston
 street, was once peculiarly attrac-
 tive and charming by affection that
 filled its rooms with a climate of
 summer and a fragrance as of bloom-
 ing roses; it was tastefully furnish-
 ed, graced with exquisite pictures,
 made poetic by the disposition and
 arrangement of its contents, and
 the ideal element visible and palpa-
 ble in every apartment. It seemed
 to realize the ideal of home.

District Politics.

BRACKENRIDGE-BAYLOR-KNOX—**STOCKDALE—THE POLITICIANS—THE REPUBLICANS.**

Our Democratic fellow-citizens held meetings in all the four wards of the city on Saturday evening last to elect delegates to their county convention, which is to meet in this city on the 8th instant, at which they will elect delegates to the Congressional Convention, which is to meet at Galena on the 26th of the present month. We notice that in three of the wards resolutions were adopted in favor of Maj. J. T. Brackenridge as the nominee of the Galena Convention. In the first ward, however, no recommendation was made of any particular man. Gen. Baylor and Gen. Knox, who are both candidates, were members of that meeting, which, we suppose, is the reason the meeting did not express an opinion in favor of any one man. It is understood, however, we believe, that the leaders of the Democratic party in this city and county have pretty generally settled upon Maj. Brackenridge as their choice for Congress. In this city he is evidently the strongest man; but Gen. Baylor seems to be the strongest man in most, if not all, of the frontier counties; while Gen. Knox seems to have considerable strength in the Rio Grande region, and scattered about in the District. Judge Upson was developing considerable strength until he caused it to be understood that he would not be a candidate.

In the meantime, the papers in the lower counties are declaring for Gov. Stockdale. Whether or not they represent the general wishes of the Democrats in that section, we are not advised; but we suppose they do. If such be the case, it would appear that at present Gov. Stockdale is the strongest man among the Democratic journals and leaders of the District. Whether or not he is the strongest man among the masses of Democratic voters, we are not prepared to say. Gov. Stockdale is not a people's man. He is not popular in the true sense of that term. He has none of the personal magnetism which makes a popular candidate. Among the ex-Confederate soldiers, he has no popular strength, as he made no record worthy of such a man during

our great and tremendous civil war. He was not in any way equal to such a gigantic emergency. He is an able man, an accomplished man, but a man unfitted to sympathize with and lead the people in a time of great trial. Both Brackenridge and Baylor are eminently his superiors in the popular sympathy and confidence. If Stockdale is the nominee, he will be the nominee of the politicians and wire workers, and not of the party. In a close race between two nearly equally matched parties he would be the easiest sort of a man to beat. Indeed, the Democracy would never think of nominating him if they did not feel certain of a safe majority in the District.

The movement for him is, at the secret bottom, a movement of the politicians of the party. It is a movement to elect a man to Congress who is a safe partizan, who lacks the courage to act with any independence, should the interests of Western Texas require it. It is a secret movement to elect a man who is in perfect harmony with John Ireland, and who is a safe supporter of the administration of Gov. Coke. Neither of these will be avowed or admitted by the men behind the scenes, for they know that both Ireland and Coke have greatly damaged Western Texas, and are not in good odor with our people. Stockdale is pitched upon, not because he is strong for frontier protection, or for the extension of railroads into Western Texas, or because he can have any influence in Congress in behalf of the improvement of Western Texas ports; but because he will be a safe partizan in the estimation of such men as Coke and Ireland.

There is another influence at work in behalf of Stockdale. He is the Vice-President of Morgan's railroad, and its attorney in fact, and is devoted to the interests of that road, to the exclusion of the Pierce road and the International, and regardless of what may be for the general interest of Western Texas.

It is the people of Western Texas are not wise enough to send an able and influential Republican to Congress, who can do four times as much for our interests as the best Democrat can do; if the Republicans are to be called on, for the sake of the interests of the District, to acquiesce in the election of a Democrat—a member of the party which abuses and vilifies all Republicans, and the national administration, in the most vituperative manner—it will be a great disappointment to them, if Stockdale should be nominated. It will be too bitter a pill for them to swallow. They will not swallow it.

Telegraphic Items.

THE TEXAS MERCHANTS IN LOUISVILLE.
LOUISVILLE, July 30.—The Texas excursionists arrived in this city last night, and were met at the depot by a delegation of merchants. To-day they meet the merchants at the Board of Trade, where they will offer a general interchange of remarks. Several addresses were made in the afternoon. A grand banquet was given to the visitors at the Louisville Hotel. Tomorrow they will be taken to points of interest in and about the city.

PERILS OF KANSAS JOURNALISM.
MANHATTAN, Mo., July 30.—Albert Griffin, editor of the *Nationalist*, was horsewhipped on the streets here this afternoon by a young lawyer named T. L. Magruder, who took offense at an article which appeared in Griffin's paper. There is a diversity of opinion in regard to the affair, some characterizing it as a cowardly assault, while others justify Magruder.

A DEMAND FOR THE RETURN OF THE POPE'S SHIP.

LONDON, July 30.—It is stated that Italy has made a demand upon France for a recall of the war ship *Oronoko*. A ship has been permanently stationed at Civita Vecchia as a refuge for the Pope in case of necessity.

REPUBLICAN CONGRESSIONAL MATTERS IN VIRGINIA

PROCEEDINGS, Va., July 30.—The Republican Congressional Committee of the First Congressional District, met at Tappahannock yesterday, and unanimously resolved to call no convention, and to make no nomination, but to leave the field to J. B. Sever, on his record as a Republican representative in the present Congress, and the committee further recommended Sever, unanimously to the people of the district.

ALABAMA DEMOCRATIC CONVENTION

MONTGOMERY, Ala., July 30.—The Democratic State Convention to-day nominated George S. Houston, by a unanimous rising vote, for Governor. A. R. Manning, of Mobile; C. Brickell, of Madison; and Thos. J. Judge, of Butler, were nominated for

Justices of the Supreme Court on the second ballot.

ALABAMA CONGRESSIONAL NOMINATIONS

WASHINGTON, D. C., July 29.—A dispatch from Uniontown, Ala., says the Republican Convention of the Fourth District of that State nominated Hays for Congress by acclamation.

ROCHEFORD BUSY WRITING LETTERS IN LONDON.

New York, July 30.—A London letter says: Rochefort's work is going on at a good pace. If you visit him at his hotel, you are likely to find him surrounded by four or five secretaries, all as busy as himself. It is not difficult to guess the intended destination of his writings, but of the means by which they are to reach it, it may not be prudent to say much.

AMERICAN BASK BALLISTS IN LIVERPOOL.

LONDON, July 30.—The two American bask ball clubs, now visiting England, gave their first exhibition match at Liverpool to-day. The attendance was large. The Athletics beat the Red Stockings in ten innings by a score of 14 to 11. The play was much admired, and called forth considerable applause from the spectators.

Long-continued rains might bring them, but they would be too late to do much injury. It is feared the continuance of dry weather may cause the young bolls to drop off. The *Herald* of this city is engaged in a controversy with the *Galveston* and *Houston* press in relation to the treatment of Western Texas in the matter of railroad legislation. It is especially worth with the *Houston* papers, and with the *Age* more than all. The *Age* says:

By the terms of its charter 1,600,000 acres are given to the Mexican, Gulf and San Antonio road.

Another 1,000,000 are given to the Harrisburg and San Antonio road.

And about the same amount is given to the Western Narrow Gauge from Houston to San Antonio.

Thus we have three companies chartered all pointing to San Antonio as their terminal points, and to those companies the State has offered four millions five hundred acres of land to be given from the general domain. And yet the *Herald* would have us believe that San Antonio has been entirely neglected.

To this the *Herald* makes the following reply:

The Mexican Gulf and San Antonio road never did receive the quantity of land thus specifically enumerated by the *Age*, nor has the Harrisburg and San Antonio road, and we challenge the proof; as for the third road, Western Narrow Gauge from Houston to San Antonio, we have never heard of the existence of such a road, and we infer the land donation, like the road itself, is but a myth.

The *Age* again says:

The Texas Pacific road gets an immense land grant, and from Fort Worth to El Paso it runs through 600 miles of the unsettled West. Then there is the Sabine Pass, El Paso and Mexican road, and the Rio Grande road, from Brownsville up to El Paso, and magnificently endowed with public lands.

The *Herald* comes back as follows:

Why this road thus far is only constructed in Eastern and Northern Texas, and if built through to the Pacific would not strike Western Texas until it reached Cent. Page Wicks on the Pecos. As for the other roads mentioned, they never had an existence, mere wild cat charters.

The *Age* then, in a very foolish and ignorant style, gets off the following:

Let San Antonio do as did the capitalists of Houston. Let them take the lands given by the State, and furnish the money from their own resources. In that way Western Texas may soon be checked all over with railroads.

The *Herald* replies to this as follows: What a farce! Why the very first thing that helped Houston out of her native swamp, was the United States Bonds for millions of dollars, set apart as the Education fund of the State, by which she was enabled to start her Central road, and which she has never refunded to the State Treasury, although by its use, Houston has called for her aid and built her road, the principal of the Education fund so that it could be released by the State to other railroad enterprises. It is possible that Western Texas would not have quite so many grounds of just complaint as the Grab all, Hold-all policy of Houston and other points trans-Colored.

The *Age* ought to know that Houston capital did not build her roads. It ought to know that no part of Texas has the capital to build railroads, much less Western Texas, vast and thinly populated as is her territory. Without help by Congress or the State, or both, railroads could not be built throughout Western Texas for twenty years to come. But if the East continues as selfish as the *Age* indicates, the West will unitedly seek division, and win it, also. The very next meeting of the Legislature will determine this matter.

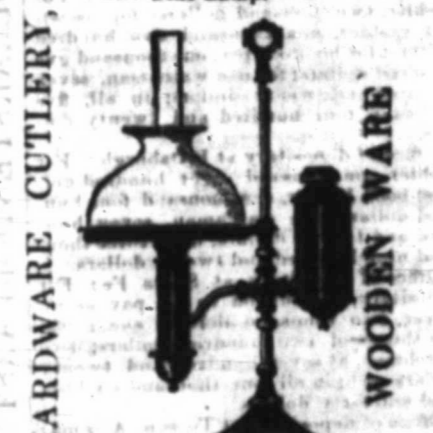

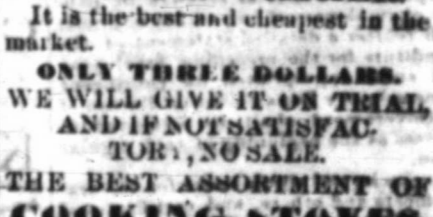

LAW OF THE UNITED STATES, PASSED AT THE FIRST SESSION OF THE FORTY-THIRD CONGRESS.

GENERAL NATURE—No. 53. AN ACT making appropriations for the legislative, executive, and judicial expenses of the Government for the year ending June thirtieth, eighteen hundred and seventy-five, and for other purposes.

Office of assistant treasurer at Baltimore: For assistant treasurer, five thousand dollars; for clerk, two thousand five hundred dollars; for two clerks, five thousand four hundred dollars; for three clerks, four thousand two hundred dollars; for two clerks, two thousand four hundred dollars; for one messenger, eight hundred dollars; for five vault-wardens, three thousand six hundred dollars; in all, twenty-three thousand nine hundred and forty dollars.
