Mr. C. P. Huntington, of the Northern Pacific Railroad, the line of which is said to be possible from San Francisco to El Paso, Texas, has written a letter full of facts and information to the Austin Freeman. It is stated, this road that the Central Texas Extension Company, composed of the leading capitalists of the Texas Central and International companies, is now being organized. It proposes to build from San Antonio toward El Paso to meet the Southern Pacific line (California). It also asks the benefit of the Texas land grant for the portion it builds.

Mr. Huntington says that his company has already invested \$15,000,000 in gold to build their road from San Francisco to the Colorado river, that most of that gold would not have been built for years for any local trade, but was hoarded in view of a through connection across the continent; and that having invested so much they prefer building as much as they can through a poor country, to secure through speculation, than to wait for the Texas Pacific to get Government aid.
