CRITICAL TIMES ON THE RIO GRANDE. THE news contained in the letter from Brazos, which we publish elsewhere, indicates that matters on the Rio Grande border may be approaching a crisis at last.

EXTENSION OF THE INTERNATIONAL RAILWAY. The article below, which we take from the editorial columns of the Austin Statesman, contains food for thought on a subject of paramount interest to San Antonio and Western Texas.

It will be observed that the International company must begin its compulsory work at Jefferson. It has extended the highway, since this act was passed, from Rockledge fifty miles to Austin, and since the two years contemplated will expire in July, thirty miles of the road, from Longview towards Jefferson, has been completed.

East Tennessee and Virginia. The wealth of Southern travel and traffic should be given to Southern railways. Louisville and Nashville and Richmond are deeply interested in this extension of the International to Jefferson, and thence to De Vaux's Hill, the point of connection in Arkansas of the road from Memphis. Such a road from Jefferson penetrates the richest farming districts of Arkansas, while Allen's Iron Mountain and St. Louis Road makes a desert waste accessible.
