Address to the People of the Sixth Congressional District.

I consider it proper to lay before my constituents a correct account of the circumstances surrounding the late proceedings of Congress on the Presidential contest...

Never in the history of our country has there been a time of complications and difficulties equal to the period between the 7th of November, 1876, and the 4th of March, 1877...

First, the closeness of the election, turning finally upon one electoral vote, arraying a nearly equal body of voters—about four millions on each side—equally anxious for victory...

It is true that theoretically the Southern States had become equals in the Union with the Northern States...

On the Democratic side there was the abstract right. We had the right of the majority of opposing force, if necessary...

No argument is needed to show to our people the necessity of avoiding a civil strife. As long as it lasts we shall not be equal participants in our national affairs...

Any discussion of events could easily see that any strife would at once result again in a hostile position of the two sections...

the electoral bill was presented to Congress by leading Northern Democrats...

When the bill was under discussion, the "General" Committee on the bill, which was then called the "Tilden Bill," was presented...

The idea that a certain amount of "aid" would be given to the Democratic side...

The passage of the bill was universally considered an advance to Tilden. For the first time no one doubted that it would result in Tilden's victory.

There is no doubt that the best judgment of the country was in favor of the bill...

Mr. Bayard had closed his speech in behalf of the Electoral Bill as follows:

At a second time we were thrown upon our judgment. We had the right of the majority of commission had counted in Hayes, a large number of Democrats, exasperated and stung to the highest pitch of indignation...
