

4,000-Foot Wildcat Staked Near Clyde In Callahan County

A wildcat is to be drilled 4 1/2 miles northwest of Clyde in Callahan County, on location between the Three Aces and Dyer-Strawn Fields.

It is McCarrick, Gouger and Mitchell of San Antonio No. 2 A. E. Dyer Heirs.

Having a proposed depth of 4,000 feet with rotary, it spots 1,650 feet from the north and 330 feet from the west lines of G. W. Riley Survey 56.

Rhodes Drilling Company No. 3-A A. E. Dyer, section 57, BBB&C Survey, seven miles northwest of Clyde, has been completed as the third producer in the Dyer Strawn pool.

It flowed 189.56 barrels of 40 gravity oil daily through 24/64-inch choke and open hole at 3,866 to 3,869 feet.

Warren & Wico, Cisco, No. 1 Tom Odum, 1,320 feet from north and 1,460 feet from west lines of section 15, BBB&C Survey, is a 1,500-foot wildcat three miles northeast of Denton and 1 1/2 miles southeast of production.

Neaves Petroleum Developments of Beverly Hills, Calif., announced location for a new wildcat eight and one-half miles northeast of Baird.

Slated for 1,350 feet with rotary, it will be 420 feet from the north and 636 feet from the west lines of the east half of Section 16, ETRR Survey.

Application to deepen a wildcat five miles northeast of Baird has been filed by William D. Austin of Abilene. The test, No. 1 James L. Snyder, originally was slated for 2,700 feet, but now will be drilled to 4,200 feet.

Daily potential was 126 barrels of 43 gravity oil, through a 70/64-inch choke with packer on casing and 130 pounds on tubing. Production was from 16 perforations at 1,550-1,554 feet. Casing was set on bottom at 1,586 feet. Gas-oil ratio was 300-1.

R. W. Brown of Abilene has completed three new producers in the A. C. Scott (Cross Plains Sand) Field, two of them on the Fred Heysler lease in William A. Smith Survey 219.

No. 1-C Fred Heysler pumped 61 barrels of 44 gravity oil, plus 5 per cent water, in 24 hours. Oil came from 24 perforations at 1,825-28 feet, where formation was ruptured. Casing was set at 1,843 feet, total depth.

Daily potential for No. 1-D Fred Heysler was 115 barrels of 44 gravity oil, pumping from 16 perforations at 1,861-63 feet. Total depth was 1,900 feet, with casing run to bottom. Formation was ruptured.

The No. 2-C Naomi Heysler, William Scurlock Survey 211, flowed 137 barrels of 44 gravity oil daily. Production was through 26 64-inch choke with packer on casing and 20 pounds on tubing. Flow was from 24 perforations at 1,831-34 feet. Casing was set on bottom at 1,870 feet. Gas-oil ratio was 365-1.

Paramount Oil Co. of Abilene No. 2-A Troy Gifford has been completed as a St. Patrick (Tannehill) Field producer five miles north of Clyde in SP Survey 1, Block D.

Daily potential was 53.55 barrels of 39 gravity oil, plus 10 per cent water, pumping from 66 perforations at 1,525-1,540 feet. Casing was set at 1,596 feet.

EDITORIAL

DRIVE ON "COMIC" BOOKS

Fort Worth and Dallas are currently conducting campaigns against so-called "comic" books of the kind Dr. Frederick Wertham of New York denounced in a book, "Seduction of the Innocent."

In Fort Worth a mayor's committee is riding herd on the distribution of undesirable books of this type, principally by persuading drug stores and newsstands not to carry them. This campaign is making progress, for reputable dealers are willing to cooperate.

In Dallas, a News staff writer is telling the story in a series of articles describing the contents of "comic" books designed to attract children, only to stuff their heads with violence and murder, and other types aimed at the high school trade, where the emphasis is on sex. The News points out that "these are juvenile comic books and not the regular pulp love magazines."

We do not know what the situation is in our community, but we imagine that it does not differ greatly from the general situation. We imagine reputable dealers here, as elsewhere, would be found cooperative in any effort to dry up this source of the corruption of youth.

The drives against degrading "literature" in Dallas and Fort Worth, if successful, should place other communities on their guard; for the makers and marketers of this trash, driven from the large cities, will concentrate on the smaller places. They are in business for one purpose, and one purpose only: to make a profit.

In Fort Worth the drive originated in the City Council, and has the cooperation of the police. There is only so much the authorities can do with a situation of this kind. Basically, it is a parents' job. If parents, as individuals and as groups, don't take enough interest in the type of corrupting influences that their children are exposed to, it is a little too much to expect the police to originate and carry out a drive without the help and encouragement of the citizenry.

And if New York City and other large communities throughout the nation are concerned over this problem, it is high time the smaller places showed some interest in it.

SOIL EROSION



(Editor's Note — This is the second in a series of articles on Soil Erosion, prepared by the Soil Conservation Service.)

II. Preventative Treatment

1. Cover and Litter.
A minimum of 2,000 pounds of cover and litter per acre managed for erosion control enables farmers and ranchers to farm and ranch at a profit.

Nature controls both wind erosion and water erosion by preserving a mulch on the land. When we try to understand the needs of nature and supply those needs, we will be rewarded with higher yields. Nature will take over much of the heavier work of farming by keeping the soil loose and permeable to water and roots, thus eliminating the necessity for some of the cultivation. When cultivation is needed it will be much easier in a soil that is in good physical condition.

Scientists and many farmers recognize mulch farming as one of the greatest techniques for holding soil. Mulch farming means working with mulch, raising crops through it, working the ground under it, but never working it under.

Mulch farming, also called stubble farming, is a necessity on land that is subject to wind erosion and is being used more and more for the control of wind erosion. It has other values. It gets water into the soil and conserves it there. It slows evaporation of water from the soil. It prevents extreme changes in soil temperature, maintaining a temperature more favorable

in a bare soil.

2. Soil Conditioning.
For maximum production, soils must be kept in good physical condition and a high state of fertility. This probably is of even greater importance with mulch farming than with clean tillage practices. However, mulch farming can be managed in such a way that it will build up nitrogen, encourage activity of beneficial soil organisms, help control weeds and improve the physical condition of the soil.

Cover crops for mulch farming can be used to remove excess moisture. For example, vetch on the land to be followed by cotton will take a lot of moisture from the soil in the spring before cotton planting time. In a wet spring season the vetch can be left growing until cotton planting time. It will help to dry out the soil so that the land can be planted several days sooner than if the soil was bare. In a dry spring the vetch can be cut loose from the ground before the soil gets too dry, and the mulch will conserve the moisture for the cotton crop.

3. Pattern of Farming.
In order to maintain residue on the surface in cultivated land, special tillage equipment is necessary. To keep the residue on the surface, subsurface tillage tools that loosen and pulverize the soil without burying the

residue are used. In order to keep the residue on the surface until the next crop is large enough to protect the soil, both tillage and planting operations must be done without burying the residue.

The sub-surface tiller has a sweep or blade that runs beneath the surface. These tillers may have large single sweeps sometimes as much as eight feet across, or they may have several smaller sweeps. A sub-tiller with rolling coulters in front of the sweeps can work through a mat of residue without difficulty. Depth-gauge wheels on tillers add materially to the smoothness of operation.

Machines such as the skew treader may be used to pack the soil somewhat and help eradicate weeds. This machine consists of two lines of fingered wheels which cultivate as they rotate.

A planter equipped with disk furrow openers as desirable for working through residue. To avoid clogging, a disk rolling coulters between the disks may be used.

To maintain residue on the surface until the row crop has reached considerable height, a sweep-type cultivator has been used. Large sweeps help to keep the mulch on the surface. Disk tillers may be mounted next to the rows to help eradicate weeds in the rows.

When clean tilled crops which provide little protection against wind erosion are grown, strip cropping with sorghum or suitable may be necessary. The rows should run about at right angles to the direction of the prevailing winds. The erosion resisting strips should be spaced closely

enough to protect the non-erosion resisting crop. The strips should probably be not less than four rows wide and may be wider. The width of the main crop strips may vary but generally should not be greater than 20 rows. The actual width will depend on soil type, direction of rows, and type of crops involved.

No rigid system of cropping or rotation has been devised that can equal a flexible cropping plan in effective wind erosion control and economy of production. Such a plan should take into consideration the soil, moisture and fertility conditions at each successive planting period of the year. Crops should be selected which will provide sufficient cover under these varying conditions.

Frozen Pineapple Surprise

Broadcast: August 7, 1954

1/2 cup Pet Evaporated Milk
14-oz. can pineapple juice
1 cup thinly sliced, drained
ripe bananas
2 Tablespoons drained maraschino cherries, finely cut

2 Tablespoons pineapple juice
1/4 teaspoon salt
3-oz. pkg. white cream cheese, softened
1/4 cup sugar
2 teaspoons lemon juice

Put milk into ice cube tray of refrigerator. Chill until ice crystals begin to form around the edges. Mix in a bowl the pineapple, bananas, cherries, pineapple juice and salt. Let stand. Put soft cream cheese in a 1 1/2-quart bowl. Mix in the sugar until smooth. Fold in fruit mixture. Put ice cold milk into a small cold bowl and whip with cold rotary beater by hand, or with electric beater at high speed, until fluffy. Add lemon juice. Whip until stiff. Fold into fruit mixture. Freeze, without stirring, in ice cube tray of refrigerator. Makes 1 quart.
