



CHRISTIANITY, A WAY OF LIFE

Each week we have been pointing out what one must do to be saved. We have read from the Bible that man must believe (Hebrews 11:6), repent (Luke 13:3), confess Christ (Acts 8:36), and be baptized (Mark 16:16). But today we wish to point out the fact that Christianity is a way of life, a new life.

The Bible tells us many will have a "form of godliness but deny the power thereof." (2 Timothy 3:5) This, of course, refers to people who are not living the Christian life, yet they profess to be Christians. But the Bible says: "Therefore we are buried with him by baptism into death: that like as Christ was raised up from the dead by the glory of the Father, even so we also should walk in newness of life." (Romans 6:4) God does not tell us that we are turned "foot loose and fancy free" after becoming Christians, but rather He tells us that we are "new creatures in Christ Jesus." (2 Corinthians 5:17)

A woman told me one time at the point of tears that her husband drank, cursed, mistreated her and yet declared that he was a Christian. He had had some kind of an experience back through the years. But was he a Christian? Certainly not. Notice the warning of the Bible: "Be not deceived; God is not mocked: for whatsoever a man soweth, that shall he also reap." (Galatians 6:7)

Man will reap what he sows. To be saved he must live (sow) the Christian life, Man cannot live like the devil and have hope of going to heaven simply because he has had some kind of "religious experience."

It is one thing to BECOME a Christian and another thing to REMAIN a Christian. When the Christian sins he must go to God in prayer and ask for forgiveness. And he must truly repent before he will be forgiven and when he repents he will change. Christianity is a way of life.
