Fort Worth-Summer movement of cattle reached a peak at Fort Worth Monday that was a record for the season, and the largest run of grown cattle since 1934 arrived. Some 10.500 cattle and 1,500 calves were estimated and during the day both figures were eclipsed.

Biggest modern day run of cattle and calves to Fort Worth was the second week of October 1946, the week after OPA regulations were dropped. On that Monday, some 10,150 cattle and over 9,800 calves arrived. That being a season of heavy calf sales, which June is not, the combined totals far surpassed the Monday run at Fort Worth.

#### Chocolate Angels

2 egg whites; 1/8 teaspoon salt; 1/8 teaspoon cream of tartar; 1/2 cup sifted granulated sugar; 1/2 cup finely chopped walnut or pecan meats; ½ teaspoon vanilla.

1 package (% pound) sweet chocolate; 3 tablespoons water; 1 teaspoon vanilla; 1 cup cream, whipped.

Combine egg whites, salt, and cream of tartar in mixing bowl. Beat until foamy throughout. Add sugar, 2 table-spoons at a time, beating after each addition until sugar is blended. Then continue beating until mixture will stand in very stiff peaks. Fold in nut stand in very stift peaks. Fold in hut meats and ½ teaspoon vaniila and blend well. Using a spoon or pastry tube, shape this meringue mixture into rounds on unglazed paper on baking sheet, making each about 3 inches in diameter and 1½ inches high. With the back of a smoon wake a next like the back of a spoon, make a nest-like depression in the center of each. Bake in a slow oven (300\* F.) 30 to 35 min-utes. Cool and remove from paper. Makes 6 meringue shells.

Place chocolate and water in saucepan over low heat. Stir until chocolate is melted. Cool until thickened. Then add 1 teaspoon vanilla and fold into whipped cream. Spoon into center of meringue shells. Chill about 2 hours before serving. Top each with whipped cream and cherry cut in fan-shape. Makes 6 servings.





Families rate fruit shortcakes "tops" for dessert! And since we are coming into the peak straw-berry season, every homemaker should save this recipe for a rich, easy-to-make shortcake.

Strawberry Shortcakes

cups sifted all-purpose flour teaspoons baking powder 2 tablespoons sugar 1 teaspoon salt

3 cup Mazola Salad Oil Milk

Strawberries, sweetened to taste Whipped cream

Mix and sift dry ingredients together. Add egg to salad oil in measuring cup. Pour in milk to make 1 cup total liquid. Then pour all at once over entire surface of flour mixture. Mix with fork to make a soft dough. Shape lightly with hands to make a round ball Place on wax paper and knead lightly ten times or until smooth. Pat out to 1/2-inch thickness or roll between 2 squares wax paper (about 12 inches square). Remove top sheet of paper; cut shortcakes with unfloured 2½-inch cutter. Place on ungreased baking sheet. Bake in hot oven (450° F.) 12 to 15 minutes. Split shortcakes with a fork, while still warm. Spread fruit between layers and on top. (Use any fresh, frozen or canned fruit, as desired.) Serve with sweetened whipped cream. Makes 8 shortcakes.



A Perfect Pie - The Parfait Way

Rare indeed is a truly excellent pie that takes only 6 minutes to mix. Called Maple Nut Parfait Pie, it can be made in three simple steps with a minimum of fuss. Fruit-flavored gelatin and ice cream are the magic basis of this wonderfully different, new kind of pie whose creamy, light texture emphasizes the appeal of its delicate flaver. You'll want to serve it over and over again; here's the recipe:

Maple Nut Filling

1 package lemon-flavored gelatin 1¼ cups hot water

- pint maple nut ice cream 1 teaspoon maple flavoring cup chopped walnut meats
- 1 baked 8-inch pie shell, cooled 1. Dissolve gelatin in hot water in

2-quart saucepan.

Add ice cream by spoonfuls, stirring until melted. Add maple flavoring, and stir to blend. Then chill until thickened, but not set (20 to 30 minutes).

Fold in chopped walnut meats. Turn into pie shell. Chill until frm (20 to 30 minutes). Garnish with whipped cream and waln' halves.






