Banana Ice Cream

package vanilla pudding and pie filling mix; ¼ cup sugar; 2 cups milk; 1 cup heavy whipping cream; 1/2 cup mashed ripe bananas.

Combine pudding mix, sugar, and milk in a saucepan. Cook and stir over medium heat until mixture comes to a full boil. Remove from heat. Cool, then chill. Whip the cream; fold into pudding mix-ture. Then fold in bananas.

Pour mixture into freezing tray of refrigerator and set control for coldest freezing temperature. Freeze 1 hour. Then pour mixture into bowl and beat with egg beater or mixer until smooth, but not melted. Return to tray and freeze until firm. Freezing time: 3 to 4 hours. Makes 1 quart.


WEBB HUDSON'S BROTHER DEAD


METHODIST CHURCH NEWS



Proposed Constitutional Amend ments To Be Voted on at an Election To Be Held November 6, 1956

HOUSE JOINT RESOLUTION NO. 11 proposing an amendment to Article I of the Constitution of the State of Texas by adding section 15-a, requiring medical or paychiat-ric testimony for commitment of persons of unsound mind, and authorizing the Leg-sislature to provide for trial and commit-ment of such persons and for waiver of trial by jury where the person under in-quiry has not been charged with commis-sion of a criminal offense.
BE IT RESOLVED BY THE LEGISLA-TURE OF THE STATE OF TEXAS:
Section 1. That Article I of the Consti-tution of the State of Texas be and the same is hereby amended by adding another section thereto following Section 15, to be designated Section 15-a, to read as follows:
"Section 15-a. No person shall be com-mitted as a person of unsound mind except of insanity and commitment of per-sons of unsound mind and to provide for a method of appeal from judgments rendered in such cases. Sec. 3. The Governor of the State of Texas shall issue the necessary proclama-tion for said election and have the same published as required by the Constitution and laws of this State.

**Good Samaritan** 



REMNANTS OF ANCIENT SECT: About 200 of the last remaining members of a unique sect of Samaritan Jews still live peaceably in the town of Nablus, 10 miles north of Jerusalem, in Jordan, one of the Bible Lands. They are strict adherents to one God, believe only in the Pentateuch or first five books of the Old Testament and make three pilgrimages a year to Mt. Gerezim, their sacred mountain, for sacrificial rites. They pitch their tents and carry out ceremonies enjoined upon them since the time of Moses, including the sacrifice of a sheep for each person present. Their Patriarch, dressed in red turban and flowing white surplice, is shown here pointing to the words of the Torah of Law of Moses. The Good Samaritan who came to the rescue of the stranger on the road to Jericho, (Luke 10:33) was a member of this sect.







Queen Dina of Jordan -Beauty Plus Brains



From a simple school-teacher to the queen of an entire nation —this is the Cinderelia story of Jordan's beautiful Queen Dina.

Once upon a time, as our true story goes, a young student prince visited the home of distant relatives in Egypt. And in this home Prince Hussein of Jordan met his princess, Dina Abdel-Hamid Al-Aoun, daughter of the house. In addition to her beauty, the prince was impressed by his cousin's determination to pursue her education at Cambridge University in England. In an area where the veil remains more common than lipstick, a thoroughly modern wom-an was still somewhat of a novelty.

The prince continued his edu-callen at Harrow and Britain's Royal Military Academy while Dina earned the degree of Master of Arts at Cambridge and took a job as salaried lecturer in English literature at the University of Cairo. Several years later, after his father's death, the newly-crowned King Hussein visited Dina's father to ask for the hand of the daughter he had never forgotten.

Jordan's lovely Queen probably has the best formal education enjoyed by any queen in history. And even before her marriage in April 1955, Dina added to her formal knowled ge by visiting, incognito, Jordanian villages and refugee camps and talking to leaders of the feminist movement. By the time of her marriage, she was prepared to assume not only the honors of royalty but the responsibilities of good citizenship in her adopted land.

The Queen's daily routine in the palace at Amman now reads something like a cross between the duties of an executive and a busy housewife. Up at eight, she has breakfast and goes over the local and foreign press. Then comes her mail, much of which she handles personally; and the supervision of numerous orders necessary for the smooth running of a royal household. If she has any time left before luncheon at two, she reads her fa. vorite books of philosophy and poetry, including works by Shakespeare and Gibran Khail Gibran, the great Arab-American poet.

Lunch is usually with the King and his guests, who come from within the official circle or abroad. The meal may be fol-lowed by a walk or reception of the Queen's own visitors, par-ticularly men and women who are working to promote progress and welfare among the people of Jordan. Dinner is at nine, again with the King; and the rest of the evening may be spent watching movies at the palace or driving to visit a hospital or

charity party. Typical of the Queen is the fact that she greatly admires the vitality of American wo-men, and during her teaching days she emulated her western sisters by driving her own small car alone through Cairo's crowded streets. And what will be the effect of her influence on Jordan? Her marriage was barely eight months old, when the King promised to build a ne ? university in her honor. Further progress may surely be expected from Jordan's personable but hard-working Queen.
